A GLOBAL ANALYSIS PROOF OF THE STABILITY OF MINKOWSKI SPACE AND THE POLYHOMOGENEITY OF THE METRIC

ABSTRACT. We first give a new proof of the non-linear stability of the (3+1)-dimensional Minkowski spacetime as a solution of the Einstein vacuum equation. We then show that the metric admits a full asymptotic expansion at infinity, more precisely at the boundary hypersurfaces (corresponding to spacelike, null, and timelike infinity) of a suitable compactification of \mathbb{R}^4 adapted to the bending of outgoing light cones. We work in a wave map/DeTurck gauge closely related to the standard wave coordinate gauge. Similarly to our previous work on the stability of cosmological black holes, we construct the solution of the non-linear equation using an iteration scheme in which we solve a linearized equation globally at each step; to fix the geometry of null infinity throughout the iteration scheme, we devise a hyperbolic formulation of Einstein's equation which ensures constraint damping. The weak null condition of Lindblad and Rodnianski arises naturally as a nilpotent coupling of certain metric components in a linear model operator at null infinity. Furthermore, we relate the Bondi mass to a logarithmic term in the expansion of the metric at null infinity and prove the Bondi mass loss formula.

1. Introduction

We prove the non-linear stability of (3 + 1)-dimensional Minkowski space as a vacuum solution of Einstein's field equation and obtain a precise full expansion of the solution in all asymptotic regions, i.e. near spacelike, null, and timelike infinity. On a conceptual level, we show how some of the methods we developed for our proofs of black hole stability in cosmological spacetimes [HiVa16b, Hi16b] apply in this more familiar setting, studied by Christodoulou–Klainerman [ChKl93], Lindblad–Rodnianski [LiRo05, LiRo10], and many others: this includes the use of an iteration scheme for the construction of the metric in which we solve a linear equation globally at each step, keeping track of the precise asymptotic behavior of the iterates by working on a suitable compactification M of the spacetime, and the implementation of constraint damping. The global nature of the approach and the way in which we deal with the non-linearity are akin to how one would solve elliptic equations, though the underlying linear estimates are of course different. Moreover, in our systematic approach, both the relevant notion of regularity and the determination of the precise asymptotic behavior of the solution are clear from an inspection of the geometric and algebraic properties of the linearized gauged (or 'reduced') Einstein equation;

correspondingly, once M and the required function spaces are defined ($\S\S2-3$), the proof of stability itself is rather concise ($\S\S4-6$).

The estimates we prove for the linear equations—which arise as linearizations of the gauged Einstein equation around metrics which lie in the precise function space in which we seek the solution—are based on energy estimates, including versions giving iterated regularity with respect to certain vector fields, which are rather refined in terms of a splitting of the symmetric 2-tensor bundle (different components behave differently at null infinity); these vector fields are closely related to those used in [Kl86, ChKl93]. Recall that energy estimates are essentially positive commutator estimates, where the commutant is a vector field. This is a major restriction relative to microlocal estimates; however, the special feature is a better control of error terms, which is important for our analysis at null infinity: while the analysis on Minkowski space (or a modification of this with a logarithmically distorted light cone at infinity if the ADM mass is nonzero) can be done fully microlocally [BaVaWu16] on a (logarithmically modified) radial compactification of \mathbb{R}^4 , microlocal analysis seems much more difficult once one linearizes around metrics which are well-behaved (conormal) only on a blow-up of that compactification (see Figure 2.2).

Recall that in Einstein's theory of general relativity, a vacuum spacetime is described by a 4-manifold M° which is equipped with a Lorentzian metric g with signature (+, -, -, -) satisfying the *Einstein vacuum equation*

$$Ric(g) = 0. (1.1)$$

The simplest solution is the *Minkowski spacetime* $(M^{\circ}, g) = (\mathbb{R}^4, g)$,

$$g := dt^2 - dx^2, \quad \mathbb{R}^4 = \mathbb{R}_t \times \mathbb{R}_x^3. \tag{1.2}$$

The far field of an isolated gravitational system (M°, g) with total (ADM) mass m is usually described by the *Schwarzschild metric*

$$g \approx g_m^S = \left(1 - \frac{2m}{r}\right)dt^2 - \left(1 - \frac{2m}{r}\right)^{-1}dr^2 - r^2 \phi, \quad r \gg 1,$$
 (1.3)

where g denotes the round metric on \mathbb{S}^2 ; the Minkowski metric $\underline{g} = g_0^S$ differs from this by terms of size $\mathcal{O}(mr^{-1})$. In the absence of singular objects close to r=0, such as black holes, g is then expected to be a smooth extension of (a short range perturbation of) g_m^S to all of \mathbb{R}^4 . Such spacetimes are asymptotically flat: keeping t fixed and letting $|x| \to \infty$ in \mathbb{R}^3 , g approaches the flat Minkowski metric g in a quantitative fashion.

Suitably interpreted, the field equation (1.1) has the character of a quasilinear wave equation; in particular, it predicts the existence of gravitational waves, which were recently observed experimentally [LIGO16]. Correspondingly, the evolution and long time behavior of solutions of (1.1) can be studied from the perspective of the *initial value problem*: given a 3-manifold Σ° and symmetric 2-tensors $\gamma, k \in C^{\infty}(\Sigma^{\circ}; S^2T^*\Sigma^{\circ})$, with γ a Riemannian metric, one seeks a vacuum spacetime (M°, g) and an embedding $\Sigma^{\circ} \subset M^{\circ}$ such that

$$\operatorname{Ric}(g) = 0 \text{ on } M^{\circ}, \quad g|_{\Sigma^{\circ}} = -\gamma, \ II_g = k \text{ on } \Sigma^{\circ},$$
 (1.4)

¹On Kerr–de Sitter space, the linear estimates proved in [HiVa16a, HiVa16b] are based (almost) entirely on microlocal estimates from b-analysis. The huge freedom microlocal analysis gives is that one is not restricted to using e.g. symbols of pseudodifferential operators which happen to be linear on the fibers of the cotangent bundle (i.e. those of vector fields); this is crucial due to the complicated structure of the Hamilton dynamics e.g. at the horizons and at the trapped set.

where II_g denotes the second fundamental form of Σ° ; the minus sign is due to our sign convention for Lorentzian metrics. A fundamental result due to Choquet-Bruhat and Geroch [ChBr52, ChBrGe69] states that necessary and sufficient conditions for the well-posedness of this problem are the *constraint equations* for γ and k,

$$R_{\gamma} + (\operatorname{tr}_{\gamma} k)^2 - |k|_{\gamma}^2 = 0, \quad \delta_{\gamma} k + d \operatorname{tr}_{\gamma} k = 0,$$
 (1.5)

where R_{γ} is the scalar curvature of γ , and δ_{γ} is the (negative) divergence. Concretely, if these are satisfied, there exists a maximal globally hyperbolic solution (M°, g) of (1.4) which is unique up to isometries. By the future development of an initial data set $(\Sigma^{\circ}, \gamma, k)$, we mean the causal future of Σ° as a Lorentzian submanifold of (M°, g) . Our main theorem concerns the long time behavior of solutions of (1.4) with initial data close to those of Minkowski space:

Theorem 1.1. Let $b_0 > 0$. Suppose that (γ, k) are smooth initial data on \mathbb{R}^3 satisfying the constraint equations (1.5) which are small in the sense that for some small $\delta > 0$, a cutoff $\chi \in \mathcal{C}_c^{\infty}(\mathbb{R}^3)$ identically 1 near 0, and $\widetilde{\gamma} := \gamma - (1 - \chi)g_m^S|_{\{t=0\}}$, where $|m| < \delta$, we have

$$\sum_{j \le N+1} \|\langle r \rangle^{-1/2+b_0} (\langle r \rangle \nabla)^j \widetilde{\gamma} \|_{L^2} + \sum_{j \le N} \|\langle r \rangle^{1/2+b_0} (\langle r \rangle \nabla)^j k \|_{L^2} < \delta, \tag{1.6}$$

where N is some large fixed integer (N = 26 works). Assume moreover that the weighted L^2 norms in (1.6) are finite for all $j \in \mathbb{N}$.




FIGURE 1.1. Left: the compact manifold M (solid boundary), containing a compactification Σ of the initial surface Σ° . The boundary hypersurfaces i^{0} , \mathscr{I}^{+} , and i^{+} are called spatial infinity, (future) null infinity, and (future) timelike infinity, respectively. One can think of M as a blow-up of M as the blow-up of a Penrose diagram at timelike and spatial infinity. A global compactification would extend across Σ to the past, with additional boundary hypersurfaces \mathscr{I}^{-} (past null infinity) and i^{-} (past timelike infinity). Right: for comparison, the Penrose diagram of Minkowski space.

Then the future development of the data $(\mathbb{R}^3, \gamma, k)$ is future causally geodesically complete and decays to the flat (Minkowski) solution. More precisely, there exist a smooth manifold with corners M with boundary hypersurfaces Σ , i^0 , \mathscr{I}^+ , i^+ , and a diffeomorphism of the interior M° with $\{t>0\}\subset\mathbb{R}^4$, as well as an embedding $\mathbb{R}^3\cong\Sigma^\circ$ of the Cauchy hypersurface, and a solution g of the initial value problem (1.4) which is <u>conormal</u> on M and satisfies $|g-\underline{g}|\lesssim (1+t+|r|)^{-1+\epsilon}$ for all $\epsilon>0$. See Figure 1.1. For fixed ADM mass m, the solution g depends continuously on $\widetilde{\gamma}$, k, see Remark 6.4.

If the normalized initial data $(\langle r \rangle \widetilde{\gamma}, \langle r \rangle^2 k)$ are in addition \mathcal{E} -smooth, i.e. <u>polyhomogeneous</u> at infinity with index set \mathcal{E} (see below), then the solution g is also polyhomogeneous on M, with index sets given explicitly in terms of \mathcal{E} .

More precise versions will be given in Theorem 1.7 and in §6. The condition (1.6) allows for $\tilde{\gamma}$ to be pointwise of size $r^{-1-b_0-\epsilon}$, $\epsilon > 0$; since $b_0 > 0$ is arbitrary, this means that we allow for the initial data to be Schwarzschildean modulo $\mathcal{O}(r^{-1-\epsilon})$ for any $\epsilon > 0$. The assumption of \mathcal{E} -smoothness, i.e. polyhomogeneity with index set $\mathcal{E} \subset \mathbb{C} \times \mathbb{N}_0$, means, roughly speaking, that $\langle r \rangle \tilde{\gamma}$ (similarly $\langle r \rangle^2 k$) has a full asymptotic expansion as $r \to \infty$ of the form

$$\langle r \rangle \widetilde{\gamma} \sim \sum_{(z,k) \in \mathcal{E}} r^{-iz} (\log r)^k \widetilde{\gamma}_{(z,k)}(\omega), \quad \omega = x/|x| \in \mathbb{S}^2, \ \widetilde{\gamma}_{(z,k)} \in \mathcal{C}^{\infty}(\mathbb{S}^2; S^2 T^* \mathbb{R}^3), \tag{1.7}$$

with $\operatorname{Im} z < -b_0$, where for any fixed C, the number of $(z,k) \in \mathcal{E}$ with $\operatorname{Im} z > -C$ is finite. (That is, $\langle r \rangle \widetilde{\gamma}$ admits a generalized Taylor expansion into powers of r^{-1} , except the powers may be fractional or even complex—that is, oscillatory—and logarithmic terms may occur. A typical example is that all z are of the form z = -ik, $k \in \mathbb{N}$, in which case (1.7) is an expansion into powers r^{-k} , with potential logarithmic factors.) The polyhomogeneity of g on the manifold with corners M means that at each of the hypersurfaces i^0 , \mathscr{I}^+ , and i^+ , the metric g admits an expansion similar to (1.7), with r^{-1} replaced by a defining function

of the respective boundary hypersurface (for example \mathscr{I}^+) such that moreover each term in the expansion (which is thus a tensor on \mathscr{I}^+) is itself polyhomogeneous at the other boundaries (that is, at $\mathscr{I}^+ \cap i^0$ and $\mathscr{I}^+ \cap i^+$). We refer the reader to §2.2 for precise definitions, and to Examples 7.2 and 7.3 for the list of index sets for two natural classes of polyhomogeneous initial data.

Applying a suitable version of this theorem both towards the future and the past, we show that the maximal globally hyperbolic development is given by a causally geodesically complete metric g, with analogous regularity and polyhomogeneity statements as in Theorem 1.1, on a suitable manifold with corners whose interior is diffeomorphic to \mathbb{R}^4 (and contains Σ°), which now has the additional boundary hypersurfaces \mathscr{I}^- and i^- ; see Theorem 6.7 and the end of §7.

Like many other approaches to the stability problem (see the references below), our arguments apply to the Einstein–massless scalar field system $\operatorname{Ric}(g) = |\nabla \phi|_g^2$, $\Box_g \phi = 0$, with small initial data for the scalar field in order to obtain global stability, and also give the stability of the far end of a Schwarzschild black hole spacetime with any mass $m \in \mathbb{R}$, i.e. of the domain of dependence of the complement of a sufficiently large ball in the initial surface, without smallness assumptions on the data; in this case, we control the solution up to some finite point along the radiation face \mathscr{I}^+ . See Remark 6.6.

The compactification M only depends on the ADM mass m of the initial data set;² for the class of initial data considered here, the mass gives the only long range contribution to the metric that significantly (namely, logarithmically) affects the bending of light rays: for the Schwarzschild metric (1.3), radially outgoing null-geodesics lie on the level sets of

²By the positive mass theorem [SchYa79, Wi81], we have $m \ge 0$, but we will not use this information. In fact, our analysis of the Bondi mass, summarized in Theorem 1.8 below, *implies* the positive mass theorem for the restricted class of data considered in Theorem 1.1.

 $t-r-2m\log(r-2m)$. Concretely, near $i^0\cup\mathscr{I}^+$, M will be the Penrose compactification of the region $\{t/r < 2, r \gg 1\} \subset \mathbb{R}^4$ within the Schwarzschild spacetime, i.e. equipped with the metric g_m^S , blown up at spacelike and future timelike infinity. As in our previous work [HiVa16b, Hi16b] on Einstein's equation, we prove Theorem 1.1 using a Newton-type iteration scheme in which we solve a linear equation globally on M at each step. We do not quite use the wave coordinate gauge as in Lindblad-Rodnianski [LiRo10, LiRo05], but rather a wave map gauge with background metric given by the Schwarzschild metric with mass mnear $i^0 \cup \mathcal{I}^+$, glued smoothly into the Minkowski metric elsewhere; this is a more natural choice than using the Minkowski metric itself as a background metric (which would give the standard wave coordinate gauge), as the solution g will be a short range perturbation of g_m^S there. This gauge, which can be expressed as the vanishing of a certain 1-form $\Upsilon(g)$, fixes the long range part of g and hence the main part of the null geometry at \mathscr{I}^+ . In order to ensure the gauge condition to a sufficient degree of accuracy (i.e. decay) at \mathscr{I}^+ throughout our iteration scheme, we implement constraint damping, first introduced in the numerics literature in [GuCaHiMaGa05], and crucially used in [HiVa16b]. This means that we use the 1-form encoding the gauge condition in a careful manner when passing from the Einstein equation (1.1) to its 'reduced' quasilinear hyperbolic form: we can arrange that for each iterate g_k in our iteration scheme, the gauge 1-form $\Upsilon(g_k)$ vanishes sufficiently fast at \mathscr{I}^+ so as to fix the long range part of g. In order to close the iteration scheme and control the non-linear interactions, we need to keep precise track of the leading order behavior of the remaining metric coefficients at \mathscr{I}^+ ; this is analogous to the arguments by Lindblad–Rodnianski. We discuss this in detail in §1.2.

Remark 1.2. Fixing the geometry at \mathscr{I}^+ in this manner, the first step of our iteration scheme, i.e. solving the linearized gauged Einstein equation with the given (non-linear) initial data of size δ , produces a solution with the correct long range behavior and which is δ^2 close to the non-linear solution in the precise function spaces on M in which we measure the solution. (Subsequent iteration steps give much more accurate approximations since the convergence of the iteration scheme is exponential.) This suggests that our formulation of the gauged Einstein equation could allow for improvements of the accuracy of post-Minkowskian expansions—which are iterates of a Picard-type iteration scheme as in [LiRo10, Equation (1.7)]—used to study gravitational radiation from isolated sources [Bl14].

The global stability of Minkowski space was established by Friedrich [Fr86] (see [Fr91] for the Einstein–Yang–Mills case), using a conformal method, for a restrictive class of initial data but with precise information on the asymptotic structure of the spacetime; subsequently in the monumental work by Christodoulou–Klainerman [ChKl93] for asymptotically Schwarzschildean data (in a sense similar to (1.6), but with $b_0 > \frac{1}{2}$) and precise control at null infinity, with an alternative proof using double null foliations by Klainerman–Nicolò [KlNi03a]; and more recently in [LiRo05, LiRo10] using the wave coordinate gauge, for initial data as in Theorem 1.1. Bieri [BiZi09] studied the problem for a very general class of data which are merely decaying like $\langle r \rangle^{-1/2-\delta}$ for some $\delta > 0$ —thus more slowly even than the $\mathcal{O}(r^{-1})$ terms of Schwarzschild; in this case, the 'correct' compactification on which the metric has a simple description will have to depend on more than just the ADM mass. (This is clear e.g. for the initial data constructed by Carlotto–Schoen [CaSch16], which are non-trivial only in conic wedges.) Bieri and Chruściel [BiCh16, Ch17] construct a piece of \mathscr{I}^+ for the data considered in [BiZi09] but without a smallness assumption. Further

works on the stability of Minkowski space for the Einstein equations coupled to other fields include those by Speck [Sp14] on (a generalization of) the Einstein–Maxwell system, Taylor [Ta16], Lindblad–Taylor [LiTa17], and Fajman–Joudioux–Smulevici [FaJoSm17] for both the massless and the massive Einstein–Vlasov system. The global stability for a minimally coupled massive scalar field was proved by LeFloch–Ma [LeMa15].

The present paper contains the first proof of full conormality and polyhomogeneity of small non-linear perturbations of Minkowski space in 3+1 dimensions. Previously, this was proved in spacetime dimensions > 9 for the Einstein vacuum and Einstein-Maxwell equations, for initial data stationary outside of a compact set, by Chruściel-Wafo [ChWa11]; this relied on earlier work by Chruściel-Leski [ChLe06] on the polyhomogeneity of solutions of hyperboloidal initial value problems³ for a class of semilinear equations, and Loizelet's proof [Lo08, Lo06] of the electrovacuum extension (using wave coordinate and Lorenz gauges) of [LiRo05]; see also [BeCh07]. Lengard [Le01] studied hyperboloidal initial value problems and established the propagation of weighted Sobolev regularity for the Einstein equation, and of polyhomogeneity for non-linear model equations. In spacetime dimensions 5 and above, Wang [Wa10, Wa13] obtained the leading term (i.e. the 'radiation field') of g-gat \mathscr{I}^+ , and proved high conormal regularity. Baskin-Wang [BaWa14] and Baskin-Sá Barreto [BaSaBa15] defined radiation fields for linear waves on Schwarzschild as well as for semilinear wave equations on Minkowski space. In 3+1 dimensions, Lindblad-Rodnianski also established high conormal regularity, see [LiRo10, Equation (1.14)], though, in the context of the present paper, on the compactification corresponding to Minkowski rather than on M, and hence with a loss in the weights. This was improved by Lindblad [Li17] who proved sharp asymptotics for the metric (which are the same as our leading order asymptotics, albeit in a slightly different gauge), and uses them to establish a relationship between the ADM mass and the total amount of gravitational radiation. For initial data exactly Schwarzschildean outside a compact set and in even spacetime dimensions ≥ 6 , a simple conformal argument, which requires very little information on the structure of the Einstein(-Maxwell) equation, stability and smoothness of \mathscr{I}^+ were proved by Choquet-Bruhat-Chruściel-Loizelet [ChBrChL006]; see also [AnCh05] for a different approach in the vacuum case. The construction of the required initial data sets as well as questions of their smoothness and polyhomogeneity were taken up in the hyperboloidal context by Andersson-Chruściel-Friedrich [AnChFr92] and extended in [AnCh93, AnCh96], see also [ChLe00]. Paetz and Chruściel [ChPa15, Pa14] studied this for characteristic data; we refer to Corvino [Co00], Chruściel–Delay [ChDe03], and references therein for the case of asymptotically flat data sets.

The backbone of our proof is a systematic treatment of the stability of Minkowski space as a problem of proving regularity and asymptotics for a quasilinear (hyperbolic) equation on a compact, but geometrically complete manifold with corners M. That is, we employ analysis based on complete vector fields on M and the corresponding natural function spaces, which in this paper are b-vector fields, i.e. vector fields tangent to ∂M , and spaces with conormal regularity or (partial) polyhomogeneous expansions; following Melrose [Me93, Me96], this is called b-analysis ('b' for 'boundary'). The point is that once the smooth structure (the manifold M) and the algebra of differential operators appropriate for the problem at hand have been identified, obtaining precise results becomes conceptually straightforward (even if

³This means that the initial data are posed on a spacelike but asymptotically null hypersurface transversal to \mathscr{I}^+ .

there are technical details along the way); we will give examples and details in $\S 1.1$. In this context, it is often advantageous to work on a more complicated manifold M if this simplifies the algebraic structure of the equation at hand. While this point of view has a long history in the study of elliptic equations, see e.g. [MaMe87, Me93, Ma91], its explicit use in hyperbolic problems is rather recent [BaVaWu15, BaVaWu16, HiVa15, Hi16a, HiVa16a, HiVa16b].

Working in a compactified setting makes the structures allowing for global existence clearly visible in the form of linear model operators defined at the boundary hypersurfaces. Among the key structures for Theorem 1.1 are the symmetries of the model operator L^0 at \mathscr{I}^+ , which is essentially the product of two transport ODEs, as well as constraint damping and a certain null structure, both of which are simply a certain Jordan block structure of L^0 , with the null structure corresponding to a nilpotent Jordan block. At i^+ , the model operator will be closely related (via a conformal transformation) to the conformal Klein–Gordon equation on static de Sitter space, which enables us to determine the asymptotic behavior of g there via resonance expansions from known results on the asymptotics of conformal waves on de Sitter space.

While the manifold M is compact, our analysis of the linear equations (arising from a linearization of the gauged Einstein equation) on M lying at the heart of this paper is not a short-time existence/regularity analysis near the interiors of i^0 , resp. i^+ , but rather a global in space, resp. global in time analysis. (Conformal methods such as [Fr98] bringing i^0 to a finite place have the drawback of imposing very restrictive conditions on the initial data.) At \mathscr{I}^+ , we use a version of Friedlander's rescaling [Fr80] of the wave equation, which does give equations with singular (conormal or polyhomogeneous) coefficients; but since \mathscr{I}^+ is a null hypersurface, conormality or polyhomogeneity—which are notions of regularity defined with respect to (b-)vector fields, which are complete—are essentially transported along the generators of \mathscr{I}^+ . At the past and future boundaries of \mathscr{I}^+ , i.e. at $i^0 \cap \mathscr{I}^+$ and $\mathscr{I}^+ \cap i^+$, the two pictures fit together in a simple and natural fashion. We discuss this in detail in §§1.1.1 and 1.1.3.

We reiterate that our goal is to exhibit the conceptual simplicity of our approach, which we hope will allow for advances in the study of related stability problems which have a more complicated geometry on the base, i.e. on the level of the spacetime metric, on the fibers, i.e. for equations on vector bundles, or both. In particular, we are not interested in optimizing the number of derivatives needed for our arguments based on Nash–Moser iteration.

Following our general strategy, one can also prove the stability of Minkowski space in spacetime dimensions n+1, $n \geq 4$, for sufficiently decaying initial data, with the solution conormal (or polyhomogeneous, if the initial data are such), thus strengthening Wang's results [Wa13]. There are a number of simplifications due to the faster decay of linear waves in \mathbb{R}^{1+n} : the compactification M of \mathbb{R}^{1+n} does not depend on the mass anymore and can be taken to be the blow-up of the Penrose diagram of Minkowski space at spacelike and future timelike infinity; we do not need to implement constraint damping as metric perturbations no longer have a long range term which would change the geometry of \mathscr{I}^+ ; and we do not need to keep track of the precise behavior (such as the existence of leading terms at \mathscr{I}^+) of the metric perturbation. We shall not discuss this further here.

1.1. Aspects of the systematic treatment; examples. Consider a non-linear partial differential equation P(u) = 0, with P encoding boundary or initial data as well, whose

global behavior one wishes to understand for small high regularity data; denote by $L_u := D_u P$ the linearized operators. Our strategy is:

- 1. fix a \mathcal{C}^{∞} structure, that is, a *compact* manifold M, with boundary or corners, on which one expects the solution u to have a simple description (regularity, asymptotic behavior);
- 2. choose an algebra of differential operators and a scale of function spaces on M, say $\mathcal{X}^s, \mathcal{Y}^s$, encoding the amount $s \in \mathbb{R}$ of regularity as well as relevant asymptotic behavior, such that for $u \in \mathcal{X}^{\infty} := \bigcap_{s>0} \mathcal{X}^s$ small in some \mathcal{X}^s norm, the operator L_u lies in this algebra and maps $\mathcal{X}^{\infty} \to \mathcal{Y}^{\infty} := \bigcap_{s>0} \mathcal{Y}^s$;
- 3. show that for such small u, the operator L_u has a (right) inverse on these spaces,

$$(L_u)^{-1} \colon \mathcal{Y}^{\infty} \to \mathcal{X}^{\infty};$$
 (1.8)

4. solve the non-linear equation using a global iteration scheme, schematically

$$u_0 = 0; \quad u_{k+1} = u_k + v_k, \ v_k = -(L_{u_k})^{-1}(P(u_k)); \quad u = \lim_{k \to \infty} u_k \in \mathcal{X}^{\infty}.$$
 (1.9)

5. (Optional.) Improve on the regularity of the solution $u \in \mathcal{X}^{\infty}$, provided the data has further structure such as polyhomogeneity or better decay properties, by using the PDE P(u) = 0 directly, or its approximation by linearized model problems in the spirit of $0 = P(u) \approx L_0 u + P(0)$ and a more precise analysis of L_0 .

We stress that steps 1 and 2 are non-trivial, as they require significant insights into the geometric and analytic properties of the PDE in question, and are thus intimately coupled to step 3; the function spaces in step 2 must be large enough in order to contain the solution u, but precise (i.e. small) enough so that the non-linearities and linear solution operators are well-behaved on them.

Note that if one has arranged 3, then the iteration scheme (1.9) formally closes, i.e. all iterates u_k lie in \mathcal{X}^{∞} modulo checking their required smallness in \mathcal{X}^s . Checking the latter, thus making (1.9) rigorous, is however easy in many cases, for example by using Nash–Moser iteration [Ha82, SaRa89], which requires $(L_u)^{-1}$ to satisfy so-called tame estimates; these in turn are usually automatic from the proof of (1.8), which is often ultimately built out of simple algebraic operations like multiplications and taking reciprocals of operator coefficients or symbols, and energy estimates, for all of which tame estimates follow from the classical Moser estimates. The precise bookkeeping, done e.g. in [HiVa16a], can be somewhat tedious but is only of minor conceptual importance: it only affects the number of derivatives of the data which need to be controlled, i.e. the number N in (1.6); in this paper, we shall thus be generous in this regard.

As a further guiding principle, which applies in the context of our proof of Theorem 1.1, one can often separate step 3, i.e. the analysis of the equation $L_uv = f$, into two pieces:

- 3.1. prove infinite regularity of v but without precise asymptotics;
- 3.2. improve on the asymptotic behavior of v to show $v \in \mathcal{X}^{\infty}$.

The point is that a 'background estimate' from step 3.1 may render many terms of L_u lower order, thus considerably simplifying the analysis of asymptotics and decay; see e.g. the discussion around (1.19).

Remark 1.3. Let us compare this strategy to proofs using bootstrap arguments, which are commonly used for global existence problems for non-linear hyperbolic equations as

e.g. in [ChKl93, LiRo10, Lu13]. The choice of bootstrap assumptions is akin to choosing the function space \mathcal{X}^{∞} (and thus implicitly \mathcal{Y}^{∞}) in step 2, while the consistency of the bootstrap assumptions, without obtaining a gain in the constants in the bootstrap, is similar to proving (1.8). However, note that the bootstrap operates on a solution of the non-linear equation, whereas we only consider linear equations; the gain in the bootstrap constants thus finds its analogue in the fact that one can make the iteration scheme (1.9) rigorous, e.g. using Nash-Moser iteration, and keep low regularity norms of u_k bounded (and v_k decaying with k) throughout the iteration scheme. In the context in particular of Einstein's equation, a bootstrap argument has the advantage that the gauge condition is automatically satisfied as one is dealing with solutions of the non-linear equation; thus the issue of constraint damping does not arise, whereas we do have to arrange this. In return, we gain significant flexibility in the choice of analytic tools for the global study of the linearized equations (e.g. methods from microlocal analysis, scattering theory), as used extensively in [HiVa16b]; bootstrap arguments on the other hand are strongly tied to the character of P(u) as a (non-linear) hyperbolic and differential operator, and it is much less clear how to exploit global information (e.g. resonances).

We proceed to describe this strategy for wave equations on Minkowski space before discussing Einstein's equation in §1.2.

1.1.1. Linear waves in Minkowski space. For step 1, our manifold M should have as one of its boundary hypersurfaces null infinity \mathscr{I}^+ , as this is the locus of the radiation field. At future timelike infinity i^+ , the asymptotic behavior of waves is governed by quantum resonances [BaVaWu15] on a class of asymptotically Minkowski spacetimes, and non-linear interactions are much simpler to deal with than near \mathscr{I}^+ ; thus, we want to include i^+ as a 3-dimensional boundary hypersurface, rather than, say, a 2-sphere as in a Penrose compactification. (The fact that i^+ can be blown down smoothly is a very special feature of exact Minkowski space!) Likewise, spacelike infinity i^0 , as a place where (non-)linear analysis is conceptually different and simpler than at \mathscr{I}^+ , should be another boundary hypersurface. Thus, let $\overline{\mathbb{R}^4}$ denote the radial compactification of \mathbb{R}^4 , defined as

$$\overline{\mathbb{R}^4} := \mathbb{R}^4 \sqcup ([0,1)_R \times \mathbb{S}^3) / \sim, \tag{1.10}$$

where \sim identifies $(R,\omega),\ R>0,\ \omega\in\mathbb{S}^3,$ with the point $R^{-1}\omega\in\mathbb{R}^4;$ the quotient carries a natural smooth structure. The function $\rho:=(1+t^2+r^2)^{-1/2}\in\mathcal{C}^\infty(\overline{\mathbb{R}^4})$ is a boundary defining function, i.e. $\partial\overline{\mathbb{R}^4}=\rho^{-1}(0)$ with $d\rho$ non-degenerate everywhere on $\partial\overline{\mathbb{R}^4}.$ Letting v=(t-r)/r away from r=0, all future null-geodesics tend to $S^+=\{\rho=0,\ v=0\},$ and we then define M as the closure of $t\geq 0$ within the blow-up $[\overline{\mathbb{R}^4},S^+]$ of $\overline{\mathbb{R}^4}$ at S^+ (see Figure 1.1), i.e. the manifold obtaining by declaring polar coordinates around S^+ to be smooth down to the origin. We refer to the front face \mathscr{I}^+ of this blow-up as $null\ infinity$ or the $null\ infinity$ or the $null\ infinity$ or the $null\ infinity$ or the $null\ infinity$ and $null\ infinity$ or the $null\ infinity$ or $null\ infini$

To motivate a preliminary choice of function spaces for step 2, recall that the behavior of solutions of $\Box_g u := -u_{;\mu}^{\mu}$ near \mathscr{I}^+ can be studied using the Friedlander rescaling

$$L := \rho^{-3} \square_g \rho. \tag{1.11}$$

This operator extends smoothly and non-degenerately as a conformally related wave operator to \mathscr{I}^+ and across; its solutions, for $\mathcal{C}_c^{\infty}(\mathbb{R}^3)$ initial data, are thus smooth up to \mathscr{I}^+ and typically non-vanishing there. (A more sophisticated version of this observation lies at the heart of Friedrich's conformal approach [Fr83] to the study of Einstein's equation.) However, for more general initial data, and, more importantly, in many non-linear settings (see §§1.1.2 and 1.2 below), smoothness will not be the robust notion, and we must settle for less: conormality at ∂M . Namely, let $\mathcal{V}_{b}(M)$ denote the Lie algebra of b-vector fields, i.e. vector fields tangent to the boundary hypersurfaces of M other than the closure Σ of the initial surface $\Sigma^{\circ} = \{t = 0\}$, a function u on M is conormal iff it remains in a fixed weighted L^2 space on M upon application of any finite number of b-vector fields. For Mdefined above, $\mathcal{V}_b(M)$ is spanned over $\mathcal{C}^{\infty}(M)$ by translations ∂_t and ∂_{x^i} as well as the scaling vector field $t\partial_t + x\partial_x$, boosts $t\partial_{x^i} + x^i\partial_t$, and rotation vector fields $x^i\partial_{x^j} - x^j\partial_{x^i}$; note however that the definition of $\mathcal{V}_b(M)$ depends only on the smooth structure of M. $(\mathcal{V}_{\mathrm{b}}(M))$ can also be characterized directly on $\overline{\mathbb{R}^4}$, cf. [BaVaWu15, Definition 4.2] who write M for our $\overline{\mathbb{R}^4}$.) For comparison, the space $\mathcal{V}_{\rm b}(\overline{\mathbb{R}^4})$ is spanned by translation vector fields and all linear vector fields $t\partial_t$, $t\partial_{x^i}$, $x^j\partial_t$, $x^j\partial_{x^i}$.

Considering L globally, one finds that $L \in \operatorname{Diff}_{b}^{2}(\overline{\mathbb{R}^{4}})$, the algebra generated by $\mathcal{V}_{b}(\overline{\mathbb{R}^{4}})$. Let us explain how to obtain a background estimate, step 3.1 above, for the forcing problem Lu = f with trivial initial data. First, we can estimate u in H^{1} on any compact subset of $\mathbb{R}^{4} \cap \{t \geq 0\}$ by f on another compact set. Then, on a neighborhood of $(i^{0})^{\circ}$ which is diffeomorphic to $[0,1)_{\rho_{0}} \times (0,1)_{\tau} \times \mathbb{S}^{2}$, where

$$\rho_0 := r^{-1}, \quad \tau := t/r,$$

with ρ_0 a local boundary defining function of i^0 , this problem roughly takes the form

$$(D_{\tau}^2 - (\rho_0 D_{\rho_0})^2 - \Delta)u = f;$$
 (1.12)

here $\Delta = \Delta_{\mathcal{J}} \geq 0$ is the Laplacian on \mathbb{S}^2 , and f has suitable decay properties making its norms in the estimates below finite. This is a wave equation on the (asymptotically) cylindrical manifold $[0,1)_{\rho_0} \times \mathbb{S}^2$. For any weight $a_0 \in \mathbb{R}$, we can run an energy estimate using the vector field multiplier $\rho_0^{-2a_0}\partial_{\tau}$ and obtain




FIGURE 1.2. The domain U_0 on which the energy estimate (1.13) holds. Left: as a subset of M. Right: as a subset of the Penrose compactification.

$$||u||_{\rho_0^{a_0} H_{\mathbf{b}}^1} \lesssim ||f||_{\rho_0^{a_0} L_{\mathbf{b}}^2} \tag{1.13}$$

in the domain U_0 , see Figure 1.2. Here L_b^2 is the L^2 space with respect to the b-density $d\tau \frac{d\rho_0}{\rho_0}|d\phi|$, the weighted L_b^2 norm is defined by $||f||_{\rho_0^{a_0}L_b^2} = ||\rho_0^{-a_0}f||_{L_b^2}$, and H_b^1 is the space of all $u \in L_b^2$ such that $Vu \in L_b^2$ for all $V \in \mathcal{V}_b(M)$; taking $V = \partial_{\tau}$, $\rho_0 \partial_{\rho_0}$, ∇ suffices in U_0 . In order to obtain a higher regularity estimate, one can commute any number of b-vector fields through (1.12); the estimate (1.13) only relies on the principal (wave) part of L; lower order terms arising as commutators are harmless. Thus, $f \in \rho_0^{a_0} H_b^{\infty}$ (weighted L_b^2 -regularity with respect to any finite number of b-vector fields) implies $u \in \rho_0^{a_0} H_b^{\infty}$, with estimates.

The same conclusion holds for the initial value problem for Lu=0 with initial data which near i^0 are $(u|_{\tau=0}, \partial_{\tau}u|_{\tau=0}) = (u|_{t=0}, r\partial_tu|_{t=0}) = (u_0, u_1), u_j \in \rho_0^{a_0} H_b^{\infty}(\overline{\mathbb{R}^3})$, where $\overline{\mathbb{R}^3}$ is the radial compactification of \mathbb{R}^3 , defined analogously to (1.10), which has boundary defining function $\rho_0 = r^{-1}$. The assumption (1.6) on the size initial data is a smallness condition on $\|\langle r \rangle \widetilde{\gamma}\|_{\rho_0^{b_0} H_b^{N+1}} + \|\langle r \rangle^2 k\|_{\rho_0^{b_0} H_b^{N}}$.

Re-defining $\rho = r^{-1}$ near S^+ , a neighborhood of $i^0 \cap \mathscr{I}^+$ is diffeomorphic to $[0,1)_{\rho_0} \times [0,1)_{\rho_I} \times \mathbb{S}^2$, where

$$\rho_0 := -\rho/v = (r-t)^{-1}, \quad \rho_I := -v = (r-t)/r$$
(1.14)

are boundary defining functions of i^0 and \mathscr{I}^+ , respectively. The lift of L to M is singular as an element of $\mathrm{Diff}^2_\mathrm{b}(M)$ but with a very precise structure at \mathscr{I}^+ : the equation Lu=f is now of the form

$$(2\partial_{\rho_I}(\rho_0\partial_{\rho_0} - \rho_I\partial_{\rho_I}) - \Delta)u = f \tag{1.15}$$

modulo terms with more decay; here, ignoring weights, $\rho_I \partial_{\rho_I} \sim \partial_t + \partial_r$ and $\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I} \sim \partial_t - \partial_r$ are the radial null vector fields. Assuming f vanishes far away from \mathscr{I}^+ , we can run an energy estimate using $V = \rho_0^{-2a_0} \rho_I^{-2a_I} V_0$, where $V_0 = -c \rho_I \partial_{\rho_I} + \rho_0 \partial_{\rho_0}$ is future timelike in $M \setminus \mathscr{I}^+$ if we choose c < 1; note that V_0 is tangent to i^0 and \mathscr{I}^+ (and null at \mathscr{I}^+); this is necessary for compatibility with our conormal function spaces, and gives control at \mathscr{I}^+ which is weaker but more robust than the smoothness following from Friedlander's argument. A simple calculation, cf. Lemma 4.4, shows that for $a_I < a_0$ and $a_I < 0$,

$$||u||_{\rho_0^{a_0}\rho_I^{a_I}L_b^2} + ||(\rho_0\partial_{\rho_0}, \rho_I\partial_{\rho_I}, \rho_I^{1/2}\nabla)u||_{\rho_0^{a_0}\rho_I^{a_I}L_b^2} \lesssim ||\rho_I f||_{\rho_0^{a_0}\rho_I^{a_I}L_b^2} \text{ in } U_I,$$




FIGURE 1.3. The domain U_I on which the energy estimate (1.16) holds.

(1.16)

see Figure 1.3, where $L_{\rm b}^2$ is the L^2 space with integration measure $\frac{d\rho_0}{\rho_0}\frac{d\rho_I}{\rho_I}|d\not g|$. The assumptions on the weights are natural: since $\partial_t - \partial_r$ transports mass from i^0 to \mathscr{I}^+ , we certainly need $a_I \leq a_0$, while $a_I < 0$ is necessary since, in view of the behavior of linear waves discussed after (1.11), the estimate must apply to u which are smooth and non-zero down to \mathscr{I}^+ . In (1.16), derivatives of u along b-vector fields tangent to the fibers of the radiation face are controlled without a loss in weights, while general derivatives such as spherical ones lose a factor of $\rho_I^{1/2}$. When controlling error terms later on, we thus need to separate them into terms involving fiber-tangent b-derivatives and general b-derivatives, and check that the coefficients of the latter have extra decay in ρ_I ; see §2.4.

From (1.15), $L \in \rho_I^{-1} \operatorname{Diff}_b^2(M)$ is equal to the model operator

$$L^0 := 2\partial_{\rho_I}(\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I})$$

modulo $\operatorname{Diff}_b^2(M)$. The commutation properties of this model are what allows for higher regularity estimates:⁵ (ρ_I times) equation (1.15) commutes with $\rho_0 \partial_{\rho_0}$ (scaling), $\rho_I \partial_{\rho_I}$ (roughly

⁴This is to be expected: indeed, letting $x := \rho_I^{1/2}$, the rescaled metric $x^{-2}(\rho^2 \underline{g})$ is an edge metric [Ma91], i.e. a quadratic form in $\frac{d\rho_0}{\rho_0}$, $\frac{dx}{x}$, $\frac{d\theta^a}{x}$, with θ^a coordinates on \mathbb{S}^2 , for which the natural vector fields are precisely those tangent to the fibers of \mathscr{I}^+ , that is, $\rho_0 \partial_{\rho_0}$, $x \partial_x = 2\rho_I \partial_{\rho_I}$, and $x \partial_{\theta^a} = \rho_I^{1/2} \partial_{\theta^a}$.

a combination of scaling and boosts), and spherical vector fields which are independent of ρ_0 and ρ_I .⁶ In the end, we obtain $u \in \rho_0^{a_0} \rho_I^{a_I} H_b^{\infty}$ when $f \in \rho_0^{a_0} \rho_I^{a_I-1} H_b^{\infty}$.




FIGURE 1.4. The neighborhood (shaded) of i^+ on which we use a global (in i^+) weighted energy estimate.

Lastly, near i^+ , one can use energy estimate with weight $\rho_I^{-2a_I}\rho_+^{-2a_+}$, $a_+ < a_I$ large and negative, multiplying a timelike extension of the above V_0 ; higher regularity follows by commuting with the scaling vector field $\rho_+\partial_{\rho_+}$, where ρ_+ is a defining function of i^+ —this is automatic, modulo terms with faster decay, for any b-differential operator—and elliptic regularity for $C(\rho_+D_{\rho_+})^2-L$, C>0 large, in i^+ away from \mathscr{I}^+ , which is a consequence of the timelike nature of the scaling vector field $\rho_+\partial_{\rho_+}$ in $(i^+)^\circ$. See Figure 1.4. Note that it is only at this stage that one uses the asymptotically Minkowskian nature of the metric in a neighborhood of all of i^+ ; when dealing with a more complicated geometry, as e.g. in the study of perturbations of a Schwarzschild black hole, establishing this part of the background estimate (as well as the more precise asymptotics at i^+ discussed momentarily) is the main difficulty.

Putting everything together, we find that

$$f \in \rho_0^{a_0} \rho_I^{a_I - 1} \rho_+^{a_+} H_{\mathbf{b}}^{\infty}(M), \ f \equiv 0 \text{ near } \Sigma \implies u \in \rho_0^{a_0} \rho_I^{a_I} \rho_+^{a_+} H_{\mathbf{b}}^{\infty}(M),$$
for $a_I < \min(a_0, 0)$ and $a_+ < a_I$ (the latter explicit, if desired). (1.17)

⁶We briefly sketch the argument: denoting the collection of these vector fields—which span $\mathcal{V}_{b}(M)$ locally—by $\{V_{j}\}$, this gives $L(V_{j}u) = V_{j}f + [L, V_{j}]u$ with $[L, V_{j}] \in \operatorname{Diff}_{b}^{2}$ (modulo multiples of L which arise for $V = \rho_{I}\partial_{\rho_{I}}$, and which we drop here), which is one order better in the sense of decay than the a priori expected membership in $\rho_{I}^{-1}\operatorname{Diff}_{b}^{2}$ due to these commutation properties. Write $[L, V_{j}] = C_{jk}V_{k}$ with $C_{jk} \in \operatorname{Diff}_{b}^{1}$ and apply the estimate (1.16) to $V_{j}u$; then the additional forcing term $[L, V_{j}]u$ obeys the bound $\sum_{k} \|\rho_{I}C_{jk}V_{k}u\|_{\rho_{0}^{a_{0}}\rho_{I}^{a_{I}}L_{b}^{2}} \lesssim \sum_{k} \|V_{k}u\|_{\rho_{0}^{a_{0}}\rho_{I}^{a_{I}-1}H_{b}^{1}}$, which close to \mathscr{I}^{+} is bounded by a small constant times the left hand side of (1.16), with $V_{j}u$ in place of u and summed over j, due to the gain (of at least $\frac{1}{2}$) in the weight in ρ_{I} .

⁷Explicit calculations allow one to make a_+ explicit; we accomplish this in §4.3 by identifying L with the conformal wave operator on static de Sitter space for a suitable choice of ρ .

For non-linear applications, this is not sufficient; let us thus turn to step 3.2 and analyze Lu = f for f, vanishing near Σ , having more decay,

$$f \in \mathcal{Y}^{\infty} := \rho_0^{b_0} \rho_I^{-1+b_I} \rho_+^{b_+} H_b^{\infty}(M); \quad b_+ < b_I < b_0, \quad b_I \in (0,1).$$
 (1.18)

The background estimate (1.17) gives $u \in \rho_0^{b_0} \rho_I^{-\epsilon} \rho_+^{a_+} H_b^{\infty}$ for all $\epsilon > 0$. Near $i^0 \cap \mathscr{I}^+$ then, the conormality of u allows for equation (1.15) to be written as




FIGURE 1.5. The integral curves of the vector fields $\partial_t + \partial_r \sim -\rho_I \partial_{\rho_I}$ and $\partial_t - \partial_r \sim \rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}$. Integration along the former gives the leading term at \mathscr{I}^+ , while integration along the latter transports weights (and polyhomogeneity) from i^0 to \mathscr{I}^+ .

$$\rho_I \partial_{\rho_I} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) u = \frac{1}{2} (\rho_I f + \rho_I \Delta u) \in \rho_0^{b_0} \rho_I^{b_I} H_b^{\infty} \quad \text{on } U_I, \tag{1.19}$$

i.e. L effectively becomes the composition of transport ODEs along the two radial null directions. See Figure 1.5. Integration of $\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}$ is straightforward, while integrating $\rho_I \partial_{\rho_I}$, which is a regular singular ODE with indicial root 0, implies that u has a leading order term at \mathscr{I}^+ ; one finds that

$$u = u^{(0)} + u_b; \ u^{(0)} \in \rho_0^{b_0} H_b^{\infty}(\mathscr{I}^+), \ u_b \in \rho_0^{b_0} \rho_I^{b_I} H_b^{\infty}(M) \ \text{near } i^0 \cap \mathscr{I}^+,$$

which implies the existence of the radiation field.⁸ The procedure to integrate along (approximate) characteristics to get sharp decay is frequently employed in the study of nonlinear waves on (asymptotically) Minkowski spaces, see e.g. [LiRo10, §2.2], [Li17], and their precursors [Li90, Li92].

At $\mathscr{I}^+ \cap i^+$, the same argument works, showing that $u^{(0)}$ and u_b have weight $\rho_+^{a_+}$ at i^+ . Improving this weight however does not follow from such a simple argument. Indeed, at i^+ , the behavior of u is governed by scattering theoretic phenomena: the asymptotics are determined by scattering resonances of a model operator at i^+ , namely the normal operator of the b-differential operator L at i^+ , obtained by freezing its coefficients at i^+ , see equation (2.1). We thus use the arguments introduced in [Va13], see also [HiVa15, Theorem 2.21], based on Mellin transform in ρ_+ , inversion of a 'spectral family' $\widehat{L}(\sigma)$, which is the conjugation of the model operator (called 'normal operator' in b-parlance) of L at i^+ by the Mellin transform in i^+ , with σ the dual parameter to ρ_+ , and contour shifting in the inverse Mellin transform to find the correct asymptotic behavior at i^+ : the resonances $\sigma \in \mathbb{C}$, which are the poles of $\widehat{L}(\sigma)^{-1}$, give rise to a term $\rho_+^{i\sigma}v$, v a function on i^+ , in the asymptotic expansion of u. (See §§5.2 and 7 for details.) The resonances can

⁸For rapidly decaying f, one can plug this improved information into the right hand side of (1.19), thereby obtaining an expansion of u into integer powers of ρ_I and recovering the smoothness of u at \mathscr{I}^+ .

easily be calculated explicitly in the present context, and they all satisfy $-\text{Im }\sigma \geq 1 > b_+$. The upshot is that

$$f \in \mathcal{Y}^{\infty} \implies u \in \mathcal{X}^{\infty} := \left\{ \chi u^{(0)} + u_{b} \colon u^{(0)} \in \rho_{0}^{b_{0}} \rho_{+}^{b_{+}} H_{b}^{\infty}(\mathscr{I}^{+}), \ u_{b} \in \rho_{0}^{b_{0}} \rho_{I}^{b_{I}} \rho_{+}^{b_{+}} H_{b}^{\infty}(M) \right\}, \tag{1.20}$$

where χ cuts off to a neighborhood of \mathscr{I}^+ .

For later use as a simple model for constraint damping, consider a more general equation,

$$L_{\gamma}u \equiv \rho^{-3}(\Box_g - 2\gamma t^{-1}\partial_t)(\rho u) = f, \tag{1.21}$$

for $\gamma \in \mathbb{R}$; near \mathscr{I}^+ and i^0 , this now roughly takes the form

$$(2\rho_I^{-1}(\rho_I\partial_{\rho_I} - \gamma)(\rho_0\partial_{\rho_0} - \rho_I\partial_{\rho_I}) - \Delta)u = f.$$

Once the conormality of u is known, integrating the first vector field on the left gives a leading term ρ_I^{γ} , which is decaying for $\gamma > 0$. (One can show that the background estimate (1.17) holds for $a_I < \gamma$, but even an ineffective bound $a_I \ll 0$ would be good enough, as the transport ODE argument automatically recovers the optimal bound.)

Remark 1.4. Note that for small γ , the normal operator of L_{γ} at i^+ is close to the normal operator for $\gamma=0$, hence one would like to conclude that mild decay $\rho_+^{b_+}$, $b_+<1$, at i^+ still holds in this case. This is indeed true, but the argument has a technical twist: L_{γ} does not have smooth coefficients at \mathscr{I}^+ as a differential operator (unlike L in Friedlander's argument) due to the presence of derivatives which are not tangential to S^+ . However, we still have $L_{\gamma} \in \operatorname{Diff}_b^2(\overline{\mathbb{R}^4})$; we thus deduce asymptotics at i^+ via normal operator analysis on the blown-down space $\overline{\mathbb{R}^4}$, analogously to [BaVaWu15, BaVaWu16]. See §5.2.

Remark 1.5. The improved decay at \mathscr{I}^+ translates into higher b-regularity of u on the blown-down space $\overline{\mathbb{R}^4}$, as we will show in Lemma 5.6; in the language of [BaVaWu15, Proposition 4.4], this corresponds to a shift of the threshold regularity at the radial set by γ coming from the skew-symmetric part of L_{γ} .

1.1.2. Non-linearities and null structure. If u is conormal on M, then its derivatives along $\partial_0 := \partial_t + \partial_r$ or size 1 spherical derivatives $r^{-1}\nabla$ have faster decay by one order at \mathscr{I}^+ , whereas its 'bad' derivative along $\partial_1 := \partial_t - \partial_r$ does not gain decay there; indeed, modulo vector fields with more decay at \mathscr{I}^+ , we calculate near $i^0 \cap \mathscr{I}^+$ using (1.14)

$$\partial_0 = -\frac{1}{2}\rho_0\rho_I\rho_I\partial_{\rho_I}, \quad \partial_1 = \rho_0(\rho_0\partial_{\rho_0} - \rho_I\partial_{\rho_I});$$

note the extra factor of ρ_I in ∂_0 . All these derivatives gain an order of decay at i^0 , hence the structure of non-linearities is relevant mainly at \mathscr{I}^+ ; let us thus restrict the discussion to a neighborhood of $i^0 \cap \mathscr{I}^+$. (Similar considerations apply to a neighborhood of $i^+ \cap \mathscr{I}^+$.) Consider the non-linear equation $\Box_g u - (\partial_1 u)^2 = f$, or rather the closely related equation

$$P(u) = Lu - \rho^{-1}(\partial_1 u)^2 - f, \quad f \in \mathcal{Y}^{\infty} \quad \text{small}, \tag{1.22}$$

with L given by (1.11); this is well-known to violate the *null condition* introduced by Christodoulou [Ch86] and Klainerman [Kl86]. From our compactified perspective, the issue is the following. For $u \in \mathcal{X}^{\infty}$, the linearization $L_u = L - 2\rho^{-1}(\partial_1 u)\partial_1$ is, to leading order as a b-operator,

$$2\rho_I^{-1}(\rho_I\partial_{\rho_I}-\partial_1 u)(\rho_0\partial_{\rho_0}-\rho_I\partial_{\rho_I}),$$

so the indicial root at \mathscr{I}^+ is shifted from 0 to $\partial_1 u|_{\mathscr{I}^+}$. Therefore, a step $L_u v = -P(u)$ in the Newton iteration scheme (1.9) does not give $v \in \mathcal{X}^{\infty}$. A Picard iteration, solving

 $L_0v = -P(u)$ would, due to the leading term of $\rho^{-1}(\partial_1 u)^2$ of size ρ_I^{-1} , cause v to have a logarithmic leading term when integrating the analogue of (1.19). Neither iteration scheme closes, and this will remain true for any modification of the space \mathcal{X}^{∞} , e.g. by including leading terms involving higher powers of $\log \rho_I$. In fact, solutions of global versions of this equation blow up in finite time [Jo81].

Assuming initial data to have sufficient decay, the non-linear system $Lu_1^c = 0$, $Lu_1 - \rho^{-1}(\partial_1 u_1^c)^2 = 0$ on the other hand can be solved easily if we design the function space \mathcal{X}^{∞} in step 2 to encode a ρ_I^0 leading term for u_1^c at \mathscr{I}^+ , as in (1.20), and two leading terms, of size $\log \rho_I$ and ρ_I^0 , for u_1 . Extending this model slightly, let $\gamma > 0$, recall L_{γ} from (1.21), and consider the system for $u = (u_0, u_1^c, u_1)$,

$$P(u) = (L_{\gamma}u_0, Lu_1^c - \rho^{-1}(\partial_1 u_0)^2, Lu_1 - \rho^{-1}(\partial_1 u_1^c)^2) = 0;$$
(1.23)

which is a toy model for the non-linear structure of the gauged Einstein's equation with constraint damping, as we will argue in §1.2. Only working in $(\mathscr{I}^+)^{\circ}$, i.e. ignoring weights at i^0 and i^+ for brevity, the above discussions suggest taking $b_I \in (0, \gamma)$ and working with the space⁹

$$\mathcal{X}^{\infty} = \{ u = (u_0, u_1^c, u_1) : (u_0, u_1^c - (u_1^c)^{(0)}, u_1 - (u_1)^{(1)} \log \rho_I - (u_1)^{(0)}) \in \rho_I^{b_I} H_b^{\infty}(M) \}, (1.24)$$

where $(u_1^c)^{(0)}$, $(u_1)^{(1)}$, $(u_1)^{(0)} \in \mathcal{C}^{\infty}((\mathscr{I}^+)^{\circ})$ are the leading terms. Then

$$P \colon \mathcal{X}^{\infty} \to \mathcal{Y}^{\infty} = \{ f = (f_0, f_1^c, f_1) \colon (f_0, f_1^c, f_1 - \rho_I^{-1}(f_1)^{(0)}) \in \rho_I^{-1 + b_I} H_b^{\infty} \},$$

where $(f_1)^{(0)} \in \mathcal{C}^{\infty}((\mathscr{I}^+)^{\circ})$. The linearization L_u of P around $u \in \mathcal{X}^{\infty}$ then has as its model operator at \mathscr{I}^+

$$L_u^0 = 2\rho_I^{-1}(\rho_I \partial_{\rho_I} - A_u)(\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}), \quad A_u = \begin{pmatrix} \gamma & 0 & 0 \\ 0 & 0 & 0 \\ 0 & \partial_1 (u_1^c)^{(0)} & 0 \end{pmatrix}, \tag{1.25}$$

which has a (lower triangular) Jordan block structure, with all blocks either having positive spectrum (the upper 1×1 entry) or being nilpotent (the lower 2×2 block). Thus, by integrating $\rho_I \partial_{\rho_I} - A_u$, we conclude that for $L_u v = -P(u)$, we have $v \in \mathcal{X}^{\infty}$, thus closing the iteration scheme (1.9). A background estimate as well as its higher regularity version, which is the prerequisite for L_u^0 being of any use, can be proved as before. Error terms arising from commutation with A_u have lower differential order and can thus be controlled inductively; that is, only the commutation properties of the principal part of L_u^0 matter for this.

Remark 1.6. A tool for the study of the long time behavior of non-linear wave equations on Minkowski space introduced by Hörmander [Hö87] is the asymptotic system, see also [Hö97, §6.5] and [LiRo03]: this arises by making an ansatz $u \sim \epsilon r^{-1}U(t-r,\epsilon\log r,\omega)$ for the solution and evaluating the ϵ^2 coefficient, which gives a PDE in 1+1 dimensions in the coordinates t-r and $\ell:=\epsilon\log r$ which one expects to capture the behavior of the non-linear equation near the light cone; if the classical null condition is satisfied, the PDE is linear, otherwise it it non-linear. The weak null condition [LiRo03] is the assumption that solutions of the asymptotic system grow at most exponentially in ℓ , and for the Einstein

⁹Here as well as in the previous example, one could of course work with much less precise function spaces since the full non-linear system is lower triangular; for the Einstein equation on the other hand, we will need this kind of precision.

vacuum equation in harmonic gauge, solutions are polynomial (in fact, linear) in ℓ . The latter finds its analogue in our framework in the nilpotent structure of the coupling matrix in (1.25). (However, quasilinear equations with variable long-range perturbations, see the discussion around (1.32), cannot be treated directly with our methods, corresponding to the difficulty in assigning a geometric meaning to the asymptotic system in such situations.) For works which establish global existence of nonlinear equations even when the asymptotic system has merely exponentially bounded (in ℓ) solutions, we refer to Lindblad [Li92, Li08] and Alinhac [Al03].

1.1.3. Polyhomogeneity. Consider again equation (1.12) near $(i^0)^\circ$, now assuming that f is polyhomogeneous. For simplicity, let $f = \rho_0^{iz} f_z + \widetilde{f}$, where $f_z \in \mathcal{C}^\infty(\partial \overline{\mathbb{R}^4})$, $z \in \mathbb{C}$, and \widetilde{f} decays faster than the leading term, so $\widetilde{f} \in \rho_0^{b_0} H_{\mathrm{b}}^\infty$ with $b_0 > -\operatorname{Im} z$. A useful characterization of the polyhomogeneity of f is that the decay of f improves upon application of the vector field $\rho_0 D_{\rho_0} - z$. The solution u satisfies $u \in \rho_0^{a_0} H_{\mathrm{b}}^\infty$ for any $a_0 < -\operatorname{Im} z$; but $u' := (\rho_0 D_{\rho_0} - z)u$ solves¹⁰

$$Lu' = (\rho_0 D_{\rho_0} - z)f = (\rho_0 D_{\rho_0} - z)\tilde{f} \in \rho_0^{b_0} H_b^{\infty},$$

so $u' \in \rho_0^{b_0} \underline{H}_\mathrm{b}^\infty$. This is exactly the statement that u has the form $u = \rho_0^{iz} u_z + \widetilde{u}$ for some $u_z \in \mathcal{C}^\infty(\partial \overline{\mathbb{R}^4})$, $\widetilde{u} \in \rho_0^{b_0} H_\mathrm{b}^\infty$. If f has a full polyhomogeneous expansion, an iteration of this argument shows that u has one too, with the same index set.

Near the corner $i^0 \cap \mathscr{I}^+$ then, one can proceed iteratively as well, picking up the terms of the expansion at \mathscr{I}^+ one by one, by analyzing the solution of the product of transport equations in equation (1.19) when the right hand side has a partial polyhomogeneous expansion at \mathscr{I}^+ : the point is that $\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}$ transports expansions from i^0 to \mathscr{I}^+ , ultimately since it annihilates $\rho_0^{iz} \rho_I^{iz}$. See Lemmas 7.5–7.7.

To obtain the expansion at i^+ , we argue iteratively again, using the resonance expansion obtained via normal operator analysis as in the proof of [HiVa15, Theorem 2.21]. One needs to invert the normal operator family of L on spaces of functions which are polyhomogeneous at the boundary ∂i^+ , which is easily accomplished by solving away polyhomogeneous terms formally and using the usual inverse, defined on spaces of smooth functions, to solve away the remainder; see Lemma 7.8.

1.2. Analysis of Einstein's equation. For Einstein's equation, the strategy outlined in §1.1 needs to be supplemented by a preliminary step, the choice of the non-linear operator P, which in particular means choosing a gauge, i.e. a condition on the solution g of Ric(g) = 0 which breaks the diffeomorphism invariance; by the latter we mean the fact that for any diffeomorphism ϕ of M, ϕ^*g also solves $Ric(\phi^*g) = 0$. Following DeTurck [DeTu82], the presentation by Graham–Lee [GrLe91], and [HiVa16b], we consider the gauged Einstein equation

$$P_0(g) = \operatorname{Ric}(g) - \widetilde{\delta}^* \Upsilon(g) = 0, \tag{1.26}$$

where $\widetilde{\delta}^*$ is a first order differential operator with the same principal symbol (which is independent of g) as the symmetric gradient $(\delta_g^* u)_{\mu\nu} = \frac{1}{2}(u_{\mu;\nu} + u_{\nu;\mu})$; we comment on the choice of $\widetilde{\delta}^*$ below. Further, the gauge 1-form is

$$\Upsilon(g; g_m)_{\mu} := (gg_m^{-1}\delta_g G_g g_m)_{\mu} = g_{\mu\nu}g^{\kappa\lambda}(\Gamma(g)_{\kappa\lambda}^{\nu} - \Gamma(g_m)_{\kappa\lambda}^{\nu}), \tag{1.27}$$

 $^{^{10}}$ Commutator terms have improved decay at $\rho_0 = 0$ as before, hence are dropped here for clarity.

where δ_g is the adjoint of δ_g^* , i.e. the (negative) divergence, $G_g = 1 - \frac{1}{2}g \operatorname{tr}_g$ is the trace reversal operator, and g_m is a fixed background metric; we write $\Upsilon(g) \equiv \Upsilon(g; g_m)$ from now on. This is a manifestly coordinate invariant generalization of the wave coordinate gauge, where one would choose $g_m = \underline{g}$ to be the Minkowski metric on \mathbb{R}^4 and demand that a global coordinate system $(x^{\mu}): (M^{\circ}, g) \to (\mathbb{R}^4, \underline{g})$ be a wave map. (Friedrich describes $\Upsilon(g) = 0$ and more general gauge conditions using gauge source functions, see in particular [Fr85, Equation (3.23)].)

Two fundamental properties of $P_0(g)$ are: (1) $P_0(g)$ is a quasilinear wave equation, hence has a well-posed initial value problem; (2) by the second Bianchi identity—the fact that the Einstein tensor $\text{Ein}(g) := G_g \text{Ric}(g)$ is divergence-free—the equation $P_0(g) = 0$ implies the wave equation

$$\delta_q G_q \widetilde{\delta}^* \Upsilon(g) = 0 \tag{1.28}$$

for $\Upsilon(g)$, which thus vanishes identically provided its Cauchy data are trivial; we call $\delta_g G_g \widetilde{\delta}^*$ the gauge propagation operator. Therefore, solving (1.26) with Cauchy data for which $\Upsilon(g)$ has trivial Cauchy data is equivalent to solving Einstein's equation (1.1) in the gauge $\Upsilon(g) = 0$.

Since we wish to solve the initial value problem (1.4), we need to choose the Cauchy data for g, i.e. the restrictions g_0 and g_1 of g and its transversal derivative to the initial surface Σ° as a Lorentzian metric on M° such that γ is the pullback of g_0 to Σ° and k is the second fundamental form of any metric with Cauchy data (g_0, g_1) ; note that k only depends on up to first derivatives of the ambient metric, hence can indeed be expressed purely in terms of (g_0, g_1) . These conditions do not determine g_0, g_1 completely, and one can arrange in addition that $\Upsilon(g)$ vanishes at Σ° as a 1-form on M. Provided then that $P_0(g) = 0$, with these Cauchy data for g, holds near Σ° , the constraint equations at Σ° can be shown to imply that also the transversal derivative of $\Upsilon(g)$ vanishes at Σ° (see the proof of Theorem 6.3), and then the argument involving (1.28) applies.

If the initial data in Theorem 1.1 are exactly Schwarzschildean for $r \geq R \gg 1$, the solution g is equal (i.e. isometric) to the Schwarzschild metric in the domain of dependence of the region $r \geq R$; more generally, for initial data which are equal to those of mass m Schwarzschild modulo decaying corrections, we expect all outgoing null-geodesics to be bent in approximately the same way as for the metric g_m^S . Thus, we should define the manifold M in step 1 so that \mathscr{I}^+ is null infinity of the Schwarzschild spacetime. Now, along radial null-geodesics of g_m^S , the difference $t - r_*$ is constant, where

$$r_* = r + 2m\log(r - 2m) \tag{1.29}$$

is the tortoise coordinate up to an additive constant, see [Wa10, Equation (6.4.20)]. Correspondingly, we define the compactification ${}^m\overline{\mathbb{R}^4}$ near $t\sim r_*$ such that $\rho=r^{-1}$ is a boundary defining function, and ${}^mv:=(t-r_*)/r$ is smooth up to the boundary; mM is defined by blowing this up at $S^+=\{\rho=0, {}^mv=0\}$. (This is smoothly extended away from $t\sim r_*$ to a compactification of all of \mathbb{R}^4 .) Thus, ${}^m\overline{\mathbb{R}^4}$ and the Minkowski compactification $\overline{\mathbb{R}^4}={}^0\overline{\mathbb{R}^4}$ are canonically identified by continuity from \mathbb{R}^4 , but have slightly different smooth structures; see §2.3 and [BaVaWu16, §7].) The interior of the front face \mathscr{I}^+ of the blow-up is diffeomorphic to $\mathbb{R}_s\times\mathbb{S}^2$, where $s:={}^mv/\rho=t-r_*$ is an affine coordinate along the fibers of the blow-up. We denote defining functions of i^0 (the closure of $\{\rho=0, {}^mv<0\}$ in mM), \mathscr{I}^+ , and i^+ (the closure of $\{\rho=0, {}^mv>0\}$ in mM) by ρ_0 , ρ_I , and ρ_+ , respectively.

It is then natural to fix the background metric g_m to be equal to g_m^S near $i^0 \cup \mathscr{I}^+$ and smoothly interpolate with the Minkowski metric near r=0 (which is non-singular there, unlike g_m^S). We then work with the gauge $\Upsilon(g;g_m)=0$, and seek the solution of

$$P(h) := \rho^{-3} P_0(g) = 0, \quad g = g_m + \rho h,$$
 (1.30)

with h to be determined; the factors ρ are introduced in analogy with the discussion of the scalar wave equation (1.11). Here, ρ is a global boundary defining function of ${}^m\overline{\mathbb{R}^4}$; one can e.g. take $\rho = r^{-1}$ away from the axis r/t = 0, and $\rho = t^{-1}$ near r/t = 0. Now, due to the quasilinear character of (1.26), the principal part of $L_h := D_h P$ depends on h: it is given by $\frac{1}{2}\Box_g$. Thus, one needs to ensure that throughout the iteration scheme (1.9), the null-geometry of g is compatible with mM , in the sense that the long range term of g determining the bending of light rays remains unchanged. To see what this means concretely, consider a metric perturbation h in (1.30) which is not growing too fast at \mathscr{I}^+ , say $|h| \lesssim \rho_I^{-\epsilon}$ for $\epsilon < 1/2$; one can then check that, modulo terms with faster decay at \mathscr{I}^+ ,

$$\square_g = 2\rho_I^{-1} \left(\rho_I \partial_{\rho_I} + 2\rho_0 h_{00} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) \right) (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) \text{ near } i^0 \cap \mathscr{I}^+, \tag{1.31}$$

which identifies

$$h_{00} = h(\partial_0, \partial_0), \quad \partial_0 = \partial_t + \partial_{r_*}, \tag{1.32}$$

as the (only) long range component of h; see the calculation (3.15).¹² Indeed, the first vector field in (1.31) is approximately tangent to outgoing null cones, so for $h_{00} \neq 0$ at \mathscr{I}^+ , outgoing null cones do not tend to $(\mathscr{I}^+)^{\circ}$. (Rather, if $h_{00} > 0$, say, they are less strongly bent, like in a Schwarzschild spacetime with mass smaller than m.) Whether or not h_{00} vanishes at \mathscr{I}^+ depends on the choice of gauge. A calculation, see (A.5), shows that the gauge condition $\Upsilon(g) = 0$ implies the constancy of h_{00} along \mathscr{I}^+ ; but since h_{00} is initially 0 due to g_m already capturing the long range part of the initial data, this means that $h_{00}|_{\mathscr{I}^+} = 0$ indeed—provided that P(h) = 0 with Cauchy data satisfying the gauge condition, as we otherwise cannot conclude the vanishing of $\Upsilon(g)$. We remark that $\Upsilon(g) = 0$ implies the vanishing of further components of h, namely $r^{-1}h_{0a} \equiv h(\partial_0, r^{-1}\partial_{\theta^a})$ and $r^{-2} \not = h_{ab}$, $h_{ab} := h(\partial_{\theta^a}, \partial_{\theta^b})$, which we collectively denote by h_0 ; see (3.4) and (3.11), where the notation $h_0 := \pi_0 h$ is introduced.

As we are solving approximate (linearized) equations at each step of our Newton-type iteration scheme in step 4, we thus need an extra mechanism to ensure that $\Upsilon(g)$, $g = g_m + \rho h$, is decaying sufficiently fast at \mathscr{I}^+ to guarantee the vanishing of h_{00} at \mathscr{I}^+ . This is where constraint damping comes into play. Roughly speaking, if one only has an approximate solution of $P_0(g) \approx 0$, then we still get $\delta_g G_g \widetilde{\delta}^* \Upsilon(g) \approx 0$; if one chooses $\widetilde{\delta}^*$ carefully, solutions of this can be made to decay at \mathscr{I}^+ sufficiently fast so as to imply the vanishing of h_{00} (provided the right hand side is sufficiently small). We shall show that the choice

$$\widetilde{\delta}^* u = \delta_{q_m}^* u + 2\gamma_1 \frac{dt}{t} \otimes_s u - \gamma_2(\iota_{t^{-1}\nabla t} u) g_m, \quad \gamma_1, \gamma_2 > 0,$$

¹¹Note that we use g_m in two distinct roles: once as a background metric in the gauge condition, and once as a rough first guess of the solution of the initial value problem which (1) already has the correct long range behavior at null infinity and (2) is *globally* close to a solution of the Einstein vacuum equation if m is small. See also Remark 6.6.

¹²In the case that h_{00} vanishes at \mathscr{I}^+ , the approximate null directions $\rho_I \partial_{\rho_I}$ and $\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}$ have the same form as in the discussion surrounding (1.19), however, due to our choice of compactification mM , they are now the radial null directions of Schwarzschild with mass m. (Integration along these more precise characteristics was key in Lindblad's proof of sharper asymptotics in [Li17].)

accomplishes this.¹³ As a first indication, one can check that $2\delta_{g_m}G_{g_m}\widetilde{\delta}^*$ has a structure similar to (1.21) with $\gamma > 0$, for which we had showed the improved decay at \mathscr{I}^+ .

Regarding steps 2 and 3 of our general strategy, the correct function spaces can now be determined easily (after some tedious algebra): solving $L_0u = 0$, where $L_h = D_hP$ as usual, one finds that $u_0 = \pi_0 u$, so in particular the long range component u_{00} of u decays at \mathscr{I}^+ , while the remaining components, denoted u_0^c , have a size 1 leading term at \mathscr{I}^+ , just like solutions of the linear scalar wave equation. This follows from the schematic structure

$$\rho_I^{-1} \left(\rho_I \partial_{\rho_I} - \begin{pmatrix} \gamma & 0 \\ 0 & 0 \end{pmatrix} \right) (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) \begin{pmatrix} u_0 \\ u_0^c \end{pmatrix}$$

of the model operator at \mathscr{I}^+ in this case. However, for such u then, solutions of $L_u u' = -P(u)$ have slightly more complicated behavior. Indeed, the model operator at \mathscr{I}^+ has a schematic structure similar to (1.25), acting on $(u'_0, (u')^c_{11}, u'_{11})$, where we separate the components of $(u')^c_0$ into two sets, one of which consists of the single component

$$u'_{11} = u(\partial_1, \partial_1), \quad \partial_1 = \partial_t - \partial_{r_*}, \tag{1.33}$$

while $(u')_{11}^c$ captures the remaining components, which are u_{01} , $r^{-1}u_{1b}$, and the part $r^{-2}(u_{ab} - \frac{1}{2} g_{ab} g^{cd}u_{cd})$ of the spherical part of u which is trace-free with respect to g. Correspondingly, we need to allow u'_{11} to have a logarithmic leading order term, just like the component called u_1 in the definition of the function space (1.24). In the next iteration step, $L_{u'}u'' = -P(u')$, no further adjustments are necessary: the structure of the model operator at \mathscr{I}^+ is unchanged, hence the asymptotic behavior of u'' does not get more complicated. We remark that due to our precise control over each iterate, encoded by membership in \mathscr{X}^{∞} , the relevant structure of the model operators and the regularity of the coefficients of the linearized equations are the same at each iteration step; in particular, the fact that equation (1.30) is quasilinear rather than semilinear does not cause any complications beyond the need for constraint damping.

The decoupling of the model operator at \mathscr{I}^+ into three pieces—one for the decaying components u_0 , one for the components u_{11}^c which have possibly non-trivial leading terms at \mathscr{I}^+ , and one for the logarithmically growing component u_{11} —is the key structure making our proof of global stability work. The fact that the equation for the components u_0 decouples is not coincidental, as they are governed by the gauge condition and thus are expected to decouple to leading order in view of the second Bianchi identity as around (1.28). The decoupling of u_{11} and u_{11}^c on the other hand is the much more subtle manifestation of the weak null condition, as discussed in Remark 1.6.

The solution h of (1.30) is a symmetric 2-tensor in M° ; as part of step 1, we still need to specify the smooth vector bundle on M which h will be a section of. Consider first the Minkowski metric \underline{g} on the radial compactification ${}^{0}\overline{\mathbb{R}^{4}}$. In \mathbb{R}^{4} , \underline{g} is a quadratic form, with constant coefficients, in the 1-forms dt and dx^{i} , which extend smoothly to the boundary as

¹³For technical reasons related to the definition of the smooth structure on ${}^{m}\overline{\mathbb{R}^{4}}$, we shall modify t slightly; see Definition 2.3 and equation (3.3).

¹⁴The coupling matrix, called A_u in (1.25), is in fact slightly more complicated here, see Lemma 3.8, necessitating a more careful choice of the weights of the remainder terms of elements of the spaces \mathcal{X}^{∞} and \mathcal{Y}^{∞} at \mathscr{I}^+ , whose precise definitions we give in Definitions 3.1 and 3.3.

 $^{^{15}}$ In practice, it is easier to analyze u_0 directly using the structure of the linearized gauged Einstein equation, rather than via an (approximate) linearized second Bianchi identity, so this is how we shall proceed.

sections of the scattering cotangent bundle ${}^{\text{sc}}T^{*\,0}\overline{\mathbb{R}^{4}}$ first introduced in [Me94]; in a collar neighborhood $[0,1)_{\rho} \times \mathbb{R}^{3}_{X}$ of a point in $\partial^{0}\overline{\mathbb{R}^{4}}$, the latter is by definition spanned by the 1-forms $\frac{d\rho}{\rho^{2}}$, $\frac{dX^{i}}{\rho}$, which are smooth and linearly independent sections of ${}^{\text{sc}}T^{*\,0}\overline{\mathbb{R}^{4}}$ down to the boundary. For instance, near r=0, we can take $\rho=t^{-1}$ and X=x/t, in which case $\frac{d\rho}{\rho^{2}}=-dt$ and $\frac{dX^{i}}{\rho}=dx^{i}-X^{i}dt$. Similarly then, g_{m} will be a smooth section of the second symmetric tensor power $S^{2\,\text{sc}}T^{*\,m}\overline{\mathbb{R}^{4}}$. Since our non-linear analysis takes place on the blown-up space ${}^{m}M$, we seek h as a section of the pullback bundle $\beta^{*}S^{2\,\text{sc}}T^{*\,m}\overline{\mathbb{R}^{4}}$, where $\beta: {}^{m}M \to {}^{m}\overline{\mathbb{R}^{4}}$ is the blow-down map. For brevity, we shall suppress the bundle from the notation here.

Theorem 1.7. Suppose the assumptions of Theorem 1.1 are satisfied, i.e. for some small $m \in \mathbb{R}$ and $b_0 > 0$ fixed, the normalized data $\rho_0^{-1}\widetilde{\gamma}$ and $\rho_0^{-2}k \in \rho_0^{b_0}H_b^{\infty}(\overline{\mathbb{R}^3})$ are small in $\rho_0^{b_0}H_b^{N+1}$ and $\rho_0^{b_0}H_b^{N}$, respectively. Then there exists a solution g of the initial value problem (1.4) satisfying the gauge condition $\Upsilon(g) = 0$, see (1.27), which on ${}^{m}M$ is of the form $g = g_m + \rho h$, $h \in \rho_0^{b_0}\rho_1^{-\epsilon}\rho_+^{-\epsilon}H_b^{\infty}({}^{m}M)$ for all $\epsilon > 0$; here ρ is a boundary defining function of ${}^{m}\overline{\mathbb{R}^4}$, and ρ_0 , ρ_I , and ρ_+ are defining functions of i^0 , \mathscr{I}^+ , and i^+ , respectively.

More precisely, near \mathscr{I}^+ and using the notation introduced after (1.32) and (1.33), the components h_{00} , $r^{-1}h_{0b}$, and $r^{-2}\not = ^abh_{ab}$ lie in $\rho_0^{b_0}\rho_I^{b_I}\rho_+^{-\epsilon}H_{\rm b}^{\infty}(^mM)$ for all $b_I<\min(1,b_0)$ and $\epsilon>0$, while h_{01} , $r^{-1}h_{1b}$, and $r^{-2}(h_{ab}-\frac{1}{2}\not = _{ab}\not= ^{cd}h_{cd})$ have size 1 leading terms at \mathscr{I}^+ plus a remainder in the same space, and h_{11} has a logarithmic and a size 1 leading term at \mathscr{I}^+ plus a remainder in the same space. At i^+ on the other hand, h has a size 1 leading term: there exists $h^+\in\rho_I^{-\epsilon}H_{\rm b}^{\infty}(i^+)$ such that $h-h^+\in\rho_I^{-\epsilon}\rho_+^bH_{\rm b}^{\infty}(^mM)$ near i^+ for any $b_+<\min(b_0,1)$.

See Theorem 6.3 for the full statement, which in particular allows for the decay rate b_0 of the initial data to be larger and gives the corresponding weight at i^0 for the solution. The final conclusion follows from resonance considerations, as indicated before (1.20), and will follow from the arguments used to establish polyhomogeneity in §7. We discuss continuous dependence on initial data in Remark 6.4. A typical example of a polyhomogeneous expansion of h arises for initial data which are smooth functions of 1/r in $r \gg 1$: in this case, the leading terms of the expansion of h are schematically (and not showing the coefficients, which are functions on \mathscr{I}^+)

$$h_0 \sim \rho_I \log^{\leq 3} \rho_I$$
, $h_{11}^c \sim 1 + \rho_I \log^{\leq 4} \rho_I$, $h_{11} \sim \log^{\leq 1} \rho_I + \rho_I \log^{\leq 6} \rho_I$ at \mathscr{I}^+ , and $h \sim 1 + \rho_+ \log^{\leq 8} \rho_+$ at i^+ ; see Example 7.3.

While a solution g of $\operatorname{Ric}(g)=0$ in the gauge $\Upsilon(g)=0$ of course solves equation (1.26) for any choice of $\widetilde{\delta}^*$, we argued why a careful choice is crucial to make our global iteration scheme work. Another perspective is the following: implementing constraint damping allows us to solve the gauged equation (1.26) for any sufficiently small Cauchy data; whether or not these data come from an initial data set satisfying the constraint equations is *irrelevant*. Only at the end, once one has a solution of (1.26), do we use the constraint equations and the second Bianchi identity to deduce $\Upsilon(g)=0$.

In contrast, consider the choice $\widetilde{\delta}^* = \delta_g^*$ in (1.26); the linearization of $P_0(g)$ around the Minkowski metric $g = \underline{g}$ is then equal to $\frac{1}{2}\Box_{\underline{g}}$, which is $\frac{1}{2}$ times the scalar wave operator acting component-wise on the components of a symmetric 2-tensor in the frame $dx^{\mu} \otimes dx^{\nu} +$

 $dx^{\nu} \otimes dx^{\mu}$, where $x^{0} = t$, x^{i} , i = 1, 2, 3, are the standard coordinates on $\mathbb{R}^{1+3}_{t,x}$. Solving $\Box_{\underline{g}}(\rho h) = 0$ with given initial data, which would be the first step in our iteration scheme for initial data with mass m = 0, does not imply improved behavior for any components of h, in particular h_{00} ; this means that constraint damping fails for this choice of δ^* . Thus, the next iterate $\underline{g} + \rho h$ in general has a different long range behavior, and correspondingly ${}^{0}M$ is no longer the correct place for the analysis of the linearized operator in the next iteration step—even though the final solution of Einstein's equation is well-behaved on ${}^{0}M$ for such initial data. With constraint damping on the other hand, the linearized equation always produces behavior consistent with the qualitative properties of the non-linear solution.

1.3. Bondi mass loss formula. The description of the asymptotic behavior of the metric $g = g_m + \rho h$ in Theorem 1.7 on the compact manifold mM and in the chosen gauge allows for a precise description of outgoing light cones close to the radiation face \mathscr{I}^+ . Work on geometric quantities at \mathscr{I}^+ started with the seminal works of Bondi–van der Burg–Metzner [Bo60, BoBuMe62], Sachs [Sa62b, Sa62a], Newman–Penrose [NePe62], and Penrose [Pe65]; the precise decay properties of the curvature tensor—in particular 'peeling estimates' or their failure—were discussed in [KlNi03b, Ch02], see also [Da12]. (For studies on conditions on initial data which ensure or prevent smoothness of the metric at \mathscr{I}^+ in suitable coordinates, see [Fr83, Fr85, ChMaSi95, AnCh93, Va04] and [KlNi03a, §8.2].)

As remarked before, the logarithmic bending of light cones is controlled by the ADM mass m, which measures mass on spacelike, asymptotically flat, Cauchy surfaces. A more subtle notion is the $Bondi\ mass\ [BoBuMe62]$, see also [Ch91], which is a function of retarded time $x^1=t-r_*$ that can be defined as follows: let $S(u)\subset \mathscr{I}^+$ denote the u-level set of x^1 at null infinity; S(u) is a 2-sphere, and naturally comes equipped with the round metric. If C_u denotes the outgoing light cone which limits to S(u) at null infinity and which asymptotically approaches the radial Schwarzschild light cone $\{x^1=u\}$, one can define a natural $area\ radius\ \mathring{r}$ on C_u , equal to the coordinate r plus lower order correction terms; the Bondi mass $M_B(u)$ is then the limit of the $Hawking\ mass$ of the 2-sphere $\{x^1=u,\ \mathring{r}=R\}$ as $R\to\infty$. See §8 for the precise definitions. A change $\frac{d}{du}M_B(u)$ of the Bondi mass reflects a flux of gravitational energy to \mathscr{I}^+ along C_u . We shall calculate these quantities explicitly and show:

Theorem 1.8. Suppose we are given a metric constructed in Theorem 1.7, and write $h_{11} = h_{11}^{(1)} \log(r) + \mathcal{O}(1)$ near \mathscr{I}^+ , where $h_{11}^{(1)} \in \rho_0^{b_0} \rho_+^{-\epsilon} H_b^{\infty}(\mathscr{I}^+)$ is the logarithmic leading term. Then the Bondi mass is equal to

$$M_{\rm B}(u) = m + \frac{1}{4\pi} \int_{S(u)} \frac{1}{2} h_{11}^{(1)} d\phi. \tag{1.34}$$

The Bondi mass loss formula takes the form $\frac{d}{du}M_B(u) = -E(u)$, where

$$E(u) = \frac{1}{32\pi} \int_{S(u)} |N|_{\mathscr{g}}^2 \, d\mathscr{g}, \quad N_{ab} = r^{-2} \partial_1 h_{ab}|_{\mathscr{I}^+},$$

is the outgoing energy flux. Finally, $M_B(-\infty) = m$ and $M_B(+\infty) = 0$.

We prove this for all initial data which are small and asymptotically flat in the sense of (1.6). The Bondi mass was shown to be well-defined (and to satisfy a mass loss formula) for the weakly decaying initial data used in [BiZi09] by Bieri-Chruściel [BiCh16] in the geometric framework of [ChKl93], but the question of how to define Bondi-Sachs coordinates

remained open. Our result is the first to accomplish this for a large class of initial data, and to identify the Bondi mass in a (generalized) wave coordinate gauge setting. ¹⁶ The key to establishing the first part of Theorem 1.8 is the construction and precise control of the aforementioned geometric quantities leading to the identification (1.34); the mass loss formula itself is then equivalent to the vanishing of the leading term of the (1,1) component of the gauged Einstein equation at \mathscr{I}^+ . The vanishing of $M_{\rm B}(u)$ as $u\to -\infty$ follows immediately from the decay properties of h there. On the other hand, the proof that the total radiated energy $\int E(u)\,du$ equals the initial mass m proceeds by studying the leading order term $h|_{i^+}$ as the solution of a linear equation on i^+ (obtained by restricting the non-linear gauged Einstein equation to i^+), with a forcing term that comes from the failure of our glued background metric g_m to satisfy the Einstein equation and which is thus proportional to m. This equation now is closely related to the spectral family of exact hyperbolic space at the bottom of the essential spectrum; ¹⁷ a calculation of the scattering matrix acting on the incoming data given by $h_{11}^{(1)}$ and comparing the (0,0) component of the outgoing data with h_{00} —which vanishes by construction!—then establishes the desired relationship.

Theorem 1.8 shows that the logarithmic term in the asymptotic expansion of h_{11} carries physical meaning. Its vanishing forces m=0, which by the positive mass theorem means that the spacetime is exact Minkowski space. (The observation that $\int E(u) du \ge 0$ immediately implies the non-negativity of the ADM mass of the *small* initial data under consideration here, which in this case was first proved by Choquet-Bruhat-Marsden [ChBrMa76].)

Further geometric properties of the vacuum metrics constructed in this paper, such as the identification of $(\mathscr{I}^+)^{\circ} \subset M$, resp. $(i^+)^{\circ}$, as the set of endpoints of future-directed null, resp. timelike, geodesics, will be discussed elsewhere.

1.4. Outline of the paper. In §§2 and 3, we set the stage for the analysis (steps 1 and 2): we give the precise definition of the compactification $M = {}^{m}M$ on which we will find the solution of (1.4) in §2.1; the relevant function spaces are defined in §2.2, and the relationships between different compactifications are discussed in §2.3. In §2.4, we prepare the invariant formulation of estimates such as (1.16); the results there are not needed until §4. In §3.1, we define the spaces \mathcal{X}^{∞} and \mathcal{Y}^{∞} on M in which we shall find the solution h in Theorem 1.7, and calculate the mapping properties and model operators of the (linearized) gauged Einstein operator in §§3.2 and 3.3, respectively. (The necessary algebra is moved to Appendix A.) The key structures (constraint damping, null structure) critical for our proof will be discussed there as well. We accomplish part 3.1 of step 3—the proof of a high regularity background estimate with imprecise weights—by exploiting these structures in §4. The recovery of the precise asymptotic behavior in §5 finishes step 3.2. Putting this into a Nash-Moser framework allows us to finish the proof of Theorem 1.7 in §6; the proof of polyhomogeneity, thus of the last part of Theorem 1.1, is proved in §7. Finally, a finer description of the resulting asymptotically flat spacetime near null infinity, leading to the proof of Theorem 1.8, is given in $\S 8$.

¹⁶As a by-product, we also obtain a lower bound for the regularity of the conformally rescaled metric down to \mathscr{I}^+ , namely $\mathscr{C}^{1,\alpha}$ for all $\alpha < \min(b_0,1)$, which is expected to be sharp [Ch02]; see Remark 8.12.

 $^{^{17}}$ This linear operator acts on the symmetric scattering 2-tensor bundle restricted to i^+ ; see [Ha17] for the relation with the hyperbolic Laplacian acting on its intrinsic 2-tensor bundle. The spectral parameter here is *fixed*, and the definition of the scattering matrix (incoming data having logarithmic rather than algebraic growth) is specific to working at the bottom of the spectrum; this is in contrast to the description of the scattering matrix depending on the spectral parameter as e.g. in [GrZw03].

For the reader only interested in the key parts of the proof, we recommend reading §§2.1 and 2.2 for the setup, §3.1 for the form of metric perturbations we need to consider, and §3.2 for an explanation of the main features of the linearized problem; taking the background estimate, Theorem 4.2 (whose proof roughly follows the steps outlined in §1.1.1), as a black box, the argument formally concludes in §5. (Getting the actual non-linear solution in §6 is then routine.)

2. Compactification

As explained in §1.2, we shall find the metric g in Theorem 1.7 as a perturbation of a background metric g_m which interpolates between mass m Schwarzschild in a neighborhood $\{r \gg 1, |t| < 2r\}$ of $i^0 \cup \mathscr{I}$ and the Minkowski metric elsewhere. In §2.1, we define such a metric g_m as a smooth scattering metric on a suitable partial compactification $m\overline{\mathbb{R}^4}$ of \mathbb{R}^4 to a manifold with boundary which is closely related to the radial compactifications of asymptotically Minkowski spaces used in [BaVaWu15, BaVaWu16]. The ideal boundaries i^0 , \mathscr{I}^+ , and i^+ are then the boundary hypersurfaces of a manifold with corners obtained by blowing up $m\overline{\mathbb{R}^4}$ at the 'light cone at infinity.' The spaces of conormal and polyhomogeneous functions on this manifold are defined in §2.2.

Let us recall the notion of the scattering cotangent bundle ${}^{\text{sc}}T^*X$ over an n-dimensional manifold X with boundary ∂X . Over the interior X° , ${}^{\text{sc}}T^*_{X^{\circ}}X := T_{X^{\circ}}X$ is the usual cotangent bundle. Near the boundary, let $\rho \geq 0$ and $y = (y^1, \ldots, y^{n-1}) \in \mathbb{R}^{n-1}$ denote local coordinates, in which ∂X is given by $\rho = 0$; then the 1-forms $\frac{d\rho}{\rho^2}$, $\frac{dy^j}{\rho}$ $(j = 1, \ldots, n-1)$ are a smooth local frame of ${}^{\text{sc}}T^*X$, i.e. smooth scattering 1-forms are precisely the linear combinations $a(\rho, y) \frac{d\rho}{\rho^2} + a_j(\rho, y) \frac{dy^j}{\rho}$ with a, a_j smooth. (Equivalently, we can use $d(1/\rho)$ and $d(y^j/\rho)$ as a smooth local frame.) The point is that, viewed from the perspective of X° , such 1-forms have a very specific behavior as one approaches ∂X . Tensor powers and their symmetric versions $S^k {}^{\text{sc}}T^*X$, $k \in \mathbb{N}$, are defined in the usual manner; the dual bundle is denoted ${}^{\text{sc}}TX$ and called scattering tangent bundle. In the case that $\partial X = Y \times Z$ and $X = [0,1)_{\rho} \times \partial X$ are products, so $T^*Y \subset T^*X$ is a well-defined subbundle, then the rescaling $\rho^{-1}T^*Y \subset {}^{\text{sc}}T^*X$, spanned by covectors of the form $\rho^{-1}\eta$, $\eta \in T^*Y$, is a smooth subbundle.

To give an example, calculations similar to the ones prior to Theorem 1.7 show that the differentials of the standard coordinates on \mathbb{R}^n extend to the radial compactification $\overline{\mathbb{R}^n}$ as smooth scattering 1-forms; they are in fact a basis of ${}^{\text{sc}}T^*\overline{\mathbb{R}^n}$, and any metric on \mathbb{R}^n with constant coefficients, such as the Minkowski or Euclidean metric, is a *scattering metric*, i.e. an element of $\mathcal{C}^{\infty}(\overline{\mathbb{R}^n}; S^{2 \text{ sc}}T^*\overline{\mathbb{R}^n})$.

The *b-cotangent bundle* ${}^{b}T^{*}X$ is locally spanned by the 1-forms $\frac{d\rho}{\rho}$, dy^{j} $(j=1,\ldots,n-1)$; its dual is the *b-tangent bundle* ${}^{b}TX$, spanned locally by $\rho\partial_{\rho}$ and $\partial_{y^{j}}$. The space $\mathcal{V}_{b}(X)$ of b-vector fields on X, consisting of those vector fields V on X which are tangent to ∂X , is then canonically identified with $\mathcal{C}^{\infty}(X; {}^{b}TX)$. A *b-metric* is a non-degenerate section of $S^{2} {}^{b}TX$. The space $\mathrm{Diff}_{b}^{k}(X)$ of b-differential operators of degree k consists of finite sums of k-fold products of b-vector fields. Fixing a collar neighborhood $[0,\epsilon)_{\rho} \times \partial X$ and choosing local coordinates y^{j} on ∂X as before, the *normal operator* of an operator $L \in \mathrm{Diff}_{b}^{k}(X)$ given locally by $L = \sum_{j+|\alpha| < k} a_{j\alpha}(\rho, y)(\rho D_{\rho})^{j}D_{y}^{\alpha}$ is defined by freezing coefficients at $\rho = 0$,

$$N(L) := \sum_{j+|\alpha| \le k} a_{j\alpha}(0,y) (\rho D_{\rho})^j D_y^{\alpha} \in \mathrm{Diff}_{\mathrm{b}}^k([0,\infty)_{\rho} \times \partial X). \tag{2.1}$$

This depends on the choice of collar neighborhood only through the choice of normal vector field $\partial_{\rho}|_{\partial X}$; see [Me93, §4.15] for an invariant description. The *Mellin-transformed normal* operator family $\widehat{L}(\sigma)$, $\sigma \in \mathbb{C}$, is the conjugation of N(L) by the Mellin transform in ρ , that is,

$$\widehat{L}(\sigma) := \sum_{j+|\alpha| \le k} a_{j\alpha}(0,y)\sigma^j D_y^{\alpha};$$

this is a holomorphic family of elements of $\mathrm{Diff}^k(\partial X)$. Analogous constructions can be performed for b-operators acting on vector bundles.

2.1. **Analytic structure.** Fix the mass $m \in \mathbb{R}$; for now, m does not have to be small. The Schwarzschild metric, written in polar coordinates on $\mathbb{R} \times \mathbb{R}^3$, takes the form

$$\begin{split} g_m^S &= (1 - \frac{2m}{r})dt^2 - (1 - \frac{2m}{r})^{-1}dr^2 - r^2 \mathbf{g} \\ &= (1 - \frac{2m}{r})ds^2 + 2ds \, dr - r^2 \mathbf{g}, \end{split} \tag{2.2}$$

where g denotes the round metric on \mathbb{S}^2 , and where we let

$$s := t - r_*, \quad r_* := r + 2m \log(r - 2m),$$
 (2.3)

so $dr_* = \frac{r}{r-2m}dr$. Note that level sets of s are radial outgoing null cones. Define

$$\rho := r^{-1}, \quad v := r^{-1} \left(t - r - \chi(t/r) 2m \log(r - 2m) \right), \tag{2.4}$$

where $\chi(x) \equiv 1$, x < 2, and $\chi(x) \equiv 0$, x > 3. Let then

$$C_1 := [0, \epsilon_0)_{\rho} \times (-\frac{7}{4}, 5)_v \times \mathbb{S}^2_{\omega},$$
 (2.5)

where we shrink $\epsilon_0 > 0$ so that t is well-defined and depends smoothly on $\rho > 0$ and v, via the implicit function theorem applied to (2.4). This will provide the compactification near the future light cone (and part of spatial infinity). Near future infinity, we use standard coordinates $(t, x) \in \mathbb{R} \times \mathbb{R}^3$ on \mathbb{R}^4 ; define

$$\rho'_{+} = t^{-1}, \quad X = x/|t|,$$
 (2.6)

and put

$$C_2 := [0, \epsilon_0)_{\rho'_+} \times \{X \in \mathbb{R}^3 \colon |X| < \frac{1}{4}\}.$$
 (2.7)

For $\epsilon_0 > 0$ small enough, we can consider the interiors C_1° , C_2° as smooth submanifolds of \mathbb{R}^4 using the identifications (2.4) and (2.6). (Note in particular that the smooth structures agree with the induced smooth structure of \mathbb{R}^4 .) Let us consider the transition map between

 C_1° and C_2° in more detail: in $C_1^{\circ} \cap C_2^{\circ}$ and for t^{-1} small enough, we have $\chi(t-r) \equiv 0$ and $\frac{r}{t} > \frac{1}{7}$, so the map

$$(\rho'_{+}, X) \mapsto (\rho = \rho'_{+}/|X|, \ v = |X|^{-1} - 1, \ \omega = X/|X|)$$
 (2.8)

extends smoothly (with smooth inverse) to $\rho'_{+} = 0$. We then let




FIGURE 2.1. The partial compactification $\overline{\mathbb{R}^4}$ of \mathbb{R}^4 , constructed from \mathbb{R}^4 , C_1 , and C_2 . Also shown is the hypersurface Σ from (2.14).

$$\overline{\mathbb{R}^4} := (\mathbb{R}^4 \sqcup C_1 \sqcup C_2) / \sim$$

where \sim identifies C_1 and C_2 with subsets of \mathbb{R}^4 as above, and the boundary points of C_1 and C_2 are identified using the map (2.8). This is thus a smooth manifold with boundary, $\overline{\mathbb{R}^4}$ though both $\overline{\mathbb{R}^4}$ and $\partial \overline{\mathbb{R}^4} = (\partial C_1 \sqcup \partial C_2)/\sim$ are non-compact. In other words, $\overline{\mathbb{R}^4}$ is only a compactification of the region $v > -\frac{7}{4}$. See Figure 2.1.

The scattering cotangent bundle of $\overline{\mathbb{R}^4}$ near the light cone at infinity has a smooth partial trivialization ${}^{\text{sc}}T_{C_1}^*\overline{\mathbb{R}^4}=\langle dr\rangle\oplus\langle d(v/\rho)\rangle\oplus\rho^{-1}T^*\mathbb{S}^2$, thus if ψ is a smooth function with $\psi(v)\equiv 1$ for v<1 and $\psi(v)\equiv 0$ for v>2, then

$$g_{m,1} := \left(1 - \frac{2m\psi(v)}{r}\right)d(v/\rho)^2 + 2d(v/\rho)\,dr - r^2 \not g \in \mathcal{C}^{\infty}(C_1; S^{2\,\text{sc}}T_{C_1}^*\overline{\mathbb{R}^4}). \tag{2.9}$$

In v > 3 and for $\epsilon_0 > 0$ small enough, we simply have $g_{m,1} = dt^2 - dr^2 - r^2 \phi$, which is thus equal to

$$g_{m,2} := d(1/\rho'_+)^2 - d(X/\rho'_+)^2 \in \mathcal{C}^{\infty}(C_2; S^{2 \text{ sc}} T_{C_2}^* \overline{\mathbb{R}^4})$$

on the overlap $C_1 \cap C_2$. Thus, we can use a partition of unity to glue $g_{m,1}$ and $g_{m,2}$ together and define a Lorentzian scattering metric \widetilde{g}_m on $C_1 \cup C_2$. Lastly, fix $\phi \in \mathcal{C}^{\infty}(\overline{\mathbb{R}^4})$ such that supp $\phi \subset C^1 \cup C^2$, and set

$$g_m := \phi \widetilde{g}_m + (1 - \phi)(dt^2 - dx^2) \in \mathcal{C}^{\infty}(\overline{\mathbb{R}^4}; S^2 {}^{\mathrm{sc}}T^*\overline{\mathbb{R}^4}), \tag{2.10}$$

thus gluing \widetilde{g}_m to the Minkowski metric away from $C_1 \cup C^2$.

Next, denote the light cone at future infinity by

$$S^{+} := \{ \rho = 0, \ v = 0 \} \subset \partial \overline{\mathbb{R}^4}$$
 (2.11)

and let

$$M' := [\overline{\mathbb{R}^4}; S^+]$$




FIGURE 2.2. Left: the partial compactification $\overline{\mathbb{R}^4}$ and its light cone at infinity S^+ . Right: the blow-up $M' = [\overline{\mathbb{R}^4}; S^+] \xrightarrow{\beta} \overline{\mathbb{R}^4}$, with front face \mathscr{I}^+ (null infinity) and side faces i^0 (spatial infinity), i^+ (future timelike infinity).

¹⁸Different choices of χ produce the same topological space, indeed \mathcal{C}^{α} manifold ($\alpha < 1$); on the other hand, the smooth structure at the boundary does depend on χ , but only in the gluing region $C_1 \cap C_2$. All resulting smooth structures work equally well.

denote the homogeneous blow-up, see Figure 2.2.

Thus, M' is a smooth (non-compact) manifold with corners. Denote the front face by

$$\mathscr{I}^+ = \mathrm{ff}([M'; S^+]);$$

note that $s = v/\rho = t - r_*$ is an affine parameter on the fibers of the blow-down map

$$\beta \colon M' \to \overline{\mathbb{R}^4},$$
 (2.12)

so $\mathscr{I}^+ = \beta^{-1}(S^+)$ is the set of all endpoints of future-directed outgoing radial null-geodesics of mass m Schwarzschild. We further denote the future temporal face by

$$i^+ = \overline{\beta^{-1}((\partial C_2 \cap \partial \overline{\mathbb{R}^4}) \cup \{v > 0\})},$$

whose image $\beta(i^+)$ is a closed 3-ball with boundary S^+ . The spatial face, or rather the part of it that we chose to include in the compactification $\overline{\mathbb{R}^4}$, is defined by

$$i^0 := \overline{\beta^{-1} \big(\partial \overline{\mathbb{R}^4} \cap \{ v < 0 \} \big)}.$$

Using β , one can pull back natural vector bundles on $\overline{\mathbb{R}^4}$ to M'; for instance, the pullback $\beta^* g_m$, which we simply denote by g_m for brevity, is an element of $\mathcal{C}^{\infty}(M'; \beta^* S^2 {}^{\text{sc}} T^* \overline{\mathbb{R}^4})$ (and constant along the fibers of β).

Denote by $t_{\rm b}$ the smooth function

$$t_{\rm b} = \rho_0(t - 2m\chi(r)\log(r - 2m)),$$
 (2.13)

defined for $|t|/\langle r \rangle < \frac{1}{2}$, where $\rho_0 = r^{-1}$ near v = -1, and where $\chi \equiv 0$ for r < R and $\chi \equiv 1$ for r > 2R, with R > 0 large; this extends the function v + 1 smoothly into the interior \mathbb{R}^4 , and $dt_{\rm b}$ is timelike on

$$\Sigma := t_{\mathbf{b}}^{-1}(0). \tag{2.14}$$

We restrict our analysis from now on to the smooth manifold with corners

$$M := M' \cap \left(\{ t_{\mathbf{b}} \ge 0 \} \cup \{ t > \frac{1}{3} \langle r \rangle \} \right),\,$$

where we regard the boundary Σ as 'artificial,' i.e. incomplete, from the point of view of b-analysis; recall Figure 1.1; abusing notation slightly, we shall denote the part $i^0 \cap M$ of spatial infinity contained in M again by i^0 . We denote by ρ_0 , ρ_I , and $\rho_+ \in \mathcal{C}^{\infty}(M)$

defining functions of i^0 , \mathscr{I}^+ , and i^+ , respectively; we further let $\rho \in \mathcal{C}^{\infty}(M)$ denote a total boundary defining function, e.g. $\rho = \rho_0 \rho_I \rho_+$. Defining functions are well-defined up to multiplication by smooth positive functions. We shall often make concrete choices to simplify local calculations; by a *local defining function* of i^0 , say, on some open subset $U \subset M$ we then mean a function $\rho_0 \in \mathcal{C}^{\infty}(U)$ so that for any $K \subseteq U$, $\rho_0|_K$ can be extended to a globally defined defining function of i^0 . We remark that $\rho_0|_{\Sigma} \in \mathcal{C}^{\infty}(\Sigma)$ is a defining function of $\partial \Sigma$ within Σ .

Remark 2.1. The causal character (spacelike, null, timelike) of level sets of ρ_0 , i.e. of $d\rho_0$, depends on the particular choice of ρ_0 . On the other hand, the vector field $\rho_0\partial_{\rho_0}$, defined using any local coordinate system, is well-defined as an element of ${}^bT_{i0}M$, and thus so is its causal character at i^0 with respect to the b-metric ρ^2g_m : it is the scaling vector field at infinity, see the discussion after equation (1.11), and spacelike away from the corner $i^0 \cap \mathscr{I}^+$. Likewise, $\rho_+\partial_{\rho_+}$ is the scaling vector field at i^+ , which is timelike.

Let us relate Σ to the radial compactification $\overline{\mathbb{R}^3}$ of Euclidean 3-space; recall that the latter is defined using polar coordinates $(r,\omega) \in (0,\infty) \times \mathbb{S}^2$ on \mathbb{R}^3 as the closed 3-ball

$$\overline{\mathbb{R}^3} := (\mathbb{R}^3 \sqcup ([0, \infty)_{\rho_0} \times \mathbb{S}^2)) / \sim, \text{ where } (r, \omega) \sim (\rho_0, \omega), \ \rho_0 = r^{-1}, \ r > 0.$$

Consider the map $\iota : \mathbb{R}^3 \ni x = (r, \omega) \mapsto (2m\chi(r)\log(r-2m), x) \in \Sigma^{\circ} \subset \mathbb{R}_t \times \mathbb{R}_x^3$, which is the projection along the flow of ∂_t . Expressed near $\partial \overline{\mathbb{R}^3}$, i.e. for small ρ_0 , this takes the form $\iota(\rho_0, \omega) = (\rho, v, \omega)$ for $\rho = \rho_0$ and v = -1; thus, ι extends to a diffeomorphism

$$\Sigma \cong \overline{\mathbb{R}^3}.\tag{2.15}$$

Whenever necessary, we shall make the mass parameter m in these constructions explicit by writing

$${}^{m}\overline{\mathbb{R}^{4}}, {}^{m}M', {}^{m}M, {}^{m}\Sigma, {}^{m}t_{b}, {}^{m}i^{0}, {}^{m}\mathscr{I}^{+}, {}^{m}i^{+}, {}^{m}\beta, {}^{m}\rho, \text{ etc.}$$
 (2.16)

In particular, ${}^{0}\overline{\mathbb{R}^{4}}$ is the radial compactification of \mathbb{R}^{4} with the closed subset $\{|t|^{-1}=0,\ t/r\leq -\frac{3}{4}\}$ of the boundary removed; note here that on their respective domains of definition, r^{-1} and $|t|^{-1}$ are indeed local boundary defining functions of ${}^{0}\overline{\mathbb{R}^{4}}$. Moreover, the metric g_{m} for m=0 is equal to the Minkowski metric \underline{g} . We shall explore the relationships between ${}^{m}\overline{\mathbb{R}^{4}}$ etc. for different values of m in §2.3.

Working on ${}^{m}\overline{\mathbb{R}^{4}}$, it is convenient for performing calculations near the light cone at infinity S^{+} to introduce double null coordinates,

$$q = t + r_*, \quad s = t - r_*,$$

which we will also denote $x^0 := q$, $x^1 := s$. Using $dq = ds + 2dr_*$ and (2.3),

$${}^{\mathrm{sc}}T^*\overline{\mathbb{R}^4} = \langle dq \rangle \oplus \langle ds \rangle \oplus r \, T^*\mathbb{S}^2$$
 (2.17)

therefore defines a smooth partial trivialization near S^+ ; recall that $\rho = r^{-1}$ there. Similarly,

$$\partial_0 \equiv \partial_{x^0} = \partial_q = \frac{1}{2}(\partial_t + \partial_{r_*}), \quad \partial_1 \equiv \partial_{x^1} = \partial_s = \frac{1}{2}(\partial_t - \partial_{r_*})$$

are smooth scattering vector fields on $\overline{\mathbb{R}^4}$, and together with $r^{-1}T\mathbb{S}^2$, they give a smooth partial trivialization of ${}^{\text{sc}}T\overline{\mathbb{R}^4}$ near S^+ . Letting x^a , a=2,3, denote local coordinates on \mathbb{S}^2 , we will denote spherical indices by early alphabet Latin letters a,b,c,d,e, and general

¹⁹On the other hand, t^{-1} is not smooth on ${}^{m}\overline{\mathbb{R}^{4}}$ for $m \neq 0$; see Lemma 2.2 below.

indices ranging from 0 to 3 by Greek letters. The components of a section ω of ${}^{\text{sc}}T^*\mathbb{R}^4$ in the splitting (2.17) are denoted with barred indices:

$$\omega_{\bar{0}} := \omega(\partial_0), \quad \omega_{\bar{1}} := \omega(\partial_1), \quad \omega_{\bar{a}} := \omega(\rho\partial_a) = r^{-1}\omega(\partial_a).$$
 (2.18)

Thus, the components of a tensor with respect to this splitting have size comparable to the components in the coordinate basis of $T^*\mathbb{R}^4$. The splitting (2.17) induces the splitting

$$S^{2 \text{ sc}} T^* \overline{\mathbb{R}^4} = \langle dq^2 \rangle \oplus \langle 2dq \, ds \rangle \oplus (2dq \otimes_s r \, T^* \mathbb{S}^2)$$

$$\oplus \langle ds^2 \rangle \oplus (2ds \otimes_s r \, T^* \mathbb{S}^2) \oplus r^2 \, S^2 T^* \mathbb{S}^2,$$

$$(2.19)$$

as well as the dual splittings of the dual bundles ${}^{\text{sc}}T\overline{\mathbb{R}^4}$ and $S^2{}^{\text{sc}}T\overline{\mathbb{R}^4}$. We will occasionally use the further splitting

$$S^2T^*\mathbb{S}^2 = \langle g \rangle \oplus \langle g \rangle^{\perp}. \tag{2.20}$$

For calculations of geometric quantities associated with the metric, the bundle splittings induced by the coordinates q, s, x^2, x^3 , i.e.

$$T^*\mathbb{R}^4 = \langle dq \rangle \oplus \langle ds \rangle \oplus T^*\mathbb{S}^2,$$

$$S^2T^*\mathbb{R}^4 = \langle dq^2 \rangle \oplus \langle 2dq \, ds \rangle \oplus (2dq \otimes_s T^*\mathbb{S}^2) \oplus \langle ds^2 \rangle \oplus (2ds \otimes_s T^*\mathbb{S}^2) \oplus S^2T^*\mathbb{S}^2,$$
(2.21)

are more convenient. Components are denoted without bars, that is, for a 1-form ω and for $\mu = 0, 1$, we have $\omega_{\mu} := \omega(\partial_{\mu}) = \omega_{\bar{\mu}}$, while we let $\omega_a := \omega(\partial_a) = r\omega_{\bar{a}}$. In short, we have

$$\omega_{\bar{\mu}} = r^{-s(\mu)}\omega_{\mu}, \quad s(\mu_1, \dots, \mu_N) := \#\{\lambda \colon \mu_{\lambda} \in \{2, 3\}\},$$
 (2.22)

likewise for tensors of higher rank.

On the resolved space M, the null derivatives ∂_0, ∂_1 can be computed as follows: near $i^0 \cap \mathscr{I}^+$, we can take

$$\rho_0 = -\rho/v = (r_* - t)^{-1}, \quad \rho_I = -v = (r_* - t)/r, \quad \rho = \rho_0 \rho_I = r^{-1};$$
(2.23)

then

$$\partial_0 = -\frac{1}{2}\rho_0\rho_I(1-2m\rho)\rho_I\partial_{\rho_I},$$

$$\partial_1 = \rho_0\left(\rho_0\partial_{\rho_0} - (1-\frac{1}{2}\rho_I(1-2m\rho))\rho_I\partial_{\rho_I}\right),$$
(2.24)

and dually

$$\rho \, dq = -\frac{2}{1 - 2m\rho} \left(\frac{d\rho_0}{\rho_0} + \frac{d\rho_I}{\rho_I} \right) + \rho_I \frac{d\rho_0}{\rho_0}, \quad \rho \, ds = \rho_I \frac{d\rho_0}{\rho_0}. \tag{2.25}$$

A similar calculation near $i^+ \cap \mathscr{I}^+$ yields

$$\partial_0 = f_0 \rho_0 \rho_I \rho_+ \cdot \rho_I \partial_{\rho_I}, \quad \partial_1 \in \rho_0 \rho_+ \mathcal{V}_b(M), \tag{2.26}$$

for some $f_0 \in \mathcal{C}^{\infty}(M)$, $f_0 > 0$, depending on the choices of boundary defining functions.

2.2. **Function spaces.** We first recall the notion of b-Sobolev spaces on $\mathbb{R}^{n,d}_+ := [0,\infty)_x^d \times \mathbb{R}^{n-d}_y$: first, we set $H^0_b(\mathbb{R}^{n,d}_+) \equiv L^2_b(\mathbb{R}^{n,d}_+) := L^2(\mathbb{R}^{n,d}_+; |\frac{dx^1}{x^1} \dots \frac{dx^d}{x^d} dy|)$; for $k \in \mathbb{N}$ then, $H^k_b(\mathbb{R}^{n,d}_+)$ consists of all $u \in L^2_b$ such that $V_1 \dots V_j u \in L^2_b$ for all $0 \le j \le k$, where each V_ℓ is equal to either $x^p \partial_{x^p}$ or ∂_{y^q} for some $p=1,\dots,d,\ q=1,\dots,n-d$. For general $s \in \mathbb{R}$, one defines $H^s_b(\mathbb{R}^{n,d}_+)$ by interpolation and duality. One can define b-Sobolev spaces on compact manifolds with corners by localization and using local coordinate charts; we give an invariant description momentarily. Note that the logarithmic change of coordinates $t^j := -\log x^j, \ j=1,\dots,d$, induces an isometric isomorphism $H^s_b(\mathbb{R}^{n,d}_+) \cong H^s(\mathbb{R}^n)$ with the standard Sobolev space on \mathbb{R}^n .

Now on M', fix any smooth b-density, i.e. in local coordinates as above a smooth positive multiple of $|\frac{dx^1}{x^1}\dots \frac{dx^d}{x^d}dy|$, then the space $L^2_{\rm b}(M')$ with respect to this density is well-defined; the space $L^2_{\rm b}(M)$ of restrictions of elements $u\in L^2_{\rm b}(M')$ to M is similarly well-defined, and since M is compact, any two choices of b-densities on M' yield equivalent norms on $L^2_{\rm b}(M)$. More generally, if $b_0, b_I, b_+ \in \mathbb{R}$ are weights, we define the weighted L^2 space

$$\rho_0^{b_0}\rho_I^{b_I}\rho_+^{b_+}H_{\mathrm{b}}^0(M) \equiv \rho_0^{b_0}\rho_I^{b_I}\rho_+^{b_+}L_{\mathrm{b}}^2(M) := \big\{u\colon \rho_0^{-b_0}\rho_I^{-b_I}\rho_+^{-b_+}u \in L^2_{\mathrm{b}}(M)\big\}.$$

The b-Sobolev spaces of order $k=0,1,2,\ldots$ are defined using a finite collection of vector fields $\mathscr{V} \subset \mathcal{V}_{\mathrm{b}}(M')$ such that at each point $p \in M$, the collection \mathscr{V}_{p} spans ${}^{\mathrm{b}}T_{p}M$, namely

$$H_{\rm b}^k(M) := \{ u \in L_{\rm b}^2(M) \colon V_1 \dots V_j u \in L_{\rm b}^2(M), \ 0 \le j \le k, \ V_{\ell} \in \mathcal{V} \};$$

the norm on this space is the sum of the $L^2_b(M)$ -norms of u and its up to k-fold derivatives along elements of $\mathscr V$. One defines $\rho_0^{b_0} \rho_I^{b_I} \rho_+^{b_+} H_b^k(M)$ and its norm correspondingly. Note that the vector fields in $\mathscr V$ are required to be tangent to i^0 , $\mathscr I^+$, and i^+ , but not to Σ ; thus, we measure standard Sobolev regularity near Σ , and b- (conormal) regularity at i^0 , $\mathscr I^+$, and i^+ . (Thus, our space $H_b^k(M)$ would be denoted $\bar H_b^k(M)$ in the notation of [Hö07, Appendix B].) Due to the compactness of M, any two choices of collections $\mathscr V$ and boundary defining functions ρ_0, ρ_I, ρ_+ give rise to the same b-Sobolev space, up to equivalence of norms. The space $H_b^\infty(M) = \bigcap_{k \geq 1} H_b^k(M)$ and its weighted analogues have natural Fréchet space structures; we refer to their elements as conormal functions. Weighted b-Sobolev spaces of sections of vector bundles on M are defined using local trivializations. We will in particular use the space

$$H_{\mathbf{b}}^{k;b_0,b_I,b_+}(E) \equiv H_{\mathbf{b}}^{k;b_0,b_I,b_+}(M;E) := \rho_0^{b_0} \rho_I^{b_I} \rho_+^{b_+} H_{\mathbf{b}}^k(M;E), \tag{2.27}$$

with E denoting the trivial bundle $\underline{\mathbb{C}}:=M\times\mathbb{C}\to M$, or $E=\beta^{*\mathrm{sc}}T^*\overline{\mathbb{R}^4}$, or $E=\beta^*S^2\,^{\mathrm{sc}}T^*\overline{\mathbb{R}^4}$. When the bundle E is clear from the context, we will simply write $H_{\mathrm{b}}^{k;b_0,b_I,b_+}$. When estimating error terms, we will often use the inclusion

$$\mathcal{C}^{\infty}(\overline{\mathbb{R}^4}) \subset \mathcal{C}^{\infty}(M) \subset H^{\infty;-0,-0,-0}_{\mathrm{b}} := \bigcap_{\epsilon>0} H^{\infty;-\epsilon,-\epsilon,-\epsilon}_{\mathrm{b}}.$$

For the last part of Theorem 1.1, we need to define the notion of polyhomogeneity (or \mathcal{E} smoothness) and discuss its basic properties; see [Ma91, §2A] and [Me96, §4.15] for detailed accounts and proofs. An index set is a discrete subset $\mathcal{E} \subset \mathbb{C} \times \mathbb{N}_0$ such that

$$(z,j) \in \mathcal{E} \implies (z,j') \in \mathcal{E} \ \forall j' \le j;$$
 (2.28a)

$$(z_{\ell}, j_{\ell}) \in \mathcal{E}, \ |z_{\ell}| + j_{\ell} \to \infty \implies \operatorname{Im} z_{\ell} \to -\infty;$$
 (2.28b)

$$(z,j) \in \mathcal{E} \implies (z-i,j) \in \mathcal{E}.$$
 (2.28c)

We shall write

$$\operatorname{Im} \mathcal{E} < c : \iff \operatorname{Im} z < c \ \forall (z, k) \in \mathcal{E}, \tag{2.29}$$

likewise for the non-strict inequality sign. Let now X denote a compact manifold with boundary ∂X , and let $\rho \in \mathcal{C}^{\infty}(X)$ be a boundary defining function. The choice of a collar neighborhood $[0,1)_{\rho} \times \partial X$ makes the vector field ρD_{ρ} well-defined, and any two choices of collars give the same vector field ρD_{ρ} modulo elements of $\rho \mathcal{V}_{b}(X)$. The space $\mathcal{A}_{phg}^{\mathcal{E}}(X)$

then consists of all $u\in \rho^{-\infty}H^\infty_{\rm b}(X)=\bigcup_{N\in\mathbb R}\rho^NH^\infty_{\rm b}(X)$ for which

$$\prod_{\substack{(z,j)\in\mathcal{E}\\\operatorname{Im}\,z\geq -N}} (\rho D_{\rho} - z)u \in \rho^{N} H_{\mathrm{b}}^{\infty}(X) \text{ for all } N \in \mathbb{R};$$

$$(2.30)$$

equivalently, there exist $a_{(z,j)} \in \mathcal{C}^{\infty}(X)$, $(z,j) \in \mathcal{E}$, such that

$$u - \sum_{\substack{(z,j) \in \mathcal{E} \\ \text{Im } z > -N}} \rho^{iz} (\log \rho)^j a_{(z,j)} \in \rho^N H_b^{\infty}(X).$$
 (2.31)

(Condition (2.28c) ensures that this is independent of the choice of ρD_{ρ} .) In particular, $u \in \rho^{-\operatorname{Im} \mathcal{E} - 0} H_{\mathrm{b}}^{\infty}(X)$. When no confusion can arise, we write

$$(a,k) := \{(a-in,j) : n \in \mathbb{N}_0, 0 \le j \le k\}, \quad a := (a,0).$$
 (2.32)

For example, $\mathcal{A}_{\text{phg}}^{-ia}(X) = \rho^a \mathcal{C}^{\infty}(X)$. We also recall the notion of the *extended union* of two index sets \mathcal{E}_1 , \mathcal{E}_2 , defined by

$$\mathcal{E}_1 \overline{\cup} \mathcal{E}_2 = \mathcal{E}_1 \cup \mathcal{E}_2 \cup \{(z,k) \colon \exists (z,j_\ell) \in \mathcal{E}_\ell, \ k \le j_1 + j_2 + 1\},$$

so e.g. $0 \overline{\cup} 0 = (0,1)$, as well as their sum

$$\mathcal{E}_1 + \mathcal{E}_2 := \{(z, j) : \exists (z_\ell, j_\ell) \in \mathcal{E}_\ell, \ z = z_1 + z_2, \ j = j_1 + j_2\};$$

thus $\mathcal{A}^{\mathcal{E}_1}_{\mathrm{phg}}(X) \cdot \mathcal{A}^{\mathcal{E}_2}_{\mathrm{phg}}(X) \subset \mathcal{A}^{\mathcal{E}_1 + \mathcal{E}_2}_{\mathrm{phg}}(X)$. For $j \in \mathbb{N}$ and an index set \mathcal{E} , we define

$$j\mathcal{E}_1 := \mathcal{E}_1 + \cdots + \mathcal{E}_1,$$

with j summands.

If X is a manifold with corners with embedded boundary hypersurfaces H_1, \ldots, H_k to each of which is associated an index set \mathcal{E}_i , we define $\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_1, \ldots, \mathcal{E}_k}(X)$, as the space of all $u \in \rho^{-\infty} H_{\mathrm{b}}^{\infty}(X)$, with $\rho \in \mathcal{C}^{\infty}(X)$ a total boundary defining function, such that for each $1 \leq i \leq k$, there exist weights $b_j \in \mathbb{R}, j \neq i$, such that, with $\rho_i \in \mathcal{C}^{\infty}(X)$ denoting a defining function of H_i , 20

$$\prod_{\substack{(z,j)\in\mathcal{E}_i\\\operatorname{Im} z\geq -N}} (\rho_i D_{\rho_i} - z) u \in \rho_i^N \prod_{j\neq i} \rho_j^{b_j} H_{\mathrm{b}}^{\infty}(X) \text{ near } H_i.$$

This is equivalent to u admitting an asymptotic expansion at each H_i as in (2.31), with each $a_{(z,j)}$ polyhomogeneous with index set \mathcal{E}_j at each non-empty boundary hypersurface $H_j \cap H_i$ of H_i .

We shall also need spaces encoding polyhomogeneous behavior at one hypersurface but not others; for brevity, we only discuss this in the case of two boundary hypersurfaces H_1, H_2 : for an index set \mathcal{E} and $\alpha \in \mathbb{R}$, $\mathcal{A}_{\mathrm{phg,b}}^{\mathcal{E},\alpha}$ consists of all $u \in \rho^{-\infty} H_{\mathrm{b}}^{\infty}$ such that

ndex set
$$\mathcal{E}$$
 and $\alpha \in \mathbb{R}$, $\mathcal{A}_{\text{phg,b}}^{c,\alpha}$ consists of all $u \in \rho^{-\infty} H_{\text{b}}^{\infty}$ s
$$\prod_{\substack{(z,j)\in\mathcal{E}_i\\\text{Im }z\geq -N}} (\rho_1 D_{\rho_1} - z) u \in \rho_1^N \rho_2^{\alpha} H_{\text{b}}^{\infty} \text{ near } H_1, \text{ for all } N \in \mathbb{R};$$

this is equivalent to u having an expansion at H_1 with terms $a_{(z,j)} \in \rho_2^{\alpha} H_b^{\infty}(H_2)$.

We briefly discuss non-linear properties of b-Sobolev and polyhomogeneous spaces; for brevity, we work on an n-dimensional compact manifold X with boundary ∂X , and leave

²⁰As before, the vector fields $\rho_i D_{\rho_i}$, defined using a collar neighborhood of H_i , are in fact well-defined modulo $\rho_i \mathcal{V}_b(X)$, which is all that matters in this definition.

the statements of the obvious generalizations to the setting of manifolds with corners to the reader. Thus, if s > n/2, then $H_{\rm b}^s(X)$ is a Banach algebra, and more generally $u_1 \cdot u_2 \in \rho^{a_1+a_2}H_{\rm b}^s(X)$ if $u_j \in \rho^{a_j}H_{\rm b}^s(X)$, j=1,2. Regarding the interaction with polyhomogeneous spaces, if $\mathcal E$ is an index set, then $\mathcal A_{\rm phg}^{\mathcal E}(X) \cdot \rho^a H_{\rm b}^s(X) \subset \rho^{a-e}H_{\rm b}^s(X)$ for all $a,s \in \mathbb R$ when $e > \operatorname{Im} \mathcal E$; in the case that $\mathcal E = (a_0,0) \cup \mathcal E'$ with $\operatorname{Im} \mathcal E' < \operatorname{Im} a_0$, we may take $e = \operatorname{Im} a_0$. One can also take inverses, to the effect that $u/(1-v) \in H_{\rm b}^s(X)$ provided $u,v \in H_{\rm b}^s(X)$, s > n/2, and $v \leq C < 1$, which follows readily from the corresponding results on $\mathbb R^n$, see e.g. [Ta96, §13.10], by a logarithmic change of coordinates.

For comparisons with the Minkowski metric, we study the regularity properties of t^{-1} on ${}^{m}\overline{\mathbb{R}^{4}}$. Define the index set

$$\mathcal{E}_{\log} := \{ (-ik, j) : k \in \mathbb{N}_0, \ 0 \le j \le k \}, \ \mathcal{E}'_{\log} := \mathcal{E}_{\log} \setminus \{ (0, 0) \}.$$
 (2.33)

Lemma 2.2. Letting $U = \overline{\{t > \frac{2}{3}r\}} \subset {}^m \overline{\mathbb{R}^4}$, we have

$$t^{-1} \in \rho \cdot \mathcal{A}_{\text{phg}}^{\mathcal{E}_{\log}}(U) \subset \rho \, \mathcal{C}^{\infty}(U) + \rho^{2-0} H_{\text{b}}^{\infty}(U) \subset \rho^{1-0} H_{\text{b}}^{\infty}(U), \tag{2.34}$$

and $t^{-1}/\rho \in \mathcal{C}^{\infty}(U \cap \partial \overline{\mathbb{R}^4})$ is everywhere non-zero.

Definition 2.3. We define $\rho_t \in \mathcal{C}^{\infty}(^m\overline{\mathbb{R}^4})$ to be any boundary defining function satisfying $\rho_t/\rho = t^{-1}/\rho$ at $U \cap \partial^m\overline{\mathbb{R}^4}$.

By Lemma 2.2, this fixes ρ_t in U modulo $\rho^2 \mathcal{C}^{\infty}(^m \overline{\mathbb{R}^4})$; away from U, ρ_t is merely well-defined modulo $\rho \mathcal{C}^{\infty}(^m \overline{\mathbb{R}^4})$.

Proof of Lemma 2.2. Using the notation of §2.1, we have $t^{-1} \in \mathcal{C}^{\infty}(C_2)$. Thus, it suffices to work in $C_1 \cap \{v > -\frac{1}{2}\}$, where we can take $\rho = r^{-1}$; we then need to prove $f := \rho t \in \mathcal{A}^{\mathcal{E}_{log}}_{phg}$ and $f|_{\partial \mathbb{R}^4} \neq 0$ there, which implies the claim about $t^{-1}/\rho = 1/f$ as $\mathcal{A}^{\mathcal{E}_{log}}_{phg}$ is closed under multiplication. Note that $f \in \mathcal{C}^{\infty}(\mathbb{R}^4)$, and $f > \frac{1}{4}$. Let $\tilde{\chi}(x) = \chi(x^{-1}) \in \mathcal{C}^{\infty}((0, \infty); [0, 1])$ in the notation (2.4), so $\tilde{\chi}(x) \equiv 0$, $x < \frac{1}{3}$, and $\tilde{\chi}(x) \equiv 1$, $x > \frac{1}{2}$, then

$$f = 1 + v - 2m\rho\tilde{\chi}(f)(\log\rho - \log(1 - 2m\rho)). \tag{2.35}$$

Note that near $\rho = 0$, $f = \rho^{-1}t^{-1}$ is the *unique* positive function satisfying this equation: indeed, if f' is another such function, then $|f - f'| \lesssim (\rho \log \rho)|f - f'|$. At $\rho = 0$, we have f = 1 + v. Thus, let $k \geq 2$ be an integer, and consider the map

$$T : \tilde{f} \mapsto -2m\rho(\log \rho - \log(1 - 2m\rho))\tilde{\chi}(1 + v + \tilde{f})$$

on $\rho^{1-\delta}H_{\rm b}^k([0,\epsilon_k)_{\rho}\times(-1/2,5)_v)$, where $\delta\in(0,1)$ is fixed. Now

$$||T(\tilde{f}) - T(\tilde{f}')||_{\rho^{1-\delta}H_{h}^{k}} \leq C_{k} ||\rho\log\rho - \rho\log(1-2m\rho)||_{H_{h}^{k}} ||\tilde{\chi}||_{\mathcal{C}^{k}} ||\tilde{f} - \tilde{f}'||_{\rho^{1-\delta}H_{h}^{k}};$$

choosing $\epsilon_k > 0$ sufficiently small, the first norm on the right can be made arbitrarily small. By the contraction mapping principle, this gives $f - 1 - v \in \rho^{1-\delta} H_b^{\infty}$ since k was arbitrary. We can now improve the remainder term by plugging this into (2.35), which gives

$$f - (1 + v - 2m\tilde{\chi}(1+v)(\rho\log\rho - \rho\log(1-2m\rho))) \in \rho^{2-\delta}H_b^{\infty}$$

so $f \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_{\mathrm{log}}} + \rho^{2-\delta} H_{\mathrm{b}}^{\infty}$. Using that $\chi \circ (\cdot)$ maps $\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_{\mathrm{log}}}$ into itself, as follows from the testing definition (2.30), the desired conclusion follows from an iterative argument.

2.3. Relationships between different compactifications. The only difference between the compactifications ${}^{m}\overline{\mathbb{R}^{4}}$ for different values of m is the manner in which a smooth collar neighborhood of $\partial^{m}\overline{\mathbb{R}^{4}}$ is glued together with \mathbb{R}^{4} . Since this difference is small due to the logarithmic correction in (2.4) being only of size $r^{-1}\log r$, different compactifications are closely related; see also [BaVaWu16, §7]. Indeed:

Lemma 2.4. The identity map $\mathbb{R}^4 \to \mathbb{R}^4$ induces a homeomorphism $\phi \colon {}^m \overline{\mathbb{R}^4} \to {}^0 \overline{\mathbb{R}^4}$, which in fact is a polyhomogeneous diffeomorphism with index set \mathcal{E}_{\log} ; that is, in smooth local coordinate systems near $\partial^m \overline{\mathbb{R}^4}$ and $\partial^0 \overline{\mathbb{R}^4}$, the components of both ϕ and ϕ^{-1} are real-valued functions on $[0,\infty) \times \mathbb{R}^3$ of class $\mathcal{A}^{\mathcal{E}_{\log}}_{phg}$. Moreover, ϕ induces a smooth diffeomorphism $\partial^m \overline{\mathbb{R}^4} \cong \partial^0 \overline{\mathbb{R}^4}$, which restricts to ${}^m \beta({}^m i^+) \cong {}^0 \beta({}^0 i^+)$, and also induces a smooth diffeomorphism ${}^m i^+ \cong {}^0 i^+$.

Proof. We have $\mathcal{A}^{\mathcal{E}_{\log}}_{\mathrm{phg}} \subset \mathcal{C}^{\infty} + \rho^{1-0} H_{\mathrm{b}}^{\infty} \subset \mathcal{C}^{0}$, so it suffices to prove the polyhomogeneity statement. Defining the smooth coordinates ρ and v as in (2.4), and the corresponding smooth coordinates ${}^{0}\rho = r^{-1}$ and ${}^{0}v = r^{-1}(t-r)$ on ${}^{0}\overline{\mathbb{R}^{4}}$, we then observe that ${}^{0}\rho = \rho$, while in the notation of equation (2.35), we established that $1 + {}^{0}v = f \in \mathcal{A}^{\mathcal{E}_{\log}}_{\mathrm{phg}}$ on ${}^{m}\overline{\mathbb{R}^{4}}$, giving the desired conclusion for ϕ . For ϕ^{-1} , we write $v = {}^{0}v - r^{-1}\chi(t/r)2m\log(r-2m)$ and note that $t/r \in \mathcal{C}^{\infty}({}^{0}\overline{\mathbb{R}^{4}})$. For the last claim, we observe that

$$v = {}^{0}v \text{ at } \partial^{m}\overline{\mathbb{R}^{4}}$$
 (2.36)

under the identification with $\partial^0 \overline{\mathbb{R}^4}$ given by ϕ . This also shows that the sets ${}^m\beta({}^mi^+) = \{v \geq 0\}$ and ${}^0\beta({}^0i^+) = \{{}^0v \geq 0\}$ are diffeomorphic. On mM , resp. 0M then, v, resp. 0v , are local defining functions of the boundaries $\partial^m i^+$, resp. $\partial^0 i^+$, hence by (2.36), the identification ${}^mi^+ \cong {}^0i^+$ in the interior of ${}^mi^+$ indeed extends smoothly to its boundary. \square

In a similar vein, the scattering (co)tangent bundles can be naturally identified over the boundary:

Lemma 2.5. The identity map $T^*\mathbb{R}^4 \to T^*\mathbb{R}^4$ extends by continuity to a continuous bundle map ${}^{\mathrm{sc}}T^*{}^m\overline{\mathbb{R}^4} \to {}^{\mathrm{sc}}T^*{}^0\overline{\mathbb{R}^4}$ which restricts to a smooth bundle isomorphism over the boundary.

Proof. Since away from r=0, $\langle d(r^{-1}) \rangle$ and $rT^*\mathbb{S}^2$ are smooth subbundles of ${}^{\text{sc}}T^{*\,m}\overline{\mathbb{R}^4}$ for any m, it suffices to show that $d(t^{-1})$, which is a smooth section of ${}^{\text{sc}}T^{*\,0}\overline{\mathbb{R}^4}$, extends by continuity from \mathbb{R}^4 to $\partial^m\overline{\mathbb{R}^4}$ and restricts to a smooth section of ${}^{\text{sc}}T^*_{\partial^m\overline{\mathbb{R}^4}}{}^m\overline{\mathbb{R}^4}$. By Lemma 2.2, we have $t=\rho^{-1}f$, $f\in\mathcal{A}^{\mathcal{E}_{\log}}_{\mathrm{phg}}$, so $dt=f\,d(\rho^{-1})+\rho^{-1}df$; but $f|_{\partial^m\overline{\mathbb{R}^4}}$ is smooth indeed, while in a local product neighborhood $[0,1)_{\rho}\times\mathbb{R}^3_X$ of a point in $\partial^m\overline{\mathbb{R}^4}$, $\rho^{-1}df=(\rho\partial_{\rho}f)\frac{d\rho}{\rho^2}+(\partial_X f)\frac{dX}{\rho}$ restricts to the smooth scattering 1-form $(\partial_X f)\frac{dX}{\rho}$ on $\partial^m\overline{\mathbb{R}^4}$.

Let us discuss this on the level of function spaces. The map ϕ in Lemma 2.4 induces $\mathcal{C}^{\infty}(^{m}\overline{\mathbb{R}^{4}}) \subset \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_{\mathrm{log}}}(^{0}\overline{\mathbb{R}^{4}})$ and vice versa. Moreover, it induces an isomorphism

$$({}^{m}\rho)^{\alpha}H_{\mathrm{b,loc}}^{s}({}^{m}\overline{\mathbb{R}^{4}}) \cong ({}^{0}\rho)^{\alpha}H_{\mathrm{b,loc}}^{s}({}^{0}\overline{\mathbb{R}^{4}}), \quad s,\alpha \in \mathbb{R},$$
 (2.37)

as follows from $\phi \in \mathcal{A}_{phg}^{\mathcal{E}_{log}}$. The corresponding statement is not quite true on the blown-up spaces ${}^{m}M$, the failure happening at ${}^{m}\mathscr{I}^{+}$; there, let us use

$${}^{m}\rho = {}^{0}\rho = r^{-1}; \quad {}^{m}v = {}^{0}v - 2m({}^{0}\rho)\log(({}^{0}\rho)^{-1} - 2m), \ {}^{0}v = r^{-1}(t-r).$$

Now, the b-tangent bundle on ${}^{0}M$ is spanned near ${}^{0}\mathscr{I}^{+}$ by spherical derivatives,

$${}^{0}\rho\partial_{0\rho}\in{}^{m}\rho\partial_{m\rho}+\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}'_{\mathrm{log}}}\cdot\partial_{mv},\ \ {}^{0}v\partial_{0v}\in\left({}^{m}v+\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}'_{\mathrm{log}}}\right)\partial_{mv},$$

and ${}^{0}\rho\partial_{0}_{v}={}^{m}\rho\partial_{m}_{v}$; due to the logarithmic loss at \mathscr{I}^{+} , we thus only have

$$(^{m}\rho_{0})^{b_{0}}(^{m}\rho_{I})^{b_{I}}(^{m}\rho_{+})^{b_{+}}H^{s}_{\mathrm{b,loc}}(^{m}M)\subset (^{0}\rho_{0})^{b_{0}}(^{0}\rho_{I})^{b_{I}-\epsilon}(^{0}\rho_{+})^{b_{+}}H^{s}_{\mathrm{b,loc}}(^{0}M)$$

for all $\epsilon > 0$, but the inclusion fails for $\epsilon = 0$. That is, conormal function spaces are the same on ${}^{m}M$ and ${}^{0}M$ up to an arbitrarily small loss in the weight at \mathscr{I}^{+} .

Polyhomogeneous spaces on ${}^{m}\overline{\mathbb{R}^{4}}$ for different values of m are related in a simple manner: if $\mathcal{E} \subset \mathbb{C} \times \mathbb{N}_{0}$ is an index set and \mathcal{E}_{\log} is given by (2.33), then ϕ induces inclusions

$$\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}}(^{m}\overline{\mathbb{R}^{4}}) \hookrightarrow \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}+\mathcal{E}_{\mathrm{log}}}(^{0}\overline{\mathbb{R}^{4}}), \quad \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}}(^{0}\overline{\mathbb{R}^{4}}) \hookrightarrow \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}+\mathcal{E}_{\mathrm{log}}}(^{m}\overline{\mathbb{R}^{4}}); \tag{2.38}$$

this is only non-trivial where the two compactifications differ, i.e. away from r=0, i.e. where we can use r^{-1} as a boundary function for both ${}^0\overline{\mathbb{R}^4}$ and ${}^m\overline{\mathbb{R}^4}$. Considering a single term $r^{-iz}(\log r)^k f({}^m v, \omega)$, with $\omega \in \mathbb{S}^2$ and f smooth, in the expansion of an element of $\mathcal{A}^{\mathcal{E}}_{\mathrm{phg}}({}^m\overline{\mathbb{R}^4})$, the first inclusion in (2.38) follows from $f \circ \phi \in \mathcal{A}^{\mathcal{E}_{\mathrm{log}}}_{\mathrm{phg}}({}^0\overline{\mathbb{R}^4})$, which in turn can be seen by Taylor expanding $f({}^0v-2m({}^0\rho)\log(({}^0\rho)^{-1}-2m),\omega)$ in the first argument around 0v . The proof of the second inclusion is similar. See [BaVaWu16, Proposition 7.8] for an alternative argument.

Polyhomogeneity on different spaces ${}^m\!M$ on the other hand is much less well-behaved: for instance, a function $u \in \mathcal{C}^{\infty}({}^m\!M)$ compactly supported near a point in $({}^m\!\mathscr{I}^+)^{\circ}$, m > 0, so $u \in \mathcal{A}^{\emptyset,0,\emptyset}_{\mathrm{phg}}({}^m\!M)$, is not polyhomogeneous on ${}^0\!M$: it vanishes near $({}^0\!\mathscr{I}^+)^{\circ}$ and $({}^0i^+)^{\circ}$, but is non-trivial at the corner ${}^0\!\mathscr{I}^+ \cap {}^0i^+$.

2.4. Bundles and connections near null infinity. In the energy estimate (1.16) for the toy problem (1.15), derivatives of u along vector fields tangent to the fibers of $\beta \colon \mathscr{I}^+ \to S^+$ are better controlled than general b-derivatives. In this section, we introduce analytic structures on the blow-up M of \mathbb{R}^4 capturing this in an invariant manner.

Definition 2.6. For vector bundles $E_j \to \overline{\mathbb{R}^4}$, j = 1, 2, let

$$\mathcal{M}_{\beta^*E_1,\beta^*E_2} \subset \operatorname{Diff}^1_{\mathrm{b}}(M;\beta^*E_1,\beta^*E_2)$$

denote the $\mathcal{C}^{\infty}(M)$ -module of all first order b-differential operators A which satisfy the following condition near \mathscr{I}^+ : if $E_j \cong \mathcal{U} \times \mathbb{C}^{k_j}$, j=1,2, is a local trivialization of E_j , with $\mathcal{U} \subset \overline{\mathbb{R}^4}$ a neighborhood of S^+ , see (2.11), and we pull these trivializations back to $\beta^* E_j \cong \beta^{-1}(\mathcal{U}) \times \mathbb{C}^{k_j}$, then A = V + f, where V is a $k_2 \times k_1$ matrix of vector fields $V_{ij} \in \mathcal{V}_{\mathbf{b}}(M)$ which are tangent to the fibers of β , and $f \in \mathcal{C}^{\infty}(M)^{k_2 \times k_1}$. Let moreover

$${}^{0}\mathcal{M}_{\beta^*E_1,\beta^*E_2}\subset\mathcal{M}_{\beta^*E_1,\beta^*E_2}$$

denote the submodule for which $f|_{\mathscr{Q}^+} = 0$

For a single vector bundle $E \to \overline{\mathbb{R}^4}$, we write ${}^{(0)}\mathcal{M}_{\beta^*E} := {}^{(0)}\mathcal{M}_{\beta^*E,\beta^*E}$. Whenever the bundle E is clear from the context, we shall simply write ${}^{(0)}\mathcal{M} := {}^{(0)}\mathcal{M}_{\beta^*E}$. For $k \in \mathbb{N}$, we write $\mathcal{M}^k \subset \operatorname{Diff}_b^k$ for sums of k-fold products of elements of \mathcal{M} .

It is easy to check that the definition of $\mathcal{M}_{\beta^*E_1,\beta^*E_2}$ is independent of the choice of local trivializations; for ${}^0\mathcal{M}$, this is true as well, since vector fields tangent to the fibers of β annihilate the matrices for changes of frames of E_1 and E_2 which lift to be *constant* along the fibers of β . We make some elementary observations:

Lemma 2.7. We have:

- (1) $\rho_I \operatorname{Diff}_{\mathbf{b}}^1(M; \beta^* E) \subset {}^0 \mathcal{M}_{\beta^* E} \subset \mathcal{M}_{\beta^* E};$
- (2) if $A, B \in \mathcal{M}_{\beta^*E}$, and A has a scalar principal symbol, then $[A, B] \in \mathcal{M}_{\beta^*E}$. Strengthening the assumption to $A, B \in {}^{0}\mathcal{M}_{\beta^*E}$, we have $[A, B] \in {}^{0}\mathcal{M}_{\beta^*E}$;
- (3) there is a well-defined map

$$\mathcal{M}_{\mathbb{C}} \ni A \mapsto A \otimes \mathrm{Id} \in {}^{0}\mathcal{M}_{\beta^{*}E}/\rho_{I}\,\mathcal{C}^{\infty}(M;\mathrm{End}(\beta^{*}E)).$$

Proof. (1) and (2) are clear from the definition. The map in (3) is given in a local trivialization $E \cong \mathcal{U} \times \mathbb{C}^k$ of E near S^+ as $A \cdot \operatorname{Id}_{k \times k} \in \operatorname{Diff}^1_b(M)^{k \times k}$; the transition function between two different trivializations is given by $C \in \mathcal{C}^{\infty}(\mathcal{U}; \mathbb{C}^{k \times k})$, which pulls back to M to be constant along the fibers of β ; but then $C^{-1}(A \cdot \operatorname{Id}_{k \times k})C - (A \cdot \operatorname{Id}_{k \times k}) = C^{-1}A(C) \in \mathcal{C}^{\infty}(M; \mathbb{C}^{k \times k})$, with A acting component-wise, vanishes on \mathscr{I}^+ by definition of $\mathcal{M}_{\mathbb{C}}$. \square

In local coordinates $[0, \epsilon_0)_{\rho_0} \times [0, \epsilon_0)_{\rho_I} \times \mathbb{R}^2_{x^2x^3}$ near $i^0 \cap \mathscr{I}^+$ as in (1.14), with \mathbb{R}^2 a local coordinate patch on \mathbb{S}^2 , elements of $\mathcal{M}_{\mathbb{C}}$ are linear combinations of $\rho_0 \partial_{\rho_0}$, $\rho_I \partial_{\rho_I}$, and $\rho_I \partial_{x^a}$, a=2,3, plus smooth functions. We thus see that ${}^{(0)}\mathcal{M}_{\mathbb{C}}$ is generated over $\mathcal{C}^{\infty}(M)$ by $(\rho_I)\mathcal{C}^{\infty}(M)$ and lifts of elements $V \in \mathcal{V}_{\mathrm{b}}(\overline{\mathbb{R}^4})$ which vanish at S^+ as incomplete vector fields, i.e. $V|_{S^+} = 0 \in T_{S^+}\overline{\mathbb{R}^4}$. (This should be compared to the larger space $\mathcal{V}_{\mathrm{b}}(M)$, which is generated by lifts of elements $V \in \mathcal{V}_{\mathrm{b}}(\overline{\mathbb{R}^4})$ which are merely tangent to S_+ .) Note that by (2.26), we have

$$\rho^{-1}\partial_0, \ \rho_0^{-1}\rho_+^{-1}\partial_1 \in {}^0\mathcal{M}_{\underline{\mathbb{C}}};$$
 (2.39)

for a fixed choice of ρ , the operators $\rho^{-1}\partial_0$ and ∂_1 acting on sections of any bundle β^*E are therefore well-defined, modulo $\rho_I \mathcal{C}^{\infty}$ and $\rho_0 \rho_I \rho_+ \mathcal{C}^{\infty}$ valued in $\operatorname{End}(\beta^*E)$, respectively.

The modules defined above are closely related to a natural subbundle of ${}^{\rm b}T_{\mathscr{I}^+}M$:

Definition 2.8. Denote by

$${}^{\beta}T_{\mathscr{I}^+}M\subset {}^{\mathrm{b}}T_{\mathscr{I}^+}M$$

the rank 2 subbundle generated by all $V \in {}^{\mathrm{b}}T_{\mathscr{I}^+}M$ which are tangent to the fibers of β , see (2.12), and let ${}^{\beta}TM$ be any smooth rank 2 extension of ${}^{\beta}T_{\mathscr{I}^+}M$ to a neighborhood of \mathscr{I}^+ . Let then

$$({}^{\beta}TM)^{\perp} := \{ \alpha \in {}^{\mathbf{b}}T^{*}M \colon \alpha(V) = 0 \text{ for all } V \in {}^{\beta}TM \} \subset {}^{\mathbf{b}}T^{*}M$$

denote the annihilator of ${}^{\beta}TM$ in ${}^{\mathbf{b}}T^{*}M$.

Near $i^0 \cap \mathscr{I}^+$, we can for instance take ${}^{\beta}TM \subset {}^{b}TM$ to be the subbundle whose fibers are spanned by $\rho_I \partial_{\rho_I}$ and $\rho_0 \partial_{\rho_0}$.

Remark 2.9. Another equivalent characterization of \mathcal{M} is that the principal symbols of its elements vanish on $({}^{\beta}T_{\mathscr{I}^+}M)^{\perp}$. We also note that for $p \in \mathscr{I}^+$, there is a natural isomorphism

$$(^{\beta}TM)_p^{\perp} \cong T_{\beta(p)}^* S^+. \tag{2.40}$$

Indeed, given $V \in {}^{\mathrm{b}}T_{p}M$, note that $\beta_{*}V \in {}^{\mathrm{b}}T_{S^{+}}\overline{\mathbb{R}^{4}}$ is tangent to S^{+} , hence has a well-defined image in $T_{p}S^{+}$; and $V \in {}^{\beta}T_{p}M$ is precisely the condition that this image be 0. Thus, the isomorphism (2.40) is obtained by mapping $\eta \in T_{\beta(p)}^{*}S^{+}$ to ${}^{\mathrm{b}}T_{p}M \ni V \mapsto \eta(\beta_{*}V)$.

Using this subbundle, we have

$$\mathcal{M}_{\mathbb{C}} = \mathcal{C}^{\infty}(M; {}^{\beta}TM + \rho_I{}^{\mathbf{b}}TM) + \mathcal{C}^{\infty}(M) \subset \mathrm{Diff}^1_{\mathbf{b}}(M),$$

where we write

$$\mathcal{C}^{\infty}(M; {}^{\beta}TM + \rho_I{}^{\mathbf{b}}TM) := \mathcal{C}^{\infty}(M; {}^{\beta}TM) + \rho_I \mathcal{C}^{\infty}(M; {}^{\mathbf{b}}TM). \tag{2.41}$$

Note here that the sum of the first two spaces on the right is globally well-defined on M even though we only defined ${}^{\beta}TM$ in a neighborhood of \mathscr{I}^+ : this is due to ${}^{\beta}TM \subset {}^{b}TM$. The general modules $\mathcal{M}_{\beta^*E_1,\beta^*E_2}$ have a completely analogous description obtained by tensoring the bundles with $\operatorname{Hom}(\beta^*E_1,\beta^*E_2)$.

We next prove some lemmas allowing us to phrase energy estimates for bundle-valued waves invariantly.

Lemma 2.10. Let $E \to \overline{\mathbb{R}^4}$ be a vector bundle, and let $d^E \in \mathrm{Diff}^1(\overline{\mathbb{R}^4}; E, T^*\overline{\mathbb{R}^4} \otimes E)$ be a connection. Then d^E induces a b-connection, i.e. a differential operator

$$d^{E} \in \text{Diff}_{b}^{1}(M; \beta^{*}E, {}^{b}T^{*}M \otimes \beta^{*}E), \tag{2.42}$$

on $\beta^*E \to M$. If \tilde{d}^E is another connection on E, then, with notation analogous to (2.41),

$$d^{E} - \tilde{d}^{E} \in \mathcal{C}^{\infty}(M; ((^{\beta}TM)^{\perp} + \rho_{I}{}^{b}T^{*}M) \otimes \operatorname{End}(\beta^{*}E)). \tag{2.43}$$

Proof. Fix a local frame e^i of E, then for $u_i \in \dot{\mathcal{C}}^{\infty}(M) \subset \dot{\mathcal{C}}^{\infty}(\overline{\mathbb{R}^4})$, we have

$$d^E(u_i e^i) = du_i \otimes e^i + u_i d^E e^i.$$

Now the map $u_i \mapsto du_i$ extends to M as the map $u_i \mapsto {}^{\mathrm{b}}du_i$, with ${}^{\mathrm{b}}d \in \mathrm{Diff}^1_{\mathrm{b}}(M;\underline{\mathbb{C}},{}^{\mathrm{b}}T^*M)$; and $f^i := d^E e^i \in \mathcal{C}^{\infty}(\overline{\mathbb{R}^4};T^*\overline{\mathbb{R}^4}\otimes E)$ canonically induces $\beta^* f^i \in \mathcal{C}^{\infty}(M;{}^{\mathrm{b}}T^*M\otimes \beta^*E)$ by $\beta^* f^i(V) = f^i(\beta_*V), \ V \in {}^{\mathrm{b}}TM$. Therefore, the expression $d^E(u_i \cdot \beta^* e^i) = {}^{\mathrm{b}}du_i \otimes \beta^* e^i + u_i \cdot \beta^* f^i$ proves (2.42).

Letting $\tilde{f}^i := \tilde{d}^E e^i$, we have $(d^E - \tilde{d}^E)(u_i \cdot \beta^* e^i) = u_i \cdot (\beta^* f^i - \beta^* \tilde{f}^i)$. But ${}^{\beta}T_{\mathscr{I}^+}M \subset \ker \beta_*$, so the bundle map $d^E - \tilde{d}^E$ annihilates ${}^{\beta}TM$ at \mathscr{I}^+ , giving (2.43).

Lemma 2.11. In the notation of Lemma 2.10, suppose E is equipped with a fiber metric $\langle \cdot, \cdot \rangle_E$, and let

$$K \in \mathcal{C}^{\infty}(M; (S^{2\beta}TM + \rho_I S^{2b}TM) \otimes \operatorname{End}(\beta^*E)).$$
(2.44)

Moreover, let $B \in \mathcal{C}^{\infty}(M; \operatorname{Hom}({}^{\mathrm{b}}TM, {}^{\mathrm{b}}T^*M))$ denote a fiber metric on ${}^{\mathrm{b}}TM$. Then, acting on sections of β^*E , we have

$$(d^{E})^{*}BKd^{E} - (\tilde{d}^{E})^{*}BK\tilde{d}^{E} \in \rho_{I} \operatorname{Diff}_{b}^{1}(M; \beta^{*}E), \tag{2.45}$$

where we take adjoints with respect to the fiber metrics on ${}^{\mathrm{b}}TM$ and E, and any fixed b-density on M. Moreover, if $(d^E)^{\dagger}$ denotes the adjoint with respect to another fiber metric on E, then $(d^E)^{\dagger}BKd^E - (d^E)^*BKd^E \in \rho_I \mathrm{Diff}^1_\mathrm{b}(M;\beta^*E)$.

Note that for K as in (2.44) with both the $S^{2}{}^{\beta}TM$ and the $S^{2}{}^{b}TM$ summands positive definite, and adding weights, the pairing $\langle (d^{E})^{*}BKd^{E}u,u\rangle$ provides the control on fiber-tangential derivatives of u as in the toy model (1.16), but is weaker by $\rho_{I}^{1/2}$ for general b-derivatives; we will take care of this in Definition 4.1. The space in (2.45) will be weak enough to be treated as an error term (similar to the Diff_b spaces arising as error terms in Lemma 3.8 below).

Proof of Lemma 2.11. We write the left hand side of (2.45) as

$$(d^{E})^{*}BK(d^{E}-\tilde{d}^{E})+(d^{E}-\tilde{d}^{E})^{*}BK\tilde{d}^{E},$$

with one summand being the adjoint of the other. Now, $(d^E)^*B \in \text{Diff}_b^1(M; {}^bTM \otimes \beta^*E, \beta^*E)$, while Lemma 2.10 implies

$$K(d^E - \tilde{d}^E) \in \rho_I \mathcal{C}^{\infty}(M; {}^{\mathrm{b}}TM \otimes \mathrm{End}(\beta^*E)).$$

This proves (2.45). (Alternatively, one can analyze the second summand directly, using that over $p \in M$, $\langle (d^E - \tilde{d}^E)^*(B(V) \otimes e), e' \rangle_E = \langle e, (d^E - \tilde{d}^E)(V \otimes e') \rangle_E$ for $V \in {}^bT_pM$, $e, e' \in E_{\beta(p)}$.) For the second part, note that the two adjoints are related via $(d^E)^{\dagger} = C^{-1}(d^E)^*C$ for some $C \in \mathcal{C}^{\infty}(\overline{\mathbb{R}^4}; \operatorname{End}(E))$, hence $\tilde{d}^E := (d^E)^{\dagger *} = d^E + C^*[d^E, (C^{-1})^*]$ is a connection on E, and therefore

$$((d^E)^{\dagger} - (d^E)^*)BKd^E = (\tilde{d}^E - d^E)^*BKd^E \in \rho_I \text{Diff}_b^1(M; \beta^*E)$$

by what we already proved.

Lemma 2.12. Equip $E \to \overline{\mathbb{R}^4}$ with a fiber metric and fix a b-density on $\overline{\mathbb{R}^4}$. Then for principally scalar $W \in {}^0\mathcal{M}_{\beta^*E}$, with principal symbol equal to that of the real vector field $W_1 \in \mathcal{V}_{\mathbf{b}}(M)$, we have $W + W^* \in -\operatorname{div} W_1 + \rho_I \mathcal{C}^{\infty}(M; \operatorname{End}(\beta^*E))$.

Proof. In a local trivialization on E, we have $W = W_1 \otimes 1 + W_0$, $W_0 \in \rho_I C^{\infty}(M; \operatorname{End}(\beta^* E))$, while the fiber inner product k on E is related to the standard Euclidean fiber inner product \underline{k} in the trivialization by $k(e, e') = \underline{k}(\widetilde{C}e, \widetilde{C}e')$ for some \widetilde{C} smooth on $\overline{\mathbb{R}^4}$, hence fiber constant on M. Denoting adjoints with respect to \underline{k} by \dagger , and letting $C := \widetilde{C}^*\widetilde{C}$, we thus have

$$W + W^* = (W_1 \otimes 1 + C^{-1}(W_1^{\dagger} \otimes 1)C) + (W_0 + W_0^*)$$

$$\in -(\operatorname{div} W_1) \otimes 1 + C^{-1}[W_1^{\dagger} \otimes 1, C] + \rho_I C^{\infty},$$

with the second term also lying in $\rho_I \mathcal{C}^{\infty}$ since C is fiber-constant.

3. Gauged Einstein equation

As motivated in §1.2, we work in the wave map gauge with respect to the background metric g_m constructed in §2.1, since we expect the solution g of the initial value problem (1.4) for the Einstein vacuum equation with initial data asymptotic to mass m Schwarzschild to be well-behaved on the space mM. The gauge condition reads

$$\Upsilon(g; g_m)_{\mu} := (gg_m^{-1}\delta_g G_g g_m)_{\mu} = g_{\mu\nu}g^{\kappa\lambda}(\Gamma(g)_{\kappa\lambda}^{\nu} - \Gamma(g_m)_{\kappa\lambda}^{\nu}) = 0, \tag{3.1}$$

where we recall the notation $G_g = 1 - \frac{1}{2}g \operatorname{tr}_g$, and $(\delta_g u)_{\mu} = -u_{\mu\nu;}^{\nu}$. For brevity, we shall write

$$\Upsilon(g) \equiv \Upsilon(g; g_m),$$

when the background metric g_m is clear from the context. A simple calculation shows that if $h \in H_b^{\infty; -\epsilon, -\epsilon, -\epsilon}({}^mM)$, $\epsilon > 0$ small, is a metric perturbation, and $g = g_m + \rho h$, then the gauge condition $\Upsilon(g; g_m) = 0$ implies that the ∂_1 -derivatives of the good components h_{00} , $h_{0\bar{b}}$, and $th h := \not g^{ab}h_{\bar{a}\bar{b}}$ decay towards \mathscr{I}^+ . (See equation (A.5) for this calculation for h with special structure.) A key ingredient of our iteration scheme is therefore constraint damping, which ensures that the gauge condition, or, more directly, the improved decay of the good components at \mathscr{I}^+ , is satisfied to leading order for each iterate h. We implement constraint damping by considering the gauged Einstein equation

$$P(h) := \rho^{-3} P_0(g_m + \rho h), \quad P_0(g) := \text{Ric}(g) - \widetilde{\delta}^* \Upsilon(g; g_m),$$
 (3.2)

where on 1-forms u

$$\widetilde{\delta}^* u = \delta_{g_m}^* u - 2\gamma_1 \frac{d\rho_t}{\rho_t} \otimes_s u + \gamma_2 (\iota_{\rho_t^{-1} \nabla^{g_m} \rho_t} u) g_m$$
(3.3)

is a modification of the symmetric gradient $\delta_{g_m}^*$ by a 0-th order term; here ρ_t is fixed according to Definition 2.3. We discuss the effect of this modification in §3.3, see in particular (3.25a). From now on, the mass parameter m will be fixed and dropped from the notation whenever convenient.

3.1. Form of metric perturbations. One can easily establish the existence of a solution of (1.4) near $i^0 \setminus (i^0 \cap \mathscr{I}^+)$ for normalized initial data (see Theorem 1.7) which lie merely in $\rho_0^{1/2+0}H_{\rm b}^{\infty}$; this is due to non-linear interactions being weak at i^0 , which in turn can ultimately be traced back to the null derivatives (2.26) coming with extra factors of ρ_0 . However, we will use (and prove) the existence of leading terms of the perturbation h of $g = g_m + \rho h$ at \mathscr{I}^+ ; as discussed around (1.15), this requires the initial data to be decaying to mass m Schwarzschild data. At i^+ however, weak control, i.e. $h \in \rho_+^{-1/2+0}H_{\rm b}^{\infty}$ away from \mathscr{I}^+ , suffices due to the non-linear interactions being as weak there as they are at i^0 . (The decay of our initial data does imply the existence of a leading term at i^+ , see §7.) Motivated by this and the discussion of constraint damping above, and recalling the notation (2.27) and the bundle splittings (2.17) and (2.19), we will seek the solution h of P(h) = 0 in the function space $\mathscr{X}^{k;b_0,b_I,b_I',b_+}$:

Definition 3.1. Let $k \in \mathbb{N}_0 \cup \{\infty\}$, and fix weights²²

$$-\frac{1}{2} < b_{+} < 0 < b_{I} < b'_{I} < \min(\frac{1}{2}, b_{0});$$

let further $\chi \in \mathcal{C}^{\infty}(M)$ be identically 1 near \mathscr{I}^+ , with support in a small neighborhood of \mathscr{I}^+ where the bundle splitting (2.17) is defined; different choices of χ will produce the same function space, as we shall discuss below. The space $\mathcal{X}^{k;b_0,b_I,b_I',b_+}$ consists of all $h \in H_{\mathrm{b}}^{k;b_0,-1,b_+}(M;\beta^*S^2 \operatorname{sc} T^*\overline{\mathbb{R}^4})$ such that

$$\chi h_{00}, \ \chi \not\vdash h \in H_{\mathrm{b}}^{k;b_{0},b'_{I},b_{+}}(\underline{\mathbb{C}}), \ \chi h_{0\bar{b}} \in H_{\mathrm{b}}^{k;b_{0},b'_{I},b_{+}}(\beta^{*}(r \, T^{*}\mathbb{S}^{2})), \tag{3.4}$$

 $^{^{21}}$ This is related to the solvability of semilinear equations with initial data or forcing terms which are mildly growing at spatial infinity, see [HiVa15, Theorem 5.14], where one can take the weight l < -1/2 in certain circumstances. This is also the level of decay for which Bieri [BiZi09] establishes the *global* stability of Minkowski space.

²²The imposed upper bound of $\frac{1}{2}$ for b_I and b_I' simplifies the arithmetic in §4 but is otherwise artificial; the natural bound is $b_I < b_I' < \min(1, b_0)$, with the upper bound 1 arising from the expected presence of lower order terms in expansion of the metric at \mathscr{I}^+ as well as from the requirement that the function space be independent of the choice of collar neighborhood of \mathscr{I}^+ .

$$\chi h_{11} = \chi h_{11}^{(1)} \log \rho_I + \chi h_{11}^{(0)} + h_{11,b}, \tag{3.5}$$

$$\chi(h_{01}, h_{1\bar{b}}, h_{\bar{a}\bar{b}}) = \chi(h_{01}^{(0)}, h_{1\bar{b}}^{(0)}, h_{\bar{a}\bar{b}}^{(0)}) + (h_{01,b}, h_{1\bar{b},b}, h_{\bar{a}\bar{b},b}), \tag{3.6}$$

where the leading and remainder terms are

$$\begin{aligned} h_{11}^{(\ell)}, \ h_{01}^{(0)}, \ h_{1\bar{b}}^{(0)}, \ h_{\bar{a}\bar{b}}^{(0)} \in \rho_0^{b_0} \rho_+^{b_+} H_{\mathrm{b}}^k(\mathscr{I}^+), \\ h_{01,\mathrm{b}}, \ h_{11,\mathrm{b}}, \ h_{1\bar{b},\mathrm{b}}, \ h_{\bar{a}\bar{b},\mathrm{b}} \in H_{\mathrm{b}}^{k;b_0,b_I,b_+}, \end{aligned}$$

the latter supported on supp χ and valued in the bundles \mathbb{C} (for $\ell=0,1$), \mathbb{C} , $\beta^*(rT^*\mathbb{S}^2)$, and $\beta^*(r^2S^2T^*\mathbb{S}^2)$, respectively; we describe the topology on $\mathcal{X}^{k;b_0,b_I,b_I',b_+}$ below. Here, we use a collar neighborhood to extend functions from \mathscr{I}^+ to a neighborhood of \mathscr{I}^+ in M, and to extend the relevant bundles from \mathscr{I}^+ to smooth subbundles of $\beta^*S^2 {}^{\text{sc}}T^*\overline{\mathbb{R}^4}$ near \mathscr{I}^+ ; all choices of collar neighborhoods and extensions give the same function space. We shall suppress the parameters b_0, b_I, b_I', b_+ from the notation when they are clear from the context, so

$$\mathcal{X}^k := \mathcal{X}^{k;b_0,b_I,b_I',b_+}.$$

Remark 3.2. The partial expansions amount to a statement of partial polyhomogeneity: for example, the condition on h_{01} in (3.6) for $k = \infty$ can be phrased as $h_{01} \in \mathcal{A}_{b,phg,b}^{b_0,0,b_+} + H_b^{\infty;b_0,b_I,b_+}$, and similarly for $k < \infty$ if one replaces the first summand by a function space capturing the finite regularity of the leading term at \mathscr{I}^+ . In view of the existence of at most logarithmically growing leading terms of $h \in \mathcal{X}^k$ at \mathscr{I}^+ , we automatically have $h \in H_b^{k;b_0,-0,b_+}$.

Thus, $h \in \mathcal{X}^k$ decays at i^0 , while (3.4) encodes the vanishing of the good components at \mathscr{I}^+ ; (3.5) and (3.6) assert the existence of leading terms of the remaining components, in the case of h_{11} allowing for a logarithmic term; ²³ at i^+ finally, h is allowed to have mild growth. The existence of leading terms of $h \in \mathcal{X}^{k;b_0,b_I,b_I',b_+}$ at \mathscr{I}^+ implies in particular that

$$\rho_{I}\partial_{\rho_{I}}h_{\bar{\mu}\bar{\nu}} \in H_{\mathbf{b}}^{k-1;b_{0},b_{I},b_{+}}, \quad (\bar{\mu},\bar{\nu}) = (0,1), (1,\bar{b}), (\bar{a},\bar{b}),
\rho_{I}\partial_{\rho_{I}}h_{11} \in h_{11}^{(1)} + H_{\mathbf{b}}^{k-1;b_{0},b_{I},b_{+}}, \quad (\rho_{I}\partial_{\rho_{I}})^{2}h_{11} \in H_{\mathbf{b}}^{k-2;b_{0},b_{I},b_{+}},$$
(3.7)

which we will frequently use without further explanation.

For $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$, we describe P(h) using a closely related function space:

Definition 3.3. For $k \in \mathbb{N}_0 \cup \{\infty\}$ and weights b_0, b_I, b'_I, b_+ as above, the function space $\mathcal{Y}^{k;b_0,b_I,b'_I,b_+}$ consists of all $f \in H_{\mathrm{b}}^{k;b_0,-2,b_+}(M;\beta^*S^2 {}^{\mathrm{sc}}T^*\overline{\mathbb{R}^4})$ so that near \mathscr{I}^+ ,

$$f_{00}, f_{0\bar{b}}, \forall f \in H_{\mathbf{b}}^{k;b_0,-1+b'_I,b_+}, f_{01}, f_{1\bar{b}}, f_{\bar{a}\bar{b}} \in H_{\mathbf{b}}^{k;b_0,-1+b_I,b_+},$$

$$f_{11} = f_{11}^{(0)} + f_{11,\mathbf{b}}, f_{11}^{(0)} \in \rho_0^{b_0} \rho_+^{b_+} H_{\mathbf{b}}^{k}(\mathscr{I}^+), f_{11,\mathbf{b}} \in H_{\mathbf{b}}^{k;b_0,-1+b_I,b_+}.$$

$$(3.8)$$

The shift by -1 in the decay order at \mathscr{I}^+ is due to the linearized gauged Einstein equation, or even the linear scalar wave equation, being ρ_I^{-1} times a b-differential operator at \mathscr{I}^+ , cf. (1.15). A calculation will show that $P(h) \in \mathcal{Y}^{\infty;b_0,b_I,b_I',b_+}$, see Lemma 3.5 for

 $^{^{23}}$ The slightly faster decay b'_I of the good components as compared to the decay b_I of the remainder terms of the other components is needed to handle the logarithmically large size of the coefficients coupling good components into the others, encoded in the (4,1) entries of A_h and B_h in Lemma 3.8; see the discussion following (3.25c).

a more precise statement. Note here that P(h) is well-defined in a neighborhood of ∂M due to the decay (in L^{∞}) of $g = g_m + \rho h$ to g_m ; in order for P(h) to be defined globally, we need to assume ρh to be small in L^{∞} , or h to be small in \mathcal{X}^3 (using the norm defined momentarily) by Sobolev embedding.

Fixing a smooth cutoff χ as in Definition 3.1, we can define a norm on $\mathcal{Y}^{k;b_0,b'_I,b_I,b_+}$ using the notation of Definition 3.3 by setting

$$\begin{split} \|f\|_{\mathcal{Y}^{k;b_0,b_I',b_I,b_+}} &:= \|(\chi f_{00},\ \chi f_{0\bar{b}},\ \chi \not\vdash f)\|_{H^{k;b_0,-1+b_I',b_+}_b} + \|(\chi f_{01},\ \chi f_{1\bar{b}},\ \chi f_{\bar{a}\bar{b}})\|_{H^{k;b_0,-1+b_I,b_+}_b} \\ &+ \|\chi f_{11}^{(0)}\|_{\rho_0^{b_0}\rho_+^{b_+}H^k_b(\mathscr{I}^+)} + \|\chi (f_{11} - f_{11}^{(0)})\|_{H^{k;b_0,-1+b_I,b_+}_b} + \|f\|_{H^{k;b_0,-2,b_+}_b}, \end{split}$$

where the choice of ρ_I -weight in the remainder term is arbitrary (as long as it is fixed and less than -1). Equipped with this norm, $\mathcal{Y}^{k;b_0,b_I,b'_I,b_+}$ is a Banach space. A completely analogous definition gives a norm $\|\cdot\|_{\mathcal{X}^{k;b_0,b_I,b'_I,b_+}}$. The spaces $\mathcal{X}^{\infty;b_0,b_I,b'_I,b_+}$ and $\mathcal{Y}^{\infty;b_0,b_I,b'_I,b_+}$, equipped with the projective limit topologies, are Fréchet spaces.

It will occasionally be useful to write

$$\mathcal{X}^k = \mathcal{X}_{\text{phg}}^k \oplus \mathcal{X}_{\text{b}}^k, \quad \mathcal{Y}^k = \mathcal{Y}_{\text{phg}}^k \oplus \mathcal{Y}_{\text{b}}^k, \tag{3.9}$$

where $\mathcal{Y}_{\mathrm{phg}}^{k} = \{\chi f_{11}^{(0)} : f_{11}^{(0)} \in \rho_{0}^{b_{0}} \rho_{+}^{b_{+}} H_{\mathrm{b}}^{k}(\mathscr{I}^{+})\}$ encodes the leading term of elements of \mathcal{Y}^{k} , while $\mathcal{Y}_{\mathrm{b}}^{k} = \{f \in \mathcal{Y}^{k} : f_{11}^{(0)} = 0\}$ captures the remainder terms (i.e. with vanishing leading terms at \mathscr{I}^{+}); the spaces $\mathcal{X}_{\mathrm{phg}}^{k}$ and $\mathcal{X}_{\mathrm{b}}^{k}$ are defined analogously.

In order to exhibit the 'null structure,' or upper triangular block structure, of the linearized gauged Einstein operator D_hP for $h \in \mathcal{X}$ at \mathscr{I}^+ in a compact fashion, we introduce:

Definition 3.4. Define the subbundles

$$K^c_{11} := \langle 2 \operatorname{ds} \operatorname{dq} \rangle \oplus (2 \operatorname{ds} \otimes r \operatorname{T}^* \mathbb{S}^2) \oplus \langle r^2 \mathbf{g} \rangle^\perp, \quad K^c_0 := K^c_{11} \oplus \langle \operatorname{ds}^2 \rangle,$$

of $S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4}|_{S^+}$, which we extend in a smooth but otherwise arbitrary fashion to a neighborhood of S^+ as rank 5, resp. 6, subbundles of $S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4}$, still denoted by K_{11}^c and K_0^c . Let K_{11} and K_0 be any subbundles of $S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4}$, defined near S^+ , such that

$$K_0^c \oplus K_0 = S^2 {}^{\text{sc}} T^* \overline{\mathbb{R}^4}, \quad K_{11}^c \oplus K_{11} = K_0^c.$$

For example, we can take

$$K_0 = \langle dq^2 \rangle \oplus \langle 2dq \otimes r \, T^* \mathbb{S}^2 \rangle \oplus \langle r^2 \not g \rangle \tag{3.10}$$

and $K_{11} = \langle ds^2 \rangle$, but the particular choices are irrelevant. Denote by

$$\pi_0 \colon S^{2 \text{ sc}} T^* \overline{\mathbb{R}^4} \to S^{2 \text{ sc}} T^* \overline{\mathbb{R}^4} / K_0^c \cong K_0,
\tilde{\pi}_{11} \colon K_0^c \to K_0^c / K_{11}^c \cong K_{11}$$
(3.11)

the projections onto the quotient bundles,

$$\pi_0^c := 1 - \pi_0 \colon S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4} \to K_0^c,$$

and

$$\pi_{11} := \tilde{\pi}_{11} \pi_0^c \colon S^2 {}^{\text{sc}} T^* \overline{\mathbb{R}^4} \to K_{11}, \quad \pi_{11}^c := (1 - \tilde{\pi}_{11}) \pi_0^c \colon S^2 {}^{\text{sc}} T^* \overline{\mathbb{R}^4} \to K_{11}^c. \tag{3.12}$$

Writing

$$\beta^* S^2 \equiv \beta^* S^{2 \text{ sc}} T^* \overline{\mathbb{R}^4} \tag{3.13}$$

from now on, the improved decay (3.4) of the good components of $h \in \mathcal{X}^{k;b_0,b_I,b_I',b_+}$ can then be expressed as $\pi_0 h \in H_{\mathrm{b}}^{k;b_0,b_I',b_+}(\beta^*K_0)$, similarly for (3.8). The refinement $K_{11}^c \subset K_0^c$ will be used to encode part of the 'null structure' of the linearized gauged Einstein equation at \mathscr{I}^+ , as discussed in §5.

Consider now a fixed $h \in \mathcal{X}^{\infty}$ which is small in \mathcal{X}^3 so that $g := g_m + \rho h$ is a Lorentzian metric on \mathbb{R}^4 . Working near \mathscr{I}^+ , we recall $g_m = (1 - \frac{2m}{r})dq\,ds - r^2 \not g$ and the barred index notation (2.18), so with $\rho = r^{-1}$, the coefficients of g in the product splitting (2.21) are

$$g_{00} = r^{-1}h_{00}, \quad g_{01} = \frac{1}{2} + r^{-1}(h_{01} - m), \quad g_{0b} = h_{0\bar{b}}, g_{11} = r^{-1}h_{11}, \quad g_{1b} = h_{1\bar{b}}, \qquad g_{ab} = -r^2 g_{ab} + rh_{\bar{a}\bar{b}};$$
(3.14)

the coefficients $g^{\mu\nu}$ of the inverse metric $g^{-1} = g_m^{-1} - r^{-1}g_m^{-1}hg_m^{-1} + r^{-2}g_m^{-1}hg_m^{-1} + H_h^{\infty;3+3b_0,3-0,3+3b_+}$ are

$$g^{00} \in -4r^{-1}h_{11} + H_{\mathbf{b}}^{\infty;2+b_{0},2-0,2+2b_{+}}, \quad g^{01} \in 2 + 4r^{-1}(m - h_{01}) + H_{\mathbf{b}}^{\infty;2-0,2-0,2+2b_{+}},$$

$$g^{0b} \in 2r^{-2}h_{1}^{\bar{b}} + H_{\mathbf{b}}^{\infty;3+b_{0},3-0,3+2b_{+}}, \quad g^{11} \in -4r^{-1}h_{00} + H_{\mathbf{b}}^{\infty;2+b_{0},2+b'_{I},2+2b_{+}},$$

$$g^{1b} \in 2r^{-2}h_{0}^{\bar{b}} + H_{\mathbf{b}}^{\infty;3+b_{0},3+b'_{I},3+2b_{+}}, \quad g^{ab} \in -r^{-2} \not p^{ab} - r^{-3}h^{\bar{a}\bar{b}} + H_{\mathbf{b}}^{\infty;4+2b_{0},4-0,4+2b_{+}},$$

$$(3.15)$$

where we raise spherical indices using the round metric g, i.e. $h_0^{\bar{a}} = g^{ab} h_{0\bar{b}}$ etc. Thus,

$$g_{\bar{\mu}\bar{\nu}}, \ g^{\bar{\mu}\bar{\nu}} \in \mathcal{C}^{\infty} + H_{\mathrm{b}}^{\infty;1+b_0,1-0,1+b_+}; \ g^{\bar{a}\bar{b}} + \not g^{ab}, \ g^{01} - 2 \in \rho \, \mathcal{C}^{\infty} + H_{\mathrm{b}}^{\infty;1+b_0,1-0,1+b_+}.$$
 (3.16)

The calculation of the connection coefficients, components of Riemann and Ricci curvature, and other geometric quantities associated with the metric g is then straightforward; the results of these calculations are given in Appendix A.

3.2. Leading terms of the gauged Einstein equation. Let $h \in \mathcal{X}^{\infty} = \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$. In order to compute the leading terms of the gauged Einstein operator $P(h) = \rho^{-3}P_0(g)$, $g = g_m + \rho h$, see (3.2), we first use the form (A.2) of $2(\tilde{\delta}^* - \delta_{g_m^S}^*)$ and the observation, from (A.5), that $\Upsilon(g) \in H_b^{\infty;2+b_0,1+b_I',2+b_+}$, to deduce that

$$2(\widetilde{\delta}^* - \delta_{g_m}^*)\Upsilon(g) \in H_{\mathbf{b}}^{\infty;3+b_0,2+b_I',3+b_+}.$$

The decay rate at i^+ holds globally there—not only near $i^+ \cap \mathscr{I}^+$ where $g_m = g_m^S$. To see this, it suffices to show that $\Upsilon(g) \in \rho_+^{2+b_+} H_{\rm b}^{\infty}$ near $(i^+)^{\circ}$. But this follows from the fact that there g differs from the smooth scattering metric g_m by an element of $\rho_+^{1+b_+} H_{\rm b}^{\infty}$ (with values in $S^{2 \text{ sc}} T^* \overline{\mathbb{R}^4}$). Concretely, choosing local coordinates y^1, y^2, y^3 in $\partial \overline{\mathbb{R}^4}$, near any point $p \in (i^+)^{\circ}$, we can introduce coordinates $z^0 := \rho_+^{-1}, z^a = \rho_+^{-1} y^a$ (a = 1, 2, 3), in a neighborhood of p intersected with $\rho > 0$, and $\{\partial_{z^{\mu}} : \mu = 0, \dots, 3\}$ is a frame of $\overline{\mathbb{R}^4}$ there; but then, using $\partial_{z^{\mu}} \in \rho_+ \mathcal{V}_{\rm b}(\overline{\mathbb{R}^4})$, one sees that $\Gamma(g_m + \rho h)_{\kappa\lambda}^{\nu} - \Gamma(g_m)_{\kappa\lambda}^{\nu}$ is a sum of terms of the form

$$((g_m + \rho h)^{\mu\nu} - (g_m)^{\mu\nu})\partial_{z^{\kappa}}(g_m)_{\lambda\sigma} \in \rho_+^{1+b_+} H_{\mathrm{b}}^{\infty} \cdot \rho_+ \mathcal{C}^{\infty}(\overline{\mathbb{R}^4}) \subset \rho_+^{2+b_+} H_{\mathrm{b}}^{\infty} \quad (\text{near } p),$$

and $(g_m + \rho h)^{\mu\nu} \partial_{z^{\kappa}}(\rho h_{\lambda\sigma})$, which likewise lies in $\rho_+^{2+b_+} H_b^{\infty}$ near p. (The Christoffel symbols themselves satisfy $\Gamma(g_m)_{\kappa\lambda}^{\nu} \in \rho^+ \mathcal{C}^{\infty}(\overline{\mathbb{R}^4})$, $\Gamma(g_m + \rho h)_{\kappa\lambda}^{\nu} \in \rho_+ \mathcal{C}^{\infty}(\overline{\mathbb{R}^4}) + \rho_+^{2+b_+} H_b^{\infty}$.)

Using the calculations (near $i^0 \cup \mathscr{I}^+$) of $\delta_{g_m}^* \Upsilon(g)$ in (A.6) and of Ric(g) in (A.8), we obtain:

Lemma 3.5. For $h \in \mathcal{X}^{\infty}$, we have $P(h) \in \mathcal{Y}^{\infty}$ near ∂M , and globally provided $||h||_{\mathcal{X}^3}$ is small. More precisely, we have $P(h)_{\bar{a}\bar{b}} \in H_b^{\infty;b_0,-1+b_I',b_+}$ and

$$P(h)_{11} \in -2\rho^{-2}\partial_1\partial_0 h_{11} - \frac{1}{4}\rho^{-1}\partial_1 h^{\bar{d}\bar{e}}\partial_1 h_{\bar{d}\bar{e}} + H_b^{\infty;b_0,-1+b_I,b_+}$$
(3.17)

when $\rho = r^{-1}$ near \mathscr{I}^+ .

Proof. It remains to justify the decay rate at i^+ . We use local coordinates near $p \in (i^+)^\circ$ as above: firstly, the membership of $\delta_{g_m}^* \Upsilon(g)$ follows directly from the above arguments. Secondly, the difference of curvature components $R(g_m + \rho h)^\mu_{\nu\kappa\lambda} - R(g_m)^\mu_{\nu\kappa\lambda}$ is a sum of terms of the schematic forms $\partial_\mu (\Gamma(g_m + \rho h)^\kappa_{\nu\lambda} - \Gamma(g_m)^\kappa_{\nu\lambda})$ and $(\Gamma(g_m + \rho h)^\kappa_{\mu\nu} - \Gamma(g_m)^\kappa_{\mu\nu})\Gamma(g_m + \rho h)^\nu_{\kappa\lambda}$, both of which lie in $\rho_+^{3+b+}H_b^\infty$ by the calculations above. But by construction, see in particular the discussion around (2.9), g_m differs from the flat Minkowski metric (expressed in a non-standard coordinate system on \mathbb{R}^4 due to the logarithmic term in v) by a smooth symmetric scattering 2-tensor of class $\rho_+\mathcal{C}^\infty(\overline{\mathbb{R}^4})$, which implies that $R(g_m)^\mu_{\nu\kappa\lambda} \in \rho_+^3\mathcal{C}^\infty(\overline{\mathbb{R}^4})$ near p. Therefore, the Riemann curvature tensor satisfies

$$R(g_m + \rho h) \in \rho_+^{3+b_+} H_b^{\infty}$$
 (3.18)

as a section of ${}^{\text{sc}}T\overline{\mathbb{R}^4}\otimes({}^{\text{sc}}T^*\overline{\mathbb{R}^4})^{\otimes 3}$ near $(i^+)^\circ$, which a forteriori gives $\operatorname{Ric}(g)\in\rho_+^{3+b_+}H_{\mathrm{b}}^{\infty}$, as desired. (The vanishing of P(h) modulo the faster decaying space $\rho_0^{b_0}H_{\mathrm{b}}^{\infty}$ near $(i^0)^\circ$ requires more structure of g_m , namely the Ricci flatness of the background metric g_m .) \square

Note that one component of P(h) has a non-trivial leading term at \mathscr{I}^+ ; in order for this to not create logarithmically growing terms in components (other than the (1,1) component) of the next iterate of our Newton-type iteration scheme (which would cause the iteration scheme to not close), one needs to exploit the special structure of the operator $D_h P$. See also the discussion around (1.23).

3.3. Leading order structure of the linearized gauged Einstein operator. For $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ small, write

$$L_h := D_h P, \tag{3.19}$$

and let $g = g_m + \rho h$. We shall now calculate the structure of L_h 'at infinity,' that is, its leading order terms at i^0 , \mathscr{I}^+ , and i^+ : at \mathscr{I}^+ , we will find that the equation $L_h u = f$ can be partially decoupled to leading order; this is the key structure for proving global existence for the non-linear problem later. Recall from [GrLe91] that

$$D_g \operatorname{Ric} = \frac{1}{2} \Box_g - \delta_g^* \delta_g G_g + \mathscr{R}_g,$$

$$\mathscr{R}_g(u)_{\mu\nu} = (R_g)^{\kappa}{}_{\mu\nu\lambda} u_{\kappa}{}^{\lambda} + \frac{1}{2} (\operatorname{Ric}(g)_{\mu}{}^{\lambda} u_{\lambda\nu} + \operatorname{Ric}(g)_{\nu}{}^{\lambda} u_{\lambda\mu}),$$

$$D_g \Upsilon(g) u = -\delta_g G_g u - \mathscr{C}_g(u) + \mathscr{Y}_g(u),$$
(3.20)

where (our notation differs from the one used in [GrLe91] by various signs, and notice that in [GrLe91, Equation (2.8)], $C_{\mu\nu}^{\lambda} = -(\Gamma(g)_{\mu\nu}^{\lambda} - \Gamma(g_m)_{\mu\nu}^{\lambda})$ and $D^{\lambda} = -\Upsilon(g)^{\lambda}$)

$$\mathscr{C}_g(u)_{\kappa} = C_{\kappa\mu\nu}u^{\mu\nu}, \ C_{\kappa\mu\nu} = \Gamma(g)_{\kappa\mu\nu} - \Gamma(g_m)_{\kappa\mu\nu}; \qquad \mathscr{Y}_g(u)_{\kappa} = \Upsilon(g)^{\lambda}u_{\kappa\lambda}.$$

Here, index raising and lowering as well as covariant derivatives are defined using the metric g, and $(\Box_g u)_{\mu\nu} = -u_{\mu\nu;\kappa}{}^{\kappa}$. Thus, for $g = g_m + \rho h$, and recalling the definition (3.3) of $\tilde{\delta}^*$, we have

$$L_h = \rho^{-3} \left(\frac{1}{2} \Box_g + (\widetilde{\delta}^* - \delta_q^*) \delta_g G_g + \widetilde{\delta}^* (\mathscr{C}_g - \mathscr{Y}_g) + \mathscr{R}_g \right) \rho, \tag{3.21}$$

which has principal symbol

$$\sigma_2(L_h) = \frac{1}{2}G_b := \frac{1}{2}(g_b)^{-1}, \quad g_b := \rho^2 g,$$
 (3.22)

where $G \in \mathcal{C}^{\infty}(T^*\mathbb{R}^4)$ is the dual metric function $G(\zeta) = |\zeta|_G^2$. As a first step towards understanding the nature of L_h as a b-differential operator on M, we prove:

Lemma 3.6. We have $L_0 \in \rho_I^{-1} \text{Diff}_b^2(M; \beta^* S^2)$ (see (3.13)).

Proof. Since g_m is a smooth scattering metric, the discussion preceding Lemma 3.5) implies

$$\mathscr{R}_{g_m} \in \rho^2 \, \mathcal{C}^{\infty}(\overline{\mathbb{R}^4}; \operatorname{End}(S^2 \, {}^{\operatorname{sc}}T^*\overline{\mathbb{R}^4})), \quad \delta_{g_m} \in \rho \operatorname{Diff}^1_{\operatorname{b}}(\overline{\mathbb{R}^4}; S^2 \, {}^{\operatorname{sc}}T^*\overline{\mathbb{R}^4}, {}^{\operatorname{sc}}T^*\overline{\mathbb{R}^4}),$$

and $\Box_{g_m} \in \rho^2 \operatorname{Diff}_b^2(\overline{\mathbb{R}^4}; S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4})$. This gives $L_0 \in \operatorname{Diff}_b^2(\overline{\mathbb{R}^4}; S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4})$, and thus the desired conclusion away from \mathscr{I}^+ . Near \mathscr{I}^+ , any element of $\operatorname{Diff}_b^1(\overline{\mathbb{R}^4})$ lifts to an element of $\rho_I^{-1}\operatorname{Diff}_b^1(M)$; moreover, for $V_1, V_2 \in \mathcal{V}_b(\overline{\mathbb{R}^4})$, the product V_1V_2 lifts to an element of $\rho_I^{-1}\operatorname{Diff}_b^2(M)$ provided at least one of the V_j is tangent to S^+ . Thus, expressing \Box_{g_m} in the null frame $\partial_0, \partial_1, \partial_a$ (a = 2, 3), we merely need to check that the coefficient of ∂_1^2 vanishes at S^+ ; but this coefficient is $g_m^{11} \equiv 0$.

As suggested by the toy estimate (1.16) and explained in §2.4, we need to describe lower order terms of L_h near \mathscr{I}^+ in two stages, one involving the module \mathcal{M} from Definition 2.6, the other being general b-differential operators but with extra decay at $\rho_I = 0$. For illustration and for later use, we calculate the leading terms, i.e. the 'normal operator,' of the scalar wave operator:

Lemma 3.7. The scalar wave operator \square_{g_b} satisfies

$$\Box_{g_{\mathbf{b}}} \in -4\rho^{-2}\partial_{0}\partial_{1} + H_{\mathbf{b}}^{\infty;1+b_{0},-1+b'_{I},1+b_{+}} \mathcal{M}_{\underline{\mathbb{C}}}^{2} + (\mathcal{C}^{\infty} + H_{\mathbf{b}}^{\infty;1+b_{0},-0,1+b_{+}}) \operatorname{Diff}_{\mathbf{b}}^{2}(M). \quad (3.23)$$

For the linearized gauged Einstein operator L_h , the analogous result is:

Lemma 3.8. For $h \in \mathcal{X}^{\infty}$ small in \mathcal{X}^3 , we have

$$L_h = L_h^0 + \widetilde{L}_h$$

where, using the notation (3.13) and fixing $\rho = r^{-1}$ near \mathscr{I}^+ ,

$$L_h^0 = -\rho^{-1} ((2\rho^{-1}\partial_0 + A_h)\partial_1 - B_h),$$

$$\widetilde{L}_h \in H_b^{\infty;1+b_0,-1+b_I',1+b_+} \mathcal{M}_{\beta^*S^2}^2 + (\mathcal{C}^{\infty} + H_b^{\infty;1+b_0,-0,1+b_+}) \text{Diff}_b^2(M;\beta^*S^2);$$
(3.24)

here $\rho^{-1}\partial_0$ and ∂_1 are defined using equation (2.39) and Lemma 2.7(3). In the refinement of the bundle splitting (2.19) by (2.20), A_h and B_h are given by

$$A_h = \begin{pmatrix} 2\gamma_1 & 0 & 0 & 0 & 0 & 0 & 0 \\ \gamma_1 - \gamma_2 - 2\partial_1 h_{01} & 0 & 0 & 0 & 0 & \frac{1}{2}(\gamma_1 - \gamma_2) & 0 \\ 0 & 0 & \gamma_1 & 0 & 0 & 0 & 0 \\ -2\partial_1 h_{11} & 0 & 0 & 0 & 0 & \gamma_1 & \frac{1}{2}\partial_1 h^{\bar{a}\bar{b}} \\ -2\partial_1 h_{1\bar{b}} & 0 & \gamma_1 + \partial_1 h_{\bar{b}}^{\bar{a}} & 0 & 0 & 0 & 0 \\ 2\gamma_2 & 0 & 0 & 0 & 0 & \gamma_2 & 0 \\ 0 & 0 & 0 & 0 & 0 & 0 & 0 \end{pmatrix}$$

44

and

We remark that this captures the structure at \mathscr{I}^+ in a well-defined manner; for example, L_h^0 is well-defined modulo the remainder space in (3.24). The proofs of these lemmas only involve simple calculations and careful bookkeeping; they are given in Appendix B. We thus see that at \mathscr{I}^+ , L_h effectively becomes a differential operator in the null coordinates $x^0 = q$ and $x^1 = s$ only, as spherical derivatives have decaying coefficients; this is to be expected since $r^{-1}V$, $V \in \mathcal{V}(\mathbb{S}^2) \subset \mathcal{V}_b(M)$, is the naturally appearing (scattering) derivative just like ∂_0 and ∂_1 . We point out that a number of terms of L_h which are not of leading order at \mathscr{I}^+ do contribute to the normal operators at i^0 and i^+ ; this includes in particular the spherical Laplacian, which is crucial for proving an energy estimate.

For the analysis of the linearized operator L_h , the structure of the leading term L_h^0 will be key for obtaining the rough background estimate, Theorem 4.2, as well as the precise asymptotic behavior at \mathscr{I}^+ , as encoded in the space \mathscr{X}^{∞} . To describe this structure concisely, recall the projection π_0 defined in (3.11) projecting a metric perturbation onto the bundle K_0 encoding the components which we expect to be decaying from the gauge condition; and the projection π_{11} defined in (3.12) onto the bundle K_{11} encoding the (1, 1) component, which we allow to include a logarithmic term. Thus, in the splitting used in Lemma 3.8, π_0 picks out components 1, 3, 6, π_{11} picks out component 4, and π_{11}^c picks out components 2, 5, 7. Suppose now h' satisfies the asymptotic equation $L_h^0 h' = 0$. Since $\pi_0 A_h|_{K_0^c} = 0$ and $\pi_0 B_h|_{K_0^c} = 0$, the components $\pi_0 h'$, which we hope to be decaying, satisfy a decoupled equation

$$(2\rho^{-1}\partial_0 + A_{\rm CD})\partial_1(\pi_0 h') = 0, \quad A_{\rm CD} := \begin{pmatrix} 2\gamma_1 & 0 & 0\\ 0 & \gamma_1 & 0\\ 2\gamma_2 & 0 & \gamma_2 \end{pmatrix},$$
 (3.25a)

where $A_{\rm CD} \in \mathcal{C}^{\infty}(M; \operatorname{End}(K_0))$ is the endomorphism induced by $\pi_0 A_h$ on $\beta^* S^2/K_0^c \cong K_0$. (Thus, this matrix is the expression for $A_{h,0}$ in the splitting of $K_0 \cong \beta^* S^2/K_0^c$ induced by the splittings (2.19)–(2.20) via the projection π_0 .) Note that by equation (2.26), $\rho^{-1}\partial_0$ is proportional to the dilation vector field $-\rho_I \partial_{\rho_I}$ (which is the asymptotic generator of dilations on outgoing light cones), hence equation (3.25a) is, schematically, $(\rho_I \partial_{\rho_I} - A_{\rm CD})(\pi_0 h') = 0$. Choosing $\gamma_1, \gamma_2 > 0$, the spectrum of $A_{\rm CD}$ is positive, which will allow us to prove that $\pi_0 h'$ decays at \mathscr{I}^+ , similarly to the discussion of the model equation (1.21); we will make this precise in §§4.1 and 5.1.

Next, using that $\pi_{11}^c A_h|_{K_{11}} = 0$ and $\pi_{11}^c B_h|_{K_{11}} = 0$, i.e. the logarithmic component h_{11} does not couple into the other non-decaying components, we can obtain an equation for the non-logarithmic components $\pi_{11}^c h'$ which only couples to (3.25a), namely

$$2\rho^{-1}\partial_0\partial_1(\pi_{11}^c h') = (-A_{h,11}^c\partial_1 + B_{h,11}^c)(\pi_0 h'), \tag{3.25b}$$

$$A_{h,11}^{c} = \begin{pmatrix} \gamma_{1} - \gamma_{2} - 2\partial_{1}h_{01} & 0 & \frac{1}{2}(\gamma_{1} - \gamma_{2}) \\ -2\partial_{1}h_{1\bar{b}} & \gamma_{1} + \partial_{1}h_{\bar{b}}^{\bar{a}} & 0 \\ 0 & 0 & 0 \end{pmatrix}, \ B_{h,11}^{c} = \begin{pmatrix} 2\partial_{1}\partial_{1}h_{01} & 0 & 0 \\ 2\partial_{1}\partial_{1}h_{1\bar{b}} & 0 & 0 \\ 2\partial_{1}\partial_{1}h_{\bar{a}\bar{b}} & 0 & 0 \end{pmatrix};$$

the precise form of $A_{h,11}^c$, $B_{h,11}^c$, mapping sections of K_0 to sections of K_{11}^c , is irrelevant: only their boundedness matters (even mild growth towards \mathscr{I}^+ would be acceptable). The operator on the left hand side of (3.25b) has the same structure as the model operator in (1.19); the fact that the forcing term in (3.25b) is decaying will thus allow us to prove that $\pi_{11}^c h'$ is bounded at \mathscr{I}^+ , consistent with what the function space \mathscr{X}^{∞} encodes.

Lastly, $\pi_{11}h'$ couples to all previous quantities,

$$2\rho^{-1}\partial_0\partial_1(\pi_{11}h') = (-A_{h,11}\partial_1 + B_{h,11}) \begin{pmatrix} \pi_0h' \\ \pi_{11}^ch' \end{pmatrix}, \tag{3.25c}$$

$$A_{h,11} = \begin{pmatrix} -2\partial_1 h_{11} & 0 & \gamma_1 & 0 & 0 & \frac{1}{2}\partial_1 h^{\bar{a}\bar{b}} \end{pmatrix}, \ B_{h,11} = \begin{pmatrix} 2\partial_1 \partial_1 h_{11} & 0 & 0 & 0 & 0 \end{pmatrix}.$$

The logarithmic growth of first components of $A_{h,11}$ and $B_{h,11}$ is more than balanced by the fast decay of the (0,0)-component of h' that it acts on; more subtly though, the $\rho_I^{b'_I}$ decay of h'_{00} is required at this point to allow for an estimate of the remainder of h_{11} with weight $\rho_I^{b'_I} \gg \rho_I^{b'_I} \log \rho_I$. The last component of $A_{h,11}$, acting on the trace-free spherical part of h', in general has a non-zero leading term at \mathscr{I}^+ ; hence, solving the equation (3.25c), schematically $\rho_I \partial_{\rho_I} (\partial_1 \pi_{11} h') \approx \partial_1 h^{\bar{a}\bar{b}} (\partial_1 h')_{\bar{a}\bar{b}}$, requires $\pi_{11} h'$ to have a $\log \rho_I$ term.

At the other boundaries i^0 and i^+ , we only need crude information about L_h for the purpose of obtaining an energy estimate in §4:

Lemma 3.9. We have
$$L_h - L_0 \in H_b^{\infty; 1+b_0, -1-0, 1+b_+} \mathrm{Diff}_b^2(M; \beta^* S^2)$$
.

Proof. Near $(i^+)^{\circ}$, one obtains this using the arguments used in the proof of Lemma 3.5. Near \mathscr{I}^+ , we revisit the proof of Lemma 3.8: in the notation of equation (3.24), the expressions for A_h and B_h give $L_h^0 - L_0^0 \in H_b^{\infty;1+b_0,-0,1+b_+} \mathrm{Diff}_b^1$. Regarding the second remainder term in \widetilde{L}_h , we note that the leading order terms, captured by the Diff_b^2 summand with \mathscr{C}^{∞} coefficients, come from terms of the metric and the Christoffel symbols which do not involve h; thus, these are equal to the corresponding terms of L_0 .

In order to obtain optimal decay results at i^+ in §5.2, we shall need the *precise* form of the normal operator of L_h , which by Lemma 3.9 is the same as that of L_0 . Now, g_m is itself merely a perturbation of the Minkowski metric, pulled back by a diffeomorphism, see (2.9). It is convenient for the normal operator analysis at i^+ in §§5.2 and 7 to relate this to the usual presentation of the Minkowski metric $g = dt^2 - dx^2$ on \mathbb{R}^4 in $U = \{t > \frac{2}{3}r\}$:

Lemma 3.10. The metric \underline{g} lies in $\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_{\mathrm{log}}}(U; S^{2 \operatorname{sc}} T^{* m} \overline{\mathbb{R}^{4}})$ for the index set $\mathcal{E}_{\mathrm{log}}$ defined in (2.33), and $\underline{g} - g_{m} \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}'_{\mathrm{log}}}(U; S^{2 \operatorname{sc}} T^{* m} \overline{\mathbb{R}^{4}}) \subset \rho^{1-0} H_{\mathrm{b}}^{\infty}(U; S^{2 \operatorname{sc}} T^{* m} \overline{\mathbb{R}^{4}}).$

The failure of smoothness (for $m \neq 0$) of \underline{g} is due to the logarithmic correction, see (2.4), in the definition of the compactification ${}^{m}\overline{\mathbb{R}^{4}}$. On the radial compactification ${}^{0}\overline{\mathbb{R}^{4}}$ on the other hand, g is a smooth scattering metric.

²⁴The discussion of Theorem 1.8 shows that for non-trivial data, this leading term must be non-trivial somewhere on \mathscr{I}^+ .

Proof of Lemma 3.10. In the region C_2 defined in (2.7), $g_m = \underline{g}$ is smooth, see the discussion after equation (2.9). In the region C_1 , see equation (2.5), the spatial part $dr^2 + r^2 \not g$ is a smooth symmetric scattering 2-tensor on ${}^m \overline{\mathbb{R}^4}$. In the region $t \geq \frac{2}{3}r$ and for large r, the claim follows from Lemma 2.2 in that region.

Define

$$\underline{L} := \frac{1}{2} \Box_g + (\underline{\widetilde{\delta}}^* - \delta_g^*) \delta_g G_g, \quad (\underline{\widetilde{\delta}}^* - \delta_g^*) u := 2\gamma_1 t^{-1} dt \otimes_s u - \gamma_2 t^{-1} (\iota_{\nabla^{\underline{g}} t} u) \underline{g}, \tag{3.26}$$

cf. the definition (3.3), which is the linearization $\operatorname{Ric}(g) - \underline{\widetilde{\delta}}^* \underline{\Upsilon}(g)$ around $g = \underline{g}$, where $\underline{\Upsilon}(g)$ is defined like $\Upsilon(g)$ in (3.1) with \underline{g} in place of g_m . Using Lemma 3.10, one finds $\underline{L} \in \mathcal{A}^{\mathcal{E}_{log}}_{phg} \cdot \operatorname{Diff}^2_b(U; S^2 \operatorname{sc} T^* \overline{\mathbb{R}^4})$. Furthermore,

$$\underline{L} - L_0 \in \mathcal{A}_{phg}^{\mathcal{E}'_{log}}(U) \cdot \text{Diff}_b^2(U; S^2 \operatorname{sc} T^* \overline{\mathbb{R}^4}); \tag{3.27}$$

but $\partial_v \in \rho_I^{-1} \mathcal{V}_b(M)$, while derivatives along b-vector fields tangent to S^+ lift to elements of $\mathcal{V}_b(M)$; thus,

$$\underline{L} - L_0 \in \rho_I^{-1-0} \rho_+^{1-0} H_b^{\infty} \cdot \text{Diff}_b^2 \quad (\text{near } i^+ \subset M). \tag{3.28}$$

4. Global background estimate

We prove a global energy estimate for solutions of the linearized equation $L_h u = f$ with $h \in \mathcal{X}^{\infty}$, and show that u lies in a weighted conormal space provided f does; recall here the definition (3.19) of L_h . The weak asymptotics of u at the boundaries i^0 , \mathscr{I}^+ , and i^+ can be improved subsequently using normal operator arguments in §5. At \mathscr{I}^+ , the estimate loses a weight of $\rho_I^{1/2}$ for general b-derivatives, as we will explain in detail in §4.1. We capture this using the function space $H_{\mathscr{I}}^1$:

Definition 4.1. Let $E \to \overline{\mathbb{R}^4}$ be a smooth vector bundle. With \mathcal{M}_{β^*E} defined in §2.4, let

$$H^1_{\beta}(M;\beta^*E) := \{ u \in L^2_{\mathbf{b}}(M;\beta^*E) \colon \mathcal{M}_{\beta^*E}u \subset L^2_{\mathbf{b}}(M;\beta^*E) \},$$

$$H^1_{\mathscr{I}}(M;\beta^*E):=\{u\in H^1_{\beta}(M;\beta^*E)\colon \rho_I^{1/2}\mathrm{Diff}^1_{\mathbf{b}}(M;\beta^*E)u\subset L^2_{\mathbf{b}}(M;\beta^*E)\}.$$

For $k \in \mathbb{N}_0$ and $\bullet = \beta, \mathscr{I}$, define

$$H^{1,k}_{\bullet,\mathbf{b}}(M;\beta^*E):=\{u\in L^2_{\mathbf{b}}(M;\beta^*E)\colon \mathrm{Diff}^k_{\mathbf{b}}(M;\beta^*E)u\subset H^1_{\bullet}(M;\beta^*E)\}.$$

If $\{A_j\} \subset \mathcal{M}_{\beta^*E}$ is a finite set spanning \mathcal{M}_{β^*E} over $\mathcal{C}^{\infty}(M)$, we define norms on these spaces by

$$||u||_{H^{1,k}_{\beta,\mathbf{b}}(M;\beta^*E)} := ||u||_{H^k_{\mathbf{b}}(M;\beta^*E)} + \sum_j ||A_j u||_{H^k_{\mathbf{b}}(M;\beta^*E)},$$

$$\|u\|_{H^{1,k}_{\beta,b}(M;\beta^*E)} := \|u\|_{H^{1,k}_{\beta,b}(M;\beta^*E)} + \|\rho_I^{1/2}u\|_{H^{k+1}_b(M;\beta^*E)}.$$

Note that for $u \in H^1_{\beta}$, we automatically have $\rho_I \operatorname{Diff}^1_{\mathbf{b}}(M) u \subset L^2_{\mathbf{b}}$ by Lemma 2.7(1), so the subspace $H^1_{\mathscr{I}} \subset H^1_{\beta}$ encodes a $\rho_I^{1/2}$ improvement over this. Away from \mathscr{I}^+ , the spaces $H^{1,k}_{\beta,\mathbf{b}}$ and $H^{1,k}_{\mathscr{I},\mathbf{b}}$ are the same as $H^{k+1}_{\mathbf{b}}$.

Fix a vector field

$$\partial_{\nu} \in \mathcal{V}_{b}(\overline{\mathbb{R}^{4}}) \tag{4.1}$$

transversal to the Cauchy surface Σ ; we extend the action of ∂_{ν} to sections u of a vector bundle E using an arbitrary fixed b-connection d^{E} on E, see (2.42), by setting $\partial_{\nu}u := (d^{E}u)(\partial_{\nu})$.

Theorem 4.2. Fix weights b_0, b'_I, b_I, b_+ as in Definition 3.1, let $\gamma_1, \gamma_2 > b'_I$ in the definition (3.3) of $\widetilde{\delta}^*$, and fix $a_0, a_I, a'_I \in \mathbb{R}$ satisfying

$$a_I < a'_I < a_0, \quad a_I < 0, \quad a'_I < a_I + b'_I.$$

Then there exists $a_+ \in \mathbb{R}$ such that the following holds for all $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ which are small in \mathcal{X}^3 : for $k \in \mathbb{N}$, $u_j \in \rho_0^{a_0} H_b^{k-j}(\Sigma)$, j = 0, 1, and $f \in H_b^{k-1;a_0,a_I-1,a_+}(M; \beta^*S^2)$ with $\pi_0 f \in H_b^{k-1;a_0,a_I'-1,a_+}(M; \beta^*S^2)$, the linear wave equation

$$L_h u = f, \quad (u, \partial_\nu u)|_{\Sigma} = (u_0, u_1),$$
 (4.2)

has a unique global solution u satisfying

$$||u||_{\rho_0^{a_0}\rho_I^{a_I}\rho_+^{a_I}H_{\mathscr{S},\mathbf{b}}^{1,k-1}(M;\beta^*S^2)} + ||\pi_0 u||_{\rho_0^{a_0}\rho_I^{a_I'}\rho_+^{a_I}H_{\mathscr{S},\mathbf{b}}^{1,k-1}(M;\beta^*S^2)} \\ \leq C\Big(||u_0||_{\rho_0^{a_0}H_{\mathbf{b}}^k} + ||u_1||_{\rho_0^{a_0}H_{\mathbf{b}}^{k-1}} + ||f||_{H_{\mathbf{b}}^{k-1;a_0,a_I-1,a_I}} + ||\pi_0 f||_{H_{\mathbf{b}}^{k-1;a_0,a_I'-1,a_I}}\Big).$$

$$(4.3)$$

In particular, if the assumptions on u_j and f hold for all k, then

$$u \in H_{\mathbf{b}}^{\infty; a_0, a_I, a_+}, \quad \pi_0 u \in H_{\mathbf{b}}^{\infty; a_0, a_I', a_+}.$$

For completeness, we prove a version of such a background estimate with an explicit weight a_+ in §4.3. As we will see in §5.2, this allows us to give an explicit bound on the number of derivatives needed to close the non-linear iteration in §6. A non-explicit value of a_+ as in Theorem 4.2 is sufficient to prove Theorem 1.1 if one is content with a non-explicit value for N. We will prove Theorem 4.2 by means of energy estimates, as outlined in §1.1.1. Microlocal techniques on $\overline{\mathbb{R}^4}$ on the other hand, as employed in [BaVaWu15], would work well away from the light cone at infinity S^+ , but since the coefficients of L_h are singular at S^+ , it is a delicate question how 'microlocal' the behavior of L_h is at S^+ , i.e. whether or not and what strengths of singularities could 'jump' from one part of the b-cotangent bundle to another at S^+ ; since we do not need precise microlocal control of L_h for present purposes, we do not study this further.

Since dt is globally timelike for $g = g_m + \rho h$ provided ρh is small in $\rho \mathcal{X}^3 \subset L^{\infty}$, existence and uniqueness of a solution $u \in H^k_{\text{loc}}(M \cap \mathbb{R}^4; S^2T^*\mathbb{R}^4)$ are immediate, together with an estimate for any compact set $K \in M \cap \mathbb{R}^4$,

$$||u||_{H^{k}(K)} \le C_{K}(||u_{0}||_{\rho_{0}^{a_{0}}H_{b}^{k}} + ||u_{1}||_{\rho_{0}^{a_{0}}H_{b}^{k-1}} + ||f||_{H_{b}^{k-1;a_{0},a_{I},a_{+}}}), \tag{4.4}$$

where one could equally well replace the norms on the right by standard Sobolev norms on sufficiently large compact subsets of $M \cap \mathbb{R}^4$ depending on K, due to the domain of dependence properties of solutions of (4.2).

²⁵One could obtain an explicit value for N even from a non-explicit weight a_+ if one improved the argument in §6, which proves precise decay rates at i^+ , to not lose regularity. We expect that this can be accomplished by microlocal propagation estimates along \mathscr{I}^+ and radial point estimates at $\mathscr{I}^+ \cap i^+$, though we do not pursue this here.

Using Lemma 3.9, it is straightforward to prove (4.3) near any compact subset of $(i^0)^\circ$, where $H^{1,k-1}_{\mathscr{I},b}$ is the same as H^k_b . Let us define ρ_0, ρ_I, ρ near i^0 as in equation (2.23). Fix $\epsilon > 0$, and define for $\delta, \eta > 0$ small

$$U := \{ \rho_I > \epsilon, \ \rho_0 - \eta \rho_I < \delta \} \subset M,$$

which for ϵ small is a neighborhood of any fixed compact subset of $M \cap (i^0)^{\circ}$. (Since ρ_I is bounded from above, U can be made to lie in any fixed neighborhood $\{\rho_0 < \delta_0\}$ of i^0 provided δ and η are sufficiently small.) In view of (3.15), we have $G \in 4\partial_0\partial_1 - r^{-2}\mathcal{G} + \rho_0^{1-0}H_{\rm b}^{\infty}(U; S^2 {}^{\rm sc}T^*\overline{\mathbb{R}^4})$, hence the calculation (2.24) gives

$$G_{\rm b} = G_{0,\rm b} + \rho_0^{1-0} H_{\rm b}^{\infty}(U; S^2 {}^{\rm b}T^* \overline{\mathbb{R}^4}), \quad G_{0,\rm b} := 2\partial_{\rho_I}(\rho_I \partial_{\rho_I} - \rho_0 \partial_{\rho_0}) - \mathcal{G}.$$
 (4.5)




FIGURE 4.1. The domain U with its spacelike boundaries U_1^{∂} , and U_2^{∂} . We draw i^0 at a 45 degree angle as the level sets of the chosen boundary defining function ρ_0 are approximately null (namely, $|d\rho_0|_{G_{0,b}}^2 = 0$). The level sets of ρ_I are spacelike in $\rho_I > 0$, but not uniformly so as $\rho_I \to 0$.

Thus, $d\rho_I$ and $d(\rho_0 - \eta\rho_I)$ are timelike in U once we fix $\delta, \eta > 0$ to be sufficiently small, and thus U is bounded by $\Sigma \cap U$ and two spacelike hypersurfaces, $U_1^{\partial} = \{\rho_I = \epsilon\}$ and $U_2^{\partial} = \{\rho_0 - \eta\rho_I = \delta\}$ (as well as by $U \cap \partial M$ at infinity), see Figure 4.1.

Proposition 4.3. Under the assumptions of Theorem 4.2, we have

$$||u||_{\rho_0^{a_0} H_{\mathbf{b}}^k(U)} \le C(||u_0||_{\rho_0^{a_0} H_{\mathbf{b}}^k(\Sigma \cap U)} + ||u_1||_{\rho_0^{a_0} H_{\mathbf{b}}^{k-1}(\Sigma \cap U)} + ||f||_{\rho_0^{a_0} H_{\mathbf{b}}^{k-1}(U)}). \tag{4.6}$$

Proof. We give a positive commutator proof of this standard estimate, highlighting the connection to the more often encountered fashion in which energy estimates are phrased [DaRo08]. Let us work in a trivialization ${}^{b}T^{*}\overline{\mathbb{R}^{4}}\cong\overline{\mathbb{R}^{4}}\times\mathbb{R}^{4}$, and fix the fiber inner product to be the Euclidean metric in this trivialization. For proving the case k=1 of the lemma, we set $L:=L_{h}$; it will be convenient however for showing higher regularity to allow $L\in \mathrm{Diff}_{b}^{2}+\rho_{0}^{1-0}H_{b}^{\infty}\mathrm{Diff}_{b}^{2}$ to be any principally scalar operator with $\sigma_{b,2}(L)=\frac{1}{2}G_{b}$, acting on \mathbb{C}^{N} -valued functions for some $N\in\mathbb{N}$; we equip \mathbb{C}^{N} with the standard Hermitian inner product. (One may also phrase the proof invariantly, i.e. not using global bundle trivializations, as we shall do in §§4.1 and 4.2 for conceptual clarity.)

We will use a positive commutator argument: let $V = -\nabla \rho_I \in \mathcal{V}_{\rm b}(\overline{\mathbb{R}^4})$, with ∇ defined with respect to $g_{\rm b}$; this is future timelike. For F > 0 chosen later, let $w = \rho_0^{-a_0} e^{F \rho_I}$, and let $\mathbb{1}_U$ denote the characteristic function of U. Put $W = \mathbb{1}_U w^2 V$. Write $L = L_2 + L_1$, where $L_2 = \frac{1}{2} \Box_{g_{\rm b}} \otimes 1_{10 \times 10}$, $L_1 \in (\mathcal{C}^{\infty} + \rho_0^{1-0} H_{\rm b}^{\infty}) \mathrm{Diff}_{\rm b}^1$. We then calculate the commutator

$$2\operatorname{Re}\langle\mathbb{1}_{U}wf,\mathbb{1}_{U}wVu\rangle = 2\operatorname{Re}\langle Lu,Wu\rangle = \langle Au,u\rangle + 2\operatorname{Re}\langle\mathbb{1}_{U}wL_{1}u,\mathbb{1}_{U}wVu\rangle \tag{4.7}$$

using the L_b^2 inner product, where $A = [L_2, W] + (W + W^*)L_2$. A simple calculation gives $\sigma_{b,2}(A)(\xi) = K_W(\xi, \xi)$, where

$$K_W := -\frac{1}{2}(\mathcal{L}_W G_b + (\operatorname{div}_{g_b} W)G_b).$$
 (4.8)

(The K-current is often given in its covariant form $\frac{1}{2}(\mathcal{L}_W g_b - (\operatorname{div}_{g_b} W)g_b)$.) Therefore, $A = d^*K_W d$, since the principal symbols of both sides agree, hence the difference is a scalar²⁶ first order b-differential operator which has real coefficients and is symmetric—thus is in fact of order zero, and since it annihilates constant vectors in \mathbb{C}^N , the difference vanishes. Differentiation of the exponential weight in W upon evaluating K_W will produce the main positive term into which all other terms can be absorbed. Indeed, the identity $\mathcal{L}_{fV}G_b = f\mathcal{L}_V G_b - 2\nabla f \otimes_s V$ for $V \in \mathcal{V}_b$ and $f \in \mathcal{C}^\infty$ gives

$$K_{fV} = T(\nabla f, V) + fK_V, \tag{4.9}$$

where

$$T(X,Y) = X \otimes_s Y - \frac{1}{2}g_{\mathbf{b}}(X,Y)G_{\mathbf{b}}$$

denotes the (abstract) energy-momentum tensor. (The energy-momentum tensor of a scalar wave u, say, is given by T(X,Y)(du,du).) Therefore, $K_W = w^2(2\digamma \mathbb{1}_U K_0 + \mathbb{1}_U K_1 + K_2)$, where

$$K_0 = T(\nabla \rho_I, V), \quad K_1 = -2a_0 T\left(\frac{\nabla \rho_0}{\rho_0}, V\right), \quad K_2 = T(\nabla \mathbb{1}_U, V).$$

Since $\nabla \rho_I$ is past timelike, the main term K_0 is negative definite; K_2 has support in $\partial U \setminus \partial M$, so $\nabla \mathbb{1}_U$ being past timelike at U_1^{∂} and U_2^{∂} , K_2 has the same sign as K_0 there. Lastly, K_1 has no definite sign, but can be absorbed into K_0 by choosing F > 0 large: indeed, $|T(\frac{\nabla \rho_0}{\rho_0}, V)(\xi, \xi)| \leq -CT(\nabla \rho_I, V)$ for some constant C depending only on K, since g_b is a b-metric. Thus, (4.7) gives the estimate

$$\langle \mathbb{1}_{U}w(-2\digamma K_{0} - K_{1})du, \mathbb{1}_{U}du \rangle \leq 2(\|\mathbb{1}_{U}wVu\|^{2} + \|\mathbb{1}_{U}wL_{1}u\|^{2}) + \|\mathbb{1}_{U}wf\|^{2} + C\|\mathbb{1}_{U}w(du_{0}, u_{1})\|^{2}.$$

$$(4.10)$$

In order to control u itself, consider the 'commutator'

 $2\operatorname{Re}\langle\mathbb{1}_{U}wu,\mathbb{1}_{U}wVu\rangle = 2\operatorname{Re}\langle u,Wu\rangle = \langle -\mathbb{1}_{U}w(\operatorname{div} V)u,\mathbb{1}_{U}wu\rangle - \langle V(\mathbb{1}_{U}w^{2})u,u\rangle, \quad (4.11)$ where $V(\mathbb{1}_{U}w^{2}) = 2F\mathbb{1}_{U}w^{2}(V\rho_{I}) - 2a_{0}\mathbb{1}_{U}w^{2}\frac{V\rho_{0}}{\rho_{0}} + w^{2}V(\mathbb{1}_{U}).$ In the first, main, term, $V\rho_{I} = -|d\rho_{I}|_{g_{b}}^{2} \leq -c_{0} < 0$ has a strictly negative upper bound on U; the third term gives δ -distributions at ∂U with the same sign as this main term at U_{1}^{∂} and U_{2}^{∂} since V is outward pointing there. Choosing F large to absorb the contribution of the second term, we get

$$c_0 F \|\mathbb{1}_U w u\|^2 \le \eta F \|\mathbb{1}_U w u\|^2 + C_\eta F^{-1} \|\mathbb{1}_U w V u\|^2 + C \|\mathbb{1}_U w u_0\|^2,$$

so fixing $\eta = c_0/2$, this gives $\|\mathbb{1}_U wu\|^2 \le CF^{-2}\|\mathbb{1}_U wVu\|^2 + C_F\|\mathbb{1}_U wu_0\|^2$. Adding C' times this to (4.10) yields

$$\langle \mathbb{1}_{U}w(-2\digamma K_{0} - K_{1})du, \mathbb{1}_{U}du \rangle + C' \|\mathbb{1}_{U}wu\|^{2}$$

$$\leq (2 + CC'\digamma^{-2})\|\mathbb{1}_{U}wVu\|^{2} + 2\|\mathbb{1}_{U}wL_{1}u\|^{2}$$

$$+ C_{\digamma} (\|\mathbb{1}_{U}wf\|^{2} + (C + C')\|\mathbb{1}_{U}w(u_{0}, du_{0}, u_{1})\|^{2}).$$

Fixing C' sufficiently large and then F > 0 large, we can absorb the two first terms on the right into the first term on the left hand side, using that $-FK_0 > -2FK_0 - K_1$ for large F. This gives (4.6) for k = 1.

²⁶That is, it is a scalar operator tensored with the identity operator on \mathbb{C}^N .

We now proceed by induction, assuming (4.6) holds for some value of k for all operators L of the form considered above. If Lu = f, let $X \in (\text{Diff}_{b}^{1}(\overline{\mathbb{R}^{4}}))^{N}$ denote an N-tuple of b-differential operators which generate $\text{Diff}_{b}^{1}(\overline{\mathbb{R}^{4}})$ over $\mathcal{C}^{\infty}(\overline{\mathbb{R}^{4}})$; writing $[L, X] = L' \cdot X$ for L' an N-tuple of operators in $(\mathcal{C}^{\infty} + \rho_{0}^{1-0}H_{b}^{\infty})\text{Diff}_{b}^{1}$, we then have (L - L')(Xu) = Xf. Applying (4.6) to this equation, we obtain the estimate (4.6) for Lu = f itself with k replaced by k + 1.

Given the structure of the operator L_h on the manifold with corners M as described in §3.3, it is natural to proceed proving the estimate (4.3) in steps: in §4.1, we propagate the control given by Proposition 4.3 uniformly up to a neighborhood of the past corner $i^0 \cap \mathscr{I}^+$ of null infinity and thus into $(\mathscr{I}^+)^{\circ}$. In §4.2, we prove the energy estimate uniformly up to i^+ ; the last estimate cannot be localized near the corner $\mathscr{I}^+ \cap i^+$ since typically limits of future-directed null-geodesic tending to $\mathscr{I}^+ \cap i^+$ pass through points in i^+ far from \mathscr{I}^+ .

4.1. Estimate up to null infinity. We work near the past corner $i^0 \cap \mathscr{I}^+$ of the radiation field; recall the definition of the boundary defining functions ρ_0 and ρ_I of i^0 and \mathscr{I}^+ from (2.23), and let $\rho = r^{-1}$. At \mathscr{I}^+ , we need to describe G_b more precisely than was needed near $(i^0)^{\circ}$; we make extensive use of the structures defined in §2.4. Equations (3.15) and (2.24) give

$$G_{\rm b} = G_{0,\rm b} + G_{1,\rm b} + \widetilde{G}_{\rm b}, \quad G_{1,\rm b} := \rho^{-2} g_m^{-1} - G_{0,\rm b} \in \mathcal{C}^{\infty}(M; S^{2\beta}TM),$$
 (4.12)

with $G_{0,b} = 2\partial_{\rho_I}(\rho_I\partial_{\rho_I} - \rho_0\partial_{\rho_0}) - \mathcal{G} \in \rho_I^{-1}\mathcal{C}^{\infty}(M; S^{2\beta}TM + \rho_I S^{2b}TM)$ as before, and

$$\widetilde{G}_{\mathbf{b}} \in \rho_0^{1+b_0} \rho_I^{-1+b_I'} H_{\mathbf{b}}^{\infty}(M; S^{2 \beta} TM + \rho_I S^{2 \mathbf{b}} TM).$$

Dually, equation (2.25) gives

$$q_{\rm b} \in (\mathcal{C}^{\infty} + \rho_0^{1+b_0} \rho_I^{b_I'} H_{\rm b}^{\infty})(M; S^2({}^{\beta}TM)^{\perp} + \rho_I S^2 {}^{\rm b}T^*M)$$
 (4.13)

where the smooth term is $\rho^2 g_m = -2\rho_I \frac{d\rho_0}{\rho_0} \left(\frac{d\rho_0}{\rho_0} + \frac{d\rho_I}{\rho_I} \right) - \mathcal{J} + \rho_I^2 \mathcal{C}^{\infty}(M; S^2 \, {}^{\mathrm{b}}T^*M).$

Fix $\beta \in (0, b'_I)$. For small $\epsilon > 0$, we define the domain




FIGURE 4.2. The domain U_{ϵ} and its subdomain U_{ϵ}^{0} where we have a priori control of u, allowing us to cut off and study equation (4.19) instead.

$$U_{\epsilon} := \{ \rho_I < \epsilon, \ \rho_0 - \rho_I^{\beta} < 1 \} \subset M, \quad U_{\epsilon}^0 := U_{\epsilon} \cap \{ \frac{1}{2} \epsilon < \rho_I < \epsilon \}, \tag{4.14}$$

see Figure 4.2. Thus, U_{ϵ} is bounded by i^0 , \mathscr{I}^+ , $\{\rho_I = \epsilon\}$, and $U_{\epsilon}^{\partial} = \{\rho_0 - \rho_I^{\beta} = 1, \ \rho_I < \epsilon\}$. At U_{ϵ}^{∂} , we use (4.5) and (4.12) to compute

$$|d(\rho_0 - \rho_I^{\beta})|_{G_b}^2 \in 2\beta \rho_I^{-1+\beta}(\rho_0 + \beta \rho_I^{\beta}) + \rho_I^{2\beta} \mathcal{C}^{\infty} + \rho_0^{1-0} \rho_I^{-1+b_I'} H_b^{\infty}, \tag{4.15}$$

hence U_{ϵ}^{∂} is timelike for small enough ϵ . As in the proof of Proposition 4.3, the main term is the K-current of a timelike vector field with suitable weights:

Lemma 4.4. Fix $c_V \in \mathbb{R}$, let $W := \rho_0^{-2a_0} \rho_I^{-2a_I} V$, and $V := -(1 + c_V) \rho_I \partial_{\rho_I} + \rho_0 \partial_{\rho_0}$, then

$$K_{W} \in \rho_{0}^{-2a_{0}} \rho_{I}^{-2a_{I}-1} \left(2a_{I} (\rho_{0} \partial_{\rho_{0}} - \rho_{I} \partial_{\rho_{I}})^{2} - 2c_{V} (a_{0} - a_{I}) (\rho_{I} \partial_{\rho_{I}})^{2} - \frac{1}{2} \left(1 + 2(a_{0} - a_{I}) + c_{V} (1 - 2a_{I}) \right) \rho_{I} \mathcal{G} \right)$$

$$+ \rho_{0}^{-2a_{0}} \rho_{I}^{-2a_{I}} (\mathcal{C}^{\infty} + \rho_{0}^{1+b_{0}} \rho_{I}^{-1+b'_{I}} H_{b}^{\infty}) (M; S^{2} \beta TM + \rho_{I} S^{2} b TM).$$

$$(4.16)$$

Furthermore,

$$\operatorname{div}_{g_{b}} W \in -2\rho_{0}^{-2a_{0}}\rho_{I}^{-2a_{I}} \left(1 + 2(a_{0} - a_{I}) + c_{V}(1 - 2a_{I})\right) + \rho_{0}^{-2a_{0}}\rho_{I}^{-2a_{I}+1} \left(\mathcal{C}^{\infty} + \rho_{0}^{1+b_{0}}\rho_{I}^{-1+b'_{I}}H_{b}^{\infty}\right)$$

$$(4.17)$$

Here, $\rho_I^{-1}|V|_{g_b}^2 \in 2c_V + \rho_I \mathcal{C}^\infty + \rho_0^{1+b_0} \rho_I^{b_I'} H_b^\infty$, so V is timelike for $c_V > 0$. This calculation also shows that the level sets of ρ_I are spacelike in U_ϵ . The term $\rho_I K_W(du, du)$ will provide control of u in $\rho_0^{a_0} \rho_I^{a_I} H_{\mathscr{I}}^1$ (modulo control of $|u|^2$ itself, which we obtain by integration), similarly to (1.16).

Proof of Lemma 4.4. Recall that $K_W = \frac{1}{2}(\pi - \frac{1}{2}(\operatorname{tr}_{g_b}\pi)G_b)$, $\pi := -\mathcal{L}_W G_b$. Since $V \in \mathcal{M}_{\mathbb{C}}$, Lemma 2.7(2) shows that $\widetilde{\pi} := -\mathcal{L}_W \widetilde{G}_b$, expressed using vector field commutators, lies in the remainder space in (4.16); using (4.13), this implies $\operatorname{tr}_{g_b}\widetilde{\pi} \in \rho_0^{-2a_0+1+b_0}\rho_I^{-2a_I+b_I'}H_b^{\infty}$, so $(\operatorname{tr}_{g_b}\widetilde{\pi})G_b$ also lies in the remainder space. Similarly, $G_{1,b}$ contributes a (weighted) smooth remainder term to K_W . Lastly, for $\pi_0 = -\mathcal{L}_W G_{b,0}$, the term $\frac{1}{2}(\pi_0 - \frac{1}{2}(\operatorname{tr}_{g_b}\pi_0)G_b)$ contributes the main term, i.e. the first line of (4.16) after a short calculation, as well as two more error terms, one from \widetilde{G}_b , the other coming from the non-smooth remainder term in (4.13). The calculation (4.17) drops out as a by-product of this, and can also be recovered by $\operatorname{div}_{g_b} W = -\operatorname{tr}_{g_b} K_W$.

In order to get the sharp weights²⁷ for the decaying components $\pi_0 u$ of u at \mathscr{I}^+ in Theorem 4.2, we need to exploit the sign of the leading subprincipal part of L_h at \mathscr{I}^+ , given by the term involving $\rho^{-1}A_h\partial_1$ in Lemma 3.8, in the decoupled equation for $\pi_0 u$, see (3.25a) for the model. We thus prove:

Lemma 4.5. Define $W = \rho_0^{-2a_0} \rho_I^{-2a_I'}(\rho_0 \partial_{\rho_0} - (1+c_V)\rho_I \partial_{\rho_I})$ similarly to previous lemma. Let $\gamma \in \mathbb{R}$, and fix $a_0, a_I' \in \mathbb{R}$ such that $a_I' < \min(\gamma, a_0)$. Then for small $c_V > 0$, there exists a constant C > 0 such that

$$K_W - 2\gamma W \otimes_s \rho^{-1} \partial_1 \le -C\rho_0^{-2a_0} \rho_I^{-2a_I'-1} ((\rho_I \partial_{\rho_I})^2 + (\rho_0 \partial_{\rho_0})^2 + \rho_I \mathcal{G}), \tag{4.18}$$

in the sense of quadratic forms, in U_{ϵ} , $\epsilon > 0$ small.

Proof. Using the expression (2.24) for $\rho_0^{-1}\rho_I^{-1}\partial_1$, we have

$$\rho_0^{2a_0} \rho_I^{2a_I'+1} W \otimes_s \rho^{-1} \partial_1$$

$$\in (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I})^2 - c_V \rho_I \partial_{\rho_I} \otimes_s (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) + \rho_I \mathcal{C}^{\infty}(M; {}^{\beta}TM)$$

We can then calculate the leading term of $\rho_0^{2a_0}\rho_I^{2a_I'+1}$ times the left hand side of (4.18) by completing the square:

$$-2(\gamma - a_I') \Big(\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I} - \frac{\gamma c_V}{2(\gamma - a_I')} \rho_I \partial_{\rho_I} \Big)^2 - c_V \Big(a_0 - a_I' - \frac{\gamma^2 c_V}{2(\gamma - a_I')} \Big) (\rho_I \partial_{\rho_I})^2 - \frac{1}{2} (1 + 2(a_0 - a_I') + c_V (1 - 2a_I')) \rho_I \mathcal{G}.$$

 $^{^{27}}$ As explained before in the context of the weight at i^+ , this is not necessary, but easy to accomplish here without lengthy calculations.

The first term is the negative of a square, and so is the second term if we choose $c_V > 0$ sufficiently small; reducing c_V further if necessary, the coefficient of the last term is negative as well, finishing the proof.

Remark 4.6. For the value of c_V determined in the proof, we have $\operatorname{div}_{g_b} W \leq -C \rho_0^{-2a_0} \rho_I^{-2a_I'}$ near \mathscr{I}^+ by inspection of the expression (4.17).

Suppose now u solves $L_h u = f$ with initial data (u_0, u_1) as in (4.2). Note that the estimates (4.4) and (4.6) provide control of u on U_{ϵ}^0 for any choice of $\epsilon > 0$; thus, it suffices to prove an estimate in U_{ϵ} for any arbitrary but fixed $\epsilon > 0$. Let $\chi \in C^{\infty}(\mathbb{R})$ be a cutoff, $\chi(\rho_I) \equiv 1$ for $\rho_I < \epsilon/4$ and $\chi(\rho_I) \equiv 0$ for $\rho_I > \epsilon/2$, and put $\tilde{u} := \chi u$, then \tilde{u} solves the forward problem

$$L_h \widetilde{u} = \widetilde{f} := \chi f + [L_h, \chi] u \tag{4.19}$$

in U_{ϵ} , with $\|\widetilde{f}\|_{\rho_0^{a_0}\rho_I^{a_I-1}H_{\rm b}^{k-1}(U_{\epsilon})} + \|\pi_0\widetilde{f}\|_{\rho_0^{a_0}\rho_I^{a_I'-1}H_{\rm b}^{k-1}(U_{\epsilon})}$ controlled by the corresponding norm of f plus the right hand sides of (4.4) and (4.6). (Use Lemma 3.9 to compute the rough form of the commutator term.) Note that $\widetilde{u} = \chi u$ is the *unique* solution of $L_h\widetilde{u} = \widetilde{f}$ vanishing in $\rho_I > \frac{1}{2}\epsilon$. See Figure 4.2.

Thus, the estimate (4.3) of u in U_{ϵ} is a consequence of the following result (dropping the tilde on \widetilde{u} and \widetilde{f}):

Proposition 4.7. For weights $b_0, b_I', b_I, a_0, a_I', a_I$, and for $h \in \mathcal{X}^{\infty}$, small in \mathcal{X}^3 , as in Theorem 4.2, and for $k \in \mathbb{N}$, let $f \in \rho_0^{a_0} \rho_I^{a_I-1} H_{\mathrm{b}}^{k-1}(U_{\epsilon})$, $\pi_0 f \in \rho_0^{a_0} \rho_I^{a_I'-1} H_{\mathrm{b}}^{k-1}(U_{\epsilon})$; suppose f vanishes in $\rho_I > \frac{1}{2}\epsilon$. Let u denote the unique forward solution of $L_h u = f$. Then

$$||u||_{\rho_0^{a_0}\rho_I^{a_I}H_{\mathcal{J},\mathbf{b}}^{1,k-1}(U_{\epsilon})} + ||\pi_0 u||_{\rho_0^{a_0}\rho_I^{a_I'}H_{\mathcal{J},\mathbf{b}}^{1,k-1}(U_{\epsilon})}$$

$$\leq C\Big(||f||_{\rho_0^{a_0}\rho_I^{a_I-1}H_{\mathbf{b}}^{k-1}(U_{\epsilon})} + ||\pi_0 f||_{\rho_0^{a_0}\rho_I^{a_I'-1}H_{\mathbf{b}}^{k-1}(U_{\epsilon})}\Big).$$

$$(4.20)$$

Proof. The idea is to exploit the decoupling of the leading terms of L_h at \mathscr{I}^+ given by equations (3.25a)–(3.25c): this allows us to prove an energy estimate (for the case k=1)

$$\|\pi_0 u\|_{\rho_0^{a_0} \rho_I^{a_I'} H_{\mathscr{I}}^1} \le C(\|\pi_0 f\|_{\rho_0^{a_0} \rho_I^{a_I'} - 1_{L_b^2}} + \|\pi_0^c u\|_{\rho_0^{a_0} \rho_I^{a_I - \delta} H_{\mathscr{I}}^1}), \tag{4.21}$$

where $\delta > 0$ fixed such that

$$a'_{I} - b'_{I} < a_{I} - \delta, \quad a_{I} < a'_{I} - \delta.$$
 (4.22)

The estimate (4.21) contains $\pi_0^c u$ as an error term, but with a weaker weight due to the decay of the coefficients of the error term \widetilde{L}_h —which is dropped in (3.25a). On the other hand, $\pi_0 u$ couples into $\pi_0^c u$ via at most logarithmic terms, hence we can prove

$$\|\pi_0^c u\|_{\rho_0^{a_0} \rho_I^{a_I} H^1_{\mathscr{I}}} \le C \left(\|\pi_0^c f\|_{\rho_0^{a_0} \rho_I^{a_I - 1} L^2_{\mathbf{b}}} + \|\pi_0 u\|_{\rho_0^{a_0} \rho_I^{a_I + \delta} H^1_{\mathscr{I}}} \right) \tag{4.23}$$

Close to \mathscr{I}^+ , the last term in the estimate (4.21), resp. (4.23), is controlled by a *small* constant times the left hand side of (4.23), resp. (4.21), hence summing the two estimates yields the full estimate (4.20). The proof of (4.23) and its higher regularity version will itself consist of two steps, corresponding to the weak null structure expressed by the decoupling of (3.25b) and (3.25c).

All energy estimates will use the vector field

$$V_1 = -(1+c_V)\rho_I\partial_{\rho_I} + \rho_0\partial_{\rho_0}$$

from Lemma 4.4, with $c_V > 0$ chosen according to Lemma 4.5. Denote $u_0 := \pi_0 u$, $u_{11} := \pi_{11} u$, $u_{11}^c := \pi_{11}^c u$, and $u_0^c := \pi_0^c u = u_{11} + u_{11}^c$. We expand $L_h u = f$ as

$$\pi_0 L_h \pi_0 u_0 = \pi_0 f - \pi_0 L_h \pi_0^c u_0^c, \tag{4.24a}$$

$$\pi_{11}^c L_h \pi_{11}^c u_{11}^c = \pi_{11}^c f - \pi_{11}^c L_h \pi_0 u_0 - \pi_{11}^c L_h \pi_{11} u_{11}, \tag{4.24b}$$

$$\pi_{11}L_h\pi_{11}u_{11} = \pi_{11}f - \pi_{11}L_h\pi_0u_0 - \pi_{11}L_h\pi_{11}^c u_{11}^c. \tag{4.24c}$$

Here, we regard $\beta^*K_0 \to M$ as a vector bundle in its own right, and u_0 as a section of β^*K_0 : the inclusion $K_0 \hookrightarrow S^{2 \text{ sc}}T^*\overline{\mathbb{R}^4}$ and the structures on the latter bundle induced by g or g_m play no role; likewise for K_{11} and K_{11}^c .

Starting the proof of the estimate (4.21) using equation (4.24a), let us abbreviate $L := \pi_0 L_h \pi_0$. By Lemma 3.8 and recalling the definition of $A_{\rm CD}$ from equation (3.25a), we have

$$L = L^{0} + \widetilde{L}, \quad L^{0} = -2\rho^{-2}\partial_{0}\partial_{1} + L_{1}^{0}, \quad L_{1}^{0} = -\rho^{-1}A_{\text{CD}}\partial_{1},$$
 (4.25)

with \widetilde{L} lying in the same space as \widetilde{L}_h in (3.24) with β^*S^2 replaced by β^*K_0 . Here, L_1^0 denotes a fixed representative in $\rho_I^{-1} \cdot {}^0 \mathcal{M}_{\beta^*K_0}$, defined by fixing a representative of $\rho_0^{-1} \partial_1 \in {}^0 \mathcal{M}_{\beta^*K_0}$, see equation (2.39), in the image space of Lemma 2.7(3). Let $w = \rho_0^{-a_0} \rho_I^{-a'_I}$; let further $\mathbb{1}_{U_{\epsilon}}$ denote the characteristic function of U_{ϵ} . Fix $V \in {}^0 \mathcal{M}_{\beta^*K_0}$, with scalar principal symbol equal to that of V_1 . Let

$$W:=\mathbb{1}_{U_{\epsilon}}W^{\circ}, \quad W^{\circ}:=w^{2}V.$$

Fix a positive definite fiber inner product $B \colon {}^{\mathrm{b}}TM \to {}^{\mathrm{b}}T^*M$ on ${}^{\mathrm{b}}TM$, a connection $d \in \mathrm{Diff}^1(\overline{\mathbb{R}^4}; K_0, T^*\overline{\mathbb{R}^4} \otimes K_0)$ on K_0 , and a positive definite fiber metric k_0 on K_0 with respect to which $A_{\mathrm{CD}} = A_{\mathrm{CD}}^*$; note here that A_{CD} is constant on the fibers of \mathscr{I}^+ , hence indeed descends to an endomorphism of $K_0|_{S^+}$. (Strictly speaking, the self-adjointness of A_{CD} can only be arranged if $\gamma_2 \neq 2\gamma_1$: equality would cause a non-trivial Jordan block in (3.25a). However, even if $\gamma_2 = 2\gamma_1$, one could still make $A_{\mathrm{CD}} - A_{\mathrm{CD}}^*$ arbitrarily small, which is sufficient for subsequent arguments.) Let $\langle \cdot, \cdot \rangle$ denote the L^2 inner product with respect to k_0 and the density $|dg_{\mathrm{b}}| \sim |\frac{d\rho_0}{\rho_0} d\rho_I d\phi|$; defining the b-density $d\mu_{\mathrm{b}} := \rho_I^{-1} |dg_{\mathrm{b}}| \sim |\frac{d\rho_0}{\rho_0} \frac{d\rho_I}{\rho_I} d\phi|$ to define $L_{\mathrm{b}}^2(M)$, we then have

$$\langle u, v \rangle = \langle \rho_I u, v \rangle_{L^2_b}.$$

We shall evaluate

Let K_W denote the current associated with the scalar principal part of W, see (4.8), now understood as taking values in the bundle $S^2 \,{}^{\mathrm{b}}TM \otimes \mathrm{End}(\beta^*K_0)$, acting on β^*K_0 by scalar multiplication. While K_W provides positivity of \mathcal{C} near \mathscr{I}^+ for suitable weights by Lemma 4.4—in particular, this would require $a_I' < 0$ —we will show around (4.34) below how to obtain a better result by exploiting the sign of A_{CD} entering through $(L^* - L)W$.

In the proof of Proposition 4.3, where we worked in a global trivialization, all terms of W and L other than the top order ones could be treated as error terms; we show that the same is true here by patching together estimates obtained from calculations in local coordinates and trivializations. Thus, let $\{\mathcal{U}_j\}$ be a covering of a neighborhood of S^+ containing U_{ϵ} by open sets on which K_0 is trivial, and let $\{\chi_j\}$, $\chi_j \in \mathcal{C}_c^{\infty}(\mathcal{U}_j)$, denote a subordinate partition of unity; let $\widetilde{\chi}_j \in \mathcal{C}_c^{\infty}(\mathcal{U}_j)$, $\widetilde{\chi}_j \equiv 1$ on supp χ_j . Fix trivializations $(K_0)|_{\mathcal{U}_j} \cong \mathcal{U}_j \times \mathbb{C}^4$ and the induced trivializations of β^*K_0 . Write

$$L = L_{j,2} + L_{j,1}, \quad W = W_{j,1} + W_{j,0},$$

where $L_{j,2} := \frac{1}{2} \square_{g_b}$ acts component-wise as the scalar wave operator and $L_{j,1}$ is a first order operator, while $W_{j,1} := \mathbb{1}_{U_{\epsilon}} w^2 V_1$ acts component-wise, and $W_{j,0} \in \mathbb{1}_{U_{\epsilon}} w^2 \rho_I \mathcal{C}^{\infty}(\mathcal{U}_j, {}^{\beta}TM)$, with the extra factor of ρ_I due to the choice of V. On $(K_0)|_{\mathcal{U}_j}$, let moreover d_j denote the standard connection, given component-wise as the exterior derivative on functions, and let k_j denote the standard Hermitian fiber metric; we denote adjoints with respect to k_j by \dagger . Now,

$$\langle \mathcal{C}u_0, u_0 \rangle = \sum \langle \mathcal{C}_j u_0, \chi_j u_0 \rangle,$$
 (4.28)

where

$$\mathcal{C}_j = \sum_{k,\ell} \mathcal{C}_{j,k\ell}, \quad \mathcal{C}_{j,k\ell} := L_{j,k}^* W_{j,\ell} + W_{j,\ell}^* L_{j,k}.$$

The usual calculation in the scalar case, see the discussion around (4.7), gives

$$\underline{C}_{j,21} := L_{j,2}^{\dagger} W_{j,1} + W_{j,1}^{\dagger} L_{j,2} = d_{j}^{\dagger} B K_{W} d_{j},$$

so

$$\langle \mathcal{C}_{j,21}u_0, \chi_j u_0 \rangle = \langle d^*BK_W du_0, \chi_j u_0 \rangle + \langle (\mathcal{C}_{j,21} - \underline{\mathcal{C}}_{j,21})u_0, \chi_j u_0 \rangle$$

$$+ \langle (d_j^{\dagger} - d_j^*)BK_W d_j u_0, \chi_j u_0 \rangle + \langle (d_j^*BK_W d_j - d^*BK_W d)u_0, \chi_j u_0 \rangle.$$

$$(4.29)$$

Summing the first term over j yields

$$\int_{U_{\epsilon}} \rho_I K_{W^{\circ}}(du_0, du_0) d\mu_{\mathbf{b}} + \int T(\rho_I \nabla \mathbb{1}_{U_{\epsilon}}, W^{\circ})(du_0, du_0) d\mu_{\mathbf{b}}$$

$$\tag{4.30}$$

upon application of the formula (4.9). The first summand—after adding the term (4.34) below—is negative definite, controlling derivatives of u_0 as in (4.21); the second term gives a contribution of the same sign: we have

$$T(\rho_I \nabla \mathbb{1}_{U_{\epsilon}}, W^{\circ}) = \delta_{U_{\epsilon}^{\partial}} \otimes w^2 T^{\partial},$$

with $T^{\partial} \leq 0$ since $-\nabla \mathbb{1}_{U_{\epsilon}}$ and W° are future causal. The remaining terms in (4.29) are error terms: the second term is equal to

$$\langle W_{j,1}u_0, (L_{j,2} - L_{j,2}^{\dagger *})\chi_j u_0 \rangle + \langle L_{j,2}u_0, (W_{j,1} - W_{j,1}^{\dagger *})\chi_j u_0 \rangle.$$

Now, k_0 and k_j are related by $k_j(\cdot, \cdot) = k_0(\widetilde{Q}_j \cdot, \widetilde{Q}_j \cdot)$, with $\widetilde{Q}_j \in \mathcal{C}^{\infty}(\mathcal{U}_j; \operatorname{End}(K_0))$ invertible, and then $A^{\dagger} = Q_j^{-1} A^* Q_j$ for $Q_j := \widetilde{Q}_j^* \widetilde{Q}_j$ when A is an operator acting on sections of K_0 .

Thus, $W_{j,1} - W_{j,1}^{\dagger *} = [W_{j,1}, Q_j^*](Q_j^{-1})^*$. On M, the constancy of Q_j , and hence of Q_j^* , along the fibers of β and $V_1 \in {}^0\mathcal{M}$ give the extra vanishing factor ρ_I in

$$W_{j,1} - W_{i,1}^{\dagger *} = \mathbb{1}_{U_{\epsilon}} \rho_I w^2 q_{j,1}, \quad q_{j,1} \in \mathcal{C}^{\infty}(\beta^{-1}(\mathcal{U}_j); \operatorname{End}(\beta^* K_0)),$$

with $q_{j,1}$ only depending on Q_j . Similarly, $L_{j,2} - L_{j,2}^{\dagger *} = [L_{j,2}, Q_j^*](Q_j^{-1})^*$; using Lemma 3.7 and $[\partial_1, Q_j^*] \in \rho \mathcal{C}^{\infty}$, we find (replacing the weight -0 there by $-1/2 + b_I'$ for definiteness)

$$L_{j,2} - L_{j,2}^{\dagger *} \in \rho_0^{1+b_0} \rho_I^{-1+b_I'} H_b^{\infty}(M) \mathcal{M}_{\beta^* K_0} + (\mathcal{C}^{\infty} + \rho_0^{1+b_0} \rho_I^{-1/2+b_I'} H_b^{\infty}) \text{Diff}_b^1(\mathcal{U}_j; \beta^* K_0). \tag{4.31}$$

Writing $L_{i,2}u_0 = Lu_0 - L_{i,1}u_0$ and using the relationship (4.26), we thus get

$$|\langle (\mathcal{C}_{j,21} - \underline{\mathcal{C}}_{j,21}) u_0, \chi_j u_0 \rangle| \leq C \|\widetilde{\chi}_j w V_1 u_0\|_{L_b^2} (\|\widetilde{\chi}_j \rho_I^{b_I'} w u_0\|_{H_b^1} + \|\widetilde{\chi}_j \rho_I^{1/2 + b_I'} w u_0\|_{H_b^1}) + C (\|\widetilde{\chi}_j \rho_I w L u_0\|_{L_b^2} + \|\widetilde{\chi}_j \rho_I w L_{j,1} u_0\|_{L_b^2}) \|\widetilde{\chi}_j \rho_I w u_0\|_{L_b^2},$$

$$(4.32)$$

where the norms are taken on U_{ϵ} . Note that in all terms on the right, at least one factor comes with an extra decaying power of ρ_I relative to wu_0 , hence is *small* compared to wu_0 if we localize to U_{ϵ} for small $\epsilon > 0$, i.e. to a small neighborhood of \mathscr{I}^+ . Next, we combine Lemmas 2.10 and 4.4 in the same fashion as in the proof of Lemma 2.11 to estimate the last two terms of (4.29) by

$$C(\|\widetilde{\chi}_{j}\rho_{I}wu_{0}\|_{H_{b}^{1}}\|\chi_{j}wu_{0}\|_{L_{b}^{2}} + (\|\widetilde{\chi}_{j}\rho_{I}wT^{\partial}(du_{0},du_{0})^{1/2}\|_{L_{b}^{2}(U_{\epsilon}^{\partial})} + \|\widetilde{\chi}_{j}\rho_{I}wu_{0}\|_{L_{b}^{2}(U_{\epsilon}^{\partial})})\|\chi_{j}wu_{0}\|_{L_{b}^{2}(U_{\epsilon}^{\partial})});$$

$$(4.33)$$

where the second term in the inner parenthesis comes from the pointwise estimate $T^{\partial}(d_j u_0, d_j u_0)^{1/2} \leq C(T^{\partial}(du_0, du_0)^{1/2} + |u_0|)$.

The next interesting term in (4.28) is $C_{j,11} + C_{j,10}$, specifically the term coming from the 'constraint damping part' L_1^0 defined in (4.25). In a local trivialization, $L_1^0 = -\rho^{-1}A_{\rm CD}\partial_1 + L_{1,j}^0$, $L_{1,j}^0 \in \mathcal{C}^{\infty}(\mathcal{U}_j)$ (using the discussion around (2.39) for this membership), so we have the pointwise equality

$$2\operatorname{Re} k_0(Wu_0, L_1^0\chi_j u_0) = -2\operatorname{Re} k_0(W_{j,1}u_0, \rho^{-1}A_{CD}\partial_1\chi_j u_0) + 2\operatorname{Re} k_0(W_{j,0}u_0, L_1^0\chi_j u_0) + 2\operatorname{Re} k_0(W_{j,1}u_0, L_{1,j}^0\chi_j u_0);$$

letting

$$K' := -2w^{2}(V_{1} \otimes_{s} \rho^{-1}\partial_{1}) \otimes A_{\mathrm{CD}}$$

$$\in \rho_{0}^{-2a_{0}} \rho_{I}^{-2a'_{I}-1} \mathcal{C}^{\infty} \left(U_{\epsilon}; (S^{2}{}^{\beta}TM + \rho_{I} S^{2}{}^{b}TM) \otimes \mathrm{End}(\beta^{*}K_{0}) \right),$$

the first term integrates to $\int \rho_I K'(d_j u_0, d_j \chi_j u_0) d\mu_b$, which equals

$$\int \rho_I K'(du_0, d\chi_j u_0) d\mu_b \tag{4.34}$$

plus error terms of the same kind as in the second line of (4.29). The extra factor of ρ_I in $W_{j,0}$ and $L_{1,j}^0$ (as compared to $W_{j,1}$ and L_1^0) allows the remaining two terms to be estimated in a fashion similar to (4.32). The remaining contributions to $C_{j,11} + C_{j,10}$ are error terms coming from \widetilde{L} in (4.25) and can be estimated as in (4.32).

Lastly, the terms of (4.28) involving $C_{i,20}$ can be rewritten and estimated as follows:

$$|2\operatorname{Re}\langle (L-L_{j,1})u_0, W_{j,0}\chi_j u_0\rangle + \langle W_{j,0}u_0, [L_{j,2}, \chi_j]u_0\rangle|$$

$$\leq 2 \left(\|\rho_I w L u_0\|_{L_{\mathbf{b}}^2} + \|\widetilde{\chi}_j \rho_I w L_{j,1} u_0\|_{L_{\mathbf{b}}^2} \right) \|\chi_j \rho_I w u_0\|_{L_{\mathbf{b}}^2} \\ + \|\widetilde{\chi}_j \rho_I w u_0\|_{L_{\mathbf{b}}^2} \left(\|\widetilde{\chi}_j \rho_I^{b_I'} w u_0\|_{H_{\mathbf{b}}^1} + \|\widetilde{\chi}_j \rho_I^{1/2 + b_I'} w u_0\|_{H_{\mathbf{b}}^1} \right);$$

the norms are taken on U_{ϵ} , and we use that $[L_{j,2}, \chi_j]$ lies in the same space as (4.31). We note that by Lemma 3.8, the terms involving $L_{j,1}$ here and in (4.32) can be estimated by

$$\|\widetilde{\chi}_{j}\rho_{I}wL_{j,1}u_{0}\|_{L_{\mathbf{h}}^{2}} \leq C(\|\bar{\chi}_{j}\rho_{I}^{b_{I}'}wu_{0}\|_{H_{\mathbf{h}}^{1}} + \|\bar{\chi}_{j}\rho_{I}^{1/2+b_{I}'}wu_{0}\|_{H_{\mathbf{h}}^{1}}),$$

where $\bar{\chi}_j \in \mathcal{C}_c^{\infty}(\mathcal{U}_j)$ is identically 1 on supp $\tilde{\chi}_j$.

This finishes the evaluation of (4.27); we now turn to the estimate of wu_0 itself by wVu. As in the proof of Proposition 4.3, this follows from integration along V. Concretely, we consider a 'commutator' as in (4.11), that is,

$$2\operatorname{Re}\langle \mathbb{1}_{U_{\epsilon}} w V u_0, \rho_I^{-1} w u_0 \rangle = -\langle \rho_I^{-1} \operatorname{div}_{g_b} (\mathbb{1}_{U_{\epsilon}} w^2 V_1) u_0, u_0 \rangle + E, \tag{4.35}$$

where $|E| \leq C \|wu_0\|_{L^2_b} \|\rho_I wu_0\|_{L^2_b}$ by Lemma 2.12. Using the negativity of the divergence near \mathscr{I}^+ due to Lemma 4.4 and Remark 4.6, and that V_1 is outward pointing at U^{∂}_{ϵ} , so $V_1(\mathbb{1}_{U_{\epsilon}})$ is a negative δ -distribution at U^{∂}_{ϵ} , we get

$$||wu_0||_{L^2_{\mathbf{h}}(U_{\epsilon})} + ||wu_0||_{L^2_{\mathbf{h}}(U_{\epsilon}^{\partial})} \le C||wVu_0||_{L^2_{\mathbf{h}}(U_{\epsilon})}; \tag{4.36}$$

recall here that u_0 vanishes in $\rho_I > \frac{\epsilon}{2}$, hence there is no a priori control term on the right. Subtracting this estimate from (4.27) (the latter having main terms which are negative definite in du_0), the main terms are the left hand side of (4.36) and $\int_{U_{\epsilon}} \rho_I(K' + K_{W^{\circ}})(du_0, du_0) d\mu_b$ from (4.30) and (4.34). By Lemma 4.5, they control $||wu_0||_{H^1_{\mathscr{I}}(U_{\epsilon})}$: the error terms in U_{ϵ} can be absorbed into this, while those at U_{ϵ}^{∂} in (4.33) can be absorbed into the second terms of (4.30) and (4.36), due to the extra decaying weights on at least one of the factors in each of those error terms as discussed after (4.32). Thus, we have proved

$$||u_0||_{\rho_0^{a_0}\rho_I^{a_I'}H^{1}_{\mathscr{Z}}} \le C(||\pi_0 f||_{\rho_0^{a_0}\rho_I^{a_I'-1}L_b^2} + ||\pi_0 L_h \pi_0^c u_0^c||_{\rho_0^{a_0}\rho_I^{a_I'-1}L_b^2}), \tag{4.37}$$

valid for $a_I' < \min(a_0, \gamma)$. Since L_h is principally scalar, $\pi_0 L_h \pi_0^c$ is a first order operator, and by Lemma 3.8, we have

$$\pi_0 L_h \pi_0^c \in \rho_0^{1-0} \rho_I^{-1+b_I'} \mathcal{M}_{\beta^* K_0} + (\mathcal{C}^{\infty} + \rho_0^{1-0} \rho_I^{-0} H_b^{\infty}) \operatorname{Diff}_b^1(M; \beta^* K_0); \tag{4.38}$$

since $a_I' < a_I + b_I' < a_I + \frac{1}{2}$, the second term in (4.37) is bounded by $\|u_0^c\|_{\rho_0^{a_0}\rho_I^{a_I-\delta}H_{\mathscr{I}}^1}$ for sufficiently small $\delta > 0$ (by the assumptions on the weights in Theorem 4.2), which establishes the estimate (4.21).

The proof of the estimate (4.23) proceeds along completely analogous lines, using the weight $w = \rho_0^{-a_0} \rho_I^{-a_I}$ and positive commutator estimates for the equations (4.24b) and (4.24c). The main difference is that $\pi_{11} L_h \pi_{11}$ and $\pi_{11}^c L_h \pi_{11}^c$ have no leading order subprincipal terms like $\pi_0 L_h \pi_0$ does, hence we need $a_I < \min(a_0, 0)$ for K_{w^2V} to have a sign—this is the case $a_I' = a_I$, $\gamma = 0$ in the notation of Lemma 4.5. In order to estimate the coupling terms on the right hand side of (4.24b), we use Lemma 3.8, so

$$\pi_{11}^{c} L_{h} \pi_{0} \in (\rho_{I}^{-1} \mathcal{C}^{\infty} + \rho_{0}^{1-0} \rho_{I}^{-1-0} H_{b}^{\infty}) \mathcal{M} + (\mathcal{C}^{\infty} + \rho_{0}^{1-0} \rho_{I}^{-0} H_{b}^{\infty}) \operatorname{Diff}_{b}^{1},$$

$$\pi_{11}^{c} L_{h} \pi_{11} \in \rho_{0}^{1-0} \rho_{I}^{-1+b_{I}'} \mathcal{M} + (\mathcal{C}^{\infty} + \rho_{0}^{1-0} \rho_{I}^{-0}) \operatorname{Diff}_{b}^{1},$$

$$(4.39)$$

which gives

$$\|u_{11}^c\|_{\rho_0^{a_0}\rho_I^{a_I}H_{\mathscr{I}}^1} \le C(\|\pi_{11}^c f\|_{\rho_0^{a_0}\rho_I^{a_I-1}L_{\mathsf{b}}^2} + \|u_0\|_{\rho_0^{a_0}\rho_I^{a_I+\delta}H_{\mathscr{I}}^1} + \|u_{11}\|_{\rho_0^{a_0}\rho_I^{a_I-\delta}H_{\mathscr{I}}^1}); \tag{4.40}$$

for our choice (4.22) of δ , the second term is bounded by a *small* constant times the left hand side of (4.21). For analyzing the equation (4.24c) for u_{11} , we observe that $\pi_{11}L_h\pi_0$ lies in the space (4.39), while

$$\pi_{11}L_h\pi_{11}^c \in \left(\rho_0^{1+b_0}\rho_I^{-1}H_{\mathbf{b}}^{\infty}(\mathscr{I}^+ \cap U_{\epsilon}) + \rho_0^{1-0}\rho_I^{-1+b_I}H_{\mathbf{b}}^{\infty}\right)\mathcal{M} + (\mathcal{C}^{\infty} + \rho_0^{1-0}\rho_I^{-0}H_{\mathbf{b}}^{\infty})\mathrm{Diff}_{\mathbf{b}}^1,$$

where we exploit that $h^{\bar{a}\bar{b}}$ has a leading term at \mathscr{I}^+ . Thus,

$$||u_{11}||_{\rho_0^{a_0}\rho_I^{a_I}H_{\mathscr{I}}^1} \le C' (||\pi_{11}f||_{\rho_0^{a_0}\rho_I^{a_I-1}L_{\mathsf{b}}^2} + ||u_0||_{\rho_0^{a_0}\rho_I^{a_I-\delta}H_{\mathscr{I}}^1} + ||u_1^c||_{\rho_0^{a_0}\rho_I^{a_I}H_{\mathscr{I}}^1}). \tag{4.41}$$

In order to obtain the estimate (4.23), we add (4.40) and a small multiple, η , of (4.41), so that $\eta C' < 1$ and u_{11}^c can be absorbed into the left hand side of (4.40); note that the u_{11} term in (4.40) is arbitrarily small compared to the left hand side of (4.41) when we localize sufficiently closely to \mathscr{I}^+ . As explained at the beginning of the proof, this establishes the desired estimate (4.20) for k=1.

To prove (4.20) for $k \geq 2$, we proceed by induction on the level of the hierarchy (4.24a)–(4.24c) and the corresponding estimates (4.21), (4.40), and (4.41). The key structures for obtaining higher regularity are the symmetries of the normal operators of $\pi_0 L_h \pi_0$ etc. at \mathscr{I}^+ . Namely, $-2\rho^{-2}\partial_0\partial_1 \in \partial_{\rho_I}(\rho_0\partial_{\rho_0} - \rho_I\partial_{\rho_I}) + \mathrm{Diff}_b^2$ commutes (modulo Diff_b^2) with $\rho_0\partial_{\rho_0}$, while for the vector field $\rho_I\partial_{\rho_I}$ generating dilations along approximate (namely, Schwarzschildean) light cones, we have

$$[-2\rho^{-2}\partial_0\partial_1, \rho_I\partial_{\rho_I}] \in -2\rho^{-2}\partial_0\partial_1 + \text{Diff}_b^2.$$

Commutation with spherical vector fields is more subtle: we need to define rotation 'vector fields' somewhat carefully. We only define these on β^*K_0 , the definition for the other bundles being analogous. Using the product splitting $\mathbb{R}_q \times \mathbb{R}_s \times \mathbb{S}^2$ of \mathbb{R}^4 near S^+ , denote by $\{\Omega_{1,i}\colon i=1,2,3\}\subset \mathcal{V}(\mathbb{S}^2)\hookrightarrow \mathcal{V}_{\mathrm{b}}(M)$ a spanning set the space of vector fields on \mathbb{S}^2 , e.g. rotation vector fields, though the concrete choice or their (finite) number, is irrelevant; we can then define elements $\Omega_i\in\mathrm{Diff}^1_{\mathrm{b}}(M;\beta^*K_0)$ with scalar principal symbols equal to those of $\Omega_{1,i}$ such that

$$[\rho^{-1}\partial_0, \Omega_i], \ [\rho_0^{-1}\partial_1, \Omega_i] \in \rho_I \operatorname{Diff}_{b}^{1}(M; \beta^* K_0),$$
 (4.42)

where $\rho^{-1}\partial_0$, $\rho_0^{-1}\partial_1$ denote elements in ${}^0\mathcal{M}_{\beta^*K_0}$. (Note that the $\rho_I\mathcal{C}^{\infty}$ indeterminacy of $\rho^{-1}\partial_0$, $\rho_0^{-1}\partial_1$ does not affect (4.42).) Here, it is crucial that we fix ρ_0 and ρ to be given by (2.23) and thus rotationally invariant: $\Omega_{i,1}\rho_0=0$, so $[\Omega_i,\rho_0]\in\rho_I\mathcal{C}^{\infty}$; we also have $[\Omega_i,\rho_I]\in\rho_I\mathcal{C}^{\infty}$ independently of choices. Regarding (4.42) then, we automatically have membership in Diff¹_b by principal symbol considerations; to get the additional vanishing at ρ_I is then exactly the statement that the normal operators of $\rho^{-1}\partial_0$, resp. $\rho_0^{-1}\partial_1$, and Ω_i commute. For $\rho^{-1}\partial_0$, whose normal operator is $-\frac{1}{2}\rho_I\partial_{\rho_I}$, this is automatic, while for $\rho_0^{-1}\partial_1$, we merely need to arrange $[\rho_0\partial_{\rho_0},\Omega_i]=0$ at \mathscr{I}^+ , which holds if we define Ω_i in the decomposition (3.10) by $\Omega_{1,i}\oplus\nabla_{\Omega_{1,i}}\oplus\Omega_{1,i}$. We therefore obtain

$$[-2\rho^{-2}\partial_0\partial_1,\Omega_i], [L^0,\Omega_i] \in \text{Diff}_b^2,$$

with L^0 given in (4.25), which improves over the a priori membership in $\rho_I^{-1}\text{Diff}_b^2$. Let us now assume that for the solution of equation (4.24a), we have already established the

estimate

$$\|u_0\|_{\rho_0^{a_0}\rho_I^{a_I'}H_{\mathscr{I},\mathbf{b}}^{1,k-1}} \le C(\|\pi_0 f\|_{\rho_0^{a_0}\rho_I^{a_I'-1}H_{\mathbf{b}}^{k-1}} + \|\pi_0^c u\|_{\rho_0^{a_0}\rho_I^{a_I-\delta}H_{\mathscr{I},\mathbf{b}}^{1,k-1}}). \tag{4.43}$$

We use $\{G_j\} := \{\rho_0 \partial_{\rho_0}, \rho_I \partial_{\rho_I}, \ \Omega_1, \ \Omega_2, \ \Omega_3, \ 1\}$, which spans $\operatorname{Diff}^1_b(M; \beta^* K_0)$ over $\mathcal{C}^{\infty}(M)$, as a set of commutators. Writing $L = \pi_0 L_h \pi_0$, we then have

$$LG_j u_0 = f_j + [L, G_j] u_0, \quad f_j := G_j \pi_0 f - G_j \pi_0 L_h \pi_0^c u_0^c. \tag{4.44}$$

We estimate the first term by

$$||f_j||_{\rho_0^{a_0}\rho_I^{a_I'-1}H_b^{k-1}} \le C(||\pi_0 f||_{\rho_0^{a_0}\rho_I^{a_I'-1}H_b^k} + ||\pi_0^c u||_{\rho_0^{a_0}\rho_I^{a_I-\delta}H_{\mathscr{I},k}^{1,k}}).$$

For the second, delicate, term, we use the above discussion to see that

$$[L, G_j] \in c_j L + \rho_0^{1-0} \rho_I^{-1+b_I'} \mathcal{M} \circ \text{Diff}_b^1 + (\mathcal{C}^\infty + \rho_0^{1-0} \rho_I^{-0}) \text{Diff}_b^2$$
 (4.45)

with $c_j = 1$ if $G_j = \rho_I \partial_{\rho_I}$, and $c_j = 0$ otherwise. Thus, $[L, G_j] = c_j L + C_j^{\ell} G_{\ell}$ with $C_j^{\ell} \in \rho_0^{1-0} \rho_I^{-1+b_I'} \mathcal{M} + (\mathcal{C}^{\infty} + \rho_0^{1-0} \rho_I^{-0}) \text{Diff}_b^1$, and therefore

$$\|[L,G_j]u_0\|_{\rho_0^{a_0}\rho_I^{a_I'-1}H_{\mathbf{b}}^{k-1}} \le c_j\|Lu_0\|_{\rho_0^{a_0}\rho_I^{a_I'-1}H_{\mathbf{b}}^{k-1}} + C\sum_{\ell}\|G_{\ell}u_0\|_{\rho_0^{a_0}\rho_I^{a_I-\delta-\delta'}H_{\mathscr{I},\mathbf{b}}^{1,k-1}}$$
(4.46)

for $\delta' > 0$ small; recall that our choice (4.22) of δ leaves some extra room. Now, applying (4.43) to $G_j u_0$ in equation (4.44) and summing over j, we can absorb the term (4.46) into the left hand side of the estimate due to the weaker weight. This establishes (4.43) for k replaced by k+1. The higher regularity analogues of the estimates (4.40) and (4.41) are proved in the same manner; as before, this then yields the estimate (4.20) for all k.

This proposition remains valid near any compact subset of $\mathscr{I}^+ \setminus i^+$: the proof only required localization near \mathscr{I}^+ . At this point, we therefore have quantitative control of the solution of the initial value problem for $L_h u = f$ in any compact subset of $M \setminus i^+$.

4.2. Estimate near timelike infinity. Near the corner $i^+ \cap \mathscr{I}^+$, fix the local defining functions

$$\rho_I := v = (t - r_*)/r, \quad \mathring{\rho}_+ := (t - r_*)^{-1}$$
(4.47)

of \mathscr{I}^+ and i^+ , and let $\rho := \rho_I \mathring{\rho}_+ = r^{-1}$; these only differ from the expressions for the defining functions ρ_I and ρ_0 used in §4.1 by a sign. We thus have $G_b = \rho^{-2}G = G_{0,b} + G_{1,b} + \widetilde{G}_b$ for

$$G_{0,\mathbf{b}} = -2\partial_{\rho_I}(\rho_I \partial_{\rho_I} - \mathring{\rho}_+ \partial_{\mathring{\rho}_+}) - \mathcal{G} \in \rho_I^{-1} \mathcal{C}^{\infty}(M; S^{2\beta}TM + \rho_I S^{2\mathbf{b}}TM)$$
(4.48)

and $G_{1,\mathbf{b}} \in \mathcal{C}^{\infty}(M; S^{2\;\beta}TM), \ \widetilde{G}_{\mathbf{b}} \in \rho_I^{-1+b_I'} \rho_+^{1+b_+} H_{\mathbf{b}}^{\infty}(M; S^{2\;\beta}TM + \rho_I \, S^{2\;\mathbf{b}}TM), \ \text{while}$

$$g_{\rm b} \in (\mathcal{C}^{\infty} + \rho_I^{b_I'} \rho_+^{1+b_+} H_{\rm b}^{\infty})(M; S^2({}^{\beta}TM)^{\perp} + \rho_I S^2 {}^{\rm b}T^*M)$$

with smooth term given by $\rho^2 g_m = 2\rho_I \frac{d\mathring{\rho}_+}{\mathring{\rho}_+} (\frac{d\mathring{\rho}_+}{\mathring{\rho}_+} + \frac{d\rho_I}{\rho_I}) + \rho_I^2 \mathcal{C}^{\infty}(M; S^2 \, {}^{\mathrm{b}}T^*M)$. In order to be able to work near *all of* i^+ , we first prove:

Lemma 4.8. There exists a defining function $\rho_+ \in \mathcal{C}^{\infty}(M)$ of i^+ such that $d\rho_+/\rho_+$ is past timelike near i^+ for the dual b-metric $\rho^{-2}g_m^{-1}$. Moreover, if C > 0 is fixed, then for any $h \in \mathcal{X}^{\infty}$ with $||h||_{\mathcal{X}^3} < C$ and for any $\epsilon > 0$, there exists $\delta > 0$ such that $d\rho_+/\rho_+$ is past timelike with $|d\rho_+/\rho_+|_{G_b}^2 > 0$ in $\{\rho_I \geq \epsilon, \ \rho_+ \leq \delta\}$ for the dual b-metric $G_b = \rho^{-2}g^{-1}$, $g = g_m + \rho h$.

Proof. For the second claim, note that in $\rho_I \geq \epsilon > 0$, we have $G_b - \rho^{-2} g_m^{-1} \in \rho_+^{1+b_+} L^{\infty}$ with norm controlled by $||h||_{\mathcal{X}^3}$, so

$$|d\rho_{+}/\rho_{+}|_{G_{b}}^{2} \in |d\rho_{+}/\rho_{+}|_{\rho^{-2}g_{m}^{-1}}^{2} + \rho_{+}^{1+b_{+}}H_{b}^{\infty}$$

$$(4.49)$$

is indeed positive near $\rho_+=0$. To prove the first claim, we compute on Minkowski space $|f_0^{-1}df_0|^2\equiv 1,\ f_0=t/(t^2-r^2)$ in t>r, computed with respect to the dual metric of $t^{-2}(dt^2-dr^2).^{28}$ Similarly, in $r/t>\frac{1}{4}$, and $t>r_*$ large, we have $|f_*^{-1}df_*|^2_{\rho^{-2}g_m}>0$ for $f_*=t/(t^2-r_*^2)$: this is a simple calculation where $g_m=g_m^S$ is the Schwarzschild metric, and follows in general by an estimate similar to (4.49) since g_m differs from g_m^S by a scattering metric of class $\rho^{1-0}H_{\rm b}^\infty$ in $r/t<\frac{3}{4}$. Moreover, f_* is (apart from minor smoothness issues, which we address momentarily) a defining function of i^+ near \mathscr{I}^+ . But $f_0-f_*\in\rho^{2-0}H_{\rm b}^\infty$ for $r/t\in(\frac{1}{4},\frac{3}{4})$, hence $f':=\chi f_*+(1-\chi)f_0$ has $|(f')^{-1}df'|^2_{\rho^{-2}g_m}>0$ near i^+ , where $\chi=\chi(r/t)$ is smooth and identically 0, resp. 1, in $r/t<\frac{1}{4}$, resp. $r/t>\frac{3}{4}$. Fixing any defining function ρ'_+ of i^+ , Lemma 2.2 implies $f'\in\rho'_+\mathcal{C}^\infty(M)+(\rho'_+)^{2-0}H_{\rm b}^\infty(M)$ (with the non-smooth summand supported away from \mathscr{I}^+ by construction), so we may take $\rho_+\in\mathcal{C}^\infty(M)$ to be any defining function of i^+ such that $f'-\rho_+\in(\rho'_+)^{2-0}H_{\rm b}^\infty$. \square

For the remainder of this section, ρ_+ will denote this particular defining function. Near $i^+ \cap \mathscr{I}^+$, we need to modify ρ_+ in the spirit of (4.15) in order to get a timelike (but not quite smooth) boundary defining function. Thus, fix $\beta \in (0, b_I')$ and some small $\eta > 0$, and let $p_\beta \in \rho_I^\beta \mathcal{C}^\infty(U)$ be a non-negative function in a neighborhood U of i^+ such that $p_\beta \equiv \eta^\beta$ in $\rho_I \geq 2\eta$, $p_\beta(\rho_I) = \rho_I^\beta$ in $\rho_I \leq \frac{1}{2}\eta$, and $0 \leq p_\beta' \leq \beta \rho_I^{\beta-1}$; let then

$$\widetilde{\rho}_{+} := \rho_{+}(1 + p_{\beta}) \in \rho_{+}(1 + \rho_{I}^{\beta}) \, \mathcal{C}^{\infty}(M).$$
(4.50)

It is easy to see that $\widetilde{\rho}_+^{a_+}H_{\rm b}^k(M)=\rho_+^{a_+}H_{\rm b}^k(M)$, likewise for weighted $H_{\mathscr{I}}$ and $H_{\mathscr{I},{\rm b}}$ spaces.

Lemma 4.9. Fix C>0. Then there exist $\eta,\delta>0$ such that for all $h\in\mathcal{X}^{\infty}$ with $\|h\|_{\mathcal{X}^3}< C$, we have $|d\widetilde{\rho}_+/\widetilde{\rho}_+|_{G_{\mathrm{b}}}^2>0$ in $\rho_+\leq\delta$.

Proof. We compute the $G_{\rm b}$ -norms

$$\left|\frac{d\widetilde{\rho}_{+}}{\widetilde{\rho}_{+}}\right|^{2} = \left|\frac{d\rho_{+}}{\rho_{+}}\right|^{2} + \frac{\rho_{I}p_{\beta}'}{1+p_{\beta}}\left(2\left\langle\frac{d\rho_{+}}{\rho_{+}},\frac{d\rho_{I}}{\rho_{I}}\right\rangle + \frac{\rho_{I}p_{\beta}'}{1+p_{\beta}}\left|\frac{d\rho_{I}}{\rho_{I}}\right|^{2}\right). \tag{4.51}$$

In $\rho_I < 2\eta$ and thus near \mathscr{I}^+ , we first note that $\rho_+ = f\mathring{\rho}_+$ with f > 0 smooth; since df/f thus vanishes at $\mathscr{I}^+ \cap i^+$ as a b-1-form, we have

$$2\left\langle \frac{d\rho_+}{\rho_+}, \frac{d\rho_I}{\rho_I} \right\rangle \in (2 + \rho_I \mathcal{C}^{\infty} + \rho_+ \mathcal{C}^{\infty}) \rho_I^{-1} + \rho_I^{-1+b'_I} \rho_+^{1+b_+} H_b^{\infty},$$

thus the second summand of (4.51) is $\gtrsim \rho_I^{-1+\beta}$ in $\rho_I \leq \frac{1}{2}\eta$ and ρ_+ small. The first and third terms on the other hand are dominated by this, as they are bounded by $\rho_I^{-1+b_I'}$ and $\rho_I^{-1+2\beta}$, respectively. In $\frac{1}{2}\eta < \rho_I < 2\eta$ and ρ_+ small, the parenthesis in (4.51) is positive, the second summand being bounded by $\rho_I^{-1+\beta}$; the prefactor being positive due to $p_\beta' \geq 0$, the claimed positivity thus follows from Lemma 4.8.

²⁸See also the related calculations and geometric explanations around equation (4.63).

We also note that $\rho_+\partial_{\rho_+}$, which is well-defined as a b-vector field at i^+ and equals the scaling vector field in $(i^+)^{\circ}$, is past timelike in $(i^+)^{\circ}$. Let

$$U = {\widetilde{\rho}_+ < \delta} \subset M$$

denote the neighborhood of $i^+ \subset M$ on which we will formulate our energy estimate. Near \mathscr{I}^+ , we need to exploit the weak null structure as in §4.1; thus, let

$$\chi \in \mathcal{C}_c^{\infty}([0,\infty)_{\rho_I}), \quad \chi \equiv 1 \text{ near } \rho_I = 0,$$
(4.52)

denote a smooth function on U localizing in a neighborhood of \mathscr{I}^+ where the projections π_0 etc. are defined, see the discussion around Definition 3.4.

Proposition 4.10. For weights b'_I , b_I , b_+ , a'_I , a_I as in Theorem 4.2, there exists $a_+ \in \mathbb{R}$ such that for all $h \in \mathcal{X}^{\infty}$ which are small in \mathcal{X}^3 , the following holds: Let $f \in \rho_I^{a_I-1}\rho_+^{a_+}H_{\rm b}^{k-1}(U)$, $\chi \pi_0 f \in \rho_I^{a'_I-1}\rho_+^{a_+}H_{\rm b}^{k-1}(U)$, and suppose f vanishes in $\widetilde{\rho}_+ > \frac{1}{2}\delta$. Let u denote the unique forward solution of $L_h u = f$. Then

$$\|u\|_{\rho_{I}^{a_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}(U)} + \|\chi\pi_{0}u\|_{\rho_{I}^{a'_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}(U)}$$

$$\leq C\Big(\|f\|_{\rho_{I}^{a_{I}-1}\rho_{+}^{a_{+}}H_{b}^{k-1}(U)} + \|\chi\pi_{0}f\|_{\rho_{I}^{a'_{I}-1}\rho_{+}^{a_{+}}H_{b}^{k-1}(U)}\Big).$$

$$(4.53)$$

Proof. We first consider k=1. Near ∂i^+ , we will make use of the vector field $V_0'=(1-c_V)\rho_I\partial_{\rho_I}-\mathring{\rho}_+\partial_{\mathring{\rho}_+},\ c_V>0$ small, analogously to Lemma 4.4; away from ∂i^+ , the vector field $V_0'':=-\nabla\rho_+/\rho_+$ is future timelike. Fix $a_+^0\le -\frac12$ and consider the vector field $V_I:=\rho_I^{-2a_I}\mathring{\rho}_+^{-2a_+^0}V_0'$, then

$$K_{V_{I}} \in \rho_{I}^{-2a_{I}-1} \mathring{\rho}_{+}^{-2a_{+}^{0}} \left(2c_{V} (a_{+}^{0} - a_{I})(\rho_{I} \partial_{\rho_{I}})^{2} + 2a_{I} (\rho_{I} \partial_{\rho_{I}} - \mathring{\rho}_{+} \partial_{\mathring{\rho}_{+}}^{*})^{2} + \left(\frac{1}{2} (1 - c_{V}) + a_{+}^{0} - a_{I} + c_{V} a_{I} \right) \rho_{I} \mathcal{G} \right)$$

$$+ \rho_{I}^{-2a_{I}} \rho_{+}^{-2a_{+}^{0}} (\mathcal{C}^{\infty} + \rho_{I}^{-1+b'_{I}} \rho_{+}^{1+b_{+}})(M; S^{2} \beta TM + \rho_{I} S^{2} b TM)$$

is $\lesssim -\rho_I^{-2a_I-1}\rho_+^{-2a_+^0}$ as a quadratic form, and $\operatorname{div}_{g_b}V_I\lesssim -\rho_I^{-2a_I}\rho_+^{-2a_+^0}$. Analogously to Lemma 4.5, if $V_I'=\rho_I^{-2a_I'}\mathring{\rho}_+^{-2a_+^0}V_0'$, then $K_{V_I'}-2\gamma V_I'\otimes_s\rho^{-1}\partial_1$ is negative definite near ∂i^+ for $c_V>0$ sufficiently small.

To explain the idea for obtaining a global (near i^+) negative commutator, consider the timelike vector field $W_0 := \chi V_I + (1-\chi)\rho_+^{-2a_+^0}V_0''$, and let $W = \widetilde{\rho}_+^{-2a_+^1}W_0$; then formula (4.9) gives

$$K_W = \widetilde{\rho}_+^{-2a_+^1} K_{W_0} + 2a_+^1 \widetilde{\rho}_+^{-2a_+^1} T(W_0, -\frac{\nabla \widetilde{\rho}_+}{\widetilde{\rho}_+}). \tag{4.54}$$

Letting

$$a_+ := a_+^0 + a_+^1,$$

the first term gives control in $\rho_I^{a_I}\rho_+^{a_+}H_{\mathscr{I}}^1$ near \mathscr{I}^+ in a positive commutator argument. On the other hand, its size is bounded by a fixed constant times $\rho_+^{-2a_+}$ in $\rho_I \geq \epsilon > 0$; but there, $T(W_0, -\frac{d\tilde{\rho}_+}{\tilde{\rho}_+}) \gtrsim \rho_+^{-2a_+^0}$ in the sense of quadratic forms on ${}^{\rm b}T^*M$ since W_0 and $-d\tilde{\rho}_+/\tilde{\rho}_+$ are both future timelike. Therefore, choosing a_+^1 large and negative, we obtain

$$K_W \le -C\rho_I^{-2a_I-1}\rho_+^{-2a_+}K_W',$$

where K'_W is positive definite on ${}^bT^*M$ in $\rho_I \geq \epsilon > 0$, while near \mathscr{I}^+ , we have $K'_W = K_1 + \rho_I K_2$, with K_1 , resp. K_2 , positive definite on ${}^bT^*M$, resp. $({}^{\beta}TM)^{\perp}$. This gives global (near i^+) control in $\rho_I^{a_I} \rho_+^{a_I} H_{\mathscr{I}}^1$.

We now apply this discussion to the situation at hand. For brevity, let us use the same symbol to denote a b-vector field in ${}^{0}\mathcal{M}$ and an arbitrary but fixed representative in ${}^{0}\mathcal{M}_{\beta^{*}E}$ according to Lemma 2.7(3), similarly for b-vector fields with weights (such as V_{I} and V'_{I}); the bundle $E \to \overline{\mathbb{R}^{4}}$ will be clear from the context. For $a_{+}^{1} \in \mathbb{R}$ chosen later, consider then the operator W acting on sections of $\beta^{*}S^{2}$,

$$W := \widetilde{\rho}_{+}^{-2a_{+}^{1}} W_{0}, \quad W_{0} := \chi \left(\pi_{0} V_{I}^{\prime} \pi_{0} + \pi_{11}^{c} V_{I} \pi_{11}^{c} + \eta \pi_{11} V_{I} \pi_{11} \right) + (1 - \chi) \rho_{+}^{-2a_{+}^{0}} V_{0}^{\prime\prime}, \quad (4.55)$$

where $\eta > 0$ will be taken small, as in the discussion after (4.41). (Since u vanishes in $\rho_+ > \frac{1}{2}\delta$, we do not need to include a cutoff term here.) 'Integrating' along W via a commutator calculation for $2 \operatorname{Re}\langle Wu, \rho_I^{-1}u \rangle$ as in (4.35) gives control on u in the function space appearing in (4.6) in terms of Wu. The evaluation of the commutator $2 \operatorname{Re}\langle L_h u, Wu \rangle = \langle \mathcal{C}u, u \rangle$, $\mathcal{C} = [L_h, W] + (W + W^*)L_h + (L_h^* - L_h)W$, then combines the three separate calculations for the equations (4.24a)–(4.24c) into one: near \mathscr{I}^+ , one writes L_h in block form according to the bundle decomposition $\beta^*S^2 = K_0 \oplus K_{11}^c \oplus K_{11}$, with the diagonal elements $\pi_0 L_h \pi_0$ etc. giving rise to the main terms of the commutator, while the off-diagonal terms can be estimated using Cauchy–Schwarz and absorbed into the main terms due to the weak null structure, as explained in detail in the proof of Proposition 4.7. Away from \mathscr{I}^+ , all error terms can be absorbed in the main term, corresponding to the second term in (4.54) upon choosing $a_+^1 < 0$ negative enough. This proves the proposition for k = 1.

Suppose now we have proved (4.53) for some $k \ge 1$. First, the b-operator L_h automatically commutes with $\rho_+\partial_{\rho_+}$ to leading order at i^+ ; concretely, Lemma 3.8 gives

$$[L_h, \rho_+ \partial_{\rho_+}] \in \rho_I^{-1+b'_I} \rho_+^{1+b_+} \mathcal{M}_{\beta^* S^2}^2 + (\rho_+ \mathcal{C}^{\infty} + \rho_I^{-0} \rho_+^{1+b_+} H_b^{\infty}) \text{Diff}_b^2.$$

Here, by an abuse of notation, $\rho_+\partial_{\rho_+} \in {}^0\mathcal{M}_{\beta^*S^2}$ is defined by first extending the vector field $\rho_+\partial_{\rho_+} \in \mathcal{C}^{\infty}(i^+, {}^bT_{i^+}M)$ to an element of ${}^0\mathcal{M}_{\mathbb{C}}$, and then taking a representative of the image space in Lemma 2.7(3); for this particular vector field, such a representative is in fact well-defined modulo $\rho_I\rho_+\mathcal{C}^{\infty}(M;\operatorname{End}(\beta^*S^2))$, the extra vanishing at ρ_+ being due to the special (b-normal) nature of $\rho_+\partial_{\rho_+}$.

Therefore, commuting $\rho_+\partial_{\rho_+}$ through the equation $L_hu=f$, we have the estimate

$$\|\rho_{+}\partial_{\rho_{+}}u\|_{\rho_{I}^{a_{I}}\rho_{+}^{a_{+}}H_{\mathscr{S},b}^{1,k-1}} + \|\chi\pi_{0}\rho_{+}\partial_{\rho_{+}}u\|_{\rho_{I}^{a_{I}'}\rho_{+}^{a_{+}}H_{\mathscr{S},b}^{1,k-1}}$$

$$\leq C\left(\|f\|_{\rho_{I}^{a_{I}-1}\rho_{+}^{a_{+}}H_{b}^{k}} + \|\chi\pi_{0}f\|_{\rho_{I}^{a_{I}'-1}\rho_{+}^{a_{+}}H_{b}^{k}} + \|u\|_{\rho_{I}^{a_{I}-\delta}\rho_{+}^{a_{+}-(1+b_{+})}H_{\mathscr{S},b}^{1,k}}\right)$$

$$(4.56)$$

by the inductive hypothesis, where we used $a_I - \delta > a_I' - b_I'$ for $\delta > 0$ small to bound the forcing term $[L_h, \rho_+ \partial_{\rho_+}]u$ by the third term on the right; see the related discussion around (4.38).

Second, the timelike character of $\rho_+\partial_{\rho_+}$ at $(i^+)^\circ$ for $\epsilon>0$ implies that $C(\rho_+D_{\rho_+})^2-L_h$ is *elliptic* in $\rho_I\geq\epsilon$ for large C (depending on ϵ); therefore, letting $\chi_j\in\mathcal{C}_c^\infty(U\setminus\mathscr{I}^+)$, j=1,2, denote cutoffs with $\chi_1\equiv 1$ on $\mathrm{supp}(1-\chi)$ and $\chi_2\equiv 1$ on $\mathrm{supp}\,\chi_1$, we have an elliptic estimate away from \mathscr{I}^+ ,

$$\|\chi_1 u\|_{\rho_+^{a_+} H_{\mathbf{b}}^{k+1}} \le C \left(\|\chi_2 \rho_+ \partial_{\rho_+} u\|_{\rho_+^{a_+} H_{\mathbf{b}}^k} + \|\chi_2 u\|_{\rho_+^{a_+} H_{\mathbf{b}}^k} + \|\chi_2 f\|_{\rho_+^{a_+} H_{\mathbf{b}}^{k-1}} \right), \tag{4.57}$$

for u supported in $\rho_+ \leq \frac{1}{2}\delta$. Near \mathscr{I}^+ on the other hand, we have the symmetries of null infinity at our disposal, encoded by the operators $\rho_I \partial_{\rho_I}$ and the spherical derivatives Ω_j , see the discussion around (4.42). Let $\widetilde{\chi} \in \mathcal{C}^{\infty}(U)$ be identically 1 on supp χ , and supported close to \mathscr{I}^+ . Defining the set of (cut-off) commutators $\{\chi G_j\} := \{\chi \rho_I \partial_{\rho_I}, \ \chi \Omega_1, \ \chi \Omega_2, \ \chi \Omega_3\}$ which together with $\rho_+ \partial_{\rho_+}$ spans $\mathcal{V}_b(M)$ near \mathscr{I}^+ , and recalling the commutation relations (4.45), we find

$$\|\chi G_{j}u\|_{\rho_{I}^{a_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}} + \|\chi \pi_{0}G_{j}u\|_{\rho_{I}^{a'_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}}$$

$$\leq C\Big(\|f\|_{\rho_{I}^{a_{I}-1}\rho_{+}^{a_{+}}H_{b}^{k}} + \|\chi \pi_{0}f\|_{\rho_{I}^{a'_{I}-1}\rho_{+}^{a_{+}}H_{b}^{k}} + \|\tilde{\chi}\rho_{+}\partial_{\rho_{+}}u\|_{\rho_{I}^{a_{I}-\delta}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}} + \|\tilde{\chi}\rho_{+}\partial_{\rho_{+}}u\|_{\rho_{I}^{a_{I}-\delta}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}}\Big). \tag{4.58}$$

But for any $\eta > 0$, we have the estimate

$$\|\widetilde{\chi}G_{\ell}u\|_{\rho_{I}^{a_{I}-\delta}\rho_{+}^{a_{+}}H_{\mathscr{I},\mathbf{b}}^{1,k-1}} \leq \eta \|\chi G_{\ell}u\|_{\rho_{I}^{a_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},\mathbf{b}}^{1,k-1}} + C_{\eta} \|\chi_{1}u\|_{\rho_{+}^{a_{+}}H_{\mathbf{b}}^{k+1}},$$

and the second term can in turn be estimated using (4.57). Summing the estimate (4.58) over j and fixing $\eta > 0$ sufficiently small, we can thus absorb the terms involving $\widetilde{\chi}G_{\ell}u$ into the left hand side, getting control by the norm of f, plus a control term $C\|\rho_{+}\partial_{\rho_{+}}u\|_{\rho_{+}^{a_{+}}H_{b}^{k}}$. Adding to this estimate 2C times (4.56), this control term can be absorbed in the left hand side of (4.56). This gives control of u as in the left hand side of (4.53) with k replaced by k+1, but with an extra term on the right coming from the last term in (4.56); however, this term has a weaker weight at i^{+} , $\rho_{+}^{a_{+}-(1-b_{+})} \gg \rho_{+}^{a_{+}}$, hence can be absorbed. This gives (4.53) for k replaced by k+1.

Combining the estimate (4.4) in compact subsets of M° with Proposition 4.3 near $(i^{0})^{\circ}$, Proposition 4.7 near $\mathscr{I}^{+} \setminus (\mathscr{I}^{+} \cap i^{+})$, and Proposition 4.10 near i^{+} proves Theorem 4.2.

4.3. Explicit weights for the background estimate. We sketch the calculations needed to obtain explicit values for the weights in the background estimate. More precisely, we prove the following slight modification of Theorem 4.2:

Theorem 4.11. Let $a_+ = -\frac{3}{2}$. There exists an $\epsilon > 0$ such that for $a_I < \bar{a}_I < a'_I < \min(0, a_0)$ with $|a_I|$, $|a'_I|$, $|\bar{a}_I|$, b_I , $b'_I < \gamma_1$, $\gamma_2 < \epsilon$ subject to the conditions in Definition 3.1, as well for $h \in \mathcal{X}^{\infty;b_0,b_I,b'_I,b_+}$ with $||h||_{\mathcal{X}^3} < \epsilon$, the unique global solution of the linear wave equation

$$L_h u = f$$
, $(u, \partial_{\nu} u)|_{\Sigma} = (u_0, u_1)$

satisfies the estimate

$$\|u\|_{\rho_{0}^{a_{0}}\rho_{I}^{a_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}} + \|\pi_{11}^{c}u\|_{\rho_{0}^{a_{0}}\rho_{I}^{\bar{a}_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}} + \|\pi_{0}u\|_{\rho_{0}^{a_{0}}\rho_{I}^{a'_{I}}\rho_{+}^{a_{+}}H_{\mathscr{I},b}^{1,k-1}}$$

$$\leq C\Big(\|u_{0}\|_{\rho_{0}^{a_{0}}H_{b}^{k}} + \|u_{1}\|_{\rho_{0}^{a_{0}}H_{b}^{k-1}} + \|\pi_{11}^{c}f\|_{H_{b}^{k-1;a_{0},\bar{a}_{I}-1,a_{+}}} + \|\pi_{0}f\|_{H_{b}^{k-1;a_{0},a'_{I}-1,a_{+}}} \Big).$$

$$(4.59)$$

Proof. The usage of an intermediate weight $\bar{a}_I \in (a_I, a_I')$ allows for a small but useful modification of the argument following (4.41): namely, in the notation of that proof, we are presently estimating u_{11} with weight $\rho_I^{a_I}$, while the term u_{11}^c coupling into the equation

for u_{11} via $\pi_{11}L_h\pi_{11}^c$ is estimated with weight $\rho_I^{\bar{a}_I} \ll \rho_I^{a_I}$, hence automatically comes with a small prefactor if we work in a sufficiently small neighborhood of \mathscr{I}^+ . Correspondingly, in the proof of Proposition 4.10, we would replace the third inner summand in (4.55) by $\pi_{11}\bar{V}_I\pi_{11}$, with $\bar{V}_I = \rho_I^{-2\bar{a}_I}\mathring{\rho}_+^{-2a_+^0}V_0'$ in order to obtain (4.59) (with $a_+ \ll 0$ not explicit at this point yet).

The only part of the proof of Theorem 4.2 in which we did not get explicit control on the weights is the energy estimate near i^+ . In order to obtain the explicit weights there, we note that for $\gamma_1, \gamma_2 = 0$, h = 0, and Schwarzschild mass m = 0, we simply have $2L_h = \Box_{\underline{g}}$, the wave operator of the Minkowski metric $\underline{g} = dt^2 - dx^2$, which acts component-wise on $S^2T^*\mathbb{R}^4$ in the trivialization given by coordinate differentials. Recalling from (2.16) that 0M denotes the manifold with corners constructed in §2.1 for m = 0, we shall prove that the solution of the scalar wave equation $t^3\Box_{\underline{g}}t^{-1}u = f$, with $f \in \rho_I^{a_I-1}\rho_+^{a_+}L_b^2$ supported in $\rho_+ < 1$, satisfies the estimate

$$||u||_{\rho_I^{a_I}\rho_+^{a_+}H_{\mathscr{I}}^1} \lesssim ||f||_{\rho_I^{a_I-1}\rho_+^{a_+}L_{\mathbf{b}}^2} \tag{4.60}$$

for $a_+ = -\frac{3}{2}$ and $a_I < 0$ small, using a vector field multiplier argument; here, $\rho_I = {}^0\rho_I$ and $\rho_+ = {}^0\rho_+$. But then, if the weights a_I, a_I', \bar{a}_I etc. are very close to one another, the non-scalar commutant used in (4.55), modified as above, is very close to being principally scalar away from \mathscr{I}^+ ; correspondingly, a slight modification of our arguments below for the Minkowski case (4.60) yield the estimate (4.59) for k=1. Higher b-regularity follows as in the proof of Proposition 4.10.

In order to prove the estimate (4.60), we introduce explicit coordinates near the temporal face $i^+ \subset M$ within the blow-up of compactified Minkowski space. First of all, the calculations in A.3 imply

$$t^{3}\Box_{g}t^{-1} = \Box_{g_{dS}} - 2, (4.61)$$

where

$$g_{\rm dS} = t^{-2}(dt^2 - dx^2) \tag{4.62}$$

is the de Sitter metric; notice though that we are interested in $t \gg 1$. Thus, consider the isometry

$$(t,x) \mapsto (\hat{\tau}, \hat{x}) = \frac{1}{t^2 - r^2} (t,x) \in [0,\infty)_{\hat{\tau}} \times \mathbb{R}^3_{\hat{x}}$$




FIGURE 4.3. Left: part of the conformal embedding of Minkowski space into the Einstein universe $(E, dt^2 - g_{\mathbb{S}^3}), E = \mathbb{R} \times \mathbb{S}^3$. Right: conformal embedding of de Sitter space into E, and the backward light cone of a point q on its conformal boundary, whose interior is the domain of the upper half space model (4.62) of de Sitter space, which near q is equal to the static model of de Sitter space near its future timelike infinity, q. The coordinates $(\hat{\tau}, \hat{x})$ are regular near $q = (\hat{\tau} = 0, \hat{x} = 0)$.

 (4.63)

of g_{dS} , defined in t > r = |x|: it maps i^+ to (0,0) and \mathscr{I}^+ to $\{\hat{\tau} = |\hat{x}|\}$, see Figure 4.3. (The map (4.63) is the change of coordinates between the upper half space models of de Sitter space associated with q on the one hand and its antipodal point on the future conformal boundary of de Sitter space on the other hand; see [HiZw17, §6.1] for the relevant formulas.)

Define the blow-up $M' := [[0, \infty)_{\hat{\tau}} \times \mathbb{R}^3_{\hat{x}}, \{(0, 0)\}]$ at the image of i^+ . Then the lift of $\{\hat{\tau} \leq |\hat{x}|\}$ to M' is canonically identified with a neighborhood of $i^+ \subset M$. Concretely,

$$(\rho_+, Z) := (\hat{\tau}, \hat{x}/\hat{\tau}) = (t/(t^2 - r^2), x/t) \in [0, \infty) \times \mathbb{R}^3$$

gives coordinates on M', in which $U := [0,1)_{\rho_+} \times \{|Z| \leq 1\}$ is identified with a collar neighborhood of $i^+ \subset M$ so that

$$g_{\rm dS} = \hat{\tau}^{-2} (d\hat{\tau}^2 - d\hat{x}^2) = (1 - |Z|^2) \frac{d\rho_+^2}{\rho_+^2} - 2Z \, dZ \frac{d\rho_+}{\rho_+} - dZ^2. \tag{4.64}$$

Furthermore, $\rho_I := 1 - |Z|^2 = 1 - r^2/t^2$ is a defining function of \mathscr{I}^+ in U. Let us write R := |Z|. Instead of the vector field $V_{\text{loc}} = (1 - c_V)\rho_I \partial_{\rho_I} - \rho_+ \partial_{\rho_+}$, which is defined locally near \mathcal{I}^+ and was used in the proof of Proposition 4.10, we use the global vector field

$$V_0 = -(1+R^2)\rho_+\partial_{\rho_+} - (1-c_V)(1-R^2)R\partial_R$$

which is equal to V_{loc} near \mathscr{I}^+ , up to an overall scalar and modulo $\rho_I \mathcal{V}_b + \rho_+ \mathcal{V}_b$; moreover, V_0 is timelike in $U \setminus \mathscr{I}^+$ for small $c_V \geq 0$. Considering the commutant/vector field multiplier $W := \rho_I^{-2a_I} \rho_+^{-2a_+} V_0$ with $a_+ = -\frac{3}{2}$ and $a_I < 0$ small, the expression for the K-current K_W is somewhat lengthy, so we merely list its main features in $0 \leq R \leq 1$, writing $\rho_I^{2a_I+1} \rho_+^{2a_+} K_W =: K_1 + K \mathcal{G}$, with K_1 a section of $S^2 \langle \rho_+ \partial_{\rho_+}, \partial_R \rangle$ (considered a 2×2 matrix in this frame) and K a scalar:

- tr $K_1|_{c_V=0} = -2(1 - R^4 - a_I R^2 (4 + R^2)) < 0$, which persists for small $c_V > 0$; - det $K_1|_{c_V=0} = -4a_I (1 + a_I) R^2 (1 - R^2) \le 0$ and

$$(\partial_{c_V} \det K_1)|_{c_V=0} = -16a_I^2 (R^2 - \frac{1}{1+4a_I})(R^2 + \frac{3}{3+4a_I}) < 0,$$

so $\det K_1 < 0$ for small $c_V > 0$;

- $K|_{c_V=0} = -2(1 + a_I R^2) < 0$, which persists for small $c_V > 0$; - $\rho_I^{2a_I} \rho_+^{2a_+} \operatorname{div}_{g_{dS}} W|_{c_V=0} = 6 - (2 - 4a_I)R^2 > 0$.

Thus, fixing $c_V > 0$ to be small, the main term arising in the evaluation of the commutator $-2\operatorname{Re}\langle(\Box_{g_{\mathrm{dS}}}-2)u,Wu\rangle$ is $\int_{U}-K_{W}(du,du)+4(\operatorname{div}_{g_{\mathrm{dS}}}W)|u|^{2}\frac{d\rho_{+}}{\rho_{+}}dZ$, which thus gives the desired control on u in $H^1_{\mathscr{I}}$, except $|u|^2$ itself is only controlled in $\rho_I^{a_I}\rho_+^{a_+-1/2}L_{\rm b}^2$ due to the weaker weight of ${\rm div}_{g_{\rm dS}}W$ at \mathscr{I}^+ ; control in $\rho_I^{a_I}\rho_+^{a_+}L_{\rm b}^2$ is obtained by integrating $\rho_+\partial_{\rho_+}u\in \mathscr{I}^{a_1}$ $\rho_I^{a_I} \rho_+^{a_+} L_b^2$ from $\rho_+ = 1$. This yields (4.60).

5. Newton Iteration

Fix b_0 , b_I , b'_I , b_+ , γ_1 , and γ_2 as in Theorem 4.2. Recall that we want to solve the symmetric 2-tensor-valued wave equation

$$P(h) = 0, (h, \partial_{\nu} h)|_{\Sigma} = (h_0, h_1)$$

for initial data (h_0, h_1) , $h_j \in \rho_0^{b_0} H_b^{\infty}(\Sigma)$, small in a suitable high regularity norm, and we hope to find a solution $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$. Following the strategy, outlined in §1, of solving a linearized equation at each step of an iteration scheme, we consider, formally, the iteration scheme with initialization

$$L_0 h^{(0)} = 0, \ (h^{(0)}, \partial_{\nu} h^{(0)})|_{\Sigma} = (h_0, h_1),$$

and iterative step $h^{(N+1)} = h^{(N)} + u^{(N+1)}$, where

$$L_{h^{(N)}}u^{(N+1)} = -P(h^{(N)}), (h^{(N+1)}, \partial_{\nu}h^{(N+1)})|_{\Sigma} = 0.$$

Assume that $h^{(N)} \in \mathcal{X}^{\infty}$ has small \mathcal{X}^3 norm. In order for this iteration scheme to close, we need to show that $h^{(N+1)} \in \mathcal{X}^{\infty}$. Since $P(h^{(N)}) \in \mathcal{Y}^{\infty}$ by Lemma 3.5, this means that we need to prove:

Theorem 5.1. For weights as above, there exists $\epsilon > 0$ such that for $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ with $||h||_{\mathcal{X}^3} < \epsilon$, the following holds: if $f \in \mathcal{Y}^{\infty;b_0,b_I,b_I',b_+}$ and $h_0,h_1 \in \rho_0^{b_0}H_b^{\infty}(\Sigma)$, then the solution of the initial value problem

$$L_h u = f$$
, $(u, \partial_{\nu} u)|_{\Sigma} = (u_0, u_1)$,

satisfies $u \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$.

According to Theorem 4.2, we have the background estimate

$$u \in H_{\mathbf{b}}^{\infty;b_0,-0,a_+}(M;\beta^*S^2), \quad \pi_0 u \in H_{\mathbf{b}}^{\infty;b_0,b'_I-0,a_+}(M;\beta^*S^2),$$
 (5.1)

for suitable a_+ . We shall improve this to $u \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ using normal operator analysis in several steps, which were outlined around (1.19): using the leading order form (3.24) of L_h , or rather its decoupled versions (3.25a)–(3.25c), we obtain the precise behavior of u near $\mathscr{I}^+ \setminus (\mathscr{I}^+ \cap i^+)$ in §5.1 by simple ODE analysis; the correct weight at i^+ but losing some precision at \mathscr{I}^+ near its future boundary in §5.2 by normal operator analysis and a contour shifting argument; and finally the precise behavior near \mathscr{I}^+ , uniformly up to $\mathscr{I}^+ \cap i^+$, again by ODE analysis in §5.3.

For later use, we record the mapping properties of P and its linearization on the polyhomogeneous and conormal parts of \mathcal{X}^{∞} —recall (3.9).

Lemma 5.2. Let $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$, with $||h||_{\mathcal{X}^3}$ small; write $h = h_{\text{phg}} + h_{\text{b}}$, $h_{\text{phg}} \in \mathcal{X}_{\text{phg}}^{\infty}$, $h_{\text{b}} \in \mathcal{X}_{\text{b}}^{\infty}$. Then: (1) $P(h_{\text{phg}}) \in \mathcal{Y}^{\infty}$, (2) $L_h^0 \colon \mathcal{X}_{\text{phg}}^{\infty} \to \mathcal{Y}^{\infty}$, (3) L_h^0 , $\widetilde{L}_h \colon \mathcal{X}_{\text{b}}^{\infty} \to \mathcal{Y}_{\text{b}}^{\infty}$, (4) $\widetilde{L}_h \colon \mathcal{X}_{\text{phg}}^{\infty} \to \mathcal{Y}_{\text{b}}^{\infty}$.

The point is that the behavior (2)–(3) of the leading term L_h^0 and simple information (1) on the non-linear operator automatically imply precise mapping properties (4) of the error term \widetilde{L}_h which are not encoded in (3.24).

Proof of Lemma 5.2. Part (1) follows from Lemma 3.5. One obtains (2) by inspection of (3.24); note that L_h^0 is only well-defined modulo terms in $(\mathcal{C}^{\infty} + \rho_0^{1+b_0} \rho_I^{-0} \rho_+^{1+b_+} H_b^{\infty}) \text{Diff}_b^1$ which always map $\mathcal{X}_{\text{phg}}^{\infty} \to \mathcal{Y}^{\infty}$. Likewise, the first part of (3) follows from (3.24); the fact that the 'good components' (encoded by the bundle K_0) have a better weight b_I' than the weight b_I of the remaining components (in K_0^c) is again due to the structure of L_h^0 discussed after Lemma 3.8. The second part of (3) is clear, since this concerns the remainder operator \widetilde{L}_h , whose coefficients are decaying relative to $\rho_I^{-1} \text{Diff}_b^2$, acting on \mathcal{X}_b^{∞} , which consists of tensors decaying at \mathscr{I}^+ .

Finally, to prove (4), we take $u_{\text{phg}} \in \mathcal{X}_{\text{phg}}^{\infty}$ and write $\widetilde{L}_h u_{\text{phg}} = D_h P(u_{\text{phg}}) - L_h^0 u_{\text{phg}}$. The second term lies in \mathcal{Y}^{∞} by (2), while the first term equals

$$\frac{d}{ds}P(h_{\text{phg}} + su_{\text{phg}} + h_{\text{b}})\big|_{s=0}$$

$$= \frac{d}{ds}\left(P(h_{\text{phg}} + su_{\text{phg}}) + \int_{0}^{1} L_{h_{\text{phg}} + su_{\text{phg}} + th_{\text{b}}}^{0}(h_{\text{b}}) + \widetilde{L}_{h_{\text{phg}} + su_{\text{phg}} + th_{\text{b}}}(h_{\text{b}}) dt\right)\Big|_{s=0};$$

but each of the three terms in parentheses depends smoothly on s as an element of \mathcal{Y}^{∞} by (1), (2), and (3), respectively.

5.1. Asymptotics near $i^0 \cap \mathscr{I}^+$. With conormal regularity of u at our disposal, all but the leading order terms of L_h can be regarded as error terms at \mathscr{I}^+ : from (5.1) and Lemma 3.8, we get

$$L_h^0 u \in \mathcal{Y}^{\infty;b_0,b_I,b_I',b_+} + H_b^{\infty;b_0,-1+b_I'-0,a_+}.$$

Let us now work in a neighborhood $U \subset M$ of $i^0 \cap \mathscr{I}^+$ and drop the weight at i^+ from the notation. To improve the asymptotics of $u_{11}^c := \pi_{11}^c u$, we use part (3.25b) of the constraint damping/weak null structure hierarchy as well as $b_I' > b_I$: this gives

$$2\rho^{-2}\partial_0\partial_1 u_{11}^c \in \rho_0^{b_0}\rho_I^{b_I-1}H_b^{\infty}.$$

Using the local defining functions ρ_0 and ρ_I from (2.23) and multiplying by ρ_I , this becomes

$$\rho_I \partial_{\rho_I} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) u_{11}^c \in \rho_0^{b_0} \rho_I^{b_I} H_b^{\infty}. \tag{5.2}$$

We can integrate the second vector field from $\rho_I \geq \epsilon$, where $u_{11}^c \in \rho_0^{b_0} H_b^{\infty}$, obtaining $\rho_I \partial_{\rho_I} u_{11}^c \in \rho_0^{b_0} \rho_I^{b_I} H_b^{\infty}$; this uses $b_I < b_0$ (see Lemma 7.7 for details). Integrating out $\rho_I \partial_{\rho_I}$ (see Lemma 7.6) shows that u_{11}^c is the sum of a leading term in $\rho_0^{b_0} H_b^{\infty}(\mathscr{I}^+ \cap U)$ and a remainder in $\rho_0^{b_0} \rho_I^{b_I} H_b^{\infty}(U)$. This then couples into the equation for $u_{11} = \pi_{11} u$, corresponding to part (3.25c) of the hierarchy:

$$\rho_I \partial_{\rho_I} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) u_{11} \in \rho_I \pi_{11} f - \frac{1}{2} (\partial_1 h^{\bar{a}\bar{b}}) \partial_1 (u_{11}^c)_{\bar{a}\bar{b}} + \rho_0^{b_0} \rho_I^{b_I} H_b^{\infty}. \tag{5.3}$$

The first two summands lie in $\rho_0^{b_0} H_{\rm b}^{\infty}(\mathscr{I}^+ \cap U) + \rho_0^{b_0} \rho_I^{b_I} H_{\rm b}^{\infty}$; integrating this along $\rho_I \partial_{\rho_I}$ generates the logarithmic leading term of u_{11} . Thus, $u_{11} = u_{11}^{(1)} \log \rho_I + u_{11}^{(0)} + u_{11,\rm b}$ with $u_{11}^{(j)} \in \rho_0^{b_0} H_{\rm b}^{\infty}(\mathscr{I}^+ \cap U)$ and $u_{11,\rm b} \in \rho_0^{b_0} \rho_I^{b_I} H_{\rm b}^{\infty}$, as desired.

It remains to improve $u_0 = \pi_0 u$. Write $u = u_{\rm phg} + u_{\rm b}$, where $u_{\rm phg} \in \mathcal{X}_{\rm phg}^{\infty}$ and $u_{\rm b} \in \rho_0^{b_0} \rho_I^{b_I} H_{\rm b}^{\infty}$ according to what we have already established; note that the space $\mathcal{X}_{\rm phg}^{\infty}$ is independent of the choice of $b_I, b_I' \in (0, 1)$. Then

$$\pi_0 L_h^0 \pi_0 u_0 = \pi_0 f - \pi_0 \widetilde{L}_h(\pi_0 u_0) - \pi_0 \widetilde{L}_h(\pi_0^c u_b) - \pi_0 \widetilde{L}_h(\pi_0^c u_{\text{phg}}) \in \rho_0^{b_0} \rho_I^{b_I'-1} H_b^{\infty} :$$

for the first summand, this follows from $f \in \mathcal{Y}^{\infty;b_0,b_I,b_I',b_+}$, for the second summand from $u_0 \in \rho_0^{b_0} \rho_I^{b_I'-0} H_b^{\infty}$ and the decay of the coefficients of \widetilde{L}_h , similarly for the third summand; and for the fourth summand, we use Lemma 5.2(4). Using the notation of part (3.25a) of the hierarchy, this means

$$(\rho_I \partial_{\rho_I} - A_{\text{CD}})(\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) u_0 \in \rho_0^{b_0} \rho_I^{b_I} H_b^{\infty}.$$

Since we are taking $\gamma_j > b_I'$, all eigenvalues of $A_{\rm CD}$ are $> b_I'$, so integration of $\rho_I \partial_{\rho_I} - A_{\rm CD}$ and then of $\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}$ (using $b_I' < b_0$) gives $u_0 \in \rho_0^{b_0} \rho_I^{b_I'} H_{\rm b}^{\infty}$. We have thus shown that $u \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_I+}$ near $i^0 \cap \mathscr{I}^+$; in fact, this holds away from i^+ .

5.2. Asymptotics at the temporal face. We work near i^+ now and drop the weight at i^0 from the notation. Recall from (3.26) the gauge-damped operator \underline{L} on Minkowski space; by Lemma 3.9 and (3.28), we have

$$L_h - \underline{L} \in \rho_I^{-1-0} \rho_+^{1+b_+} H_b^{\infty}(M) \cdot \text{Diff}_b^2(M; \beta^* S^2).$$
 (5.4)

We shall deduce the asymptotic behavior of u at i^+ from a study of the operator \underline{L} (and its resonances) on a partial radial compactification N of \mathbb{R}^4 —without blowing up the latter at the light cone at future infinity. Before making this precise, we study \underline{L} in detail as a b-operator on N. Let

$$\tau = t^{-1}, X = x/t;$$

these are smooth coordinates on the radial compactification




FIGURE 5.1. Illustration of the compactification N near its boundary at infinity $\partial N = \{\tau = 0\}$. Shown are future timelike infinity $B = {}^0\beta({}^0i^+)$, its boundary $\partial B = S^+$, and, for illustration, the light cone |x| = t (dashed).

$$N := [0, \infty)_{\tau} \times \mathbb{R}^3_X$$

of \mathbb{R}^4 in t>0, see Figure 5.1. We have $d_X=td_x$, $t\delta_e=\delta_X$, $t\delta_e^*=\delta_X^*$, and $t\partial_t=-\tau\partial_\tau-X\partial_X$. Thus, if we trivialize $S^{2\,\mathrm{sc}}T^{*\,0}\overline{\mathbb{R}^4}$ using coordinate differentials, the explicit expression of \underline{L} given in §A.3 shows that \underline{L} is a dilation-invariant element of $\mathrm{Diff}^2_\mathrm{b}(N;\underline{\mathbb{C}}^{10})$, i.e. $\underline{L}=N(\underline{L})$, recalling the definition (2.1) of the normal operator.

Note that L_h (and even L_0) has singular coefficients at $\partial i^+ \subset {}^m M$ due to the gauge/constraint damping term: the singular terms come from $-\rho^{-1}A_h\partial_1$ in Lemma 3.8. Likewise, \underline{L} , on the blow-up of N at the light cone $\{\tau=0, |X|=1\}$ at infinity, has coefficients with ρ_I^{-1} singularities, which would complicate the normal operator analysis at the temporal face $0i^+$, the lift of

$$B:=\{\tau=0,\, |X|\le 1\},$$

On the other hand, \underline{L} does have smooth coefficients on the un-blown-up space N, and we recall its well-understood b- and normal operator analysis at ∂N momentarily. The discussion of the relation between the blown-up and the un-blown-up picture starts with Lemma 5.6 below.

Conjugating \underline{L} by the Mellin-transform in τ , thus formally replacing $\tau \partial_{\tau}$ by $i\sigma$, gives the Mellin-transformed normal operator family $\underline{\widehat{L}}(\sigma) \in \operatorname{Diff}^2(\partial N; \underline{\mathbb{C}}^{10})$, depending holomorphically on $\sigma \in \mathbb{C}$; the principal symbol of $\underline{\widehat{L}}$ is independent of σ .

We already control u in Theorem 5.1 away from $i^+ \subset M$, so only need to study u (and how \underline{L} relates to it) near $^mi^+$, whose image under the blow-down map $^m\beta$ on mM is identified with B, see Lemma 2.4. For $s \in \mathbb{R}$, we then define the function space $\dot{H}^s(B;\underline{\mathbb{C}}^{10})$ as the space of all $v \in H^s_{loc}(\partial N;\underline{\mathbb{C}}^{10})$ which are supported in B. (We are using the notation of [Hö07, Appendix B].) Let

$$\mathfrak{X}^s:=\{u\in \dot{H}^s(B;\underline{\mathbb{C}}^{10})\colon \underline{\widehat{L}}(0)u\in \dot{H}^{s-1}(B;\underline{\mathbb{C}}^{10})\},\quad \mathfrak{Y}^s:=\dot{H}^s(B;\underline{\mathbb{C}}^{10}).$$

Semiclassical Sobolev spaces are defined by $\dot{H}_h^s = \dot{H}^s$ with h-dependent norm $\|u\|_{\dot{H}_h^s} = \|\langle hD\rangle^s u\|_{L^2}$ on $\partial N \cong \mathbb{R}^3_X$. Let further $\underline{\mathcal{M}} \subset \operatorname{Diff}^1(\partial N; \underline{\mathbb{C}}^{10})$ denote the $\mathcal{C}^{\infty}(\partial N)$ -module of first order operators with principal symbol vanishing on $N^*\partial B$, and fix a finite set $\{A_i\} \subset \underline{\mathcal{M}}$ of generators.²⁹ For $k \in \mathbb{N}_0$, we then define

$$\dot{H}^{s,k}(B;\underline{\mathbb{C}}^{10}) = \{ u \in \dot{H}^s \colon A_{j_1} \cdots A_{j_\ell} u \in \dot{H}^s, \ 0 \le \ell \le k \}$$

and the semiclassical analogue $\dot{H}_h^{s,k}=\dot{H}^{s,k}$ with norm

$$||u||_{\dot{H}_{h}^{s,k}}^{2} = ||u||_{\dot{H}_{h}^{s}}^{2} + \sum_{0 \le \ell \le k} ||(hA_{j_{1}}) \cdots (hA_{j_{\ell}})u||_{\dot{H}_{h}^{s}}^{2}.$$

Lemma 5.3. Let C > 0, and fix $s < \frac{1}{2} - C$. Then $\widehat{\underline{L}}(\sigma) \colon \mathfrak{X}^s \to \mathfrak{Y}^{s-1}$ is an analytic family of Fredholm operators in $\{\sigma \in \mathbb{C} \colon \operatorname{Im} \sigma > -C\}$, with meromorphic inverse satisfying

$$\|\underline{\widehat{L}}(\sigma)^{-1}f\|_{\dot{H}^{s,k}_{\langle\sigma\rangle^{-1}}} \le C_k'\langle\sigma\rangle^{-1}\|f\|_{\dot{H}^{s-1,k}_{\langle\sigma\rangle^{-1}}}, \quad |\operatorname{Im}\sigma| \le C, \ |\operatorname{Re}\sigma| \gg 1,$$

for any $k \in \mathbb{N}_0$.

Proof. For k=0, this is almost the same statement as proved in [Va13, §5], see also [BaVaWu15] and the summary of the presently relevant results in [BaVaWu16, §6]; adding higher module regularity, i.e. $k \geq 1$, follows by a standard argument, commuting (compositions of) a well-chosen spanning set of $\underline{\mathcal{M}}$ through the equation $\widehat{\underline{L}}(\sigma)u=f$; see [BaVaWu15, Proof of Proposition 4.4] and the discussion prior to [HiVa15, Theorem 5.4] for details in the closely related b-setting (i.e. prior to conjugation by the Mellin transform). We shall thus be brief.

The only two differences between the references and the present situation are: (1) $\underline{\hat{L}}(\sigma)$ is an operator acting on a vector bundle; (2) we are working with *supported* function spaces in B, i.e. future timelike infinity, rather than globally on the boundary of the radial compactification of Minkowski space. Since $\underline{\hat{L}}(\sigma)$ is principally scalar, (1) only affects the threshold regularity at the radial set $N^*\partial B$. For $\gamma_1=\gamma_2=0$, \underline{L} is simply a conjugation of $\frac{1}{2}$ times the scalar wave operator, acting diagonally on $\underline{\mathbb{C}}^{10}$, and in this case the threshold regularity is given as $s<\frac{1}{2}+\operatorname{Im}\sigma$ in [BaVaWu16, §6], which is implied by our assumption $s<\frac{1}{2}-C$. For small $\gamma_1,\gamma_2>0$ (depending on the choice of s), this assumption is still sufficient. A straightforward calculation (which we omit) shows that the eigenvalues of $\sigma_1(t^3(\underline{\widetilde{\delta}}^*-\delta_g^*)\delta_g G_g t^{-1})|_{N^*\partial B}$ are ≥ 0 , hence the threshold regularity is $s<\frac{1}{2}+\operatorname{Im}\sigma$ for

Near ∂B , and omitting the bundle $\underline{\mathbb{C}}^{10}$, one can take as generators the vector fields $(|X|-1)X\partial_X$, $X^j\partial_{X^i}-X^i\partial_{X^j}$.

any $\gamma_1, \gamma_2 \geq 0$. (This is closely related to the fact that the components of the solution of $\underline{L}u = f \in \mathcal{C}_c^{\infty}(\mathbb{R}^4)$ do not grow at \mathscr{I}^+ ; see Lemma 5.6 below for the relation between growth/decay on M and regularity on $\overline{\mathbb{R}^4}$.)

In order to deal with (2), it is convenient to first study $\underline{\widehat{L}}(\sigma)$ acting on supported distributions on a larger ball $B_d := \{|X| \leq 1 + d\}$. The only slightly delicate part of the argument establishing the Fredholm property of $\underline{\widehat{L}}(\sigma)$ acting between $\dot{H}^s(B_2; \underline{\mathbb{C}}^{10})$ -type spaces is the adjoint estimate: we need to show that $\underline{\widehat{L}}(\sigma)^*$ satisfies an estimate

$$||u||_{\bar{H}^{1-s}(B_2^\circ)} \lesssim ||\widehat{\underline{L}}(\sigma)^* u||_{\bar{H}^{-s}(B_2^\circ)} + ||u||_{\bar{H}^{s_0}(B_2^\circ)}$$

$$\tag{5.5}$$

for some $s_0 < 1 - s$; here $\bar{H}^s(B_2^\circ)$ denotes extendible distributions, i.e. restrictions of $H^s_{\rm loc}$ sections on ∂N to B_2° . This estimate however is straightforward to obtain by combining elliptic, real principal type, and radial point estimates in B_1 , as in the references, with energy estimates for $\underline{\hat{L}}(\sigma)^*$ which is a wave operator (on the principal symbol level) in $B_2 \setminus B_{1/2}$, see e.g. [Zw16, §3.2] where our $\underline{\hat{L}}(\sigma)^*$ is denoted P. High energy estimates for $\underline{\hat{L}}(\sigma)$ on $\dot{H}^s(B_2)$ -type spaces follow by similar arguments (using [Va13, Proposition 3.8] for the energy estimate).

Suppose now $\underline{\widehat{L}}(\sigma)u = f \in \dot{H}^{s-1}(B)$ with $u \in \dot{H}^s(B_2)$. Then energy estimates in $B_2 \setminus B$ imply supp $u \subset B$. This and the Fredholm property of $\underline{\widehat{L}}$ on B_2 yield the desired Fredholm property of $\underline{\widehat{L}} : \mathfrak{X}^s \to \mathfrak{Y}^{s-1}$ (specifically, the finite codimensionality of the range). Similarly, the high energy estimates on B_2 imply those on B, finishing the proof.

Lemma 5.4. For small $\gamma_1, \gamma_2 \geq 0$, all resonances $\sigma \in \mathbb{C}$ of \underline{L} satisfy $\operatorname{Im} \sigma < 0$.

Remark 5.5. One can in fact compute the divisor of \underline{L} , i.e. the set of $(z,k) \in \mathbb{C} \times \mathbb{N}_0$ such that $\underline{\widehat{L}}(\sigma)^{-1}$ has a pole of order $\geq k+1$ at $\sigma=z$, quite explicitly for any γ_1, γ_2 : it is contained in $-i \overline{\cup} -2i \overline{\cup} -i(1+\gamma_1) \overline{\cup} -i(1+\gamma_1+\gamma_2)$, using the shorthand notation (2.32).

Proof of Lemma 5.4. For $\gamma_1 = \gamma_2 = 0$, and in the trivialization of $S^2T^*\mathbb{R}^4$ by coordinate differentials, \underline{L} acts, up to conjugation and rescaling, component-wise as the scalar wave operator on Minkowski space, for which the divisor is known to be -i, see [BaVaWu15, §10.1]. For small γ_j , \underline{L} is a small perturbation of this, and the lemma follows. (See also [Va13, §2.7].)

Since by equation (3.27), $L_0 - \underline{L} \in \rho^{1-0} H_b^{\infty} \mathrm{Diff}_b^2(^m \overline{\mathbb{R}^4})$, the normal operators as b-differential operators on $^m \overline{\mathbb{R}^4}$ are the same, $N(L_0) = N(\underline{L})$, hence the above results hold for $N(L_0)$ in place of \underline{L} .

We next relate the relevant function spaces on mM , ${}^m\overline{\mathbb{R}^4}$. We only need to consider supported distributions near ${}^mi^+ \subset {}^mM$. We drop m from the notation. If $\rho_+ \in \mathcal{C}^{\infty}(M)$ denotes a defining function of i^+ such that $\rho_+ > 2$ at i^0 , let

$$U := \{ \rho_+ \le 1 \} \subset M.$$

Let $\mathcal{M}_{\mathrm{b}} \subset \mathrm{Diff}^{1}_{\mathrm{b}}(\overline{\mathbb{R}^{4}})$ be the $\mathcal{C}^{\infty}(\overline{\mathbb{R}^{4}})$ -module of b-differential operators with b-principal symbol vanishing on ${}^{\mathrm{b}}N^{*}S^{+}, {}^{30}$ and define $H^{s,k}_{\mathrm{b,loc}}(\overline{\mathbb{R}^{4}})$ to consist of all $u \in H^{s}_{\mathrm{b,loc}}(\overline{\mathbb{R}^{4}})$ for

³⁰The b-conormal bundle ${}^{\mathrm{b}}N^*S^+ \subset {}^{\mathrm{b}}T^*_{S^+}\overline{\mathbb{R}^4}$ is the annihilator of the space of b-vector fields tangent to S^+ . In the coordinates (2.5), \mathcal{M}_{b} is spanned by $\rho\partial_{\rho}$, $\rho\partial_{v}$, $v\partial_{v}$, and spherical vector fields.

which $A_1 \cdots A_{\ell} u \in H^s_{\mathrm{b,loc}}(\overline{\mathbb{R}^4})$ for all $0 \leq \ell \leq k$, $A_j \in \mathcal{M}_{\mathrm{b}}$. Supported distributions on a compact set $V \subset \overline{\mathbb{R}^4}$ are denoted $\dot{H}^{s,k}_{\mathrm{b}}(V)$.

Lemma 5.6. For $a_+ \in \mathbb{R}$, $d > -\frac{1}{2}$, and $k \in \mathbb{N}_0$, the map $\beta|_{U \setminus \partial M} : U \setminus \partial M \xrightarrow{\cong} \beta(U) \setminus \partial \overline{\mathbb{R}^4}$ induces a continuous inclusion

$$\rho_{I}^{a_{+}+d-1/2}\rho_{+}^{a_{+}}\dot{H}_{\mathrm{b}}^{k+d}(U) \hookrightarrow \rho^{a_{+}}\dot{H}_{\mathrm{b}}^{d,k}(\beta(U)), \tag{5.6}$$

and conversely

$$\rho^{a_{+}}\dot{H}_{\rm b}^{d,k}(\beta(U)) \hookrightarrow \rho_{I}^{a_{+}+d-1/2}\rho_{+}^{a_{+}}\dot{H}_{\rm b}^{k}(U). \tag{5.7}$$




FIGURE 5.2. The neighborhood U of $i^+ \subset M$ as well as its image in \mathbb{R}^4 under the blow-down map β .

Thus, given the condition on supports, b-regularity near S^+ is, apart from losses in module regularity, the same as decay at \mathscr{I}^+ . See Figure 5.2. A version of the inclusion (5.7) is (implicitly) a key ingredient of [BaVaWu16], see in particular §9.2 there.

Proof of Lemma 5.6. First consider (5.6). Dividing by $\rho^{a_+} = \rho_I^{a_+} \rho_+^{a_+}$, it suffices to prove this for $a_+ = 0$. Furthermore, elements of \mathcal{M}_b lift to b-differential operators on M; in fact, $\mathrm{Diff}_b^1(M)$ is generated, over $\mathcal{C}^\infty(M)$, by the lift of \mathcal{M}_b to M. Therefore, it suffices to consider the case k = 0 and prove

$$\rho_L^{d-1/2} \dot{H}_{\mathbf{b}}^d(U) \hookrightarrow \dot{H}_{\mathbf{b}}^d(\beta(U)), \quad d > -\frac{1}{2}. \tag{5.8}$$

For d=0, this is a consequence of the fact that ρ_I times a b-density on M pushes forward to a b-density on $\overline{\mathbb{R}^4}$, cf. (4.26). Next, note that $\mathcal{V}_{\rm b}(\overline{\mathbb{R}^4})$ lifts to $\rho_I^{-1}\mathcal{V}_{\rm b}(M)$ and thus maps $\rho_I^{\alpha}H_{\rm b,loc}^s(M)\to\rho_I^{\alpha-1}H_{\rm b,loc}^{s-1}(M)$; the Leibniz rule thus reduces the case $d\in\mathbb{N}$ to the already established case d=0. For general $d\geq 0$, (5.8) follows by interpolation; we discuss $d\in(-\frac{1}{2},0]$ below.

For (5.7), we again only need to consider $a_+ = 0$, k = 0, and prove

$$\dot{H}_{\mathbf{b}}^{d}(\beta(U)) \hookrightarrow \rho_{I}^{d-1/2} L_{\mathbf{b}}^{2}(U) \cong \rho_{I}^{d} L_{\mathbf{b}}^{2}(\beta(U)). \tag{5.9}$$

For d=0, this is trivial; for d=1, integrating the 1-dimensional Hardy inequality, $||x^{-1}u||_{L^2(\mathbb{R}_+)} \lesssim ||u'||_{L^2(\mathbb{R}_+)}$, $u \in \mathcal{C}_c^{\infty}(\mathbb{R}_+)$, in fact gives $\dot{H}_b^1(\beta(U)) \hookrightarrow xL_b^2(\beta(U))$, where x is a defining function for $\beta(\partial U)$ within $\overline{\mathbb{R}^4}$. In particular, $\beta^*x \in \mathcal{C}^{\infty}(M)$ vanishes at \mathscr{I}^+ and is hence a bounded multiple of ρ_I , from which (5.9) follows. For general $d \in \mathbb{N}$, we use the following generalization of the Hardy inequality: for $u \in \mathcal{C}_c^{\infty}(\mathbb{R}_+)$,

$$||x^{-d}u||_{L^2} = \left\| \int_0^1 \int_0^{s_2} \cdots \int_0^{s_d} u^{(d)}(tx) dt dt_d \cdots dt_2 dx \right\|_{L^2}$$

$$\leq \int_0^1 \int_0^{s_2} \cdots \int_0^{s_d} \|u^{(d)}(t\cdot)\|_{L^2} dt dt_d \cdots dt_2 dx$$
$$= \frac{2^{2d}d!}{(2d)!} \|u^{(d)}\|_{L^2}.$$

For real $d \ge 0$, (5.9) again follows by interpolation.

For $d\in(-\frac{1}{2},0]$, we dualize (5.8) with respect to $L^2_{\rm b}(\beta(U))$ and thus need to show $\bar{H}^e_{\rm b}(\beta(U))\hookrightarrow \rho_I^{e-1/2}\bar{H}^e_{\rm b}(U),\ e=-d\in[0,1/2).$ But this follows from (5.7), as in this regularity range, supported and extendible Sobolev spaces are naturally isomorphic [Ta96, §4.5]. Similarly, (5.9) for $d\in(-\frac{1}{2},0]$ follows from (5.8) for $d\in[0,\frac{1}{2})$ by dualization.

Returning to the proof of Theorem 5.1, we have already proved $(1-\chi)u \in \mathcal{X}^{\infty}$ where $\chi = \chi(\rho_+)$ is identically 1 for $\rho_+ \leq \frac{1}{2}$ and vanishes for $\rho_+ \geq 1$. Consider $\chi u \in \rho_I^{-0} \rho_+^{a_+} \dot{H}_{\rm b}^{\infty}(U)$, $a_+ < b_+$, which satisfies

$$L_h \chi u = f_1 := \chi f + [L_h, \chi] u \in \rho_I^{-1-0} \rho_+^{b_+} \dot{H}_b^{\infty}(U),$$

where we use that $[L_h, \chi]u$ is supported away from i^+ . Let

$$a'_{+} = \min(a_{+} + 1 + b_{+}, b_{+}) < 0,$$

and fix $d \in (-\frac{1}{2}, -\frac{1}{2} - a'_{+})$, then $L_h - N(L_0) \in \rho_I^{-1-0} \rho_+^{1+b_{+}} H_b^{\infty}(M) \cdot \text{Diff}_b^2(M)$ (see Lemma 3.9) and Lemma 5.6 yield

$$N(L_0)\chi u =: f_2 \in \rho_I^{-1-0} \rho_+^{a'_+} \dot{H}_b^{\infty}(U) \hookrightarrow \rho_+^{a'_+} \dot{H}_b^{d,\infty}(\beta(U)). \tag{5.10}$$

Shrinking U if necessary, we may assume that $t>1+r_*$ in U. It then suffices to use dilation-invariant operators on ${}^m\overline{\mathbb{R}^4}$ to measure module regularity at ${}^mS^+$. Indeed, for m=0 and thus $r_*=r$ (the discussion for general m being similar), recall that with $R=|X|,\ \omega=X/|X|$, we can take $\tau\partial_{\tau},\ (1-R)\partial_{R},\ \partial_{\omega},\ \text{and}\ \tau\partial_{R}$ as generators of $\mathcal{M}_{\rm b}$; but $\tau\partial_{R}=c(1-R)\partial_{R}$ with $c=\tau/(1-R)\in[0,1]$ bounded. Write (5.10) using the Mellin transform in τ as

$$\chi u = \frac{1}{2\pi} \int_{\operatorname{Im} \sigma = -\alpha} \tau^{i\sigma} \underline{\widehat{L}}(\sigma)^{-1} \widehat{f}_{2}(\sigma) d\sigma,$$

initially for $\alpha = -a_+$; then $\widehat{f}_2(\sigma)$ is holomorphic in $\operatorname{Im} \sigma > -a'_+$ with values in $\dot{H}^{d,\infty}(B;\underline{\mathbb{C}}^{10})$, and in fact extends by continuity to

$$\widehat{f}_2(\sigma) \in L^2\left(\{\operatorname{Im} \sigma = -a'_+\}; \langle \sigma \rangle^{-d-N} \dot{H}^{d,N}_{\langle \sigma \rangle^{-1}}(B; \underline{\mathbb{C}}^{10})\right) \quad (\forall N).$$
(5.11)

By Lemmas 5.3 and 5.4, $\widehat{\underline{L}}(\sigma)^{-1}\widehat{f_2}(\sigma)$ is thus holomorphic in $\operatorname{Im} \sigma > -a'_+$ as well, with values in $\dot{H}^{d+1,\infty}$, extending by continuity to the space in (5.11) with d replaced by d+1; therefore $\chi u \in \rho^{a'_+} \dot{H}^{d+1,\infty}_{\mathrm{b}}(\beta(U))$, so $\chi u \in \rho_I^{-0} \rho_+^{a'_+} \dot{H}^{\infty}_{\mathrm{b}}(U)$ by Lemma 5.6, as we may choose d arbitrarily close to $-\frac{1}{2} - a'_+$. This improves the weight of u at i^+ by $a'_+ - a_+$; iterating the argument gives $\chi u \in \rho_I^{-0} \rho_+^{b_+} \dot{H}^{\infty}_{\mathrm{b}}(U)$.

5.3. **Asymptotics near** $\mathscr{I}^+ \cap i^+$. It remains to show that the precise asymptotics at \mathscr{I}^+ which we established away from i^+ in §5.1 extend all the way up to i^+ , with the weight $\rho_+^{b_+}$ at i^+ . This is completely parallel to the arguments in §5.1: working near i^+ , we now have $L_h^0 u \in \mathcal{Y}^{\infty;b_0,b_I,b_I',b_+} + H_b^{\infty;b_0,-1+b_I'-0,b_+}$, so with coordinates ρ_I, ρ_+ as in (4.47) (dropping the superscript 'o'),

$$\rho_I \partial_{\rho_I} (\rho_+ \partial_{\rho_+} - \rho_I \partial_{\rho_I}) u_{11}^c \in \rho_I^{b_I} \rho_+^{b_+} H_b^{\infty};$$

now, in $\rho_+ > 0$ (and away from i^0), u^c_{11} has a leading term at \mathscr{I}^+ , plus a remainder in $\rho^{b_I}_I H^\infty_{\rm b}$, while in $\rho_I > 0$, $u^c_{11} = \pi^c_{11} u$ lies in $\rho^{b_+}_+ H^\infty_{\rm b}$. Using Lemma 7.6 to integrate the above equation for u^c_{11} , we conclude that u^c_{11} is the sum of a leading term in $\rho^{b_0}_0 \rho^{b_+}_+ H^\infty_{\rm b}(\mathscr{I}^+)$ and a remainder in $\rho^{b_0}_0 \rho^{b_I}_I \rho^{b_+}_+ H^\infty_{\rm b}$, as desired. Similarly, we obtain the desired asymptotic behavior, uniformly up to i^+ , of u_{11} and then of u_0 . Therefore, $u \in \mathcal{X}^{\infty;b_0,b_I,b'_I,b_+}$, completing the proof of Theorem 5.1.

6. Proof of global stability

We now make Theorem 5.1 quantitative by keeping track of the number of derivatives used and proving *tame estimates*, the crucial ingredient in Nash–Moser iteration. Fix the mass m; for weights b_0, b_I, b'_I, b_+ as in Definitions 3.1 and 3.3, let

$$B^k := \mathcal{X}^{k;b_0,b_I,b_I',b_+}; \quad \mathbf{B}^k := \mathcal{Y}^{k;b_0,b_I,b_I',b_+} \oplus D^{k;b_0}, \quad D^{k;b_0} := \rho_0^{b_0} H_{\mathbf{b}}^{k+1}(\Sigma) \oplus \rho_0^{b_0} H_{\mathbf{b}}^k(\Sigma).$$

Let us write $|\cdot|_s$, resp. $||\cdot||_s||$, for the norm on B^s , resp. \mathbf{B}^s . We recall X. Saint-Raymond's version [SaRa89] of the Nash-Moser inverse function theorem:

Theorem 6.1 (See [SaRa89]). Let $\phi: B^{\infty} \to \mathbf{B}^{\infty}$ be a C^2 map, and assume that there exist $d \in \mathbb{N}$, $\epsilon > 0$, and constants $C_1, C_2, (C_s)_{s>d}$ such that for any $h, u, v \in B^{\infty}$ with $|h|_{3d} < \epsilon$,

$$\|\phi(h)\|_{s} \le C_{s}(1+|h|_{s+d}) \quad \forall s \ge d,$$
 (6.1a)

$$\|\phi'(h)u\|_{2d} < C_1|u|_{3d},\tag{6.1b}$$

$$\|\phi''(h)(u,v)\|_{2d} \le C_2 |u|_{3d} |v|_{3d}. \tag{6.1c}$$

Moreover, assume that for such h, there exists an operator $\psi(h) \colon \mathbf{B}^{\infty} \to B^{\infty}$ satisfying $\phi'(h)\psi(h)f = f$ and the tame estimate

$$|\psi(h)f|_s < C_s(||f||_{s+d} + |h|_{s+d}||f||_{2d}), \quad \forall s > d, \ f \in \mathbf{B}^{\infty}.$$
 (6.2)

Then if $\|\phi(0)\|_{2d} < c$, where c > 0 is a constant depending on ϵ and C_s for $s \leq D$, where $D = 16d^2 + 43d + 24$, there exists $h \in B^{\infty}$, $|h|_{3d} < \epsilon$, such that $\phi(h) = 0$.

This uses a family of smoothing operators $(S_{\theta})_{\theta>1} \colon B^{\infty} \to B^{\infty}$ satisfying the estimates

$$|S_{\theta}v|_{s} \le C_{s,t}\theta^{s-t}|v|_{t}, \quad s \ge t; \qquad |v - S_{\theta}v|_{s} \le C_{s,t}\theta^{s-t}|v|_{t}, \quad s \le t.$$
 (6.3)

Acting on standard Sobolev spaces $H^s(\mathbb{R}^n)$, the existence of such a family is proved in [SaRa89, Appendix], and the extension to weighted b-Sobolev spaces on manifolds with corners is straightforward: the arguments on manifolds with boundary given in [HiVa16b, §11.2] generalize directly to the corner setting. For the spaces $B^s = \mathcal{X}^s$ at hand then, one writes $h \in B^{\infty}$ as $\chi_1 h + (1 - \chi_1) h$, with $\chi_j \in \mathcal{C}^{\infty}(M)$, j = 0, 1, 2, identically 1 in a small neighborhood of \mathscr{I}^+ , and $\chi_{j+1} \equiv 1$ on supp χ_j . We smooth out $(1 - \chi_1) h \in \rho_0^{b_0} \rho_I^{\infty} \rho_+^{b_+} H_b^{\infty}(M)$ as usual and cut the result off using $(1 - \chi_0)$; since we are working away from \mathscr{I}^+ , the weight of ρ_I plays no role here. (The proof of [HiVa16a, Lemma 5.9] shows

that cutting off the smoothing of $(1 - \chi_1)h$ away from its support does not affect the estimates (6.3).) Near \mathscr{I}^+ on the other hand, we have $\chi_1 h = (\chi_1 h_{\alpha})$, where we denote by h_{α} the components of h in the bundle splitting (2.19). The decaying components (3.4) as well as the remainder terms $h_{\alpha,b}$ in (3.5)–(3.6) can then be smoothed out and cut off using χ_2 . To smooth out the leading terms, fix a collar neighborhood of \mathscr{I}^+ ; considering for example $\chi_1 h_{01} = \chi_0 h_{01}^{(0)} + \chi_1 h_{01,b}$, see (3.6), we smooth out $h_{01}^{(0)}$ in the weighted b-Sobolev space $\rho_0^{b_0} \rho_+^{b_+} H_b^{\infty} (\mathscr{I}^+)$, extend the result to the collar neighborhood, and cut off using χ_0 ; similarly for the other components of h.

Given initial data $(h_0, h_1) \in D^{\infty}$, we want to apply Theorem 6.1 to the map

$$\phi(h) = (P(h), (h, \partial_{\nu}h)|_{\Sigma} - (h_0, h_1)), \tag{6.4}$$

with P given in (3.2). Note that the smallness of $\phi(0)$ in particular requires $P(0) = \rho^{-3} \text{Ric}(g_m)$ to be small. Now, P(0) is non-zero only in the region where we interpolate between the mass m Schwarzschild metric and the Minkowski metric (both of which are Ricci-flat!), i.e. on supp $d\psi \cup \text{supp } d\phi$ in the notation of (2.9)–(2.10); thus in fact $P(0) \in \mathcal{A}_{\text{phg}}^{\emptyset,\emptyset,0}$. It is then easy to see that $\|P(0)\|_{\mathcal{Y}^k} \leq C_k m$ for all $k \in \mathbb{N}$, which is the reason why we need to assume the ADM mass m to be small to get global solvability.

For $h \in \mathcal{X}^{\infty}$ with $|h|_3$ small, the tensor

$$g = g_m + \rho h$$

is Lorentzian (by Sobolev embedding) and hence $\phi(h)$ is defined; since P is a second order (non-linear) differential operator with coefficients which are polynomials in g^{-1} and up to 2 derivatives of g, and since $h \mapsto (h, \partial_{\nu} h)|_{\Sigma}$ is continuous as a map $\mathcal{X}^k \to D^{k-3/2}$ for $k \geq 2$, the estimate (6.1a) follows for d = 3. The estimate (6.1b) also holds for d = 3 and $|h|_{3d} < \epsilon$ small, since the first component of $\phi'(h)u$, namely $L_h u$, is a second order linear differential operator acting on u, with coefficients involving at most 2 derivatives of h; similarly for (6.1c).

The existence of the right inverse $\psi(u) \colon \mathbf{B}^{\infty} \to B^{\infty}$ is the content of Theorem 5.1; we merely need to determine a value for d such that the tame estimate (6.2) holds. (As stressed in the introduction, the mere existence of such a d is clear, since the estimates on $\psi(u)$ are obtained using energy methods, integration along approximate characteristics, and inversion of a linear, smooth coefficient, model operator in §4, §§5.1 and 5.3, and §5.2, respectively.) Consider the first term on the right in (6.2): we need to quantify the loss of derivatives of the solution v of $L_h u = f$, $(u, \partial_{\nu} u)|_{\Sigma} = (u_0, u_1)$, relative to the regularity $k \geq 0$ of $(f, (u_0, u_1)) \in \mathbf{B}^k$.

Now, dropping the $H^1_{\mathscr{I}}$ regularity part of Theorem 4.2, we obtain $u \in \rho_0^{b_0} \rho_I^{a_I} \rho_+^{a_+} H_{\mathrm{b}}^k$, $\pi_0 u \in \rho_0^{b_0} \rho_I^{a_I'} \rho_+^{a_+} H_{\mathrm{b}}^k$. The arguments near $i^0 \cap \mathscr{I}^+$ in §5.1 first express u_{11}^c as the solution of a transport equation (5.2), with the right hand side involving up to two derivatives of u; since integration of this equation does not regain full b-derivatives, the leading terms (and the remainder term) of u_{11}^c lie in H_{b}^{k-2} , with the correct weight b_0 at i^0 (and b_I at i^0); next, this couples into the transport equation (5.3) for u_{11} , again with up to 2 derivatives of u, so integrating this yields leading and remainder terms of u_{11} in H_{b}^{k-4} ; and similarly then $u_0 \in \rho_0^{b_0} \rho_I^{b'_1} H_{\mathrm{b}}^{k-6}$ near $i^0 \cap \mathscr{I}^+$.

On the other hand, improving the b-weight at i^+ by $1 + b_+$, which we may take to be arbitrarily close to 1 by taking $b_+ < 0$ close to 0, uses the rewriting (5.10), which

due to the second order nature of $L_h - N(L_0)$ involves an error term (subsumed into f_2 there) with 2 derivatives on u. Passing to the blow-down using Lemma 5.6 loses at most 1 module derivative; inverting $N(L_0)$ gains 1 b-derivative (which is used to recover the ρ_I^{-0} bound at \mathscr{I}^+), but no module derivatives, so passing back to the blow-up, we have lost at most 3 b-derivatives. Thus, improving the weight at i^+ from a_+ to $b_+ \approx 0$ loses at most $d_+ := 1 + 3\lceil a_+ \rceil$ derivatives relative to H_b^k .

These two pieces of information are combined near $\mathscr{I}^+ \cap i^+$ in §5.3, where we lose at most 6 derivatives, just as in the discussion near $i^0 \cap \mathscr{I}^+$, relative to the less regular of the two spaces $H_{\rm b}^{k-6}$ and $H_{\rm b}^{k-d_+}$ from above; we thus take $d=6+\max(6,d_+)$. If we use the explicit background estimate, Theorem 4.11, so $a_+=\frac{3}{2}$, this gives $d_+=7$ and therefore

$$d = 13.$$

For this value of d, one may then verify the tame estimate (6.2) by going through the proofs of Theorems 4.2 and 5.1 and proving tame estimates by exploiting Moser estimates; this is analogous to the manner in which the microlocal estimates for smooth coefficient operators in [Va13, §2], [HiVa15, §2.1] were extended to estimates for rough coefficient operators in [Hi16a, §§3–6], which were subsequently sharpened to tame estimates in [HiVa16a, §§3–4]. In the present setting, obtaining tame estimates is much simpler than in the references, as the estimates in $\S\S4-5$ are based on standard energy estimates, so one can appeal directly to the Moser estimates; or, in view of the fact that our energy estimates can be proved using positive commutators (and are indeed phrased this way here), which also underlie the tame estimates in these references, the arguments given there (using vector fields instead of microlocal commutants) apply here as well. We omit the details, but we do point out that it is key that the proofs as stated only use pointwise control of up to 1 derivative of h (via causality considerations and deformation tensors, see e.g. the calculation (4.15) and Lemma 4.5) in order to obtain the main positive terms in the commutator arguments; thus, control of $|h|_4$ suffices in this sense, that is, the constant in (4.3) for k=1 only depends on $|h|_4$. The proofs of higher b-regularity use commutation arguments, which do not affect the principal part of L_h , as well as ellipticity considerations around (4.57) which only require pointwise control of h itself; correspondingly, at no point do we need to use the smallness of any higher regularity norms of h. (See the end of [Hö97, $\S6.4$] for a related discussion.)

Next, we deal with a small technical complication stemming from the fact that for $m \neq 0$, the closure of $\{t=0\}$, on which in Theorem 1.1 we compare the initial data with those of the Schwarzschild metric in its standard form, inside of ${}^m\overline{\mathbb{R}^4}$ is not a smooth hypersurface when $m \neq 0$, the issue being smoothness at $\partial^m\overline{\mathbb{R}^4}$; furthermore, our discussion of linear Cauchy problems used ${}^m\Sigma \neq \overline{\{t=0\}}$ as the Cauchy surface. We resolve this issue by solving the initial value problem for a short amount of time in the radial compactification ${}^0\overline{\mathbb{R}^4}$, with initial surface $\{t=0\}$ (whose closure is smooth in ${}^0\overline{\mathbb{R}^4}$), pushing the local solution forward to ${}^m\overline{\mathbb{R}^4}$, and then solving globally from there. Recall the function t_b from (2.13), and the notation (2.16). (Thus, 0t_b is a rescaling of t, and ${}^0\Sigma = \{{}^0t_b = 0\}$.)

Lemma 6.2. Fix N large, and let $b_0 > 0$, $\epsilon > 0$. Suppose $\gamma, k \in C^{\infty}(\mathbb{R}^3; S^2T^*\mathbb{R}^3)$ are vacuum initial data on \mathbb{R}^3 , that is, solutions of the constraint equations (1.5), such that for some $m \in \mathbb{R}$,

$$\widetilde{\gamma} := \gamma - \chi(r) \left((1 - \frac{2m}{r})^{-1} dr^2 + r^2 \not g \right) \in \rho_0^{1 + b_0} H_b^{\infty}(\overline{\mathbb{R}^3}; S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^3})$$

$$(6.5)$$

and $k \in \rho_0^{2+b_0} H_b^{\infty}(\overline{\mathbb{R}^3}; S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^3})$ satisfy

$$|m| + \|\widetilde{\gamma}\|_{\rho_0^{1+b_0} H_{\mathbf{L}}^{N+1}} + \|k\|_{\rho_0^{2+b_0} H_{\mathbf{L}}^{N}} < \delta, \tag{6.6}$$

where $\delta > 0$ is a sufficiently small constant; here $\chi = \chi(r)$ is a cutoff, $\chi \equiv 0$ for r < 1, $\chi \equiv 1$ for r > 2. Then, identifying $\overline{\mathbb{R}^3} \cong {}^0\Sigma \subset {}^0M$ via $\mathbb{R}^3 \ni x \mapsto (0, x) \in \mathbb{R}^4$, there exists a solution g of the Einstein vacuum equation $\mathrm{Ric}(g) = 0$ in the neighborhood

$$U := \{ |^{0}t_{\mathbf{b}}| < \frac{1}{4} \}, \tag{6.7}$$

attaining the data (γ, k) at ${}^0\Sigma$ (that is, (1.4) holds) and satisfying the gauge condition $\Upsilon(g; g_m) = 0$; moreover, $g = g_m + \rho h$, where $h \in \rho_0^{b_0} H_b^{\infty}(U; S^{2 \text{ sc}} T^{* 0} \overline{\mathbb{R}^4})$ has norm $\|h\|_{\rho_0^{b_0} H_b^{N+1}(U)} < \epsilon$.

Proof. Note that the metric g_m is smooth on $U \subset {}^0\overline{\mathbb{R}^4}$, as near i^0 it is given by the Schwarzschild metric g_m^S , see (1.3). Using the product decomposition $\mathbb{R}^4 = \mathbb{R}_t \times \mathbb{R}_x^3$, we define a Lorentzian signature metric over the interior $({}^0\Sigma)^{\circ} = \{t=0\}$ by

$$g_0 := (1 - \chi(r)\frac{2m}{r})dt^2 - \gamma \in \mathcal{C}^{\infty}(({}^{0}\Sigma)^{\circ}; S^2T^*\mathbb{R}^4),$$
 (6.8)

whose pullback to ${}^{0}\Sigma$ is equal to $-\gamma$. We next find $g_{1} \in \mathcal{C}^{\infty}({}^{0}\Sigma; S^{2}T^{*}\mathbb{R}^{4})$ such that $k = II_{g_{0}+tg_{1}}$; denoting by $N = (1-\chi(r)\frac{2m}{r})^{-1/2}\partial_{t}$ the future unit normal, this is equivalent, by polarization, to

$$g_0((\nabla_X^{g_0+tg_1} - \nabla_X^{g_0})X, N) = k(X, X) \ \forall X \in T(^0\Sigma)^\circ;$$

Here, we view g_0 as a stationary metric near t = 0, which due to its symmetry under time reversal $t \mapsto -t$ has vanishing second fundamental form: $g_0(\nabla_X^{g_0}X, N) \equiv 0$. A calculation in normal coordinates for g_0 shows that this is uniquely solved by

$$g_1(X,X) = -2(Nt)^{-1}k(X,X) = -2(1-\chi(r)\frac{2m}{r})^{1/2}k(X,X).$$
(6.9)

It remains to specify $g_1(N,\cdot)$ and $g_1(N,N)$, which involves the gauge condition at t=0; that is, for all $V \in T_{\{t=0\}}\mathbb{R}^4$, we require

$$-\Upsilon(g_0; g_m)(V) = (\Upsilon(g_0 + tg_1; g_m) - \Upsilon(g_0; g_m))(V)$$

$$= (G_{q_0}g_1)(V, \nabla^{g_0}t) = (1 - \chi(r)\frac{2m}{r})^{-1/2}(G_{q_0}g_1)(V, N).$$
(6.10)

For $V \in T(^0\Sigma)^\circ$, this determines $(G_{g_0}g_1)(V,N) = g_1(V,N)$. Lastly, if $E_1, E_2, E_3 \in T(^0\Sigma)^\circ$ completes N to an orthonormal basis, this also determines $(G_{g_0}g_1)(N,N) = \frac{1}{2}(g_1(N,N) + \sum_j g_1(E_j,E_j))$ and thus $g_1(N,N)$.

The assumption on γ gives

$$h_0 := \rho_0^{-1}(g_0 - g_m) \in \rho_0^{b_0} H_b^{\infty}({}^{0}\Sigma; S^{2 \text{ sc}} T_{0\Sigma}^{*} \overline{\mathbb{R}^4}). \tag{6.11}$$

We claim that likewise

$$h_1 := \rho_0^{-2} g_1 \in \rho_0^{b_0} H_b^{\infty}(^0 \Sigma; S^{2 \text{ sc}} T_{0\Sigma}^{*0} \overline{\mathbb{R}^4}). \tag{6.12}$$

We introduce the extra factor of ρ_0^{-1} since $\rho_0^{-1}\partial_t$ is a smooth b-vector field on ${}^0\overline{\mathbb{R}^4}$ near ${}^0\Sigma$ and transversal to it; that is, in (4.1), we can take

$$\partial_{\nu} = \rho_0^{-1} \partial_t.$$

Now the restriction of h_1 to $S^{2 \text{ sc}} T^0 \Sigma$ lies in $\rho_0^{b_0} H_b^{\infty}$, as follows from (6.9). (Recall that ${}^{\text{sc}} T^0 \Sigma$ is spanned by coordinate vector fields on \mathbb{R}^3 .) To prove (6.12), it thus suffices to

prove that $\Upsilon(g_0; g_m)(V) \in \rho_0^{2+b_0} H_b^{\infty}$ for V equal to ∂_t or a coordinate vector field on \mathbb{R}^3 ; this however follows from (6.11) and the local coordinate expression (3.1) of Υ , as such a vector field V is equal to ρ_0 times a b-vector field on \mathbb{R}^4 .

This construction preserves smallness, i.e. we have $\|h_0\|_{\rho_0^{b_0}H_b^{N+1}} + \|h_1\|_{\rho_0^{b_0}H_b^N} < C\delta$ for some constant C. We can then solve the quasilinear wave equation P(h) = 0 in the neighborhood U of ${}^0\Sigma$, e.g. using Nash–Moser iteration as explained above. (Since we are not solving up to \mathscr{I}^+ where our arguments in §5 lose derivatives, one can use a simpler iteration scheme here, see [Ta96, §16.1].) The constraint equations then imply that $\partial_{\nu}\Upsilon(g_m + \rho h; g_m) = 0$ at ${}^0\Sigma$, see [HiVa16b, §2.1]; since Υ solves the wave equation (1.28), we have $\Upsilon \equiv 0$.

To extend this to a global solution, we recall from Lemma 2.4 and the isomorphism (2.37) that h pushes forward to an element of $\rho_0^{b_0}H_{\rm b}^{\infty}(U')$, $U':=\{|^mt_{\rm b}|<\frac{1}{8}\}$, and satisfies a bound $\|h\|_{\rho_0^{b_0}H_{\rm b}^{N+1}(U')} < C\epsilon$, with C a constant depending only on m. We can thus use $(h_0,h_1)=(h,\partial_{\nu}h)|_{m_{\Sigma}}$ as Cauchy data for the equation P(h)=0. Note that the gauge condition $\Upsilon(g)=0$, $g=g_m+\rho h$, holds identically near $^m\Sigma$; by uniqueness of solutions of P(h)=0 with Cauchy data (h_0,h_1) , a global solution h will automatically satisfy $\Upsilon(g)\equiv 0$, as this holds near $^m\Sigma$, and then globally by the argument given around equation (1.28).

Theorem 6.3. Fix N large, $b_0 > 0$, $\epsilon > 0$, and $0 < \eta < \min(\frac{1}{2}, b_0)$. Then if $m \in \mathbb{R}$ and $b_0, h_1 \in \rho_0^{b_0} H_b^{\infty}(^m \Sigma)$ satisfy

$$|m| + ||h_0||_{\rho_0^{b_0} H_{\mathbf{h}}^{N+1}} + ||h_1||_{\rho_0^{b_0} H_{\mathbf{h}}^N} < \delta,$$

where $\delta > 0$ is a small constant, then there exists a global solution h of

$$P(h) = 0, \quad (h, \partial_{\nu} h)|_{m_{\Sigma}} = (h_0, h_1),$$
 (6.13)

that is,

$$\operatorname{Ric}(g) - \widetilde{\delta}^* \Upsilon(g) = 0, \quad g = g_m + \rho h,$$

which satisfies $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ for all weights $b_I < b_I' < \min(1,b_0)$ and $b_+ < 0$, and so that moreover $\|h\|_{\mathcal{X}^{6;b_0,\eta,\eta/2,-\eta}} < \epsilon$. If in addition $\Upsilon(g_m + \rho h; g_m) = 0$, $\partial_{\nu} \Upsilon(g_m + \rho h; g_m) = 0$ at ${}^m\Sigma$, then g solves

$$Ric(q) = 0$$

in the gauge $\Upsilon(q) = 0$.

As explained above, data for which the assumption in the second part of the theorem holds arise from an application of Lemma 6.2. This assumption is equivalent to the statement that the Riemannian metric and second fundamental form of ${}^{m}\Sigma$ induced by a metric $g_m + \rho h$ with $(h, \partial_{\nu} h)|_{m_{\Sigma}} = (h_0, h_1)$ satisfy the constraint equations, and that the gauge condition $\Upsilon(h; g_m) = 0$ holds pointwise at ${}^{m}\Sigma$. These are assumptions only involving the data (h_0, h_1) ; the vanishing of $\partial_{\nu} \Upsilon(h)|_{m_{\Sigma}}$ for the solution h of P(h) = 0 with these data follows as in the proof of Lemma 6.2.

Proof of Theorem 6.3. This follows, with $b_I < b_I' < \min(\frac{1}{2}, b_0)$ at first, for N = 2d = 26, from Theorem 6.1 applied to the map in (6.4). The constant $\delta > 0$ depends in particular on the constants C_s in (6.1a) for $s \leq D = 3287$; that is, $\delta = \delta(\|h_0\|_{\rho_0^{b_0}H_b^{D+1}} + \|h_1\|_{\rho_0^{b_0}H_b^{D}})$. Repeating the arguments in §§5.1 and 5.3 once more shows that one can take $b_I < b_I' < \min(1, b_0)$; see also the proof of Theorem 7.1 below.

We remark that h is in fact small in $\mathcal{X}^{3d} = \mathcal{X}^{39}$, but if one is interested in the size of up to two derivatives (e.g. curvature) of h, control of its \mathcal{X}^6 norm is sufficient by Sobolev embedding.

Remark 6.4. In other words, using the notation of the proof and $d \ge 13$, N = 2d, $D = 16d^2 + 43d + 24 = 3287$, and fixing m and b_0 , we can solve the initial value problem (6.13) for data in the space $\mathscr{D} := \bigcup_{C} \mathscr{D}(C)$, where

$$\mathscr{D}(C) := \left\{ (h_0, h_1) \colon h_0, \ h_1 \in \rho_0^{b_0} H_b^{\infty}(^m \Sigma), \quad |m| + \|h_0\|_{\rho_0^{b_0} H_b^{N+1}} + \|h_1\|_{\rho_0^{b_0} H_b^{N}} < \delta(C), \\ \|h_0\|_{\rho_0^{b_0} H_b^{D+1}} + \|h_1\|_{\rho_0^{b_0} H_b^{D}} < C \right\}.$$

An inspection of the proof of Theorem 6.1 in [SaRa89] shows that $\lim_{C\to 0} \delta(C) > 0$, so \mathscr{D} in particular contains all conormal data (h_0,h_1) for which $|m|+\|h_0\|_{\rho_0^{b_0}H_{\rm b}^{D+1}}+\|h_1\|_{\rho_0^{b_0}H_{\rm b}^{D}} < \delta_0$, where $\delta_0 > 0$ is a universal constant (i.e. depending only on m and b_0). Moreover, one also has a continuity statement: for any choice of weights b_I, b_I', b_+ as in Theorem 6.3, the solution $h \in \mathcal{X}^{3d;b_0,b_I,b_I',b_+}$ of (6.13) depends continuously on $(h_0,h_1) \in \mathscr{D}$, the latter being equipped with the $\rho_0^{b_0}H_{\rm b}^{D+1} \oplus \rho_0^{b_0}H_{\rm b}^{D}$ topology. Indeed, to obtain continuity at the Minkowski solution, note that the map ϕ in (6.4) depends parametrically on the data $(h_0,h_1) \in \mathscr{D}$, but the constants appearing in the estimates in [SaRa89] can be taken to be uniform when (h_0,h_1) varies in $\mathscr{D}(C)$ with C fixed. Continuity at other solutions is similarly automatic, but the base point of the Nash–Moser iteration (called u_0 in [SaRa89, Lemma 1]) should then be given by the solution one is perturbing around.

The solution h of (6.13) in fact has a leading term at i^+ , as will follow from the arguments in §7, see the discussion around (7.16); this precise information was not needed to close the iteration scheme, hence we did not encode it in the spaces \mathcal{X}^s .

The conclusion in the form given in Theorem 1.1 can be obtained by combining Lemma 6.2 and Theorem 6.3: using the coordinate $t_{\rm b}$ on ${}^m\!M'$, the initial surface ${}^0\Sigma$ in Minkowski space is given by $t_{\rm b} = -2m\rho_0\chi(r)\log(r-2m)$. A diffeomorphism of ${}^m\overline{\mathbb{R}^4}$ which near ${}^m\Sigma$ is not smooth but rather polyhomogeneous with index set \mathcal{E}_{\log} , and which is the identity away from ${}^m\Sigma$, can be used to map $\{t_{\rm b} \geq -2m\rho_0\chi(r)\log(r-2m)\} \subset {}^m\!M'$ to ${}^m\!M = \{t_{\rm b} \geq 0\}$; pushing the solution g obtained from Lemma 6.2 and Theorem 6.3, which is defined on $t \geq 0$, forward using this diffeomorphism produces the solution g as in Theorem 1.1. (The gauge condition satisfied by g is the wave map condition with respect to the background metric which is the pushforward of g_m .) We omit the proofs of future causal geodesic completeness of (M,g), as one can essentially copy the arguments of Lindblad–Rodnianski [LiRo05, §16].

Remark 6.5. By Sobolev embedding, h obeys the pointwise bound

$$|h| \le C_{\eta} (1 + t + r)^{-1+\eta} (1 + (r_* - t)_+)^{b_0} \quad \forall \, \eta > 0$$
(6.14)

and is small for fixed $\eta > 0$ if $\delta = \delta(\eta) > 0$ in the theorem is sufficiently small; here, we measure the size of h using any fixed Riemannian inner product on the fibers of $\beta^* S^2$, equivalently, by measuring $\sum_{ij} |h(Z_i, Z_j)|$, where $\{Z_i\} = \{\partial_t, \partial_{x^1}, \partial_{x^2}, \partial_{x^3}\}$ are coordinate vector fields. The bound (6.14) also holds for all covariant derivatives of h along b-vector

³¹Hamilton [Ha82] shows that the data-to-solution map is in fact a tame smooth map $D^{\infty;b_0} \ni (h_0, h_1) \mapsto h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ (defined in the neighborhood \mathscr{D} of the origin of $D^{\infty;b_0}$).

fields on ${}^{m}M$. In particular, by Lemma 3.10, $|g-\underline{g}| \leq C_{\eta}(1+t+r)^{-1+\eta}$, $\eta > 0$. The Riemann curvature tensor also decays to 0 as $t+r \to \infty$, with the decay rate depending on the component: this follows from an inspection of the expressions in §A.2. Note however that the components in the frame (2.21) have no geometric meaning away from \mathscr{I}^+ . Geometric and more precise decay statements were obtained by Klainerman–Nicolò [KlNi03a].

Remark 6.6. If the ADM mass m of the initial data is large, there does not exist a metric with the mass m Schwarzschild behavior near \mathscr{I}^+ but Minkowski-like far from $i^0 \cup \mathscr{I}^+$ which is sufficiently close to being Ricci flat for an application of a small data non-linear iteration scheme like Nash-Moser: this follows from work of Christodoulou [Ch09], Klainerman-Rodnianski and Luk [KlRo12, KlLuRo14], An-Luk [AnLu14], and (for the non-characteristic problem) Li-Yu [LiYu15]. On the other hand, for arbitrary m, but without the smallness condition (1.6) on the data, one does obtain small data by restricting to the complement of a sufficiently large ball. Working on a suitable submanifold of mM , defined near $i^0 \cap \mathscr{I}^+$ by $\rho_0 < \epsilon + \rho_I^\beta$ for $\beta \in (0,b_0)$ and $\epsilon > 0$ sufficiently small, cf. (4.14), our method of proof then ensures the existence of a vacuum solution on this submanifold; in particular, the solution includes a piece of null infinity.

We can also solve towards the past: Lemma 6.2 produces a solution g of Einstein's equation in the gauge $\Upsilon(g;g_m)=0$ in a full neighborhood of $\{t=0\}$, and we can then use the time-reversed analogue of Theorem 6.3 for solving backwards in time, obtaining a global solution g on \mathbb{R}^4 . Note here that by construction, the background metric g_m is invariant under the time reversal map $\iota\colon t\mapsto -t$ on \mathbb{R}^4 , hence the gauge conditions of the future and past solutions match. To describe the behavior of g on a compact space, as illustrated in Figure 1.1, let us denote by $m\overline{\mathbb{R}^4}$ the compactification defined like $m\overline{\mathbb{R}^4}$ in §2.1 but with t replaced by -t everywhere. Thus, ι induces diffeomorphisms $m\overline{\mathbb{R}^4}\cong m\overline{\mathbb{R}^4}$; denote by S^- the image of S^+ . The identity map on \mathbb{R}^4 induces an identification of the interiors of $m\overline{\mathbb{R}^4}$ and $m\overline{\mathbb{R}^4}$ which extends to be polyhomogeneous of class $\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_{\log}}$ on the maximal domain of existence by a simple variant of Lemma 2.4. We then define the compact topological space $m\overline{\mathbb{R}^4}$ to be the union of $m\overline{\mathbb{R}^4}$ and $m\overline{\mathbb{R}^4}$ quotiented out by this identification; this is thus a manifold of class $\mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_{\log}}$, and in fact of class \mathcal{C}^{∞} away from $\partial^m \overline{\mathbb{R}^4} \cap \partial_m \overline{\mathbb{R}^4}$, hence in particular near S^{\pm} as well as near $m\beta(mi^+)$ and its image under ι . Therefore,

$$_{m}^{m}M:=\left[_{m}^{m}\overline{\mathbb{R}^{4}};S^{+},S^{-}\right]$$

is a polyhomogeneous manifold, covered by the two smooth manifolds ${}^m\!M'$ and ${}_m\!M':=[{}_m\overline{\mathbb{R}^4};S^-]$, and with interior naturally diffeomorphic to $\mathbb{R}^4_{t,x}$. We denote its boundary hypersurfaces by \mathscr{I}^\pm and i^\pm in the obvious manner, see Figure 1.1, and i^0 is the closure of the remaining part of the boundary. In view of the isomorphism (2.37), weighted b-Sobolev spaces on m_mM are well-defined. For future use, we also note that polyhomogeneity at i^0 with index set \mathcal{E}_0 is well-defined provided

$$\mathcal{E}_0 + \mathcal{E}_{\log} = \mathcal{E}_0, \tag{6.15}$$

as follows from (2.38); note that given any index set \mathcal{E}_0^0 , the index set $\mathcal{E}_0 := \mathcal{E}_0^0 + \mathcal{E}_{log}$ satisfies (6.15) (and is the smallest such index set which contains \mathcal{E}_0^0) since $\mathcal{E}_{log} + \mathcal{E}_{log} = \mathcal{E}_{log}$.

It is useful to describe ${}_{m}^{m}M$ as the union of three (overlapping) smooth manifolds, namely ${}^{m}M$, ${}_{m}M := \iota^{m}M$, and the set U defined in (6.7). We can then define the function space

$$\mathcal{X}_{ ext{global}}^{\infty;b_0,b_I,b_I',b_+}$$

to consist of all distributions on \mathbb{R}^4 which lie in $\rho_0^{b_0} H_{\mathbf{b}}^{\infty}$ on U, and such that their restriction as well as the restriction of their pullback by ι to ${}^m M$ lie in $\mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$.

Theorem 6.7. Given initial data γ , k as in Lemma 6.2, there exists a global solution g of the Einstein vacuum equation Ric(g) = 0, attaining the data γ , k at $\{t = 0\}$ and satisfying the gauge condition $\Upsilon(g)$, which is of the form $g = g_m + \rho h$ with $h \in \mathcal{X}_{\text{global}}^{\infty; b_0, b_I, b_I', b_+}$ for all $b_I < b_I' < b_0$ and $b_+ < 0$.

7. Polyhomogeneity

We state and prove a precise version of the polyhomogeneity statement, made in Theorem 1.1, about the solution of the initial value problem which we constructed in §6. We use the short hand notations (2.29) and (2.32).

Theorem 7.1. Let $b_0 > 0$, and let $\mathcal{E}_0^0 \subset \mathbb{C} \times \mathbb{N}_0$ be an index set with $\operatorname{Im} \mathcal{E}_0^0 < -b_0$. Suppose $\gamma, k \in \mathcal{C}^{\infty}(\mathbb{R}^3; S^2T^*\mathbb{R}^3)$ are initial data such that $m \in \mathbb{R}$, $\widetilde{\gamma}$, defined in (6.5), and k satisfy the smallness condition (6.6), for N large and $\delta > 0$ small. Assume moreover that the initial data are polyhomogeneous (namely, \mathcal{E}_0^0 -smooth):

$$\rho_0^{-1} \widetilde{\gamma}, \, \rho_0^{-2} k \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0^0}(\overline{\mathbb{R}^3}; S^{2 \, \mathrm{sc}} T^* \overline{\mathbb{R}^3}). \tag{7.1}$$

Let h denote the global solution of Ric(g) = 0, $g = g_m + \rho h$, in M, satisfying the gauge condition $\Upsilon(g; g_m) = 0$. Then h is polyhomogeneous on M. More precisely, h is \mathcal{E} -smooth, $\mathcal{E} = (\mathcal{E}_0, \mathcal{E}_I, \mathcal{E}_+)$:

$$h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, \mathcal{E}_I, \mathcal{E}_+},$$

with the refinements $\pi_{11}^c h \in \mathcal{A}_{phg}^{\mathcal{E}_0,\bar{\mathcal{E}}_I,\mathcal{E}_+}$ and $\pi_0 h \in \mathcal{A}_{phg}^{\mathcal{E}_0,\mathcal{E}'_I,\mathcal{E}_+}$ near \mathscr{I}^+ , where the index sets are the smallest ones satisfying³³

$$\mathcal{E}_0 \supset \mathcal{E}_0^0 + \mathcal{E}'_{\log}, \quad \mathcal{E}_0 \supset j(\mathcal{E}_0 - i) + i \quad \forall j \in \mathbb{N}$$
 (7.2a)

at i^0 , with \mathcal{E}'_{\log} defined in (2.33), while at \mathscr{I}^+ ,

$$\mathcal{E}_I' \supset \mathcal{E}_0 \,\overline{\cup} (2\mathcal{E}_I - i)$$
 (7.2b)

$$\bar{\mathcal{E}}_I \supset 0 \cup (\mathcal{E}_0 \, \overline{\cup} ((\bar{\mathcal{E}}_I + \mathcal{E}'_I) \cup (2\mathcal{E}_I - i))),$$
(7.2c)

$$\mathcal{E}_I \supset 0 \,\overline{\cup}\, \mathcal{E}_0 \,\overline{\cup} \big((\mathcal{E}_I + \mathcal{E}_I') \cup (2\bar{\mathcal{E}}_I) \big),$$
 (7.2d)

$$\mathcal{E}_I \supset j(\mathcal{E}_I - i) + i \quad \forall j \in \mathbb{N},$$
 (7.2e)

and finally at i^+ ,

$$\mathcal{E}_{+} \supset (-i \,\overline{\cup}\,0) \cup ((\mathcal{E}_{+} - i) \,\overline{\cup}\,-i \,\overline{\cup}(\mathcal{E}_{I} \setminus \{(0,1)\})). \tag{7.2f}$$

 $^{^{32}}$ We can take N=26 as in (the proof of) Theorem 6.3.

³³We shall prove that such index sets indeed exist.

At i^0 , we only need to capture the index set arising from non-linear terms in Einstein's equation since the background metric g_m solves $\rho^{-3}\mathrm{Ric}(g_m)=0$ identically near i^0 ; the addition of the index set \mathcal{E}_{\log} arises when pushing the solution near $\{t=0\}\subset {}^0\overline{\mathbb{R}^4}$ forward to mM ; see (6.15). We point out that the index sets we obtain are very likely to be non-optimal due to our rather coarse analysis of non-linear interactions.

Example 7.2. For data which are Schwarzschildean modulo Schwarzs functions, i.e. $\mathcal{E}_0^0 = \emptyset$, the above gives $\mathcal{E}_0 = \emptyset$ and

$$\mathcal{E}_{I} = \bigcup_{j \in \mathbb{N}_{0}} (-ij, 3j+1), \quad \bar{\mathcal{E}}_{I} = 0 \cup \mathcal{E}'_{I}, \quad \mathcal{E}'_{I} = \bigcup_{j \in \mathbb{N}} (-ij, 3j-1), \quad \mathcal{E}_{+} = \bigcup_{j \in \mathbb{N}_{0}} \left(-ij, \frac{3}{2}j(j+3)\right),$$

giving, schematically, leading terms $\pi_{11}h \sim \log^{\leq 1}\rho_I + \rho_I \log^{\leq 4}\rho_I$, $\pi_{11}^c h \sim 1 + \rho_I \log^{\leq 2}\rho_I$, $\pi_0 h \sim \rho_I \log^{\leq 2}\rho_I$ at \mathscr{I}^+ , and $h \sim 1 + \rho_+ \log^{\leq 6}\rho_+$ at i^+ .

Example 7.3. Consider $\mathcal{E}_0^0 = -i$: this corresponds to initial data which have a full Taylor expansion in 1/r at infinity, beginning with $\mathcal{O}(r^{-2})$ perturbations of the Schwarzschild metric. In this case, we get many additional logarithmic terms from $\mathcal{E}_0 = \mathcal{E}_0^0 + \mathcal{E}_{\log} = \bigcup_{j \in \mathbb{N}} (-ij, j-1)$, namely

$$\mathcal{E}_{I} = \bigcup_{j \in \mathbb{N}_{0}} \left(-ij, \frac{1}{2}j(3j+7) + 1 \right), \quad \bar{\mathcal{E}}_{I} = 0 \cup \bigcup_{j \in \mathbb{N}} \left(-ij, \frac{1}{2}j(3j+5) \right),$$
$$\mathcal{E}'_{I} = \bigcup_{j \in \mathbb{N}_{0}} \left(-ij, \frac{1}{2}j(3j+3) \right), \quad \mathcal{E}_{+} = \bigcup_{j \in \mathbb{N}_{0}} \left(-ij, \frac{1}{2}j(j^{2}+5j+10) \right),$$

so $\pi_{11}h \sim \log^{\leq 1} \rho_I + \rho_I \log^{\leq 6} \rho_I$, $\pi_{11}^c h \sim 1 + \rho_I \log^{\leq 4} \rho_I$, $\pi_0 h \sim \rho_I \log^{\leq 3} \rho_I$ at \mathscr{I}^+ , and $h \sim 1 + \rho_+ \log^{\leq 8} \rho_+$ at i^+ .

Remark 7.4. Let us consider the index set $\mathcal{E}_0^0 = -i$ again. As indicated above, the addition of \mathcal{E}'_{\log} in (7.2a) is only due to an inconvenient choice of initial surface which produces logarithmic terms when passing from ${}^0\overline{\mathbb{R}^4}$ (which the initial surface in Theorem 7.1 is a smooth submanifold of) to ${}^m\overline{\mathbb{R}^4}$. If instead one is given the ADM mass m and initial data (γ,k) on ${}^m\Sigma$, with (γ,k) close to the data induced by g_m on ${}^m\Sigma$ (measured in $\rho_0^{b_0}H_{\rm b}^N({}^m\Sigma;S^2{}^{\rm sc}T^*{}^m\Sigma)$ for suitable N), then the index set at i^0 can be defined as in (7.2a) but without \mathcal{E}'_{\log} . Correspondingly, the index sets at the other boundary faces have fewer logarithms:

$$\mathcal{E}_{I} = \bigcup_{j \in \mathbb{N}_{0}} (-ij, 5j+1), \quad \bar{\mathcal{E}}_{I} = 0 \cup \bigcup_{j \in \mathbb{N}} (-ij, 5j-1),$$
$$\mathcal{E}'_{I} = \bigcup_{j \in \mathbb{N}} (-ij, 5j-2), \quad \mathcal{E}_{+} = \bigcup_{j \in \mathbb{N}_{0}} (-ij, \frac{1}{2}j(5j+11)),$$

so $\pi_{11}h \sim \log^{\leq 1}\rho_I + \rho_I \log^{\leq 6}\rho_I$, $\pi_{11}^c h \sim 1 + \rho_I \log^{\leq 4}\rho_I$, $\pi_0 h \sim \rho_I \log^{\leq 3}\rho_I$ at \mathscr{I}^+ , and $h \sim 1 + \rho_+ \log^{\leq 8}\rho_+$ at i^+ . (The exponents in subsequent terms of the expansion are smaller than in Example 7.3.)

The proof of Theorem 7.1 is straightforward but requires some bookkeeping: we will peel off the polyhomogeneous expansion at the various boundary faces iteratively, writing the non-linear equation P(h) = 0 as a linear equation plus error terms with better decay, much like in §5. As a preparation, we prove a few lemmas for ODEs which were already used in §5:

Lemma 7.5. Let $X := [0, \infty)_{\rho}, u \in \rho^{-\infty} H_{\rm b}^{\infty}(X), \text{ supp } u \subset [0, 1], \text{ and } f := \rho D_{\rho} u.$ Then:

- $\begin{array}{l} (1) \ \ f \in \rho^a H^\infty_{\rm b}(X), \ a < 0 \Rightarrow u \in \rho^a H^\infty_{\rm b}(X); \\ (2) \ \ f \in \rho^a H^\infty_{\rm b}(X), \ a > 0 \Rightarrow u \in \mathcal{A}^0_{\rm phg}(X) + \rho^a H^\infty_{\rm b}(X); \\ (3) \ \ f \in \mathcal{A}^{\mathcal{E}}_{\rm phg}(X), \ \mathcal{E} \ \ any \ \ index \ set \Rightarrow u \in \mathcal{A}^{\mathcal{E} \cup 0}_{\rm phg}(X); \ \ if \ (0,0) \notin \mathcal{E}, \ then \ u \in \mathcal{A}^{\mathcal{E} \cup 0}_{\rm phg}(X). \end{array}$

Proof. This follows immediately from the characterization of b-Sobolev and polyhomogeneous spaces using the Mellin transform [Me96, §4]. Alternatively, one can explicitly construct the unique solution of $\rho D_{\rho} u = f$ with support in $\rho \leq 1$: part (1) follows easily from $u = -i \int_{\rho}^{1} f \frac{d\rho}{\rho}$, while for part (2), $u = -i \int_{0}^{1} f \frac{d\rho}{\rho} + i \int_{0}^{\rho} f \frac{d\rho}{\rho}$ gives the decomposition into constant and remainder term. The appearance of the extended union in (3) is due to the fact that while $\rho D_{\rho} u = \rho^{iz} (\log \rho)^k$, $k \in \mathbb{N}_0$, is solved to leading order by $u = \frac{1}{z} \rho^{iz} (\log \rho)^k$ for $z \neq 0$, we need an extra logarithmic term for z = 0, as $\rho D_{\rho}(\frac{1}{k+1}(\log \rho)^{k+1}a) = (\log \rho)^k a$ plus lower order terms.

Adding more dimensions is straightforward:

Lemma 7.6. Let $X = [0, \infty)_{\rho_1} \times [0, \infty)_{\rho_2} \times \mathbb{R}^n_{\omega}$, $U = \{\rho_1 < 1, \rho_2 < 1\} \subset X$, $\rho = \rho_1 \rho_2$, and let $\mathcal{E}_1, \mathcal{E}_2$ denote two index sets. Suppose $u \in \rho^{-\infty}H^{\infty}_b(X)$ has support in U, and let $f := \rho_1 D_{\rho_1} u$. Then:

- $(1) f \in \rho_{1}^{a_{1}} \rho_{2}^{a_{2}} H_{b}^{\infty}(X), a_{1} \neq 0 \Rightarrow u \in \mathcal{A}_{phg,b}^{0,a_{2}}(X) + \rho_{1}^{a_{1}} \rho_{2}^{a_{2}} H_{b}^{\infty}(X);$ $(2) f \in \mathcal{A}_{b,phg}^{a_{1},\mathcal{E}_{2}}(X), a_{1} \neq 0 \Rightarrow u \in \mathcal{A}_{phg}^{0,\mathcal{E}_{2}}(X) + \mathcal{A}_{b,phg}^{a_{1},\mathcal{E}_{2}}(X);$ $(3) f \in \mathcal{A}_{phg}^{\mathcal{E}_{1},\mathcal{E}_{2}}(X) \Rightarrow u \in \mathcal{A}_{phg}^{\mathcal{E}_{1} \overline{\cup} 0,\mathcal{E}_{2}}(X); if (0,0) \notin \mathcal{E}_{2}, then u \in \mathcal{A}_{phg}^{\mathcal{E}_{1} \cup 0,\mathcal{E}_{2}}(X).$




FIGURE 7.1. Illustration of Lemma 7.7 which describes solutions of the transport equation along the vector field $-\rho_1\partial_{\rho_1}+\rho_2\partial_{\rho_2}$; one integral curve of this vector field is shown here.

Lemma 7.7. In the notation of Lemma 7.6, with $u \in \rho^{-\infty}H_b^{\infty}(X)$ supported in $\rho_1 \leq 1$, let $f := (\rho_1 D_{\rho_1} - \rho_2 D_{\rho_2})u$. Let $\chi = \chi(\rho_1, \rho_2) \in \mathcal{C}_c^{\infty}([0, 1)^2)$ denote a localizer, identically 1 in a neighborhood of the corner $\rho_1 = \rho_2 = 0$. See Figure 7.1. Then:

- $(1) f \in \rho_{1}^{b_{1}} \rho_{2}^{b_{2}} H_{\mathbf{b}}^{\infty}(X), b_{2} > b_{1} \Rightarrow \chi u \in \rho_{1}^{b_{1}} \rho_{2}^{b_{2}} H_{\mathbf{b}}^{\infty}(X);$ $(2) f \in \mathcal{A}_{\mathbf{b}, \mathbf{phg}}^{b_{1}, \mathcal{E}_{2}}(X), \operatorname{Im} z \neq -b_{1} \text{ whenever } (z, 0) \in \mathcal{E}_{2} \Rightarrow \chi u \in \mathcal{A}_{\mathbf{phg}}^{\mathcal{E}_{2}, \mathcal{E}_{2}}(X) + \mathcal{A}_{\mathbf{b}, \mathbf{phg}}^{b_{1}, \mathcal{E}_{2}}(X);$ $(3) f \in \mathcal{A}_{\mathbf{phg}}^{\mathcal{E}_{1}, \mathcal{E}_{2}}(X) \Rightarrow \chi u \in \mathcal{A}_{\mathbf{phg}}^{\mathcal{E}_{1} \cup \mathcal{E}_{2}, \mathcal{E}_{2}}(X).$

Proof. We drop the \mathbb{R}^n_{ω} factor from the notation for brevity. For (1), write $u(\rho_1, \rho_2) = -i \int_{\rho_1}^1 f(t^{-1}\rho_1, t\rho_2) \frac{dt}{t}$ and $f = \rho_1^{b_1} \rho_2^{b_2} \widetilde{f}$, $\widetilde{f} \in H_b^{\infty}$, then for $0 < \epsilon < b_2 - b_1$

$$\begin{aligned} \|\chi u\|_{\rho_{1}^{b_{1}}\rho_{2}^{b_{2}}L_{b}^{2}}^{2} &\leq \int_{0}^{1} \int_{0}^{1} \left| \int_{\rho_{1}}^{1} t^{b_{2}-b_{1}} \widetilde{f}(t^{-1}\rho_{1}, t\rho_{2}) \frac{dt}{t} \right|^{2} \frac{d\rho_{1}}{\rho_{1}} \frac{d\rho_{2}}{\rho_{2}} \\ &\leq \int_{0}^{1} \left(\int_{\rho_{1}}^{1} t^{b_{2}-b_{1}} \left(\int_{0}^{1} |\widetilde{f}(t^{-1}\rho_{1}, x_{2})| \frac{dx_{2}}{x_{2}} \right)^{1/2} \frac{dt}{t} \right)^{2} \frac{d\rho_{1}}{\rho_{1}} \\ &\leq \left(\int_{0}^{1} t^{2(b_{2}-b_{1}-\epsilon)} \frac{dt}{t} \right) \cdot \int_{0}^{1} \int_{0}^{1} t^{2\epsilon} |\widetilde{f}(x_{1}, x_{2})|^{2} \frac{dx_{2}}{x_{2}} \frac{dt}{t} \frac{dx_{1}}{x_{1}} \\ &\leq C \|f\|_{\rho_{1}^{b_{1}}\rho_{2}^{b_{2}}L_{b}^{2}}, \end{aligned}$$

as desired; higher b-regularity follows by commuting $\rho_j D_{\rho_j}$ through the equation for u.³⁴ For the proof of (2), it suffices to consider a single term

$$f_k = \rho_2^{iz} (\log \rho_2)^k a_k(\rho_1),$$
 (7.3)

with $a_k \in \rho_1^{b_1} H_b^{\infty}(H_1)$ supported in $\rho_1 \leq 1$. Let $u_k = \rho_2^{iz}(\log \rho_2)^k b_k(\rho_1)$, where $b_k = b_k(\rho_1)$ solves

$$(\rho_1 D_{\rho_1} - z)b_k = a_k \tag{7.4}$$

and is supported in $\rho_1 \leq 1$, then the error term

$$f_{k-1} := (\rho_1 D_{\rho_1} - \rho_2 D_{\rho_2}) u_k - f_k = ((\rho_1 D_{\rho_1} - z) - (\rho_2 D_{\rho_2} - z)) u_k - f_k$$
$$= \rho_2^{iz} (\log \rho_2)^{k-1} a_{k-1}(\rho_1), \quad a_{k-1} := ikb_k,$$

is one power of $\log \rho_2$ better than f_k . Rewriting equation (7.4) as $\rho_1 D_{\rho_1}(\rho_1^{-iz}b_k) = \rho_1^{-iz}a_k \in \rho_1^{b_1+\operatorname{Im} z}H_{\mathrm{b}}^{\infty}(H_1)$, we can use Lemma 7.5 to obtain $b_k \in \mathcal{A}_{\mathrm{phg}}^z(H_1) + \rho_1^{b_1}H_{\mathrm{b}}^{\infty}(H_1)$; therefore $u_k \in \mathcal{A}_{\mathrm{phg}}^{z,(z,k)}(X) + \mathcal{A}_{\mathrm{b,phg}}^{b_1,(z,k)}(X)$. Proceeding iteratively, we next solve $(\rho_1 D_{\rho_1} - \rho_2 D_{\rho_2})u_{k-1} = f_{k-1}$ to leading order, etc., reducing k by 1 at each step, and picking up one extra power of $\log \rho_1$ at each stage by Lemma 7.5(3) (conjugated by ρ^{iz}). We obtain $u = \sum_{j=0}^k u_j \in \mathcal{A}_{\mathrm{phg}}^{(z,k),(z,k)}(X) + \mathcal{A}_{\mathrm{b,phg}}^{b_1,(z,k)}(X)$.

The proof of (3) proceeds in the same manner: if f_k is of the form (7.3), now with $a_k \in \mathcal{A}^{\mathcal{E}_1 \overline{\cup} z}_{\mathrm{phg}}(H_1)$, then $b_k \in \mathcal{A}^{\mathcal{E}_1 \overline{\cup} z}_{\mathrm{phg}}(H_1)$, so $u_k \in \mathcal{A}^{\mathcal{E}_1 \overline{\cup} z, (z, k)}_{\mathrm{phg}}(X)$ and $f_{k-1} \in \mathcal{A}^{\mathcal{E}_1 \overline{\cup} z, (z, k-1)}_{\mathrm{phg}}(X)$. Iterating as before gives $u \in \mathcal{A}^{\mathcal{E}_1 \overline{\cup} (z, k), (z, k)}_{\mathrm{phg}}(X)$.

Proof of Theorem 7.1. We shall first prove that if the Cauchy data (h_0, h_1) in the notation of Theorem 6.3 are polyhomogeneous at $\partial^m \Sigma$,

$$h_0, h_1 \in \mathcal{A}_{\text{phg}}^{\mathcal{E}_0}(^m\Sigma),$$
 (7.5)

then the conclusion of Theorem 7.1 holds. Now, by Theorem 6.3, we have $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ for all $b_I < b_I' < b_0$ and $b_+ < 0$. Note that since the gauge condition $\Upsilon(g) = 0$ is satisfied

 $^{^{34}}$ A more conceptual proof, which does not rely on explicit integration of the vector field, uses a positive commutator argument with the commutant $a=\chi_1(\rho_1)\chi_2(\rho_2)\rho_1^{-b_1}\rho_2^{-b_2}, \ \chi_j\in\mathcal{C}_c^{\infty}([0,\infty)), \ \chi_j(\rho)\equiv 1$ near 0, and $\chi_j'\leq 0$, i.e. the evaluation of $2\operatorname{Im}\langle(\rho_1D_{\rho_1}-\rho_2D_{\rho_2})u,a^2u\rangle_{L_b^2}$, in two different ways: once by using the equation satisfied by u, and once by integrating by parts and using that $(\rho_1\partial_{\rho_1}-\rho_2\partial_{\rho_2})a$ has a constant sign on $\sup a\cap\sup u$. See (4.11) for a similar argument.

identically, h solves $\operatorname{Ric}(g) - \widetilde{\delta}^* \Upsilon(g) = 0$ for any choice of $\widetilde{\delta}^*$; this will be useful as it will allow us to work with simpler normal operator models.

For now, consider h as a solution of P(h)=0 for $\gamma_1,\gamma_2>b_I'$ as in Theorem 4.2. We write

$$0 = P(h) = p_0 + \int_0^1 L_{th}(h) dt, \quad p_0 := P(0) \in \mathcal{A}_{phg}^{\emptyset,\emptyset,0}. \tag{7.6}$$

(In fact, supp $p_0 \cap (i^0 \cup \mathscr{I}^+) = \emptyset$ since g_m is the Schwarzschild metric near $i^0 \cap \mathscr{I}^+$.)

Let us first work near i^0 , away from i^+ . Suppose that for some $c \geq b_0$, we already have $h \in \mathcal{A}^{\mathcal{E}_0,-0}_{\mathrm{phg,b}} + \rho_0^c \rho_I^{-0} H_\mathrm{b}^\infty$, $\pi_0 h \in \mathcal{A}^{\mathcal{E}_0,b_I'-0}_{\mathrm{phg,b}} + \rho_0^c \rho_I^{b_I'-0} H_\mathrm{b}^\infty$, with the exponents referring to the behavior at i^0 and \mathscr{I}^+ , respectively. Then

$$L_0 h = -p_0 + \int_0^1 (L_0 - L_{th})(h) dt; \tag{7.7}$$

now $L_0 - L_{th} \in (\mathcal{A}_{phg,b}^{\mathcal{E}_0 - i, -1 - 0} + \rho_0^{c+1, -1 - 0} H_b^{\infty}) \text{Diff}_b^2$ by an inspection of the proof of Lemma 3.8, and it respects the improved behavior of $\pi_0 h$, so we find

$$L_0h \in \mathcal{A}_{\mathrm{phg,b}}^{2\mathcal{E}_0-i,-1-0} + \rho_0^{c+1,-1-0}H_\mathrm{b}^\infty, \quad \pi_0L_0h \in \mathcal{A}_{\mathrm{phg,b}}^{2\mathcal{E}_0-i,-1+b_I'-0} + \rho_0^{c+1,-1+b_I'-0}H_\mathrm{b}^\infty.$$

Denote by $\mathcal{E}_1 := \{(z, j) \in \mathcal{E}_0 \colon \operatorname{Im} z \geq -c\}$ the (finite) set of exponents already captured, and let $\mathcal{E}_2 := \{(z, j) \in \mathcal{E}_0 \colon -c -1 \leq \operatorname{Im} z < -c\}$. Let

$$R_j := \prod_{(z,k)\in\mathcal{E}_j} (\rho_0 D_{\rho_0} - z), \quad R = R_2 \circ R_1.$$

Let $N(L_0) \in \rho_I^{-1} \text{Diff}_b^2(M)$ denote the normal operator of L_0 at i^0 , i.e. freezing the coefficients of L_0 at $\rho_0 = 0$ for a fixed choice of a collar neighborhood $[0, \epsilon)_{\rho_0} \times i^0$ of i^0 ; thus $N(L_0)$ commutes with $\rho_0 \partial_{\rho_0}$, and $L_0 - N(L_0) \in \rho_0 \rho_I^{-1} \text{Diff}_b^2$. Then $Rh \in \rho_0^c \rho_I^{-0} H_b^{\infty}$ solves the equation $N(L_0)(Rh) = f$, where

$$f := -R(L_0 - N(L_0))h + RL_0h \in \rho_0^{c+1}\rho_I^{-1-0}H_b^{\infty}, \quad \pi_0 f \in \rho_0^{c+1}\rho_I^{-1+b_I'-0}H_b^{\infty},$$

due to $2\mathcal{E}_0 - i \subset \mathcal{E}_0$; the Cauchy data of Rh lie in $\rho_0^{c+1}H_{\rm b}^{\infty}$ due to the polyhomogeneity of h_0 and h_1 . The background estimate near i^0 being sharp with regards to the weight at i^0 , see Propositions 4.3 and 4.7, this gives $Rh \in \rho_0^{c+1}\rho_I^{-0}H_{\rm b}^{\infty}$, $\pi_0Rh \in \rho_0^{c+1}\rho_I^{b'_I-0}H_{\rm b}^{\infty}$. Thus, $h \in \mathcal{A}_{\rm phg,b}^{\mathcal{E}_0,-0} + \rho_0^{c+1}\rho_I^{-0}H_{\rm b}^{\infty}$, $\pi_0h \in \mathcal{A}_{\rm phg,b}^{\mathcal{E}_0,b'_I-0} + \rho_0^{c+1}\rho_I^{b'_I-0}H_{\rm b}^{\infty}$. Iterating this gives

$$h \in \mathcal{A}_{\mathrm{phg,b}}^{\mathcal{E}_0,-0}, \quad \pi_0 h \in \mathcal{A}_{\mathrm{phg,b}}^{\mathcal{E}_0,b_I'-0} \quad \text{near } i^0.$$
 (7.8)

Following the structure of the argument in §5, we next prove the polyhomogeneity at $\mathscr{I}^+ \setminus (\mathscr{I}^+ \cap i^+)$ using Lemmas 7.6 and 7.7. We now take $\gamma_1 = \gamma_2 = 0$ in the definition of P and its linearization. Thus, let us work near $i^0 \cap \mathscr{I}^+$, and assume that we already have

$$\pi_0 h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, \mathcal{E}_I'} + \mathcal{A}_{\mathrm{phg}, b}^{\mathcal{E}_0, c_I' - 0}, \quad \pi_{11}^c h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, \bar{\mathcal{E}}_I} + \mathcal{A}_{\mathrm{phg}, b}^{\mathcal{E}_0, c_I - 0}, \quad \pi_{11} h \in \mathcal{A}_{\mathrm{phg}, b}^{\mathcal{E}_0, \mathcal{E}_I} + \mathcal{A}_{\mathrm{phg}, b}^{\mathcal{E}_0, c_I - 0},$$
 (7.9)

for some $0 \le c_I < c_I' \le c_I + 1$. Using (7.6) and the structure of $L_{th} = L_{th}^0 + \widetilde{L}_{th}$, we find

$$\pi_{11}^c L_0^0 \pi_{11}^c h = -\pi_{11}^c p_0 - \int_0^1 \left(\pi_{11}^c \widetilde{L}_{th} \pi_{11}^c h + \pi_{11}^c L_{th} \pi_0 h + \pi_{11}^c L_{th} \pi_{11} h \right) dt. \tag{7.10}$$

The proof of Lemma 3.8, condition (7.2e), and the fact that $\mathcal{E}_I \supset \bar{\mathcal{E}}_I \supset \mathcal{E}_I' \supset \mathcal{E}_I - i$ give

$$\widetilde{L}_{th} \in (\mathcal{C}^{\infty} + \mathcal{A}_{\text{phg}}^{\mathcal{E}_{0} - i, \mathcal{E}_{I}} + \mathcal{A}_{\text{phg}, b}^{\mathcal{E}_{0} - i, c_{I} - 0}) \text{Diff}_{b}^{2},$$

$$\pi_{11}^{c} L_{th}^{0} \pi_{0} \in \rho_{I}^{-1} (\mathcal{C}^{\infty} + \mathcal{A}_{\text{phg}}^{\mathcal{E}_{0} - i, \bar{\mathcal{E}}_{I}} + \mathcal{A}_{\text{phg}, b}^{\mathcal{E}_{0} - i, c_{I} - 0}) \text{Diff}_{b}^{1},$$
(7.11)

and $\pi_{11}^c L_{th}^0 \pi_{11} = 0$. Multiplying (7.10) by ρ_I , grouping function spaces in the order of the summands in the integrand above, and simplifying using $2\mathcal{E}_0 - i \subset \mathcal{E}_0$ and $0 \subset \mathcal{E}_I$, this gives

$$\rho_I \partial_{\rho_I} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) \pi_{11}^c h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, \mathcal{E}_I + \bar{\mathcal{E}}_I - i} + \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, \bar{\mathcal{E}}_I + \mathcal{E}'_I} + \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, 2\mathcal{E}_I - i} + \mathcal{A}_{\mathrm{phg}, b}^{\mathcal{E}_0, c'_I - 0};$$

the first space is contained in the second. In view of condition (7.2c) (note that the index sets in parentheses there lie in Im z < 0), we obtain

$$\pi_{11}^c h \in \mathcal{A}_{\text{phg}}^{\mathcal{E}_0, \bar{\mathcal{E}}_I} + \mathcal{A}_{\text{phg,b}}^{\mathcal{E}_0, c_I' - 0}, \tag{7.12}$$

which improves on the a priori weight of the remainder term at \mathscr{I}^+ . Next,

$$\pi_{11}L_0^0\pi_{11}h = -\pi_{11}p_0 - \int_0^1 \left(\pi_{11}\widetilde{L}_{th}\pi_{11}h + \pi_{11}L_{th}\pi_0h + \pi_{11}L_{th}\pi_{11}^ch\right)dt.$$

Lemma 3.8 and the membership (7.12) imply

$$\pi_{11}L_{th}^{0}\pi_{0} \in \rho_{I}^{-1}(\mathcal{C}^{\infty} + \mathcal{A}_{phg}^{\mathcal{E}_{0}-i,\mathcal{E}_{I}} + \mathcal{A}_{phg,b}^{\mathcal{E}_{0}-i,c_{I}-0})\mathrm{Diff}_{b}^{1},$$

$$\pi_{11}L_{th}^{0}\pi_{11}^{c} \in \rho_{I}^{-1}(\mathcal{A}_{phg}^{\mathcal{E}_{0}-i,\bar{\mathcal{E}}_{I}} + \mathcal{A}_{phg,b}^{\mathcal{E}_{0}-i,c_{I}'-0})\mathrm{Diff}_{b}^{1},$$

with ρ_I times the latter having a leading order term at \mathscr{I}^+ , cf. the discussion of (5.3); together with (7.11) and (7.12), and using $\bar{\mathcal{E}}_I \subset \mathcal{E}_I$, one finds

$$\rho_I \partial_{\rho_I} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) \pi_{11} h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, 2\mathcal{E}_I - i} + \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, \mathcal{E}_I + \mathcal{E}_I'} + \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, 2\bar{\mathcal{E}}_I} + \mathcal{A}_{\mathrm{phg}, \mathbf{b}}^{\mathcal{E}_0, c_I' - 0},$$

with the first space again contained in the second. Condition (7.2d) then gives

$$\pi_{11}h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0,\mathcal{E}_I} + \mathcal{A}_{\mathrm{phg},b}^{\mathcal{E}_0,c_I'-0}.$$
 (7.13)

Lastly then, we can improve on the asymptotics of $\pi_0 h$ at \mathscr{I}^+ by writing

$$\pi_0 L_0^0 \pi_0 h = -\pi_0 p_0 - \int_0^1 \left(\pi_0 \widetilde{L}_{th} \pi_0 h + \pi_0 L_{th} \pi_{11}^c h + \pi_0 L_{th} \pi_{11} h \right) dt;$$

now $\pi_0 L_{th}^0 \pi_{11}^c = 0 = \pi_0 L_{th}^0 \pi_{11}$ and $\mathcal{E}_I' \subset \bar{\mathcal{E}}_I \subset \mathcal{E}_I$, so, since $\gamma_1 = \gamma_2 = 0$,

$$\rho_I \partial_{\rho_I} (\rho_0 \partial_{\rho_0} - \rho_I \partial_{\rho_I}) \pi_0 h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_0, 2\mathcal{E}_I - i} + \mathcal{A}_{\mathrm{phg,b}}^{\mathcal{E}_0, c_I' + 1 - 0};$$

but condition (7.2b) and Lemma 7.7 imply

$$\rho_I \partial_{\rho_I} \pi_0 h \in \mathcal{A}_{phg}^{\mathcal{E}_0, \mathcal{E}_I'} + \mathcal{A}_{phg, b}^{\mathcal{E}_0, c_I' + 1 - 0};$$

an application of Lemma 7.6 gives the same membership for $\pi_0 h$, since we already know that $\pi_0 h$ has no leading term at \mathscr{I}^+ . This establishes (7.9) for (c_I, c_I') replaced by $(c_I', c_I' + 1)$, and we can iterate the procedure to establish the full polyhomogeneity away from i^+ . Near $\mathscr{I}^+ \cap i^+$, the arguments are completely analogous, except we only have conormal regularity $\rho_+^{b_+} H_{\rm b}^{\infty}$ at i^+ . Thus,

$$\pi_0 h \in \mathcal{A}_{\mathrm{phg,phg,b}}^{\mathcal{E}_0,\mathcal{E}_I',b_+}, \quad \pi_{11}^c h \in \mathcal{A}_{\mathrm{phg,phg,b}}^{\mathcal{E}_0,\bar{\mathcal{E}}_I,b_+}, \quad \pi_{11} h \in \mathcal{A}_{\mathrm{phg,phg,b}}^{\mathcal{E}_0,\mathcal{E}_I,b_+}$$

Next, we use this information to obtain an expansion at i^+ , similarly to the arguments around (5.10). We shall use the linearization L_0 , still defined using $\gamma_1 = \gamma_2 = 0$, and its normal operator at $i^+ \subset M$ —instead of its normal operator at the boundary of $\overline{\mathbb{R}^4}$, which obviates the need to relate (partially) polyhomogeneous function spaces on $\overline{\mathbb{R}^4}$ and M. Namely, fix a collar neighborhood

$$U := [0,1)_{\rho_+} \times i^+, \quad i^+ = \{ Z \in \mathbb{R}^3 \colon |Z| \le 1 \},$$

of i^+ in M, and denote by $\mathcal{V}_{b,-}(U) \subset \mathcal{V}(U)$ the Lie subalgebra of vector fields tangent to i^+ but with no condition at \mathscr{I}^+ . Then for $\gamma_1 = \gamma_2 = 0$, we have $L_0 \in \operatorname{Diff}_{b,-}^2(U)$ (the algebra generated by $\mathcal{V}_{b,-}$), acting on sections of $\beta^*S^2|_U$: by Lemma 3.8, $\widetilde{L}_0 \in \operatorname{Diff}_b^2(M) \hookrightarrow \operatorname{Diff}_{b,-}^2(M)$ certainly has smooth coefficients, and the same is true for $L_0^0 = -2\rho^{-2}\partial_0\partial_1 = \partial_{\rho_I}(\rho_I\partial_{\rho_I} - \rho_+\partial_{\rho_+}) + \operatorname{Diff}_b^2(M)$, $\rho_I = 1 - |Z|^2$. Furthermore, by Lemmas 2.4 and 3.9 as well as equation (3.28), the normal operator $N(L_0)$ of L_0 at i^+ can be identified with $N(\underline{L})$, so that in fact $N(L_0) = \Box_{g_{\mathrm{dS}}} - 2$, defined using the expressions (4.61) and (4.64), acting component-wise on the fibers of the trivial bundle $\underline{\mathbb{R}}^{10}$, where we use Lemma 2.5 to identify $\beta^*S^2|_{i^+} \cong {}^0\beta^*(S^2 \operatorname{sc} T^{*0} \overline{\mathbb{R}}^4)|_{0_i^+} \cong \underline{\mathbb{R}}^{10}$ by means of coordinate differentials. By [Va13, §4] and the module regularity proved in [HaVa13],

$$\widehat{L}_0(\sigma)^{-1} \colon \bar{H}^{s-1,k}(i^+) \to \bar{H}^{s,k}(i^+)$$
 (7.14)

is meromorphic for $\sigma \in \mathbb{C}$ with $s > \frac{1}{2} - \operatorname{Im} \sigma$, where the bar refers to extendibility at $\partial i^+ = \{|Z| = 1\}$, while the parameter $k \in \mathbb{N}_0$ measures the amount of regularity under the $C^{\infty}(i^+)$ -module $\operatorname{Diff}_{b}^{1}(i^+)$; that is, $\bar{H}^{s,k}(i^+)$ consists of H^s functions on i^+ which remain in H^s under application of any operator in $\operatorname{Diff}_{b}^{k}(i^+)$. (This is analogous to Lemma 5.3, except in the present de Sitter setting we work on high regularity spaces rather than the low regularity spaces in the Minkowski setting, see [Va13, §5].) Strictly speaking, the references only apply to the operator obtained from L_0 by smooth extension across ∂i^+ to an operator on a slightly larger space than i^+ ; but (7.14) follows simply by using extension and restriction operators, and the choice of extensions is irrelevant since $\widehat{L_0}(\sigma)$ is principally a wave operator beyond ∂i^+ .

The divisor \mathcal{R} of L_0 , see Remark 5.5, is then

$$\mathcal{R} = -i; \tag{7.15}$$

indeed, using the relation between asymptotics on global de Sitter space and resonances on static de Sitter space as in [HiVa16b, Appendix C], this follows from [Va10, Theorem 1.1] for $n=4,\ \lambda=2$, with the logarithmic terms absent: the indicial roots are 1 and 2, see [Va10, Lemma 4.13], and in the notation of (4.64), the difference of $\Box_{g_{\text{dS}}}$ and its indicial operator $-(\hat{\tau}\partial_{\hat{\tau}})^2+3\hat{\tau}\partial_{\hat{\tau}}$ is $\hat{\tau}^2\Delta_{\hat{x}}$ vanishes quadratically in $\hat{\tau}$ as a b-operator on $[0,\infty)_{\hat{\tau}}\times\mathbb{R}^3_{\hat{x}}$, so for the formal solution $u=\hat{\tau}v_-+\hat{\tau}^2v_+$ constructed in [Va10, Lemma 4.13], the Taylor series of v_\pm only contain even powers of $\hat{\tau}$; $1-2\mathbb{N}_0$ and $2-2\mathbb{N}_0$ being disjoint, there are no integer coincidences which would cause logarithmic terms.

Now, consider again (7.7): if $\chi = \chi(\rho_+)$ denotes a localizer near i^+ , identically 1 near i^+ and vanishing near i^0 , we have

$$L_0(\chi h) = -\chi p_0 + [L_0, \chi]h + \int_0^1 \chi(L_0 - L_{th})(h) dt.$$
 (7.16)

We have $\chi p_0 \in \mathcal{A}_{phg}^{\emptyset,0}$, with the exponents now referring to the behavior at \mathscr{I}^+ and i^+ , respectively. Suppose we already have

$$\pi_0 h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_I',\mathcal{E}_+} + \mathcal{A}_{\mathrm{phg},b}^{\mathcal{E}_I',c_+}, \quad \pi_{11}^c h \in \mathcal{A}_{\mathrm{phg}}^{\bar{\mathcal{E}}_I,\mathcal{E}_+} + \mathcal{A}_{\mathrm{phg},b}^{\bar{\mathcal{E}}_I,c_+}, \quad \pi_{11} h \in \mathcal{A}_{\mathrm{phg}}^{\mathcal{E}_I,\mathcal{E}_+} + \mathcal{A}_{\mathrm{phg},b}^{\mathcal{E}}.$$
 (7.17)

Using that $\mathcal{E}_+ - i$ is closed under non-linear operations, i.e. $j(\mathcal{E}_+ - i) + i \subset \mathcal{E}_+, j \in \mathbb{N}$, we find $L_0 - L_{th} \in \mathcal{A}_{phg}^{\mathcal{E}_+ - i} + \rho_+^{c_+ + 1} H_b^{\infty}$ near $(i^+)^{\circ}$; see also Lemma 3.9. Using the structure of L_{th} near $\mathscr{I}^+ \cap i^+$ from Lemma 3.8 as above, and noting that $\sup[L_0, \chi]h \subset \sup d\chi$ is disjoint from i^+ , we deduce that

$$L_0(\chi h) \in \mathcal{A}_{\mathrm{phg}}^{\emptyset,0} + \mathcal{A}_{\mathrm{phg}}^{\widetilde{\mathcal{E}}_I + i,\emptyset} + \mathcal{A}_{\mathrm{phg}}^{\widetilde{\mathcal{E}}_I + i,2\mathcal{E}_+ - i} + \mathcal{A}_{\mathrm{phg},b}^{\widetilde{\mathcal{E}}_I + i,c_+ + 1}, \quad \widetilde{\mathcal{E}}_I := \mathcal{E}_I \setminus \{(0,1)\},$$

where the weight of the remainder term is as stated since all $(z, k) \in \mathcal{E}_+$ except for (0, 0) have $\operatorname{Im} z < 0$. (Here $\widetilde{\mathcal{E}}_I \supset \overline{\mathcal{E}}_I + i \supset \mathcal{E}'_I + i$ allows for a non-logarithmic leading term at \mathscr{I}^+ , capturing the worst component of elements of the space \mathscr{Y}^{∞} in Definition 3.3, and moreover captures all non-linear terms of (7.16).) Replacing L_0 by $N(L_0)$ causes another error term, $(L_0 - N(L_0))(\chi h) \in \mathcal{A}_{\operatorname{phg}}^{\widetilde{\mathcal{E}}_I + i, \mathcal{E}_+ - i} + \mathcal{A}_{\operatorname{phg},b}^{\widetilde{\mathcal{E}}_I + i, \mathcal{E}_+ + 1}$, so

$$N(L_0)(\chi h) \in \mathcal{A}_{\mathrm{phg}}^{\emptyset,0} + \mathcal{A}_{\mathrm{phg}}^{\widetilde{\mathcal{E}}_I + i, \mathcal{E}_+ - i} + \mathcal{A}_{\mathrm{phg,b}}^{\widetilde{\mathcal{E}}_I + i, c_+ + 1}.$$

Mellin transforming in ρ_+ at $\operatorname{Im} \sigma = -b_+$, inverting $\widehat{L_0}(\sigma)$ on $\mathcal{A}_{\operatorname{phg}}^{\widetilde{\mathcal{E}}_I+i}(i^+)$ using Lemma 7.8 below, taking the inverse Mellin transform, and shifting the contour to $\operatorname{Im} \sigma = -c_+ - 1$, we obtain

$$\chi h \in \mathcal{A}_{\mathrm{phg}}^{0,\mathcal{R}\,\overline{\cup}\,0} + \mathcal{A}_{\mathrm{phg}}^{0\,\overline{\cup}\,\widetilde{\mathcal{E}}_I,(\mathcal{R}\,\overline{\cup}\,\widetilde{\mathcal{E}}_I)\,\overline{\cup}(\mathcal{E}_+-i)} + \mathcal{A}_{\mathrm{phg},b}^{0\,\overline{\cup}\,\widetilde{\mathcal{E}}_I,c_++1}.$$

The index set at i^+ is contained in \mathcal{E}_+ by condition (7.2f), so this improves over (7.17) by the weight 1 in the remainder term; the index sets at \mathscr{I}^+ on the other hand are automatically the ones stated (but now with the improvement at i^+), as the presence of a non-zero term in the expansion of $\pi_{11}h$, say, at \mathscr{I}^+ corresponding to some element in $(0 \cup \widetilde{\mathcal{E}}_I) \setminus \mathcal{E}_I$, would contradict our a priori knowledge (7.17). Iterating this gives the polyhomogeneity at i^+ , as claimed.

Next, let us show that the smallest sets satisfying conditions (7.2a)–(7.2f) are indeed index sets: we need to verify condition (2.28b). For \mathcal{E}_0 , this is clear since, letting $\widetilde{\mathcal{E}}_0^0 := \mathcal{E}_0^0 + \mathcal{E}'_{\log}$,

$$\mathcal{E}_0 = \widetilde{\mathcal{E}}_0^0 \cup \bigcup_{j \in \mathbb{N}} j(\widetilde{\mathcal{E}}_0^0 - i) + i$$

and Im $\widetilde{\mathcal{E}}_0^0 < 0$; note that this gives Im $\mathcal{E}_0 < 0$. At \mathscr{I}^+ , we take $\mathcal{E}_I' = \bigcup_{k \in \mathbb{N}} \mathcal{E}_{I,k}'$, likewise for $\bar{\mathcal{E}}_I$ and \mathcal{E}_I , where we recursively define $\mathcal{E}_{I,0}' = \bar{\mathcal{E}}_{I,0} = \mathcal{E}_{I,0} = \emptyset$ and

$$\mathcal{E}'_{I,k+1} = \mathcal{E}_0 \,\overline{\cup} (2\mathcal{E}_{I,k} - i),\tag{7.18a}$$

$$\bar{\mathcal{E}}_{I,k+1} = 0 \cup \left(\mathcal{E}_0 \,\overline{\cup} \left((\bar{\mathcal{E}}_{I,k} + \mathcal{E}'_{I,k}) \cup (2\mathcal{E}_{I,k} - i) \right) \right), \tag{7.18b}$$

$$\mathcal{E}_{I,k+1} = \left(0 \,\overline{\cup} \,\mathcal{E}_0 \,\overline{\cup} \left((\mathcal{E}_{I,k} + \mathcal{E}'_{I,k}) \cup (2\bar{\mathcal{E}}_{I,k}) \right) \right) \cup \bigcup_{j \in \mathbb{N}} \left(j(\mathcal{E}_{I,k} - i) + i \right). \tag{7.18c}$$

It easy to see by induction that

$$\operatorname{Im} \mathcal{E}'_{I,k}, \ \operatorname{Im} \left(\bar{\mathcal{E}}_{I,k} \setminus (0,0) \right), \ \operatorname{Im} \left(\mathcal{E}_{I,k} \setminus (0,1) \right) \leq -c, \ c := \min(1, -\sup \operatorname{Im} \mathcal{E}_0) > 0,$$

for all k. Therefore, to compute the index sets in any fixed half space $\operatorname{Im} z > -N$, it suffices to restrict to $j \leq N+1$ in (7.18c), which implies that the truncated sets $\mathcal{E}'_{I,k;N} := \mathcal{E}'_{I,k} \cap \{\operatorname{Im} z > -N\}$ etc. are finite for all k; we must show that $\mathcal{E}'_{I,k;N}$ etc. are independent of k for sufficiently large k (depending on N). Note then:

- $\mathcal{E}'_{I,k+1;N}$ only depends on $\mathcal{E}_{I,k;(N-1)/2}$;
- $-\bar{\mathcal{E}}_{I,k+1;N}$ only depends on $\mathcal{E}_{I,k;(N-1)/2}$, $\bar{\mathcal{E}}_{I,k;N-c}$, and $\mathcal{E}'_{I,k;N}$;
- $-\mathcal{E}_{I,k+1;N}$ only depends on $\mathcal{E}_{I,k;N-c}$, $\mathcal{E}_{I,k;(N-1)/2}$, $\bar{\mathcal{E}}_{I,k;N}$, and $\mathcal{E}'_{I,k;N}$.

Combining these, one finds that, a forteriori, $\mathcal{E}'_{I,k+1;N}$, $\bar{\mathcal{E}}_{I,k+1;N}$, and $\mathcal{E}_{I,k+1;N}$ only depend on the sets $\mathcal{E}'_{I,k-\ell;N-c}$, $\bar{\mathcal{E}}_{I,k-\ell;N-c}$, $\mathcal{E}_{I,k-\ell;max(N-c,(N-1)/2)}$, $\ell=0,1,2$. Therefore, for N>0, $\mathcal{E}'_{I,k;N}$ etc. are independent of k for k>3N/c, as desired. An analogous argument implies that \mathcal{E}_+ is an index set as well.

Finally, we show that the polyhomogeneity of the initial data γ and k in the sense of (7.1) implies that the solution in the neighborhood U, see (6.7), of $\{t=0\}$ constructed in Lemma 6.2 is indeed polyhomogeneous at $i^0 \cap U$ with index set \mathcal{E}_0 ; this however follows from the same arguments used to prove (7.8) (and we can in fact ignore the weight at \mathscr{I}^+). In fact, working on ${}^0\overline{\mathbb{R}^4}$, we have $h \in \mathcal{A}^{\mathcal{E}'_0}_{\mathrm{phg}}(U)$ where $\mathcal{E}'_0 = \bigcup_{j \in \mathbb{N}_0} \left(j(\mathcal{E}^0_0 - i) + i\right)$ does not include the extra logarithmic terms from $\mathcal{E}_{\mathrm{log}}$; this relies on the observation that the gauged Cauchy data constructed in the proof of Lemma 6.2, see (6.11)–(6.12), lie in $\mathcal{A}^{\mathcal{E}'_0}_{\mathrm{phg}}({}^0\Sigma)$, which follows from an inspection of the proof. Upon pushing the local solution h in U forward to ${}^m\overline{\mathbb{R}^4}$, we incur the logarithmic terms encoded in the index set $\mathcal{E}_{\mathrm{log}}$, see (6.15); this proves (7.5).

To complete the proof, we need to study the action of $\widehat{L_0}(\sigma)^{-1}$ on polyhomogeneous spaces. Let \mathcal{E} be an index set, and let $c \in \mathbb{R}$ be such that $\operatorname{Im} z < -c$ for all $(z,0) \in \mathcal{E}$; then $\mathcal{A}_{\operatorname{pho}}^{\mathcal{E}+i}(i^+) \subset \rho_I^{c-1} H_{\operatorname{b}}^{\infty}(i^+) \subset \bar{H}^{-1/2+c-0,\infty}(i^+)$.

Lemma 7.8. The operator $\widehat{L_0}(\sigma)^{-1}$ in (7.14) extends from $\operatorname{Im} \sigma > -c$ as a meromorphic operator family $\widehat{L_0}(\sigma)^{-1} : \mathcal{A}^{\mathcal{E}+i}_{\operatorname{phg}}(i^+) \to \mathcal{A}^{0\overline{\cup}\mathcal{E}}_{\operatorname{phg}}(i^+)$ with divisor contained in $\mathcal{R} \overline{\cup} \mathcal{E}$.

Proof. Given $f \in \rho_I^{-1} \mathcal{A}_{phg}^{\mathcal{E}}(i^+)$, we explicitly construct a formal solution u_{phg} of $\widehat{L_0}(\sigma)u_{phg} = f$ at ∂i^+ , which we then correct using the inverse (7.14) acting on $\dot{\mathcal{C}}^{\infty}(i^+)$. The construction uses that

$$\widehat{L}_0(\sigma) = -D_{\rho_I}(\rho_I D_{\rho_I} - \sigma) + \text{Diff}_b^2(i^+), \tag{7.19}$$

which follows from the form (4.48) of the dual metric of $\rho^{-2}g_m$. Thus, consider $(z,k) \in \mathcal{E}$, $f_0 \in \mathcal{C}^{\infty}(\partial i^+) = \mathcal{C}^{\infty}(\mathbb{S}^2)$, and suppose $f = \rho_I^{iz-1}(\log \rho_I)^k f_k \in \rho_I^{-1} \mathcal{A}_{phg}^{(z,k)}(i^+)$ near $\rho_I = 0$. If $z \neq 0$, we then have

$$\widehat{L_0}(\sigma) \left(-z^{-1} (z - \sigma)^{-1} \rho_I^{iz} (\log \rho_I)^k f_k \right) - f_{\text{phg}}$$

$$= (z - \sigma)^{-1} \rho_I^{iz-1} (\log \rho_I)^{k-1} f_{k-1} + (z - \sigma)^{-1} f'$$

for some $f_{k-1} \in \mathcal{C}^{\infty}(\partial i^+)$, and with $f' \in \rho_I^{-1} \mathcal{A}_{phg}^{(z,k)-i}(i^+)$ holomorphic in σ . We can iteratively solve away the first term, obtaining $u_j \in \mathcal{C}^{\infty}(\partial i^+)$ such that

$$\widehat{L_0}(\sigma) \left(\sum_{j=0}^k (z - \sigma)^{-j-1} \rho_I^{iz} (\log \rho_I)^{k-j} u_j \right) - f = \sum_{j=0}^k (z - \sigma)^{-j-1} f_j',$$

where $f'_j \in \rho_I^{-1} \mathcal{A}_{\text{phg}}^{(z,k-j)-i}(i^+)$ is holomorphic in σ and has improved asymptotics at ∂i^+ . If on the other hand z = 0, $f = \rho_I^{-1} (\log \rho_I)^k f_k \in \rho_I^{-1} \mathcal{A}_{\text{phg}}^{(0,k)}(i^+)$, we need an extra $\log \rho_I$ term: there exist $u_j \in \mathcal{C}^{\infty}(\partial i^+)$ such that

$$\widehat{L_0}(\sigma) \left(\sum_{j=0}^k \sigma^{-j-1} (\log \rho_I)^{k+1-j} u_j \right) - f = \sum_{j=0}^k \sigma^{-j-1} f_j', \quad f_j' \in \rho_I^{-1} \mathcal{A}_{\text{phg}}^{(0,k+1-j)-i}(i^+).$$

(Note that there is no term on the left with $(\log \rho_I)^0$.) In general, given $f \in \rho_I^{-1} \mathcal{A}_{\text{phg}}^{\mathcal{E}}(i^+)$, we can use these arguments and asymptotic summation to construct, locally in σ , a family $u_{\text{phg}} \in \mathcal{A}_{\text{phg}}^{0 \cup \mathcal{E}}(i^+)$, depending meromorphically on σ with divisor contained in \mathcal{E} , such that

$$\widehat{L_0}(\sigma)u_{\mathrm{phg}} - f =: f' \in \mathcal{A}_{\mathrm{phg}}^{\emptyset}(i^+) = \dot{\mathcal{C}}^{\infty}(i^+)$$

is meromorphic with divisor contained in \mathcal{E} ; applying $\widehat{L_0}(\sigma)^{-1}$ to this gives an element of $\mathcal{C}^{\infty}(i^+) = \mathcal{A}^0_{\text{phg}}(i^+)$, and

$$u := \widehat{L_0}(\sigma)^{-1} f = u_{\text{phg}} - \widehat{L_0}(\sigma)^{-1} f'$$

solves $\widehat{L_0}(\sigma)u = f$, with divisor contained in $\mathcal{R} \cup \mathcal{E}$ due to the second term.

The global solution $g = g_m + \rho h$ constructed on the space ${}^m_m M$ in Theorem 6.7 is polyhomogeneous as well; the only place where this is not immediate is i^0 , where however polyhomogeneity is well-defined under the assumption (6.15) on the index set \mathcal{E}_0 , which is already satisfied for the set \mathcal{E}_0 constructed in Theorem 7.1. Thus, the index sets of h at i^- , \mathscr{I}^- , i^0 , \mathscr{I}^+ , and i^+ are \mathcal{E}_+ , \mathcal{E}_I , \mathcal{E}_0 , \mathcal{E}_I , and \mathcal{E}_+ , respectively, likewise for the refined asymptotics of $\pi^c_{11}h$ and π_0h near \mathscr{I}^{\pm} .

8. Bondi mass and the mass loss formula

We shall first use a different characterization of the Bondi mass than the one outlined in §1.3: the Bondi mass can be calculated from the leading lower order terms of the metric g in a so-called Bondi–Sachs coordinate system in §8.2; in order to define these coordinates, we first need to study a special class of null-geodesics in §8.1, namely those which asymptotically look like outgoing radial null-geodesics in the Schwarzschild spacetime. For simplicity, we work with the infinite regularity solutions of Theorem 1.7, and we only control the Bondi–Sachs coordinates in a small neighborhood of $(\mathscr{I}^+)^{\circ}$, as this is all that is needed for deriving the mass loss formula. More precise estimates, including up to $\mathscr{I}^+ \cap i^+$, of this coordinate system, and a precise description of future-directed null-geodesics and other aspects of the geometry near (null) infinity will be discussed elsewhere.

8.1. Asymptotically radial null-geodesics. Suppose $g = g_m + \rho h$, $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$, solves Ric(g) = 0 in the gauge $\Upsilon(g;g_m) = 0$, where the weights are as in Definition 3.1; by an inspection of the expressions in §A.2, the gauge condition implies improved decay of certain (sums and derivatives of) components of the metric perturbation h, for instance, $\Upsilon(g)_0 = 0$ implies

$$\Gamma_0^{00} \in mr^{-2} + H_b^{\infty;2+b_0,2+b_I,2+b_+}.$$
 (8.1)

We wish to study null-geodesics near $(\mathscr{I}^+)^{\circ}$. Introducing coordinates v^{μ} on $T\mathbb{R}^4$ by writing tangent vectors as $v^{\mu}\partial_{x^{\mu}}$, the geodesic vector field $H \in \mathcal{V}(T\mathbb{R}^4)$ takes the form

$$H = v^{\mu} \partial_{x^{\mu}} + \Gamma^{\mu}_{\kappa \lambda} v^{\kappa} v^{\lambda} \partial_{v^{\mu}}.$$

As usual, we will use $x^0 = t + r_*$, $x^1 = t - r_*$, and local coordinates x^2, x^3 on \mathbb{S}^2 . Consider first the case that h = 0, so g is the Schwarzschild spacetime near \mathscr{I}^+ . Radial null-geodesics then have constant x^1 and x^b , b = 2, 3, while $v^0(s) = \dot{x}^0(s)$ satisfies the ODE $\dot{v}^0 = -mr(s)^{-2}(v^0)^2$, so $\ddot{x}^0 = -mr^{-2}(\dot{x}^0)^2$. We then use:

Lemma 8.1. We have $r = r_* - 2m \log r_* + \mathcal{O}(r_*^{-1} \log r_*)$, and $r_* = \frac{1}{2}(x^0 - x^1)$.

Proof. Let $r_0(r_*) \equiv r_*$ and

$$r_{k+1}(r_*) = r_* - 2m\log(r_k(r_*) - 2m) = r_* - 2m\log(r_k) - 2m\log(1 - 2mr_k^{-1}),$$

then $|r_{k+1} - r_k| \le Cr_*^{-1}|r_k - r_{k-1}|, k \ge 1$, and the fact that $|r_1 - r_0| = \mathcal{O}(\log r_*)$ show that $r - r_1 = \mathcal{O}(r_*^{-1}\log r_*)$, hence evaluation of r_1 gives the result.

Often, we will only need the consequence that

$$r = \frac{1}{2}x^0 + \mathcal{O}(\log x^0) \tag{8.2}$$

for bounded x^1 , suggesting the approximation $\ddot{x}^0 = -4m(x^0)^{-2}(\dot{x}^0)^2$ for the geodesic equation. Solving this by Picard iteration with initial guess $x_0^0(s) \equiv s$ gives

$$x_1^0(s) = s + 4m \log s, \quad \dot{x}_1^0(s) = 1 + 4ms^{-1},$$

and subsequent iterations give $\mathcal{O}(s^{-1}\log s)$, resp. $\mathcal{O}(s^{-2}\log s)$, corrections to $x_1^0(s)$, resp. $\dot{x}_1^0(s)$. Let us generalize such radial null-geodesics:

Proposition 8.2. Fix a point $p \in (\mathscr{I}^+)^\circ$ with coordinates $x^i(p) =: \bar{x}^i$. Then there exists a future-directed null-geodesic $\gamma : [0, \infty) \to M$, $\gamma(s) = (x^{\mu}(s))$ such that $\gamma(s) \to p$ in M and $x^a(s) - \bar{x}^a = o(s^{-1})$ as $s \to \infty$.

Proof. We will normalize γ by requiring that $x^0(s) \sim s + 4m \log s$, and we shall seek $\gamma \colon [s_0, \infty) \to M$ for $s_0 > 0$ large. For weights $\alpha_0, \alpha_1, \not \alpha > 0$, to be specified in (8.10) below, we will solve the geodesic equation on the level of the velocity $v^{\mu} = \dot{x}^{\mu}$ using a suitable Picard iteration scheme on the Banach space

$$X := \{ v = (v^{\mu}) \colon [s_0, \infty) \to \mathbb{R}^4 \colon \widetilde{v}^0 \in s^{-1-\alpha_0} \mathcal{C}^0, \ v^1 \in s^{-1-\alpha_1} \mathcal{C}^0, \ v^a \in s^{-1-\alpha} \mathcal{C}^0 \}, \tag{8.3}$$

where we use the notation

$$\tilde{v}^0(s) := v^0(s) - (1 + 4ms^{-1}),$$

and where $C^0 \equiv C^0([s_0, \infty))$ is equipped with the sup norm; as the norm on X, we then take the maximum of the weighted C^0 norms of \tilde{v}^0 and v^i , i = 1, 2, 3. For $v \in X$, we define its integral x = I(v), $\dot{x}^{\mu}(s) = v^{\mu}(s)$, by

$$x^{0}(s) := s + 4m \log s - \int_{s}^{\infty} \widetilde{v}^{0}(u) du,$$

$$x^{i}(s) := \overline{x}^{i} - \int_{s}^{\infty} v^{i}(u) du, \quad i = 1, 2, 3.$$
(8.4)

As the first iterate, we take

$$\tilde{v}_0^0(s), \, v_0^i(s) \equiv 0, \, x_0 := I(v_0);$$

note that $||v_0||_X = 0$. For $k \ge 0$ and $v_k \in X$, $||v_k||_X < \epsilon$, with $\epsilon > 0$ small and determined later, and $x_k = I(v_k)$, let then

$$v_{k+1}^{\mu}(s) := v_k^{\mu}(\infty) + \int_s^{\infty} \Gamma_{\kappa\lambda}^{\mu}|_{x_k(u)} v_k^{\kappa}(u) v_k^{\lambda}(u) du, \quad x_{k+1} := I(v_{k+1}). \tag{8.5}$$

Note that for some fixed constant C > 0,

$$|x_k^0(s) - s - 4m \log s| \le C\epsilon s^{-\alpha_0}, \quad |x_k^1(s) - \bar{x}^1| \le C\epsilon s^{-\alpha_1}, \quad |x_k^i(s) - \bar{x}^i| \le C\epsilon s^{-\alpha_k}, \quad (8.6)$$

which in particular allows us to estimate the Christoffel symbols appearing in (8.5). For $\mu = 0$, writing $r_k(s) = r(x_k(s))$, and using the improved decay of various Christoffel symbols due to the gauge condition $\Upsilon(g) = 0$, we have

$$\widetilde{v}_{k+1}^{0}(s) = -4ms^{-1} + \int_{s}^{\infty} mr_{k}(u)^{-2} du + \int_{s}^{\infty} \mathcal{O}_{s_{0}}(u^{-2-b_{I}}) du
+ \int_{s}^{\infty} \mathcal{O}_{s_{0}}(u^{-2} \log u \cdot 1 \cdot \epsilon u^{-1-\alpha_{1}}) + \mathcal{O}_{s_{0}}(u^{-1} \cdot 1 \cdot \epsilon u^{-1-\phi})
+ \mathcal{O}_{s_{0}}(u^{-1} \log u \cdot \epsilon^{2} u^{-2-\alpha_{1}}) + \mathcal{O}_{s_{0}}(u^{-1} \log u \cdot \epsilon u^{-1-\alpha_{1}} \cdot \epsilon u^{-1-\phi})
+ \mathcal{O}_{s_{0}}(u \cdot \epsilon^{2} u^{-2-2\phi}) du,$$
(8.7)

with the integrals on the first line coming from terms with $(\kappa, \lambda) = (0, 0)$ and using (8.1), while the remaining terms come from $(\kappa, \lambda) = (0, 1)$, (0, b), (1, 1), (1, b), (a, b), in this order, using that $v_k^0 = 1 + \mathcal{O}(\epsilon)$, $v_k^1 = \mathcal{O}(\epsilon s^{-1-\alpha_1})$, and $v_k^a = \mathcal{O}(\epsilon s^{-1-\alpha_\ell})$. As for the notation, the constants implicit in the \mathcal{O}_{s_0} notation depend only on s_0 and are non-increasing with s_0 , as they come from the size of the Christoffel symbols along $x_k(s)$, which satisfies (8.6). By (8.2) and (8.6), we have

$$\int_{s}^{\infty} m r_{k}(u)^{-2} du = \int_{s}^{\infty} 4m(u^{-2} + \mathcal{O}(u^{-3}\log u)) du = 4ms^{-1} + \mathcal{O}(s^{-2}\log s).$$

Therefore, we have

$$|\tilde{v}_{k+1}^{0}(s)| \lesssim_{s_0} s^{-1-b_I} + \epsilon s^{-2-\alpha_1} \log s + \epsilon s^{-1-\phi} + \epsilon^2 s^{-2\phi},$$

which, for fixed $\alpha_0 < b_I$, is bounded by $\epsilon s^{-1-\alpha_0}$ for large s_0 , provided $\alpha_0 < \min(\phi, 1 + \alpha_1, 2\phi - 1)$; in particular, this requires $\phi > \frac{1}{2}$. We obtain estimates on $v_{k+1}^i(s)$, i = 1, 2, 3,

in a similar manner. Namely,

$$v_{k+1}^{1}(s) = \int_{s}^{\infty} \mathcal{O}_{s_{0}}(u^{-2-b'_{I}} \cdot 1^{2}) + \mathcal{O}_{s_{0}}(u^{-2} \cdot 1 \cdot \epsilon u^{-1-\alpha_{1}}) + \mathcal{O}_{s_{0}}(u^{-1-b'_{I}} \cdot 1 \cdot \epsilon u^{-1-\phi})$$

$$+ \mathcal{O}_{s_{0}}(u^{-1} \cdot \epsilon^{2}u^{-2-2\alpha_{1}}) + \mathcal{O}_{s_{0}}(u^{-1} \cdot \epsilon u^{-1-\alpha_{1}} \cdot \epsilon u^{-1-\phi})$$

$$+ \mathcal{O}_{s_{0}}(u \cdot \epsilon^{2}u^{-2-2\phi}) du$$

$$(8.8)$$

satisfies $|v_{k+1}^1(s)| \lesssim_{s_0} s^{-1-b_I'} + \epsilon^2 s^{-2\phi}$, hence $|v_{k+1}^1(s)| < \epsilon s^{-1-\alpha_1}$ provided the weights satisfy $\alpha_1 < \min(b_I', 2\phi - 1)$, and provided we increase s_0 , if necessary. Lastly, using the precise form of the leading term of Γ_{0b}^c ,

$$v_{k+1}^{a}(s) = \int_{s}^{\infty} \mathcal{O}_{s_{0}}(u^{-3-b'_{I}}) + \mathcal{O}_{s_{0}}(u^{-3} \cdot 1 \cdot \epsilon u^{-1-\alpha_{1}})$$

$$+ (u^{-1} \cdot 1 \cdot \epsilon u^{-1-\phi} + \mathcal{O}_{s_{0}}(u^{-2} \cdot 1 \cdot \epsilon u^{-1-\phi}))$$

$$+ \mathcal{O}_{s_{0}}(u^{-2} \cdot \epsilon^{2}u^{-2-2\alpha_{1}}) + \mathcal{O}_{s_{0}}(u^{-1} \cdot \epsilon u^{-1-\alpha_{1}} \cdot \epsilon u^{-1-\phi})$$

$$+ \mathcal{O}_{s_{0}}(1 \cdot \epsilon^{2}u^{-2-2\phi}) du.$$
(8.9)

Integrating the first term in the second line gives a term bounded from above by

$$\left| -\frac{\epsilon}{1+\alpha} s^{-1-\alpha} \right| < \frac{2}{3} \epsilon s^{-1-\alpha} \quad (\alpha > \frac{1}{2}),$$

so we get $|v_{k+1}^a(s)| < \epsilon s^{-1-\phi}$ provided $\phi < 1 + b_I'$ (which is consistent with $\phi > \frac{1}{2}$). Thus, the iteration (8.5) maps the ϵ -ball in X into itself, provided we fix weights

$$\alpha_0 \in (0, b_I), \quad \alpha_1 \in (0, b_I'), \quad \alpha \in (\frac{1}{2}, 1 + b_I'),$$

$$(8.10)$$

and choose s_0 large; recall here that $0 < b_I < b'_I < 1$. Moreover, taking s_0 larger if necessary, $v_k \mapsto v_{k+1}$ is a contraction; such an estimate is only non-obvious for the difference of quadratic terms in (8.5) involving the component v^0 ; however, the corresponding terms come with a *small* prefactor due to the smallness of the relevant Christoffel symbols.

Let now $v := \lim_{k \to \infty} v_k \in X$ denote the limiting curve in $T\mathbb{R}^4$, and integrate it by setting $\gamma := I(v)$. Then v satisfies the integral equation (8.5) with v_k and v_{k+1} replaced by v, so v is \mathcal{C}^1 , hence γ is a \mathcal{C}^2 geodesic. In particular, $|v(s)|_{g(s)}^2$ is constant, hence equal to its limit as $s \to \infty$, which is

$$\mathcal{O}(s^{-1-b_I'} \cdot 1^2) + \mathcal{O}(1 \cdot 1 \cdot s^{-1-\alpha_1}) + \mathcal{O}(s^{-b_I'} \cdot 1 \cdot s^{-1-\phi})$$

$$+ \mathcal{O}(s^{-1} \log s \cdot s^{-2-2\alpha_1}) + \mathcal{O}(1 \cdot s^{-1-\alpha_1} \cdot s^{-1-\phi}) + \mathcal{O}(s^2 \cdot s^{-2-2\phi}) = o(1), \quad s \to \infty.$$

This proves that γ is a null-geodesic with the desired properties.

Note that γ is the *unique* null-geodesic, up to translation of the affine parameter, tending to p and such that $\dot{\gamma} \in X$. (Indeed, for any such γ , the velocity $\dot{\gamma}$ has *small* norm in a space defined like X but with weights decreased by a small amount and for s_0 large enough. The uniqueness then follows from the fixed point theorem.)

Definition 8.3. For $p \in (\mathscr{I}^+)^{\circ}$, denote by $\gamma_p(s)$ the maximal null-geodesic such that $v = \dot{\gamma}_p$ and $x = \gamma_p$ satisfy equation (8.4) and $v \in X$, with X given in (8.3). We call γ_p a radial null-geodesic.

We record the following stronger regularity property of the geodesics γ_p :

Lemma 8.4. In the notation of Proposition 8.2, let $\gamma_p(s) = (x^{\mu}(s))$ denote a radial null-geodesic; then we have

$$\widetilde{x}^{0}(s) \in S^{-\alpha_{0}}([s_{0}, \infty)), \quad \widetilde{x}^{1}(s) \in S^{-\alpha_{1}}([s_{0}, \infty)), \quad \widetilde{x}^{a}(s) \in S^{-\phi}([s_{0}, \infty)),$$

for all weights $\alpha_0 < b_I$, $\alpha_1 < b_I'$, $\phi < 1 + b_I'$, where $\widetilde{x}^0(s) := x^0(s) - (s + 4m \log s)$, $\widetilde{x}^i(s) := x^i(s) - \overline{x}^i$, and where $S^m([s_0, \infty))$ denotes symbols of order m, i.e. functions $u \in \mathcal{C}^{\infty}([s_0, \infty))$ such that for any $k \in \mathbb{N}_0$, $|u^{(k)}(s)| \leq C_k \langle s \rangle^{m-k}$.

Proof. Certainly $x^{\mu}(s)$ is smooth as a geodesic in a spacetime with smooth metric tensor. The symbolic estimates for $\partial_s^k \widetilde{x}^{\mu}(s)$ for k=0,1 follow immediately from the construction of γ_p in the proof of Proposition 8.2; for k=2, they follow from the proof as well, specifically, from the decay of the integrands in (8.7)–(8.9). Assuming that for some $k \geq 1$ we have $|\partial_s^j \widetilde{x}^0(s)| \lesssim \langle s \rangle^{\alpha_0 - j}$, $0 \leq j \leq k+1$, with α_0 as in (8.10), likewise for \widetilde{x}^i , i=1,2,3, we have

$$\partial_s^k(\partial_s^2 \widetilde{x}^0) = \partial_s^k \widetilde{x}^0 - \partial_s^{k+2}(s + 4m \log s) = \partial_s^k \widetilde{x}^0 + \partial_s^k (4ms^{-2}),$$

and $\partial_s^k \ddot{x}^0 = -\partial_s^k (\Gamma_{\mu\nu}^0 \dot{x}^\mu \dot{x}^\nu)$. Note that $x^0(s) = \mathcal{O}(s)$, $\partial_s x^0(s) = \mathcal{O}(1)$, and $\partial_s^j x^0(s) = \mathcal{O}(s^{-1-j})$ for $2 \le j \le k+1$. Expanding the derivatives using the Leibniz and chain rules thus gives the following types of terms: for $(\mu, \nu) = (0, 0)$ and all derivatives falling on the Christoffel symbol,

$$(\partial_s^k \Gamma_{00}^0)(\dot{x}^0)^2 = \partial_s^k (4ms^{-2} + \mathcal{O}(s^{-2-b_I}))(1 + \mathcal{O}(s^{-1}\log s))$$
$$= \partial_s^k (4ms^{-2}) + \mathcal{O}(s^{-k-2-b_I})$$

by the inductive hypothesis and the b-regularity of the remainder term in Γ_{00}^0 ; the remaining $(\mu, \nu) = (0, 0)$ terms are, with $\ell_1 + \ell_2 + \ell_3 = k$ and $\ell_2 > 0$,

$$(\partial_s^{\ell_1} \Gamma_{00}^0)(\partial_s^{\ell_2} \dot{x}^0)(\partial_s^{\ell_3} \dot{x}^0) = \mathcal{O}(s^{-2-\ell_1} \cdot s^{-1-\ell_2} \cdot s^{-\ell_3}) = \mathcal{O}(s^{-k-3}).$$

Estimating the terms with $(\mu, \nu) \neq (0, 0)$ does not require special care: derivatives falling on \dot{x}^{μ} are estimated using the inductive hypothesis (thus every derivative gives an extra power of decay in s); a derivative falling on $\Gamma^0_{\mu\nu}$ on the other hand either produces $(\partial_0 \Gamma^0_{\mu\nu}) \dot{x}^0$, which gains an order of decay due to the Christoffel symbol (recall that ∂_0 is a b-derivative which vanishes at \mathscr{I}^+), or $(\partial_i \Gamma^0_{\mu\nu}) \dot{x}^i$, which gains an order of decay due to $\dot{x}^i = \mathcal{O}(s^{-1})$. Thus, the bound $\partial_s^k (\partial_s^2 \tilde{x}^0) = \mathcal{O}(s^{-k-2-\alpha_0})$ follows from the same arithmetic of weights as used after (8.7).

The arguments for the other components \tilde{x}^i are completely analogous, and in fact simpler as no terms need to be handled separately. This finishes the inductive step, and thus the proof of the lemma.

We further note that for any compact subset $K \in (\mathscr{I}^+)^\circ$, there exists a uniform value $s_0 \in \mathbb{R}$ such that the null-geodesics γ_p , $p \in K$, are defined on $[s_0, \infty)$; since moreover γ_p arises, via $\gamma_p = I(\dot{\gamma}_p)$ as in (8.4), from the Banach fixed point theorem for a smooth (in p) contraction, Lemma 8.4 holds *smoothly* in the parameter p, that is, making the dependence on p explicit as a subscript, we have $\widetilde{x}_p^0(s) \in \mathcal{C}^\infty(K; S^{-\alpha_0}([s_0, \infty)))$ etc.

Consider now the union of radial null-geodesics tending to the points of particular \mathbb{S}^2 sections of \mathscr{I}^+ . Concretely, for fixed $\bar{x}^1 \in \mathbb{R}$, denote




FIGURE 8.1. The outgoing light cone $C_{\bar{x}^1}$ limiting to the sphere $S(\bar{x}^1) \subset (\mathscr{I}^+)^{\circ}$. Also shown are a number of radial null-geodesics.

$$S(\bar{x}^1) := \{ p \in \mathscr{I}^+ : x^1(p) = \bar{x}^1 \}, \quad C_{\bar{x}^1} := \bigcup_{p \in S(\bar{x}^1)} \gamma_p((s_0, \infty)), \tag{8.11}$$

where s_0 is chosen sufficiently large, which will always be assumed from now on. See Figure 8.1. Thus, on the Schwarzschild spacetime, $C_{\bar{x}^1}$ is the part of the null hypersurface $x^1 = \bar{x}^1$ on which $x^0 \gtrsim s_0$.

Lemma 8.5. For $\bar{x}^1 \in \mathbb{R}$, the set $C_{\bar{x}^1}$ is a smooth null hypersurface near \mathscr{I}^+ . More generally, let $I^1 \subseteq \mathbb{R}$ be a precompact open interval, then there exists a function u such that

$$u - x^1 =: \widetilde{u} \in \rho_I^{b_I' - 0} H_{\mathbf{b}}^{\infty}(M); \quad C_{\bar{x}^1} = \{ u = \bar{x}^1 \}, \quad \bar{x}^1 \in I^1.$$
 (8.12)

Proof. With coordinates x^a , a=2,3, on \mathbb{S}^2 , write $\gamma(\bar{x}^1;s,\bar{x}^2,\bar{x}^3):=\gamma_{(\bar{x}^1,\bar{x}^2,\bar{x}^3)}(s)$. First, we shall prove that there exists a coordinate change of $\mathbb{R}_{x^0}\times\mathbb{R}^2_{x^2,x^3}$,

$$\Phi(\bar{x}^1; x^0, x^2, x^3) = (x^0 - 4m \log x^0 + \widetilde{\Phi}^0, x^2 + \widetilde{\Phi}^2, x^3 + \widetilde{\Phi}^3) =: (\Phi^0, \Phi^2, \Phi^3), \tag{8.13}$$

depending parametrically on $\bar{x}^1 \in I^1$, and with $\widetilde{\Phi}^0 \in S^{-\alpha_0}$, $\widetilde{\Phi}^a \in S^{-\phi}$ for weights as in (8.10) (with the symbolic behavior in x^0), such that the map

$$\delta(x^0, \bar{x}^1, x^2, x^3) := \gamma(\bar{x}^1; \Phi(\bar{x}^1; x^0, x^2, x^3))$$

satisfies $x^i \circ \delta = x^i$, i = 0, 2, 3. To do this, recall that, putting $\gamma^\mu := x^\mu \circ \gamma$, we have $\gamma^0 - (s + 4m \log s) =: \widetilde{\gamma}^0 \in S^{-\alpha_0}, \ \gamma^1 - \bar{x}^1 =: \widetilde{\gamma}^1 \in S^{-\alpha_1}, \ \text{and} \ \gamma^a - \bar{x}^a =: \widetilde{\gamma}^a \in S^{-\alpha_0}, \ \text{so after some simplifications, our task becomes choosing } \widetilde{\Phi}^i \text{ such that}$

$$\widetilde{\Phi}^{0} = 4m \log(1 - 4m(x^{0})^{-1}(\log x^{0} + \widetilde{\Phi}^{0})) - \widetilde{\gamma}^{0}(\bar{x}^{1}; \Phi), \quad \widetilde{\Phi}^{a} = -\widetilde{\gamma}^{a}(\bar{x}^{1}; \Phi); \quad (8.14)$$

this can be solved, first with $\widetilde{\Phi}^0 \in (x^0)^{-\alpha_0} \mathcal{C}^0$ etc. using the fixed point theorem, and then in symbol spaces using the smoothness of $\widetilde{\Phi}^0$ (which follows from the implicit function theorem) and an iterative argument.

Let us drop x^0, x^2, x^3 from the notation. The desired function u is then defined implicitly by $u \circ \delta = \bar{x}^1$. Writing $x^1(\delta(\bar{x}^1)) =: \bar{x}^1 + f$, where $f \in S^{-\alpha_1}$ by Lemma 8.4, we see that δ is one to one for large x^0 , as $\bar{x}^1 + f(\bar{x}^1) = \bar{y}^1 + f(\bar{y}^1)$ implies $0 \ge |\bar{x}^1 - \bar{y}^1| - C(x^0)^{-\alpha_1}|\bar{x}^1 - \bar{y}^1|$, so $\bar{x}^1 = \bar{y}^1$ if x^0 is large. Writing $u = \bar{x}^1 + \tilde{u}$, we thus need to solve

$$(\bar{x}^1 + \widetilde{u}) + f(\bar{x}^1 + \widetilde{u}) = \bar{x}^1 \iff \widetilde{u} = -f(\bar{x}^1 + \widetilde{u}),$$

which by another application of the fixed point theorem has a solution $\widetilde{u} \in S^{-\alpha_1}$. Lastly, note that the vector fields ∂_{x^i} , i=2,3,4, and $x^0\partial_{x^0}$ span $\mathcal{V}_{\mathbf{b}}(M)$ near $(\mathscr{I}^+)^{\circ}$ in view of $\rho_I=1/x^0$, hence $S^{-\alpha_1}\subset \rho_I^{\alpha_1-0}H_{\mathbf{b}}^{\infty}$ near $(\mathscr{I}^+)^{\circ}$. Since we can take α_1 arbitrarily close to b_I' by (8.10), the lemma follows.

The function u is uniquely defined by (8.12); thus, Lemma 8.5 shows the existence of a neighborhood

$$(\mathscr{I}^+)^\circ \subset U^+ \subset M \tag{8.15}$$

and a function $u \in x^1 + \rho_I^{b_I' - 0} H_{\mathrm{b,loc}}^{\infty}(U^+)$ such that $C_{\bar{x}^1} \cap U^+ = \{u = \bar{x}^1\}$ for all $\bar{x}^1 \in \mathbb{R}$.

Remark 8.6. The weight in (8.12) is consistent with the choice of the domain (4.14) whose boundary component U_{ϵ}^{∂} is spacelike, see (4.15).

Since $|\nabla u|^2 \equiv 0$ by construction, the vector field ∇u consists of null-generators of its level sets C_u ; more precisely, we have $\nabla_{\nabla u}\nabla u=0$, so restricted to the image of a radial null-geodesic $\gamma_p \subset C_u$, we have $(\nabla u)|_{\gamma_p(s)} = c_p\dot{\gamma}_p(s)$ for some constant c_p . Taking the inner product with ∂_1 and using the form (3.14) of g yields $1 + \mathcal{O}(s^{-b_I'+0}) = c_p(\frac{1}{2} + \mathcal{O}(s^{-1}))$, so letting $s \to \infty$ gives $c_p = 2$ and thus

$$(\nabla u)|_{\gamma_p(s)} = 2\dot{\gamma}_p(s).$$

We can then extract more information using $r = \frac{1}{2}s + \mathcal{O}(\log s)$ and $g_{01} = \frac{1}{2} + 2s^{-1}(h_{01} - m) + \mathcal{O}(s^{-2}\log s)$: Lemma 8.4 then gives $2\langle \dot{\gamma}_p(s), \partial_1 \rangle = 1 + 4s^{-1}h_{01} + \mathcal{O}(s^{-1-\alpha_0})$, so

$$\partial_1 \tilde{u} - 2r^{-1} h_{01} \in \rho_I^{1+b_I-0} H_b^{\infty}.$$
 (8.16)

8.2. Bondi–Sachs coordinates; proof of the mass loss formula. The function u has non-vanishing differential everywhere on $C_{\bar{x}^1}$ when x^0 is large; we will use it one coordinate of a Bondi–Sachs coordinate system $(u, \mathring{r}, \mathring{x}^2, \mathring{x}^3)$, where the coordinates \mathring{r} and \mathring{x}^a , a = 2, 3, are geometrically defined and constructed below; with respect to such a coordinate system, the metric takes the form

$$g = g_{uu} du^2 + 2g_{u\mathring{r}} du d\mathring{r} - \mathring{r}^2 q_{ab} (d\mathring{x}^a - \widetilde{U}^a du) (d\mathring{x}^b - \widetilde{U}^b du)$$

for some g_{uu} , $g_{u\mathring{r}}$, q_{ab} , and \widetilde{U}^a , and quantities of geometric or physical interest such as the Bondi mass and the gravitational energy flux can be calculated in terms of certain lower order terms of these metric coefficients [BoBuMe62, MaWi16]. We begin by defining \mathring{r} . Introduce a projection $\pi \colon U^+ \to \mathbb{S}^2$ by

$$\pi(\gamma_{(\bar{x}^1,\theta)}(s)) := \theta, \quad \theta \in \mathbb{S}^2,$$

which is well-defined due to Lemma 8.5; in fact, in the notation of its proof, using local coordinates x^a , a = 2, 3, on \mathbb{S}^2 , we have

$$\pi(x^0, x^1, x^2, x^3) = (\Phi^a(x^1 + \widetilde{u}; x^0, x^2, x^3))_{a=2,3}, \tag{8.17}$$

which in particular gives

$$\pi(x^0, x^1, x^2, x^3) - (x^2, x^3) \in S^{-\phi}.$$
(8.18)

The map π defines a fibration of every C_u ; these fibrations have natural sections, as we proceed to explain invariantly. Let $N := \ker \pi_*$ denote the subbundle (smooth in M°) consisting of vectors tangent to the fibers of π : this is the bundle of null generators of the null hypersurfaces C_u , and therefore $N \perp TC_u$. This implies that the spacetime metric g restricts to an element

$$[g] \in S^2(TC_u/N)^*.$$

On the other hand, the pull-back $\pi^* \not g$ induces a Riemannian metric $[\pi^* \not g]$ on TC_u/N , i.e. an isomorphism $TC_u/N \to (TC_u/N)^*$, hence $[\pi^* \not g]^{-1}[g] \in \operatorname{End}(TC_u/N)$ is well-defined. We then define the area radius \mathring{r} by the formula

$$\mathring{r}^4 := \det([\pi^* \not q]^{-1}[g]), \quad \mathring{r} > 0.$$

Lemma 8.7. We have $\mathring{r} - r \in \rho_I^{b_I' - 0} H_{\rm b}^{\infty}$ and $\partial_0 \mathring{r} = \frac{1}{2} - mr^{-1} + \rho_I^{1 + b_I' - 0} H_{\rm b}^{\infty}$ near $(\mathscr{I}^+)^{\circ}$.

Proof. It suffices to prove the first claim. We start by finding representatives in TC_u of a basis of TC_u/N by considering the vector fields

$$V_a = f_a \partial_1 + \partial_a, \quad a = 2, 3, \tag{8.19}$$

with f_a to be determined. Working over the image of a fixed geodesic $\gamma_p: [s_0, \infty) \to M$, we use $\dot{\gamma}_p = (1 + \mathcal{O}(s^{-1}))\partial_0 + \mathcal{O}(s^{-1-\alpha_1})\partial_1 + \sum_c \mathcal{O}(s^{-1-\phi})\partial_c$ and the form of g to calculate

$$g(\dot{\gamma}_p, V_a) = (\frac{1}{2} + \mathcal{O}(s^{-1}))(1 + \mathcal{O}(s^{-1}))f_a + \mathcal{O}(s^{1-\phi});$$

demanding this to vanish determines $f_a = \mathcal{O}(s^{1-\phi})$. Since $\phi < 1 + b_I'$ is arbitrary, we conclude that

$$g(V_a, V_b) = -r^2 g_{ab} + r h_{\bar{a}\bar{b}} + \mathcal{O}(r^{-b_I'} + 0), \tag{8.20}$$

while the observation (8.18) implies that $\pi_*(V_a) \in \partial_a + C_a^b \partial_b$, $C_a^b = \mathcal{O}(s^{-\phi})$, hence

$$(\pi^* \mathfrak{g})(V_a, V_b) = \mathfrak{g}_{ab} + \mathcal{O}(s^{-1-b_I'+0}). \tag{8.21}$$

Therefore,

$$\mathring{r}^4 = r^4 \det \left(1 - r^{-1} (\not g^{bc} h_{\bar{a}\bar{b}})_{a,c=2,3} + \mathcal{O}(s^{-1-b_I'+0})\right) = r^4 (1 - r^{-1} \not t h + \mathcal{O}(s^{-1-b_I'+0})),$$

which is equal to $r^4(1+\mathcal{O}(s^{-1-b_I'+0}))$ due to the decay of th at \mathscr{I}^+ coming from the membership $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$, i.e. ultimately from the gauge condition. Taking fourth roots, carrying symbolic behavior in s through the argument, and noting that these calculations depend smoothly on the parameter $p \in (\mathscr{I}^+)^{\circ}$ completes the proof.

Corollary 8.8. Define the punctured neighborhood $\dot{U}^+ := U^+ \setminus (\mathscr{I}^+)^\circ$ of $(\mathscr{I}^+)^\circ$, see (8.15). Then if U^+ is a sufficiently small neighborhood, $(u, \mathring{r}, \pi) : \dot{U}^+ \to \mathbb{R} \times \mathbb{R} \times \mathbb{S}^2$ is a coordinate system on \dot{U}^+ .

Proof. This follows from Lemma 8.7 and the asymptotics of u and π in (8.12) and (8.18). \square

Choosing local coordinates x^a on \mathbb{S}^2 and letting $\mathring{x}^a := x^a \circ \pi = x^a + \rho_I^{1+b_I'-0} H_{\mathrm{b}}^{\infty}$, we can introduce the Bondi–Sachs coordinates

$$(u, \mathring{r}, \mathring{x}^2, \mathring{x}^3) \tag{8.22}$$

on U; the metric g and its dual $G = g^{-1}$ simplify in this coordinate system since, by construction,

$$G(du, du) \equiv 0, \quad G(du, d\mathring{x}^a) = (\nabla u)(\mathring{x}^a) \equiv 0.$$
 (8.23)

Furthermore, using (8.16) and Lemma 8.7,

$$G(du, d\mathring{r}) = 1 + \rho_I^{1+b_I'-0} H_{\mathbf{b}}^{\infty},$$

$$G(d\mathring{x}^a, d\mathring{x}^b) = -\mathring{r}^{-2} \mathbf{g}^{ab} - \mathring{r}^{-3} h^{\bar{a}\bar{b}} + \rho_I^{3+b_I'-0} H_{\mathbf{b}}^{\infty},$$
(8.24)

where the leading term in the first expression comes from $g^{01}(\partial_1 u)(\partial_0 \mathring{r})$. In order to calculate $G(d\mathring{r}, d\mathring{r})$ to the same level of precision, we need to sharpen Lemma 8.7.

Lemma 8.9. Near $(\mathscr{I}^+)^{\circ}$, we have

$$\partial_1 \mathring{r} = -\frac{1}{2} + \left(m + \frac{1}{2} (h_{11} - 2h_{01}) + r \partial_0 h_{11} - \frac{1}{4} \nabla_a \nabla_b h^{\bar{a}\bar{b}} \right) r^{-1} + \rho_I^{1+b_I - 0} H_b^{\infty}.$$

Note that in (8.20), we already control $g(V_a, V_b)$ modulo terms more than two orders beyond the leading term, which suffices for present purposes. On the other hand, the remainder term in (8.21) is not precise enough.

Proof of Lemma 8.9. Put $A := [\pi^* \not g]^{-1} [r^{-2}g] \in \operatorname{End}(TC_u/N)$, so $(\mathring{r}/r)^4 = \det A$, and Lemma 8.7 gives $A_a^b = \delta_a^b - r^{-1}h_{\bar{a}}^{\bar{b}} + \rho_I^{1+b_I'-0}H_{\mathrm{b}}^{\infty}$ and $(\det A) - 1 \in \rho_I^{1+b_I'-0}H_{\mathrm{b}}^{\infty}$. Suppose now that

$$\partial_1(\det A) = r^{-2}\mu + o(r^{-2}),$$
 (8.25)

then $\partial_1((\mathring{r}-r)/r) = \frac{1}{4}(\det A)^{-3/4}\partial_1(\det A) = \frac{1}{4}r^{-2}\mu + o(r^{-2})$, so expanding the left hand side as $r^{-1}(\partial_1\mathring{r} + \frac{1}{2} - mr^{-1}) + o(r^{-2})$ implies that

$$\partial_1 \mathring{r} = -\frac{1}{2} + r^{-1} \left(m + \frac{1}{4} \mu \right) + o(r^{-1}) \tag{8.26}$$

Our calculations will imply that the $o(r^{-1})$ remainder is of size $\mathcal{O}(r^{-1-b_I+0})$, but we shall stick to $o(r^{-1})$ etc. for brevity. Trivializing TC_u/N locally using the frame $\{V_a\colon a=2,3\}$, with V_a defined in (8.19), A becomes a 2×2 matrix-valued function. We can thus use the formula $\partial_1(\det A)=(\det A)\operatorname{tr}(A^{-1}\partial_1 A)$, so it suffices to determine the function μ in $\operatorname{tr}(A^{-1}\partial_1 A)=r^{-2}\mu+o(r^{-2})$. One contribution comes from differentiating $[r^{-2}g]$, which by (8.20) and $\Upsilon(g)_1=0$ yields

$$\operatorname{tr}([r^{-2}g]^{-1}\partial_{1}[r^{-2}g]) = (-\not g^{ab} - r^{-1}h^{\bar{a}\bar{b}} + \mathcal{O}(r^{-2+0}))(\partial_{1}(r^{-1}h_{\bar{a}\bar{b}}) + \mathcal{O}(r^{-2-b'_{I}+0}))$$

$$= -r^{-1}\partial_{1} \not tr h - r^{-2}h^{\bar{a}\bar{b}}\partial_{1}h_{\bar{a}\bar{b}} + o(r^{-2})$$

$$= 2r^{-2}(h_{11} - 2h_{01}) - 2r^{-2} \not \nabla_{d}h_{1}^{\bar{d}} + 4r^{-1}\partial_{0}h_{11} + o(r^{-2}).$$
(8.27)

The remaining contribution to $\operatorname{tr}(A^{-1}\partial_1 A)$ is $-\operatorname{tr}([\pi^* \not g]^{-1}\partial_1[\pi^* \not g])$ (using the cyclicity of the trace). Let us work near a point $z_0 \in \mathbb{R}^4$, and suppose x^2, x^3 are normal coordinates on \mathbb{S}^2 centered at the point $\pi(z_0)$. Then

$$\begin{aligned}
\left(\partial_{1}(\pi^{*} \mathscr{g})(V_{a}, V_{b})\right)|_{z_{0}} &= \partial_{1}\left((\mathscr{g}_{cd} \circ \pi)(\pi_{*} V_{a})^{c}(\pi_{*} V_{b})^{d}\right)|_{z_{0}} \\
&= \mathscr{g}_{cd}|_{\pi(z_{0})}(\partial_{1}(\pi_{*} V_{a})^{c})(\pi_{*} V_{b})^{d} + \mathscr{g}_{cd}|_{\pi(z_{0})}(\pi_{*} V_{a})^{c}(\partial_{1}(\pi_{*} V_{b})^{d}).
\end{aligned}$$

Now $(\pi_* V_a)^c = \delta_a^c + \mathcal{O}(r^{-1-b_I'+0})$, whose derivative along ∂_1 is of size $\mathcal{O}(r^{-1-b_I'+0})$, so

$$\partial_1(\pi^* \mathfrak{g})(V_a, V_b) = \mathfrak{g}_{bc} \partial_1(\pi_* V_a)^c + \mathfrak{g}_{ac} \partial_1(\pi_* V_b)^c + o(r^{-2}) \quad \text{at } z_0.$$
 (8.28)

Let us first calculate the contribution to this coming from the term ∂_a in V_a . By (8.17) and recalling the form of the map Φ from (8.13) as well as its defining relation (8.14), we have

$$\partial_{1}(\pi_{*}\partial_{a})^{b} = \partial_{1}\partial_{a}\widetilde{\Phi}^{b}(x^{1} + \widetilde{u}; x^{0}, x^{2}, x^{3})$$

$$= -\partial_{1}\partial_{a}\widetilde{\gamma}^{b}(x^{1} + \widetilde{u}; x^{0} - 4m\log x^{0} + \widetilde{\Phi}^{0}, x^{2} + \widetilde{\Phi}^{2}, x^{3} + \widetilde{\Phi}^{3});$$

$$(8.29)$$

now $\widetilde{\gamma}^b$, its x^c -derivatives (c=2,3), and $\widetilde{\Phi}^b$ are of size $\mathcal{O}((x^0)^{-1-b_I'+0})$, so dropping $\widetilde{\Phi}^2$ and $\widetilde{\Phi}^3$ gives an $o(r^{-2})$ error; likewise, $\partial_{x^0}\widetilde{\gamma}^b = \mathcal{O}(r^{-2-b_I'+0})$, so replacing the second argument by x^0 gives another $o(r^{-2})$ error.

To analyze this further, we need to digress: consider the 1-parameter family $w(s;\epsilon) := \gamma_{(x^1+\epsilon,x^2,x^3)}(s)$ of null-geodesics, with x^2,x^3 fixed, and let

$$Y(s) := \partial_{\epsilon} w(s; 0) \equiv \partial_1 \gamma_{(x^1, x^2, x^3)}(s)$$

denote the Jacobi field along $\gamma(s) := w(s; 0)$. The asymptotics proved in Proposition 8.2 give the a priori information

$$Y(s) = \mathcal{O}(s^{-b_I+0})\partial_0 + (1 + \mathcal{O}(s^{-b_I'+0}))\partial_1 + \sum_c \mathcal{O}(s^{-1-b_I'+0})\partial_c,$$

$$\partial_s Y(s) = \mathcal{O}(s^{-1-b_I+0})\partial_0 + \mathcal{O}(s^{-1-b_I'+0})\partial_1 + \sum_c \mathcal{O}(s^{-2-b_I'+0})\partial_c.$$
(8.30)

We shall determine the component $Y(s)^b$ by solving the Jacobi equation

$$\left(\nabla_{\dot{\gamma}}\nabla_{\dot{\gamma}}Y(s) + R(Y,\dot{\gamma})\dot{\gamma}\right)^b = 0. \tag{8.31}$$

Heuristically, it suffices to calculate this modulo $o(s^{-4})$ errors, as the second integral of such error terms (integrating from infinity) is $o(s^{-2})$; we will verify this heuristic in the course of our calculations. Using $\dot{\gamma}^0 = 1 + \mathcal{O}(s^{-1})$, $\dot{\gamma}^1 = \mathcal{O}(s^{-1-b_I'+0})$, $\dot{\gamma}^c = \mathcal{O}(s^{-2-b_I'+0})$, the a priori information (8.30), and the expressions for the curvature tensor in (A.7), one finds

$$(R(Y,\dot{\gamma})\dot{\gamma})^b = R^b{}_{\lambda\mu\nu}\dot{\gamma}^\lambda Y^\mu\dot{\gamma}^\nu = -R^b{}_{001}(\dot{\gamma}^0)^2 Y^1 - R^b{}_{00a}(\dot{\gamma}^0)^2 Y^a + o(s^{-4}).$$

Now, using the gauge condition $\Upsilon(g)_0=0$ and the expressions for Christoffel symbols given in (A.3), one finds that in fact $R^b{}_{00a}=o(s^{-3})$, rendering the second term size $o(s^{-4})$. Let us calculate $R^b{}_{001}=\partial_0\Gamma^b{}_{01}-\partial_1\Gamma^b{}_{00}+\Gamma^\mu{}_{01}\Gamma^b{}_{0\mu}-\Gamma^\mu{}_{00}\Gamma^b{}_{\mu 1}$ more accurately than in (A.7). In the third term, the only contribution which is not $o(r^{-4})$ comes from $\mu=2,3$, giving $-\frac{1}{4}r^{-3}\partial_1h_0^{\bar{b}}+\frac{1}{4}r^{-4}\nabla^bh_{01}$; the fourth term is $o(r^{-4})$. For the second term, we use

$$\Gamma_{00}^{b} = g^{0b}\Gamma_{000} + g^{1b}\Gamma_{100} + g^{ab}\Gamma_{a00} = o(s^{-4}) + o(s^{-4}) - (r^{-2}\partial_0 h_0^{\bar{b}} - \frac{1}{2}r^{-3}\nabla^b h_{00}),$$

exploiting $\Upsilon(g)_0 = 0$. In view of the leading order vanishing of $h_0^{\bar{b}}$ and h_{00} at \mathscr{I}^+ , we have $\partial_1 \Gamma^b_{00} = -r^{-2} \partial_0 (\partial_1 h_0^{\bar{b}}) + \frac{1}{2} r^{-3} \nabla^b \partial_1 h_{00} + o(s^{-4})$; now $\partial_1 h_0^{\bar{b}}$ can be rewritten, using $\Upsilon(g)_b = 0$, in terms of h_{01} , $h_{\bar{b}\bar{c}}$, and $h_{1\bar{b}}$; since these have (size 1) leading terms at \mathscr{I}^+ , subsequent differentiation along ∂_0 only produces non-trivial terms (i.e. not of size $o(r^{-4})$) when acting on the r-weights. On the other hand, $\partial_1 h_{00} = -r^{-1} h_{01} + o(r^{-1})$ from $\Upsilon(g)_0 = 0$. Arguing similarly for the computation of $\partial_0 \Gamma^b_{01}$, one ultimately finds that all non-trivial terms cancel, so

$$R^{b}_{001} = o(r^{-4}).$$

Thus, the curvature term of the Jacobi equation (8.31) is of size $o(s^{-4})$ simply. Regarding the first term of (8.31), the information (8.30) and a brief calculation give $(\nabla_{\dot{\gamma}}Y)^0 = \mathcal{O}(s^{-1-b_I+0})$, $(\nabla_{\dot{\gamma}}Y)^1 = \mathcal{O}(s^{-1-b_I'+0})$, and, using $r^{-1} = 2s^{-1} + \mathcal{O}(s^{-2}\log s)$,

$$\begin{split} (\nabla_{\dot{\gamma}} Y)^b &= \partial_s Y^b + \Gamma^b_{\mu\lambda} \dot{\gamma}^\mu Y^\lambda \\ &= \partial_s Y^b + s^{-1} Y^b - 2 s^{-3} \nabla_d h^{\bar{b}\bar{d}} + 4 s^{-3} h_1^{\bar{b}} + o(s^{-3}), \end{split}$$

with non-trivial contributions only from $(\mu, \lambda) = (0, 1)$, (0, c). In particular, $\nabla_{\dot{\gamma}} Y$ satisfies the same rough asymptotics as $\partial_s Y$ in (8.30). Since differentiation of $h^{\bar{b}\bar{d}}$ and $h_1^{\bar{b}}$ along $\dot{\gamma}$ gains a weight s^{1+b_I} due to these components having a leading term, this and (8.31) imply

$$o(s^{-4}) = (\nabla_{\dot{\gamma}} \nabla_{\dot{\gamma}} Y)^b = \partial_s (\nabla_{\dot{\gamma}} Y)^b + s^{-1} (\nabla_{\dot{\gamma}} Y)^b + o(s^{-4})$$

$$= \partial_s^2 Y^b + 2s^{-1} \partial_s Y^b + 4s^{-4} \nabla_d h^{\bar{b}\bar{d}} - 8s^{-4} h_1^{\bar{b}} + o(s^{-4})$$

= $s^{-2} (\partial_s (s^2 \partial_s Y^b) - 2\tilde{\mu} s^{-2} + o(s^{-2})),$

where

$$\widetilde{\mu} = \lim_{s \to \infty} (4h_1^{\bar{b}} - 2\nabla_d h^{\bar{b}\bar{d}})$$

is the value of this combination of metric coefficients at $\gamma(\infty) \in \mathscr{I}^+$. Since $\lim_{s\to\infty} s^2 \partial_s Y^b = 0$ due to (8.30), we find $\partial_s Y^b = -2\widetilde{\mu} s^{-3} + o(s^{-3})$ and thus

$$Y^b = \tilde{\mu}s^{-2} + o(s^{-2}) \tag{8.32}$$

since $\lim_{s\to\infty} Y^b = 0$.

Returning to the expression (8.29), dropping \widetilde{u} gives an $\mathcal{O}(r^{-2-b_I'+0})$ error term by Lemma 8.5; we thus conclude that

$$\partial_1(\pi_*\partial_a)^b = -\partial_1\partial_a\gamma^b(x^1; x_0, x^2, x^3) + o(r^{-2}) = \left(-\nabla_a h_1^{\bar{b}} + \frac{1}{2}\nabla_a\nabla_d h^{\bar{b}\bar{d}}\right)r^{-2} + o(r^{-2}). \tag{8.33}$$

We have another term in (8.28) coming from the term $f_a\partial_1$ in V_a ; but f_a and its derivative along x^1 being of size $\mathcal{O}(r^{-b_I'+0})$ (see the proof of Lemma 8.7), it suffices to show that $(\pi_*\partial_1)^c = \mathcal{O}(r^{-2})$ in order to conclude that $\partial_1(\pi_*(f_a\partial_1))^c = o(r^{-2})$ is a lower order term. But we can simplify $(\pi_*\partial_1)^c|_{(x^0,x^1,x^2,x^3)} = \partial_1\Phi^c = -\partial_1\widetilde{\gamma}^c(x^1;x^0,x^2,x^3) + o(r^{-2}) = \mathcal{O}(r^{-2})$ (using (8.32)) in the same manner as we simplified (8.29).

Finally then, plugging (8.33) into (8.28), and adding the result to (8.27) yields (8.25) for

$$\mu = 2(h_{11} - 2h_{01}) + 4r\partial_0 h_{11} - \nabla_a \nabla_b h^{\bar{a}\bar{b}},$$

which by (8.26) proves the lemma.

We can also compute $\partial_1 \mathring{x}^b = \partial_1 \pi^b$ modulo $o(r^{-2})$, as this is given by the component Y^b of the Jacobi vector field of the proof of Lemma 8.9, so $\partial_1 \mathring{x}^b = (h_1^{\bar{b}} - \frac{1}{2} \nabla d h^{\bar{b}\bar{d}}) r^{-2} + o(r^{-2})$. In summary, we have shown that

$$du = o(r^{-1})dx^{0} + \left(1 + 2r^{-1}h_{01} + o(r^{-1})\right)dx^{1} + \sum_{c} o(1)dx^{c},$$

$$d\mathring{r} = \left(\frac{1}{2} - mr^{-1} + o(r^{-1})\right)dx^{0} + \left(-\frac{1}{2} + \left(m + \frac{1}{2}(h_{11} - 2h_{01}) + r\partial_{0}h_{11} - \frac{1}{4}\nabla_{a}\nabla_{b}h^{\bar{a}\bar{b}}\right)r^{-1} + o(r^{-1})\right)dx^{1} + \sum_{c} o(1)dx^{c},$$

$$d\mathring{x}^{a} = o(r^{-2})dx^{0} + \left(\left(h_{1}^{\bar{a}} - \frac{1}{2}\nabla_{d}h^{\bar{a}\bar{d}}\right)r^{-2} + o(r^{-2})\right)dx^{1} + dx^{a} + \sum_{c} o(r^{-1})dx^{c},$$

$$(8.34)$$

where the remainders are in fact more precise: $o(r^{-k})$ can be replaced by $\rho_I^{k+b_I-0}H_{\rm b}^{\infty}$ near $(\mathscr{I}^+)^{\circ}$, so a forteriori by $\mathcal{O}(r^{-k-b_I+0})$. We can now supplement (8.23)–(8.24) by

$$G(d\mathring{r}, d\mathring{r}) = -1 + 2mr^{-1} + 2\partial_0 h_{11} - \frac{1}{2}r^{-1}\nabla_a \nabla_b h^{\bar{a}\bar{b}} + \rho_I^{1+b_I-0} H_b^{\infty},$$

$$G(d\mathring{r}, d\mathring{x}^b) = (h_1^{\bar{b}} - \frac{1}{2}\nabla_d h^{\bar{b}\bar{d}})r^{-2} + \rho_I^{2+b_I'-0} H_b^{\infty}.$$
(8.35)

(Note that in the first line, the logarithmically divergent terms h_{11} from $g^{00}(\partial_0 \mathring{r})^2$ and $g^{11}(\partial_1 \mathring{r})^2$ cancel.) Let us summarize the calculations (8.23)–(8.24) and (8.35):

Proposition 8.10. In the Bondi–Sachs coordinates (8.22), the dual metric $G = g^{-1}$ is

$$G = 2(1 + o(\mathring{r}^{-1}))\partial_{u}\partial_{\mathring{r}} - \left(1 - 2m\mathring{r}^{-1} - 2\partial_{0}h_{11} + \frac{1}{2}\mathring{r}^{-1}\nabla_{a}\nabla_{b}h^{\bar{a}\bar{b}} + o(\mathring{r}^{-1})\right)\partial_{\mathring{r}}^{2} - \mathring{r}^{-2}(\not g^{ab} + \mathring{r}^{-1}h^{\bar{a}\bar{b}} + o(\mathring{r}^{-1}))\left(\partial_{\mathring{x}^{a}} + (U_{a}\mathring{r}^{-2} + o(\mathring{r}^{-2}))\partial_{\mathring{r}}\right)\left(\partial_{\mathring{x}^{b}} + (U_{b}\mathring{r}^{-2} + o(\mathring{r}^{-2}))\partial_{\mathring{r}}\right),$$

where $U_a = -\frac{1}{2}h_{1\bar{a}} + \frac{1}{4}\nabla^c h_{\bar{a}\bar{c}}$. The metric g itself takes the form

$$g = \left(1 - 2m\mathring{r}^{-1} - 2\partial_0 h_{11} + \frac{1}{2}\mathring{r}^{-1}\nabla_a\nabla_b h^{\bar{a}\bar{b}} + o(\mathring{r}^{-1})\right)du^2 + 2(1 + o(\mathring{r}^{-1}))du\,d\mathring{r} - \mathring{r}^2(\not g_{ab} - \mathring{r}^{-1}h_{\bar{a}\bar{b}} + o(\mathring{r}^{-1}))\left(d\mathring{x}^a - (U^a\mathring{r}^{-2} + o(\mathring{r}^{-2}))du\right)\left(d\mathring{x}^b - (U^b\mathring{r}^{-2} + o(\mathring{r}^{-2}))du\right).$$

The $o(\mathring{r}^{-k})$ remainders can be replaced by $\rho_I^{k+b_I-0}H_b^{\infty} = \mathcal{O}(r^{-k-b_I+0})$ near $(\mathscr{I}^+)^{\circ}$. Furthermore, the coordinate vector fields satisfy

$$\partial_{u} = \left(1 - (h_{11} + 2r\partial_{0}h_{11} - \frac{1}{2}\nabla_{a}\nabla_{b}h^{\bar{a}\bar{b}})r^{-1} + o(r^{-1})\right)\partial_{0} + (1 - 2h_{01}r^{-1} + o(r^{-1}))\partial_{1} + \left((-h_{1}^{\bar{a}} + \frac{1}{2}\nabla_{b}h^{\bar{a}\bar{b}})r^{-2} + o(r^{-2})\right)\partial_{a}, \partial_{\hat{r}} = (2 + 4mr^{-1} + o(r^{-1}))\partial_{0} + o(r^{-1})\partial_{1} + \sum_{c} o(r^{-2})\partial_{c},$$

$$\partial_{\hat{x}^{a}} = o(1)\partial_{0} + o(1)\partial_{1} + \partial_{a} + \sum_{c} o(r^{-1})\partial_{c}.$$
(8.36)

Proof. The statement (8.36) on the dual basis of (8.34) follows by matrix inversion.

Remark 8.11. For comparison, the Bondi–Sachs coordinates on Schwarzschild are simply $u=x^1$, $\mathring{r}=r$, and spherical coordinates $\mathring{x}^a=x^a$, and the metric takes the form

$$(g_m^S)^{-1} = 2\partial_u \partial_{\mathring{r}} - (1 - 2m\mathring{r}^{-1})\partial_{\mathring{r}}^2 - \mathring{r}^{-2} \mathcal{G}, \quad g_m^S = (1 - 2m\mathring{r}^{-1})du^2 + 2du\,d\mathring{r} - \mathring{r}^2 \mathcal{G}.$$

Remark 8.12. Near $(\mathscr{I}^+)^\circ$ and relative to the smooth structure on M, the conformally rescaled metric $r^{-2}g$ is singular as an incomplete metric at \mathscr{I}^+ : indeed, $r^2\partial_0$ is a non-zero multiple of ∂_{ρ_I} by (2.24), and $r^2g(r^2\partial_0, r^2\partial_0) = rh_{00} = \mathcal{O}(\rho_I^{-1+b_I'})$. On the other hand, changing the smooth structure of M near $(\mathscr{I}^+)^\circ$ by declaring $(\mathring{r}^{-1}, u, \mathring{x}^2, \mathring{x}^3)$ to be a smooth coordinate system, so $\mathring{\rho}_I := \mathring{r}^{-1}$ is a defining function of \mathscr{I}^+ , we have $\mathring{r}^{-2}g \in \mathcal{C}^{1,b_I-0}$. Indeed, $\partial_{\mathring{\rho}_I} = -\mathring{r}^2\partial_{\mathring{r}}$ is null, while $(\mathring{r}^{-2}g)(\partial_{\mathring{\rho}_I},\partial_u) = 1 + \mathcal{O}(\mathring{\rho}_I^{1+b_I-0})$ is \mathcal{C}^{1,b_I-0} , and the remaining metric coefficients have at least this amount of regularity. Since by Theorem 6.3 one can take b_I arbitrarily close to $\min(b_0,1)$, this gives

$$\mathring{r}^{-2}g \in \mathcal{C}^{1,\alpha} \quad \forall \, \alpha < \min(b_0, 1), \tag{8.37}$$

relative to the new smooth structure. As mentioned in §1.3, smoothness properties of conformal compactifications have been widely discussed, in particular from the point of view of asymptotic simplicity [Pe65] and the decay properties of the curvature tensor [KlNi03b, Ch02]; see also [Fr04] for further references. Whether or not there exists a compactification with smooth (or at least highly regular) \mathscr{I}^+ , meaning that the conformally rescaled metric extends smoothly and non-degenerately across \mathscr{I}^+ , is a delicate issue as it depends very sensitively on the precise choice of the conformal factor and the smooth structure near \mathscr{I}^+ and requires the identification of at least two 'incommensurable' geometric quantities. The observation (8.37) shows that this cannot happen prior to the next-to-leading order terms in the expansion of g at \mathscr{I}^+ . Work by Christodoulou [Ch02] on the other hand (see

³⁵An example would be given by two metric components which have non-zero leading terms of size ρ_I and $\rho_I \log \rho_I$, respectively, though we reiterate that this depends on the choice of ρ_I , i.e. of the smooth structure.

also [Da12, §1.5.3]) strongly suggests that the conformal compactification is generically at most of class $C^{1,\alpha}$.

Therefore, the mass aspect, see [MaWi16, Equation (37)], is $-\frac{1}{2}$ times the \mathring{r}^{-1} coefficient of the du^2 component,

$$M_A(p) = m + (r\partial_0 h_{11} - \frac{1}{4} \nabla_a \nabla_b h^{\bar{a}\bar{b}})|_p, \quad p \in (\mathscr{I}^+)^\circ,$$
 (8.38)

and the Bondi mass $M_{\rm B}(u) := \frac{1}{4\pi} \int_{S(u)} M_A d\phi$ is

$$M_{\mathcal{B}}(u) = m + \frac{1}{4\pi} \int_{S(u)} r \partial_0 h_{11} \, d\mathbf{g}, \quad u \in \mathbb{R}, \tag{8.39}$$

where we exploited that the divergence in the expression (8.38) integrates to zero.

Remark 8.13. Recall that near $(\mathscr{I}^+)^{\circ}$, h_{11} can be written as $h_{11}^{(1)} \log \rho_I + h_{11}^{(0)} + \rho_I^{b_I} H_{\rm b}^{\infty}$, with $h_{11}^{(j)} \in \mathcal{C}^{\infty}((\mathscr{I}^+)^{\circ})$, j = 0, 1, so $r\partial_0 h_{11}|_{\mathscr{I}^+} = -\frac{1}{2}h_{11}^{(1)}$ picks out the logarithmic term.

Theorem 8.14. The Bondi mass (8.39) satisfies the mass loss formula

$$\frac{d}{du}M_{\rm B}(u) = -\frac{1}{32\pi} \int_{S(u)} |N|_{\not g}^2 d\not g, \quad N_{ab} := \partial_u h_{\bar{a}\bar{b}}|_{\mathscr{I}^+}. \tag{8.40}$$

Moreover, $M_B(-\infty) = m$ is the ADM mass of the initial data, while $M_B(+\infty) = 0$.

Proof. The formula (8.40) is an immediate consequence of Lemma 3.5, and $M_{\rm B}(-\infty) = m$ follows from the fact that $r\partial_0 h_{11} \in \rho_0^{b_0} \rho_+^{b_+} H_{\rm b}^{\infty}(\mathscr{I}^+)$ decays to 0 as $\rho_0 \to 0$.

Let us fix the boundary defining function ρ to be equal to r^{-1} near \mathscr{I}^+ , and fix ρ_I and ρ_+ near i^+ so that $\rho_I \rho_+ = \rho$. In order to prove $M_{\rm B}(+\infty) = 0$, we analyze the equation satisfied by $h^+ := h|_{i^+}$. The existence of this leading term was proved in §7 starting with equation (7.16) (in which we do not use constraint damping); that is, restricting that equation to i^+ and using the Mellin-transformed normal operators $\widehat{L}_0(0) = \widehat{\underline{L}}(0) \in \rho_I^{-1} {\rm Diff}_{\rm b}^2(i^+)$ at frequency 0 (so this is the action of L_0 on 2-tensors smooth down to i^+ followed by restriction to i^+), we have

$$\widehat{L}(0)h^{+} = -P(0)|_{i^{+}} = -\rho^{-3}\operatorname{Ric}(g_{m})|_{i^{+}}.$$
(8.41)

Moreover, h_{11}^+ has a logarithmic leading order term $h_\ell^+ \log \rho_I$,

$$h^{+} - h_{\ell}^{+} \log \rho_{I} (dx^{1})^{2} \in \mathcal{C}^{\infty}(i^{+}) + \rho_{I}^{b_{I}} H_{b}^{\infty}(i^{+}) \subset \bar{H}^{1/2 + b_{I} - 0}(i^{+}),$$
 (8.42)

where $h_{\ell}^+ = (\rho_I \partial_{\rho_I} h_{11})|_{\partial i^+} = (-2r \partial_0 h_{11})_{\partial i^+}$, so by Lemma 3.5

$$h_{\ell}^{+}(\theta) = \frac{1}{4} \int_{\beta^{-1}(\theta)} |N|^2 dx^1, \quad \theta \in \partial i^+.$$

Since $\widehat{\underline{L}}(0)$ is injective on $\overline{H}^{1/2+0}(i^+)$, the tensor h^+ on i^+ is uniquely determined by equation (8.41) and the 'boundary condition' (8.42). The strategy is to evaluate $h_{00}^+|_{\partial i^+}$ in two ways: one the one hand, this quantity vanishes identically by construction of the metric h in our DeTurck gauge; on the other hand, we will show that solving (8.41) directly yields the relation

$$\frac{1}{4\pi} \int_{\partial i^{+}} h_{00}^{+}|_{\partial i^{+}} d\phi = \frac{1}{2}m - \frac{1}{4}c, \quad c := \frac{1}{4\pi} \int_{\partial i^{+}} h_{\ell}^{+} d\phi, \tag{8.43}$$

which thus gives the desired conclusion. For the proof of (8.43), let us split $h^+ = h' + h''$, where

$$h' \in \mathcal{C}^{\infty}(i^+; S^{2 \operatorname{sc}} T_{i^+}^* \overline{\mathbb{R}^4}), \quad h'' \in h_{\ell}^+ \log \rho_I (dx^1)^2 + \overline{H}^{1/2+0}(i^+; S^{2 \operatorname{sc}} T_{i^+}^* \overline{\mathbb{R}^4})$$
 (8.44)

are the unique solutions with these properties solving the equations

$$\widehat{\underline{L}}(0)h' = -P(0)|_{i^+}, \tag{8.45}$$

$$\underline{\widehat{L}}(0)h'' = 0; \tag{8.46}$$

the first equation is uniquely solvable in this regularity class due to $P(0) \in C_c^{\infty}((i^+)^{\circ})$. We first solve (8.46) with the boundary condition (8.44), to the extent that we can determine h''_{00} . This can be viewed as a calculation of (a part of) the 'scattering matrix' of the operator $\underline{\hat{L}}(0)$ on i^+ , ³⁶ which can be done explicitly: writing points in i^+ using spherical coordinates as $Z = R\omega \in \mathbb{R}^3$, $R = r/t \in [0, 1]$, $\omega \in \mathbb{S}^2$, we have

$$-2\widehat{\underline{L}}(0) = R^{-2}D_R R^2 (1 - R^2)D_R + R^{-2} \Delta_{\omega} + 2,$$

acting component-wise on the coordinate trivialization of ${}^{\text{sc}}T^*\overline{\mathbb{R}^4}$; see (4.61) and (4.64). Since $\widehat{\underline{L}}(0)$ is SO(3)-invariant, it suffices to calculate $u_{00}|_{\partial i^+}$ for the solution of $\widehat{\underline{L}}(0)u=0$ for which $u-c\log\rho_I(dx^1)^2\in \overline{H}^{1/2+0}(i^+)$; recall that c was defined in (8.43). Now at i^+ ,

$$(dx^{1})^{2} = dt^{2} - 2\frac{Z^{i}}{|Z|} dt dx_{i} + \frac{Z^{i}Z^{j}}{|Z|^{2}} dx_{i} dx_{j},$$
 (8.47)

where we write x_i for the Euclidean coordinates on \mathbb{R}^3 ; observe then that if $Y_{\ell} \in \mathcal{C}^{\infty}(\mathbb{S}^2)$, $\Delta Y_{\ell} = \ell(\ell+1)Y_{\ell}$, denotes a spherical harmonic, then $\underline{\widehat{L}}(0)(u_{\ell}(R)Y_{\ell}(\omega)) = 0$ holds for

$$u_0 = R^{-1} \log(\frac{1-R}{1+R}), \quad u_1 = R^{-2} \log(\frac{1-R}{1+R}) + 2R^{-1}, \quad u_2 = \frac{3-R^2}{2R^3} \log(\frac{1-R}{1+R}) + 3R^{-2}; \quad (8.48)$$

Taylor expanding at R=0, one sees that $R^{-\ell}u_{\ell}$ is a smooth function of R^2 , hence $u_{\ell}Y_{\ell}$ is smooth there; moreover, u_{ℓ} satisfies the boundary condition $u_{\ell} - \log \rho_I = \mathcal{O}(1)$, $\rho_I = 1 - R$, at R=1. (In fact, u_{ℓ} is the unique solution with these two properties.) Using (8.47), we find $h'' = c \cdot (u_0 dt^2 - 2u_1 dt dr + u_2 dr^2)$, so writing $dt = (dx^0 + dx^1)/2$, $dr = \frac{Z^i}{|Z|} dx_i$, and $r = (dx^0 - dx^1)/2$ near ∂i^+ within i^+ , this gives

$$h_{00}''|_{\partial i^{+}} = c \cdot \left(\frac{1}{4}u_{0} - \frac{1}{2}u_{1} + \frac{1}{4}u_{2}\right)\Big|_{R=1} = -\frac{1}{4}c. \tag{8.49}$$

In order to solve (8.45), note first that the map $\underline{h} \in \mathcal{C}^{\infty}(i^+) \mapsto \rho^{-3} \operatorname{Ric}(\underline{g} + \rho \underline{h})|_{i^+}$ is linear in \underline{h} , $\underline{^{37}}$ hence writing $g_m =: g + \rho \underline{h}$, we have

$$P(0)|_{i^{+}} = \rho^{-3} (\operatorname{Ric}(\underline{g} + \rho \underline{h}) - \operatorname{Ric}(\underline{g}))|_{i^{+}} = \underline{\widehat{L}}(0)\underline{h} - \rho^{-3} \delta_{\underline{g}}^{*} \delta_{\underline{g}} G_{\underline{g}} \rho \underline{h};$$

for later use, we note that in a neighborhood of ∂i^+ in i^+ ,

$$\underline{h} = -2m\rho^{-1}r^{-1}(dt^2 + dr^2) = -m((dx^0)^2 + (dx^1)^2).$$
(8.50)

 $^{^{36}}$ Trivializing the 2-tensor bundle using coordinate differentials on \mathbb{R}^4 , a conjugated version of $\widehat{\underline{L}}(0)$ acts component-wise as the Laplacian of exact hyperbolic space with spectral parameter at the bottom of the spectrum; see Equations (4.1), (6.11), and (6.13) in [HiZw17].

³⁷This reflects the fact that the normal operator of the linearization of the Einstein equation around a metric of the form $\underline{g} + \rho \underline{h}$ only depends on the leading order part of the metric at i^+ , i.e. on \underline{g} ; see also Lemma 3.9.

This suggests writing $\rho h'$ as the sum of $-\rho \underline{h}$ (to solve away the first term) and a pure gauge term, so we make the ansatz

$$h' = -\underline{h} + \rho^{-1} \delta_g^* \omega + \widetilde{h}', \tag{8.51}$$

where $\omega \in \mathcal{C}^{\infty}((i^+)^{\circ}; {}^{\text{sc}}T_{i^+}^*\overline{\mathbb{R}^4}) \text{ solves}^{38}$

$$\rho^{-2}\delta_g G_g \delta_g^* \omega = \vartheta := \rho^{-2}\delta_g G_g(\rho \underline{h}) \in \mathcal{C}^{\infty}(i^+; {}^{\mathrm{sc}}T_{i^+}^* \overline{\mathbb{R}^4}), \tag{8.52}$$

and \widetilde{h}' is a solution of $\underline{\widehat{L}}(0)\widetilde{h}'=0$ which we will use to solve away any singular terms. We compute ϑ to leading order at ∂i^+ by using $r^2\delta_g r^{-1}dt^2=0$ and $r^2\delta_g r^{-1}dr^2=dr$, so

$$\vartheta = -2m dr = -m dx^0 + m dx^1 + \rho_I C^{\infty}(i^+).$$

Write $\rho^{-2}\delta_{\underline{g}}G_{\underline{g}}\delta_{\underline{g}}^* = \rho\underline{D}\rho^{-1}$, where $\underline{D} = \rho^{-3}\delta_{\underline{g}}G_{\underline{g}}\delta_{\underline{g}}^*\rho$ is $\frac{1}{2}$ times the wave operator on 1-forms on Minkowski space, re-weighted to a b-operator as usual, then equation (8.52) becomes

$$\widehat{\underline{D}}(i)(\rho_I^{-1}\omega) = \rho_I^{-1}\vartheta. \tag{8.53}$$

Now $\rho_I^{-1}\vartheta\in \bar{H}^{-1/2-0,\infty}(i^+)$, while $\underline{\widehat{D}}(i)^{-1}$: $\bar{H}^{s-1,\infty}(i^+)\to \bar{H}^{s,\infty}(i^+)$ for $s>-\frac{1}{2}$, see (7.14). Therefore, the solution satisfies $\omega\in\rho_I\bar{H}^{1/2-0,\infty}(i^+)\subset\rho_I^{1-0}H_{\rm b}^\infty(i^+)$ (by Sobolev embedding for functions of the single variable ρ_I), which using the expression (A.1) implies that ω does not contribute to $h'_{00}|_{\partial i^+}$, namely $(\rho^{-1}\delta^*_{\underline{g}}\omega)_{00}|_{\partial i^+}=(\rho^{-1}\partial_0\omega_0)|_{\partial i^+}=0$, where we used that $\rho^{-1}\partial_0$ is a multiple of the b-vector field $\rho_I\partial_{\rho_I}$ at ∂i^+ .

A careful inspection of the solution of (8.53) shows that $\rho^{-1}\delta_{\underline{g}}^*\omega$ is not smooth. Indeed, in the bundle splitting (2.17), we have $\underline{D} \in -2\rho^{-2}\partial_0\partial_1 + \operatorname{Diff}_b^2({}^0M)$, as follows from the same calculations as (B.13), so using the expression (7.19) for $\sigma = i$, we have $\underline{\widehat{D}}(i) \in \partial_{\rho_I}(\rho_I\partial_{\rho_I}+1)+\operatorname{Diff}_b^2(i^+)$, which implies that $^{39}\omega = \rho_I\log\rho_I\vartheta|_{\partial i^+}+\bar{H}^{5/2-0,\infty}(i^+)$; therefore

$$(\rho^{-1}\delta_{\underline{g}}^*\omega)|_{i^+} = (-dx^0 dx^1 + (dx^1)^2)m\log\rho_I \in \bar{H}^{3/2-0,\infty}(i^+).$$

Therefore, while we do have $\underline{\hat{L}}(0)(-\underline{h} + \rho^{-1}\delta_{\underline{g}}^*\omega) = -P(0)$, we need to correct the 2-tensor on the left by adding the unique solution \tilde{h}' of

$$\widehat{\underline{L}}(0)\widetilde{h}' = 0$$
, $\widetilde{h}' \in (dx^0 dx^1 - (dx^1)^2) m \log \rho_I + \overline{H}^{1/2+0}(i^+)$

in order for h' in (8.51) to have regularity above $\bar{H}^{1/2}(i^+)$, which, as remarked before, implies that it is the unique smooth solution of (8.45), as desired. Arguing similarly as around (8.47)–(8.48) and noting that $dx^0 dx^1 = dt^2 - dr^2 = dt^2 - \frac{Z^i Z^j}{|Z|^2} dx_i dx_j$, the solution is given by $\tilde{h}' = m(u_0 dt^2 - u_2 dr^2) - m(u_0 dt^2 - 2u_1 dt dr + u_2 dr^2)$. This gives

$$\tilde{h}'_{00}|_{\partial i^+} = \frac{1}{4}m(u_0 - u_2)|_{\partial i^+} - m \cdot (-\frac{1}{4}) = -\frac{1}{2}m.$$

In view of (8.50), we conclude that

$$h'_{00}|_{\partial i^+} = -\underline{h}_{00}|_{\partial i^+} + \widetilde{h}'_{00}|_{\partial i^+} = \frac{1}{2}m.$$

 $^{^{38}}$ We abuse notation by using the same expression for a b-operator on \mathbb{R}^4 and its Mellin-transformed normal operator at 0 frequency. Note that for a b-differential operator A, the operator $\widehat{A}(0)$ is independent of the choice of boundary defining function (unlike $\widehat{A}(\sigma)$ for $\sigma \neq 0$); see also [Va08, p. 762].

³⁹Using the arguments employed in the proof of Lemma 7.8, we in fact have $\rho_I^{-1}\omega \in \log \rho_I C^{\infty}(i^+) + C^{\infty}(i^+)$, as follows by constructing a formal solution at $\rho_I = 0$, starting with the stated leading order term, and solving away the remaining smooth error using $\widehat{\underline{D}}(i)^{-1}$.

Adding this to (8.49) establishes the relation (8.43), and proves $M_{\rm B}(+\infty)=0$.

Remark 8.15. The construction of Bondi–Sachs coordinates is local near $(\mathscr{I}^+)^\circ$ and as such did not rely on h being small. (The proof of Proposition 8.2 used the smallness of certain Christoffel symbols in a weighted \mathcal{C}^0 space, but this is automatic for any fixed $h \in \mathcal{X}^\infty$ if one relaxes the weights at \mathscr{I}^+ by a little and works in a sufficiently small neighborhood of \mathscr{I}^+ .) Likewise, the proof of Theorem 8.14 did not require h to be small. Therefore, we in fact conclude that any (large) solution of the Einstein vacuum equation of the form $g = g_m + \rho h$ (with m possibly large), $h \in \mathcal{X}^\infty$ —which requires it to decay to the Minkowski solution at i^+ —satisfies the conclusions of Theorem 8.14.

Let us connect this to the alternative definition of the Bondi mass and the mass loss formula used in §1.3, which has a more geometric flavor [Ch91]. To describe this, consider an outgoing null cone C_u and let

$$S_{u,\mathring{r}} := C_u \cap \{r = \mathring{r}\}$$

denote the 2-sphere of constant area radius (which is a particular choice of transversal of C_u). Let $L \in (TC_u)^{\perp}$ be a future-directed null normal vector field, i.e. a smooth positive multiple of ∇u ; then the null second fundamental form is

$$\chi_L(X,Y) := g(\nabla_X L, Y), \quad X, Y \in TS_{u,\mathring{r}}.$$

Note that $\chi_{aL} = a\chi_L$ for any function a. There exists a unique future-directed null vector field

$$\underline{L} \in (TS_{u,\hat{r}})^{\perp}$$
 such that $g(L,\underline{L}) = 2$. (8.54)

Define $T\underline{C}_u := TS_{u,\mathring{r}} \oplus \langle \underline{L} \rangle$, which is the tangent space (at $S_{u,\mathring{r}}$) of a null hypersurface \underline{C}_u which is the congruence of null-geodesics with initial condition on $S_{u,\mathring{r}}$ and initial velocity \underline{L} . (L and C_u , resp. \underline{L} and \underline{C}_u , are often called 'outgoing' and 'ingoing,' respectively.) The conjugate null second fundamental form is then

$$\chi_L(X,Y) := g(\nabla_X \underline{L}, Y) = -g(\nabla_X Y, \underline{L}), \quad X, Y \in TS_{u,\mathring{r}},$$

with the second expression showing that this depends only on \underline{L} at $S_{u,\mathring{r}}$. Letting $\mathring{g} := g|_{S_{u,\mathring{r}}}$ denote the induced metric, the trace-free parts of χ and χ are

$$\hat{\chi}_L := \chi_L - \frac{1}{2} \mathring{g} \operatorname{tr}_{\mathring{g}}(\chi_L), \quad \hat{\chi}_L := \underline{\chi}_{\underline{L}} - \frac{1}{2} \mathring{g} \operatorname{tr}_{\mathring{g}}(\underline{\chi}_{\underline{L}}).$$

Rescaling L to aL, we must rescale \underline{L} to $a^{-1}\underline{L}$, so the product $\operatorname{tr} \chi_L \operatorname{tr} \chi_{\underline{L}}$ is well-defined, and we may drop the subscripts on χ and χ . The *Hawking mass* of $S_{u,\mathring{r}}$ is defined as

$$M_{\rm H}(u,\mathring{r}) := \frac{\mathring{r}}{2} \left(1 + \frac{1}{16\pi} \int_{S(u,\mathring{r})} \operatorname{tr} \chi \operatorname{tr} \underline{\chi} \, dS \right), \tag{8.55}$$

where dS is the induced surface measure. For a 1-form, let us write its components ω in Bondi–Sachs coordinates as ω_u , $\omega_{\mathring{r}}$, $\omega_{\mathring{a}}$, a=2,3, similarly for higher rank tensors.

Lemma 8.16. We have $|M_H(u,\mathring{r}) - M_B(u)| \lesssim \mathring{r}^{-b_I+0}$, hence

$$\lim_{\mathring{r}\to\infty} M_{\mathrm{H}}(u,\mathring{r}) = M_{\mathrm{B}}(u).$$

Proof. We work in Bondi–Sachs coordinates, so $TS_{u,\mathring{r}} = \langle \partial_{\mathring{x}^2}, \partial_{\mathring{x}^3} \rangle$, and

$$\mathring{g}_{\mathring{a}\mathring{b}} = -\mathring{r}^2 \not g_{ab} + \mathring{r} h_{\bar{a}\bar{b}} + o(\mathring{r}), \quad (\mathring{g}^{-1})^{\mathring{a}\mathring{b}} = -\mathring{r}^{-2} \not g^{ab} - \mathring{r}^{-3} h^{\bar{a}\bar{b}} + o(\mathring{r}^{-3}).$$

Let us take $L = \partial_{\mathring{r}}$ and write $\chi \equiv \chi_L$, then $\chi_{\mathring{a}\mathring{b}}$ is the Christoffel symbol of the first kind, $\Gamma_{\mathring{b}\mathring{a}\mathring{r}} = g(\nabla_{\partial_{\mathring{x}^a}}\partial_{\mathring{r}}, \partial_{\mathring{x}^b})$. By Proposition 8.10, $g(\partial_{\mathring{x}^a}, \partial_{\mathring{r}^a}) \equiv 0$, therefore

$$\chi_{\dot{a}\dot{b}} = \frac{1}{2} \partial_{\dot{r}} g_{\dot{a}\dot{b}} = -\dot{r} \not g_{ab} + \frac{1}{2} h_{\bar{a}\bar{b}} + o(1), \tag{8.56}$$

which due to t/r h = o(1) gives

$$\operatorname{tr} \chi = 2\mathring{r}^{-1} + o(\mathring{r}^{-2}), \quad \hat{\chi}_{\mathring{a}\mathring{b}} = -\frac{1}{2}h_{\bar{a}\bar{b}} + o(1).$$
 (8.57)

Next, a simple calculation shows that the unique future-directed null vector field \underline{L} defined in (8.54) is given by

$$\underline{L} = (2 + o(\mathring{r}^{-1}))\partial_u - (1 - 2m\mathring{r}^{-1} - 2\partial_0 h_{11} + \frac{1}{2}\mathring{r}^{-1}\nabla_a \nabla_b h^{\bar{a}\bar{b}} + o(\mathring{r}^{-1}))\partial_{\mathring{r}} + ((-h_1^{\bar{a}} + \frac{1}{2}\nabla_b h^{\bar{a}\bar{b}})\mathring{r}^{-2} + o(\mathring{r}^{-2}))\partial_{\mathring{a}}.$$

(The spherical component is determined by $g(\underline{L}, \partial_{\mathring{c}}) = 0$, c = 2, 3, the ∂_u component by $g(\underline{L}, L) = 2$, and the $\partial_{\mathring{r}}$ component by $g(\underline{L}, \underline{L}) = 0$.) Working in normal coordinates on \mathbb{S}^2 , using $\Gamma_{u\mathring{a}\mathring{b}} = -\frac{1}{2}\mathring{r}\partial_u h_{\bar{a}\bar{b}} - \frac{1}{4}(\nabla_a h_{1\bar{b}} + \nabla_b h_{1\bar{a}}) + \frac{1}{8}(\nabla_a \nabla_c h_{\bar{b}}{}^{\bar{c}} + \nabla_b \nabla_c h_{\bar{a}}{}^{\bar{c}}) + o(1)$, $\Gamma_{\mathring{r}\mathring{a}\mathring{b}} = \mathring{r} \not g_{ab} - \frac{1}{2}h_{\bar{a}\bar{b}} + o(1)$, and $\Gamma_{\mathring{c}\mathring{a}\mathring{b}} = o(\mathring{r}^2)$, the components of $\underline{\chi} := \underline{\chi}_{\underline{L}}$ are

$$\underline{\chi}_{\mathring{a}\mathring{b}} = -\Gamma_{\mathring{\mu}\mathring{a}\mathring{b}} \underline{L}^{\mathring{\mu}} = (\mathring{r} - 2m - 2\mathring{r}\partial_{0}h_{11} + \frac{1}{2}\nabla_{c}\nabla_{d}h^{\bar{c}\bar{d}})\not g_{ab} + \mathring{r}\partial_{u}h_{\bar{a}\bar{b}} \\
- \frac{1}{2}h_{\bar{a}\bar{b}} + \frac{1}{2}(\nabla_{a}h_{1\bar{b}} + \nabla_{b}h_{1\bar{a}}) - \frac{1}{4}(\nabla_{a}\nabla_{c}h_{\bar{b}}^{\bar{c}} + \nabla_{b}\nabla_{c}h_{\bar{a}}^{\bar{c}}) + o(1), \tag{8.58}$$

which gives

$$\operatorname{tr} \underline{\chi} = -2\mathring{r}^{-1} + (4m + 4\mathring{r}\partial_{0}h_{11} - \frac{1}{2}\nabla_{a}\nabla_{b}h^{\bar{a}\bar{b}} - \nabla_{a}h_{1}^{\bar{a}})\mathring{r}^{-2} + o(\mathring{r}^{-2}),$$

$$\underline{\hat{\chi}}_{\mathring{a}\mathring{b}} = \mathring{r}\partial_{u}h_{\bar{a}\bar{b}} + (\frac{1}{4}\nabla_{c}\nabla_{d}h^{\bar{c}\bar{d}} - \frac{1}{2}\nabla_{c}h_{1}^{\bar{c}})\not g_{ab} + \frac{1}{2}h_{\bar{a}\bar{b}}$$

$$+ \frac{1}{2}(\nabla_{a}h_{1\bar{b}} + \nabla_{b}h_{1\bar{a}}) - \frac{1}{4}(\nabla_{a}\nabla_{c}h_{\bar{b}}^{\bar{c}} + \nabla_{b}\nabla_{c}h_{\bar{a}}^{\bar{c}}) + o(1).$$
(8.59)

Finally, the surface measure on $S_{u,\mathring{r}}$ is $|\det\mathring{g}|^{1/2}|d\mathring{x}^a\,d\mathring{x}^b|=(\mathring{r}^2\not g_{ab}+o(\mathring{r}))|d\mathring{x}^a\,d\mathring{x}^b|$, hence the Hawking mass is $M_{\rm H}(u,\mathring{r})=m+\frac{1}{4\pi}\int_{S(u)}\mathring{r}\partial_0h_{11}\,d\not g+o(1)=M_{\rm B}(u)+o(1)$. (As usual, the o(1) remainder is really symbolic as $\mathring{r}\to 0$, namely of class S^{-b_I+0} .)

With L and \underline{L} defined as in the proof of the lemma, consider the conjugate null vectors aL and $a^{-1}\underline{L}$. By (8.57) and (8.59), there exists a unique $a = 1 + \mathcal{O}(\mathring{r}^{-1})$ such that

$$\operatorname{tr} \chi_{aL} + \operatorname{tr} \underline{\chi}_{a^{-1}\underline{L}} = a^{-1}(a^2 \operatorname{tr} \chi + \operatorname{tr} \underline{\chi}) = 0; \tag{8.60}$$

thus $\hat{\underline{\chi}}_{a^{-1}\underline{L}} = \mathring{r}\partial_u h_{\bar{a}\bar{b}} + \mathcal{O}(1) = \hat{\underline{\chi}} + \mathcal{O}(1)$, hence to leading order, the normalization (8.60) does not change $\hat{\chi}$. We can now calculate the *outgoing energy flux* through $S_{u,\mathring{r}}$,

$$\underline{E}(u, \mathring{r}) = \frac{1}{32\pi} \int_{S(u, \mathring{r})} |\hat{\underline{\chi}}|^2 dS = \frac{1}{32\pi} \int_{S(u)} |N|_{\mathscr{J}}^2 dS + o(1),$$

with $N_{ab} = \partial_u h_{\bar{a}\bar{b}}$ is as in Theorem 8.14.⁴⁰ Clearly, \underline{E} has a limit $E(u) = \lim_{\mathring{r} \to \infty} \underline{E}(u,\mathring{r})$ at null infinity, and the Bondi mass loss formula (8.40) then takes the equivalent form

$$\frac{d}{du}M_{\rm B}(u) = -E(u).$$

⁴⁰Using (8.59), we could compute a as well as $\underline{E}(u,\mathring{r})$ to one more order, exhibiting a \mathring{r}^{-1} term plus a $o(\mathring{r}^{-1})$ remainder for both.

APPENDIX A. CONNECTION COEFFICIENTS, CURVATURE COMPONENTS, AND NATURAL OPERATORS

We list the results of calculations used in the main body of the paper: geometric quantities and relevant differential operators for the exact Schwarzschild metric in $\S A.1$, its perturbations (as considered in $\S 3.1$) near null infinity in $\S A.2$, and near the temporal face of the Minkowski metric in $\S A.3$.

$$\begin{split} &\Gamma_{100} = \frac{1}{2} m r^{-3} (r - 2m), \quad \Gamma_{c0b} = -\frac{1}{2} (r - 2m) \not g_{bc}, \quad \Gamma_{011} = -\frac{1}{2} m r^{-3} (r - 2m), \\ &\Gamma_{c1b} = \frac{1}{2} (r - 2m) \not g_{bc}, \qquad \Gamma_{0ab} = \frac{1}{2} (r - 2m) \not g_{ab}, \qquad \Gamma_{1ab} = -\frac{1}{2} (r - 2m) \not g_{ab}, \\ &\Gamma_{00}^{0} = m r^{-2}, \qquad \qquad \Gamma_{0b}^{c} = \frac{1}{2} r^{-1} (1 - \frac{2m}{r}) \delta_{b}^{c}, \quad \Gamma_{11}^{1} = -m r^{-2}, \\ &\Gamma_{1b}^{c} = -\frac{1}{2} r^{-1} (1 - \frac{2m}{r}) \delta_{b}^{c}, \quad \Gamma_{ab}^{0} = -r \not g_{ab}, \qquad \qquad \Gamma_{ab}^{1} = r \not g_{ab}. \end{split}$$

The only non-zero components of the Riemann curvature tensor (up to reordering the last two indices) are $R^a{}_{bcd} = 2mr^{-1}(\delta^a_c g_{bd} - \delta^a_d g_{bc})$ and

$$\begin{split} R^0{}_{001} &= -mr^{-3}(1-\tfrac{2m}{r}), \quad R^0{}_{b0d} = -mr^{-1} \not g_{bd}, \qquad \qquad R^1{}_{101} = mr^{-3}(1-\tfrac{2m}{r}), \\ R^1{}_{b1d} &= -mr^{-1} \not g_{bd}, \qquad \qquad R^a{}_{01d} = -\tfrac{1}{2}mr^{-3}(1-\tfrac{2m}{r})\delta^a_d, \quad R^a{}_{10d} = -\tfrac{1}{2}mr^{-3}(1-\tfrac{2m}{r})\delta^a_d. \end{split}$$

With respect to the rescaled bundle splittings (2.17) and (2.19), we have

$$g_m^S = (0, \tfrac{1}{2}(1-\tfrac{2m}{r}), 0, 0, 0, -\cancel{p})^T, \quad \operatorname{tr}_{g_m^S} = (0, \tfrac{4r}{r-2m}, 0, 0, 0, -\cancel{tr}),$$

further

We also record $dt = (\frac{1}{2}, \frac{1}{2}, 0)^T$, $\nabla^{g_m^S} t = \frac{r}{r-2m}(1, 1, 0)$, and, paralleling the definition of $\tilde{\delta}^*$ from (3.3), we have, near S_+ ,

A.2. Perturbations of Schwarzschild near the light cone. We consider a metric $g = g_m + \rho h = g_m^S + r^{-1}h$, with the perturbation $h \in \mathcal{X}^{\infty;b_0,b_I,b_I',b_+}$ lying in the function space of Definition 3.1, and continue using the splittings (2.21) of $(S^2)T^*\mathbb{R}^4$; however, we express the components of h using the rescaled splitting (2.19), since for $h \in \mathcal{X}^{\infty}$ all components $h_{\bar{\mu}\bar{\nu}}$ lie in the same space $H_b^{\infty;b_0,-\epsilon,b_+}$; more precisely, they satisfy (3.4)–(3.6). The components $g_{\mu\nu}$ and $g^{\mu\nu}$ were already computed, see (3.14) and (3.15). Recall also the observation (3.7) and the memberships (2.26). We shall write b-0 for weights which can be taken to be $b-\epsilon$ for any $\epsilon>0$; any two choices of ϵ are equivalent due to the assumption that all components of h have leading terms (possibly with a factor $\log \rho_I$ for h_{11}) at \mathscr{I}^+ . The only part of the analysis that relies on the precise structure of the gauged Einstein equation is the analysis at \mathscr{I}^+ , so in the calculations below, the weight at \mathscr{I}^+ is the most important one. We compute:

$$R^0_{\bar{b}1\bar{d}} \in -r^{-1}\partial_1\partial_1 h_{\bar{b}\bar{d}} + H_{\mathrm{b}}^{\infty;3+b_0,2-0,3+b_+}, \quad R^{\bar{a}}_{11\bar{d}} \in -\frac{1}{2}r^{-1}\partial_1\partial_1 h_{\bar{d}}^{\bar{a}} + H_{\mathrm{b}}^{\infty;3+b_0,2-0,3+b_+},$$

while all other components lie in $H_{\rm b}^{\infty;3-0,1+b_I',3+b_+}$; the decay order at i^0 is due to the contributions from the asymptotic Schwarzschild metric, as e.g. in R^0_{001} . On the other hand, (A.8) shows that ${\rm Ric}(g) \in H_{\rm b}^{\infty;3+b_0,1+b_I',3+b_+}$. Using the form (3.15) of g^{-1} , this gives

Next, we have $(\mathscr{Y}_g u)_{\bar{\kappa}} = \Upsilon(g)^{\bar{\lambda}} u_{\bar{\kappa}\bar{\lambda}}$, with $\Upsilon(g)^{\bar{\lambda}} \in H_b^{\infty;2+b_0,1+b'_I,2+b_+}$ by (A.4). Now, equation (3.3) implies

$$\widetilde{\delta}^* - \delta_{q_m}^* \in \rho \, \mathcal{C}^{\infty}(M; \operatorname{Hom}(\beta^* \, {}^{\operatorname{sc}} T^* \overline{\mathbb{R}^4}, \beta^* S^2)),$$
 (B.2)

so the expression for $\widetilde{\delta}^*$ obtained from (A.1) and the inclusions (2.39) show that

$$\widetilde{\delta}^* \in \rho_0 \rho_+ \mathcal{M}_{\beta^* \text{ sc} T^* \overline{\mathbb{R}^4} \beta^* S^2} + \rho \operatorname{Diff}_{b}^{1}(M; \beta^* \text{ sc} T^* \overline{\mathbb{R}^4}, \beta^* S^2), \tag{B.3}$$

and therefore

$$\rho^{-3}\widetilde{\delta}^* \mathscr{Y}_q \rho \in H_b^{\infty; 1+b_0, -1+b_I', 1+b_+} \mathcal{M} + H_b^{\infty; 1+b_0, b_I', 1+b_+} \text{Diff}_b^1.$$
 (B.4)

The only terms of \mathscr{C}_g which will contribute leading terms come from the components $C_{\bar{\kappa}\bar{\mu}\bar{\nu}}$ which are of size at least ρ_I at \mathscr{I}^+ ; these are, modulo $H_{\rm b}^{\infty;2+b_0,2-0,2+b_+}$,

$$C_{011} \equiv r^{-1} \partial_1 h_{01}, \ C_{111} \equiv \frac{1}{2} r^{-1} \partial_1 h_{11}, \ C_{\bar{c}11} \equiv r^{-1} \partial_1 h_{1\bar{c}}, \ C_{\bar{c}1\bar{b}} \equiv -C_{1\bar{c}\bar{b}} \equiv \frac{1}{2} r^{-1} \partial_1 h_{\bar{b}\bar{c}}, \ (B.5)$$

while all other components lie in $H_{\rm b}^{\infty;2+b_0,1+b_I',2+b_+}$. Therefore, writing sections of β^* sc $T^*\mathbb{R}^4$ in terms of the splitting (2.17), we have

$$\mathscr{C}_g \in \begin{pmatrix} 4r^{-1}\partial_1 h_{01} & 0 & 0 & 0 & 0 & 0 \\ 2r^{-1}\partial_1 h_{11} & 0 & 0 & 0 & 0 & -\frac{1}{2}r^{-1}\partial_1 h^{\bar{a}\bar{b}} \\ 4r^{-1}\partial_1 h_{1\bar{b}} & 0 & -2r^{-1}\partial_1 h_{\bar{b}}^{\bar{a}} & 0 & 0 & 0 & 0 \end{pmatrix} + H_b^{\infty;2+b_0,1+b_I',2+b_+},$$

and then (A.1), (B.2), and (B.3) give

the only terms of $\widetilde{\delta}^*$ which contribute leading terms to this operator are the ∂_1 derivatives in $\delta_{q_m}^*$.

For the second summand in (3.21), we note that $G_{g_m} \in \mathcal{C}^{\infty}(\overline{\mathbb{R}^4}, \operatorname{End}(S^{2 \operatorname{sc}} T^* \overline{\mathbb{R}^4}))$, while equation (3.16) gives $G_g \in G_{g_m} + H_b^{\infty; 1+b_0, 1-0, 1+b_+}(\beta^* S^2)$. Further, using the notation (2.22) and setting $\Gamma_{\bar{\mu}\bar{\nu}}^{\bar{\kappa}} := r^{s(\kappa)-s(\mu,\nu)}\Gamma_{\mu\nu}^{\kappa}$, we have

$$(\delta_g u)_{\bar{\mu}} = -r^{-s(\mu,\nu,\lambda)} g^{\bar{\nu}\bar{\lambda}} \partial_{\lambda} (r^{s(\mu,\nu)} u_{\bar{\mu}\bar{\nu}}) + g^{\bar{\nu}\bar{\lambda}} (\Gamma^{\bar{\kappa}}_{\bar{\mu}\bar{\lambda}} u_{\bar{\kappa}\bar{\nu}} + \Gamma^{\bar{\kappa}}_{\bar{\nu}\bar{\lambda}} u_{\bar{\mu}\bar{\kappa}}); \tag{B.7}$$

now $r^{-s(\lambda)}\partial_{\lambda}\in\rho\,\mathcal{V}_{\mathrm{b}}(M)$ unless $\lambda=1,$ and moreover

$$\Gamma^{\bar{\kappa}}_{\bar{\mu}\bar{\nu}} \in \rho \, \mathcal{C}^{\infty} + H_{\mathbf{b}}^{\infty;2+b_0,1-0,2+b_+} \tag{B.8}$$

for all indices, and $g^{01} - 2 \in \rho \mathcal{C}^{\infty} + H_{\rm b}^{\infty;1+b_0,1-0,1+b_+}$, hence only the terms with $g^{01}\partial_1$ survive to leading order:

$$\delta_g \in \begin{pmatrix} -2\partial_1 & 0 & 0 & 0 & 0 & 0 & 0 \\ 0 & -2\partial_1 & 0 & 0 & 0 & 0 & 0 \\ 0 & 0 & -2\partial_1 & 0 & 0 & 0 & 0 \end{pmatrix} + (\rho \mathcal{C}^{\infty} + H_{\mathbf{b}}^{\infty;2+b_0,1-0,2+b_+}) \mathrm{Diff}_{\mathbf{b}}^{\mathbf{1}}.$$

Since $((\delta_g^* - \delta_{g_m}^*)u)_{\bar{\mu}\bar{\nu}} = -C^{\bar{\kappa}}_{\bar{\mu}\bar{\nu}}u_{\bar{\kappa}} \in H_b^{\infty;2+b_0,1-0,2+b_+}$ from the calculations around (B.5), we can now use the precise forms (A.1) and (A.2) of G_{g_m} and $\tilde{\delta}^* - \delta_{q_m}^*$ to obtain

$$\rho^{-3}(\widetilde{\delta}^* - \delta_g^*)\delta_g G_g \rho \in -\rho^{-1}\partial_1 \begin{pmatrix} 2\gamma_1 & 0 & 0 & 0 & 0 & 0 \\ \gamma_1 - \gamma_2 & 0 & 0 & 0 & 0 & \frac{1}{2}(\gamma_1 - \gamma_2) & 0 \\ 0 & 0 & \gamma_1 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0 & \gamma_1 & 0 \\ 0 & 0 & \gamma_1 & 0 & 0 & 0 & 0 \\ 2\gamma_2 & 0 & 0 & 0 & 0 & \gamma_2 & 0 \\ 0 & 0 & 0 & 0 & 0 & 0 & 0 \end{pmatrix}$$

$$+ (\mathcal{C}^{\infty} + H_b^{1+b_0, -0, 1+b_+}) \text{Diff}_b^1.$$
(B.9)

Finally, we determine the leading terms of

$$(\Box_g u)_{\bar{\mu}\bar{\nu}} = -r^{-s(\mu,\nu,\kappa,\lambda)} g^{\bar{\kappa}\bar{\lambda}} \partial_{\lambda} (r^{s(\mu,\nu,\kappa)} u_{\bar{\mu}\bar{\nu};\bar{\kappa}}) + g^{\bar{\kappa}\bar{\lambda}} (\Gamma^{\bar{\sigma}}_{\bar{\mu}\bar{\lambda}} u_{\bar{\sigma}\bar{\nu};\bar{\kappa}} + \Gamma^{\bar{\sigma}}_{\bar{\nu}\bar{\lambda}} u_{\bar{\mu}\bar{\sigma};\bar{\kappa}} + \Gamma^{\bar{\sigma}}_{\bar{\kappa}\bar{\lambda}} u_{\bar{\mu}\bar{\nu};\bar{\sigma}}).$$
(B.10)

Consider $u_{\bar{\mu}\bar{\nu};\bar{\kappa}} = r^{-s(\mu,\nu,\kappa)}\partial_{\kappa}(r^{s(\mu,\nu)}u_{\bar{\mu}\bar{\nu}}) - \Gamma^{\bar{\lambda}}_{\bar{\mu}\bar{\kappa}}u_{\bar{\lambda}\bar{\nu}} - \Gamma^{\bar{\lambda}}_{\bar{\kappa}\bar{\nu}}u_{\bar{\mu}\bar{\lambda}}$. For $\kappa = 0$, all Christoffel symbols except for those with κ,λ both spherical lie in $\rho^2 \mathcal{C}^{\infty} + H_{\rm b}^{\infty;2+b_0,1+b'_I,2+b_+}$, while $\Gamma^{\bar{c}}_{0\bar{b}} \in \frac{1}{2}r^{-1}\delta^c_b + \rho^2 \mathcal{C}^{\infty} + H_{\rm b}^{\infty;2+b_0,2-0,2+b_+}$; the contributions of the latter cancel the leading part of the term coming from differentiating the weight $r^{-s(\mu,\nu)}\partial_0(r^{s(\mu,\nu)}) = \frac{1}{2}s(\mu,\nu)r^{-1} + r^{-2}\mathcal{C}^{\infty}$. For $\kappa \neq 0$, we use the rough estimate (B.8), and obtain

$$u_{\bar{\mu}\bar{\nu};0} \in \partial_{0}u_{\bar{\mu}\bar{\nu}} + (\rho^{2}\mathcal{C}^{\infty} + H_{b}^{\infty;2+b_{0},1+b'_{I},2+b_{+}})u$$

$$\subset (\rho\mathcal{C}^{\infty} + H_{b}^{\infty;2+b_{0},1+b'_{I},2+b_{+}})\mathrm{Diff}_{b}^{1}u,$$

$$u_{\bar{\mu}\bar{\nu};1} \in \partial_{1}u_{\bar{\mu}\bar{\nu}} + (\rho\mathcal{C}^{\infty} + H_{b}^{\infty;2+b_{0},1-0,2+b_{+}})u,$$

$$u_{\bar{\mu}\bar{\nu};\bar{c}} \in (\rho\mathcal{C}^{\infty} + H_{b}^{\infty;2+b_{0},1-0,2+b_{+}})\mathrm{Diff}_{b}^{1}u.$$
(B.11)

In the second line of (B.10) then, the only relevant terms (namely, with coefficients not decaying faster than ρ_I) are those with u differentiated along ∂_1 and the corresponding prefactor being of size at least ρ_I ; using

$$g^{\bar{\kappa}\bar{\lambda}}\Gamma^{1}_{\bar{\kappa}\bar{\lambda}} \in -2r^{-1} + \rho^{2}\mathcal{C}^{\infty} + H_{b}^{\infty;2+b_{0},1+b'_{I},2+b_{+}},$$
 (B.12)

this leaves us with

$$g^{10}\Gamma^{\bar{\sigma}}_{\bar{\mu}0}u_{\bar{\sigma}\bar{\nu};1} + g^{10}\Gamma^{\bar{\sigma}}_{\bar{\nu}0}u_{\bar{\mu}\bar{\sigma};1} + g^{\bar{\kappa}\bar{\lambda}}\Gamma^{1}_{\bar{\kappa}\bar{\lambda}}u_{\bar{\mu}\bar{\nu};1} + (\rho^{2}\mathcal{C}^{\infty} + H_{b}^{\infty;3+b_{0},2-0,3+b_{+}})Diff_{b}^{1}$$

$$\subset (s(\mu,\nu)-2)r^{-1}\partial_{1}u_{\bar{\mu}\bar{\nu}} + H_{b}^{3+b_{0},1+b'_{I},3+b_{+}}\mathcal{M}u + (\rho^{2}\mathcal{C}^{\infty} + H_{b}^{\infty;3+b_{0},2-0,3+b_{+}})Diff_{b}^{1}u.$$

Turning to the first line of (B.10), for $\lambda=0$, indices $\kappa\neq 1$ contribute terms of the form $H_{\rm b}^{\infty;3+b_0,3-0,3+b_+}{\rm Diff}_{\rm b}^2u$ due to (B.11) and the decay of $g^{\bar\kappa\bar\lambda}$, while $\kappa=1$ gives a term $-2r^{-s(\mu,\nu)}\partial_0 r^{s(\mu,\nu)}\partial_1 u_{\bar\mu\bar\nu}+(\rho^2\,\mathcal C^\infty+H_{\rm b}^{\infty;3+b_0,2-0,3+b_+}){\rm Diff}_{\rm b}^2u$. For $\lambda=1$, the term with $\kappa=0$ is equal to $-2\partial_1\partial_0 u_{\bar\mu\bar\nu}+(\rho^2\,\mathcal C^\infty+H_{\rm b}^{\infty;3+b_0,2-0,3+b_+}){\rm Diff}_{\rm b}^2u$; $\kappa=1$ produces (due to the decay of the long range component h_{00})

$$-r^{-s(\mu,\nu)}g^{11}\partial_1(r^{s(\mu,\nu)}u_{\bar{\mu}\bar{\nu};1}) \in H_{\mathbf{h}}^{\infty;3+b_0,1+b_I',3+b_+}\mathcal{M}^2u$$

and spherical κ give $H_{\rm b}^{\infty;3+b_0,2-0,3+b_+}{\rm Diff}_{\rm b}^2u$. Lastly, if λ is a spherical index and $\kappa=0,1$, we get a term in $H_{\rm b}^{\infty;3+b_0,2-0,3+b_+}{\rm Diff}_{\rm b}^2u$, while for spherical κ , we use (3.16) to deduce that the non-trivial spherical components of g^{-1} give a term in $(\rho^2\mathcal{C}^\infty+H_{\rm b}^{\infty;3+b_0,2-0,3+b_+}){\rm Diff}_{\rm b}^2u$. Putting everything together, and conjugating by weights, we obtain

$$\rho^{-3}\Box_g \rho \in -4\rho^{-2}\partial_0\partial_1 + H_{\mathbf{b}}^{1+b_0,-1+b_I',1+b_+} \mathcal{M}^2 + (\mathcal{C}^{\infty} + H_{\mathbf{b}}^{\infty;1+b_0,-0,1+b_+}) \operatorname{Diff}_{\mathbf{b}}^2.$$
 (B.13)

(Note that due to the discussion after (2.39), the first term here is well-defined modulo $\operatorname{Diff}_{\mathrm{b}}^{1}(M;\beta^{*}S^{2})$.) Together with the expressions (B.1), (B.4), (B.6), and (B.9), this proves the lemma.
